Proposed Bylaws Revisions

ARTICLE I

Sec. 2. The initiation fee shall be \$7.50

Sec. 3. The annual dues of members shall be as suggested annually by the budget committee and approved by council, Dues for members joining the council after July 1 shall be one-half the amount set for annual dues. This fee may be waived by council's discretion as appropriate.

ARTICLE IV – Meetings

Section 1. Regular meetings of the Council shall be held twice a month on a regular basis. The first meeting each month shall be a regular business meeting. All meetings shall commence at a time determined by the Grand Knight. Seven members shall constitute a quorum at business meetings. Any changes to the regular schedule of meetings shall be announced to the membership.

ARTICLE VI – Committees

Section 1.

(h) Budget Committee to prepare a budget for approval and/or revision by the council. The budget shall cover the period of July to June and shall be submitted to the council at the first meeting of July. Notice of annual budget approval meeting shall be duly published for members' notification. Copies of the budget shall be available to any council member upon request. Any unbudgeted funds to be spent over the amount of \$2,000.00 shall be published to the General Membership by mail before voting upon.

ARTICLE VII – Funds

Sec. 3. No money in excess of \$300.00 shall be paid or transferred from the Treasury of this Council, except such moneys as the Council is called upon to regularly pay for its current expenses and as provided by the Laws of the Order or for purposes

approved by the Supreme Council or Board of Directors, unless by a two-thirds vote of the members present and voting at a regular business meeting held subsequent to a regular business meeting at which notice in writing of a resolution of intention to pay or transfer such money and the purpose and amount to be paid or transferred shall have been given and regularly read.

Relief Fund

Sec. 5. The Grand Knight, Financial Secretary and the Treasurer shall constitute a Relief Committee. They shall be authorized to waive the dues of any member who is in need. This waiver shall be on a yearly basis.

Sec. 6. Special Brothers in Need Fund Sec. 6.

A Brothers in Need Fund shall be maintained as a hardship emergency fund for Council members in good standing, to enable the Council to quickly assist with a Brother Knight's temporary need in a financially difficult time. A qualifying hardship shall include the unemployment of a Brother Knight, a medical emergency involving a Brother Knight or immediate family member, or the death of an immediate family member. For these purposes, the "immediate family" of a Brother Knight shall include his wife and dependent children. Any request for moneys from this Fund shall be made by a Brother Knight, Deputy Grand Knight, and decisions to honor or reject any such request shall be made by a majority vote of the Grand Knight, Deputy Grand Knight, and Treasurer. The Deputy Grand Knight and Treasurer will be made aware of the needs of the subject Brother, but will not be made aware of the Brother's name. In order to protect the identity of the subject Brother, moneys from this Fund will be sent directly to such Brother's identified creditor (s), except that moneys provided for food will be in the form of vouchers. Disbursements from this Fund shall not exceed \$2,000 in any fiscal year, and shall be limited to \$500 per Knight during any twelve month period. Funding for the Brothers in Need Fund shall be derived from reserve funds, Council fundraisers, or other contributions; and, shall not be derived from operating funds or budgeted items.

ARTICLE VIII – Funerals, Etc.

Sec. 2. When notice of the death of a member in good standing is received the Memorial Committee shall forward to the family of the deceased a message of condolence on behalf of the Council and the Memorial Committee shall arrange to have a perpetual Mass said for the repose of the soul of the deceased.
