### Knights of Columbus Free Throw-Athon – February 21, 2021

**DATE:** FEBRUARY 21, 2021

**TIME:** 11:00AM – 5:00PM

**LOCATION:** ARENA (FOYER, RESTROOMS, MAIN FLOOR)

**ATTENDEES:** STUDENTS, NCHS PERSONNEL, VOLUNTEERS, ETC.

All Safety Precautions and Details follow the recommendations and guidance of the University Scholastic League (UIL) as well as the Texas Association of Private and Parochial Schools (TAPPS). IN ADDITION, NCHS FOLLOWS THE GUIDANCE OF THE TARRANT COUNTY PUBLIC HEALTH DEPARTMENT FOR ALL REPORTED COVID-19 CASES AT NCHS AND SUBSEQUENT QUARANTINE GUIDELINES.

#### **Requirements before all Activities-Events:**

- Before the start of any school activity-event, Nolan Catholic will pre-screen all participants for COVID-19 symptoms that they may experience. THIS WILL BE ACCOMPLISH WITH THE FOLLOWING “CHECK IN” PROCEDURE
  - Participants and parent/guardian/sibling will check in in the foyer area of the Arena
  - Two stations will be set up to promote quick check in and avoid overcrowding.
  - Temperatures will be taken and questions asked as a part of the NCHS standard COVID mitigation protocols for visitors.
- There will be a hand sanitizing station, staffed by an NCHS employee which all participants will be made to utilize before they begin and after the complete

their event-activity. Accommodations must be made for hand washing or hand sanitizing during the event.

- **Masks will be worn at all times.**
- Except for reasonable safety concerns, participants must maintain at least six feet of distance during all activities-events. Indoor activities can be conducted up to a maximum of 50%.
- There will be no sharing of liquids, foods during this event/activity. Participants must bring their own labeled water containers.
- Any used surface must be thoroughly disinfected before another participant uses it. (Basketballs will be sprayed between use by participants)

### **Locker Room Access and Flow**

- Locker room will not be available for this activity.

### **Mitigating Spread Before/During/After Activity-Event**

- Administrators of the event, participant and the parent/guardian/sibling, will ALL submit to the standard NCHS visitor COVID mitigation protocols (temperature taken and questions answered).
- Participants will be assigned specific locations within the main floor area to promote distancing. The four side baskets will be used and participants and their spectator will be assigned to sit in those same areas.
- **Masks are required at all times**
- All high touch surfaces (Tables, chairs, equipment, etc.) will be disinfected before the event begins, between the two sessions, and again at the end of the activity.
- The basketballs used will be disinfected before the event, between used by different participants, and at the conclusion of the event.
- The arena seating/ railings/etc. will be disinfected before the event. In between sessions, and at the conclusion of the event.

### **Process for Water for each participant**

- Each participant must provide their own labeled and sealable water container.

### **Parent Communication**

- The Knights of Columbus representatives responsible for the running of this event will send a communication to all participants and their families outlining, in details, the activity schedule for the day, including specified arrival times, as well the COVID mitigation protocols that will be a functioning part of this event. Participants and their families must be clear on what is expected of them.

### **Activity Specific Instruction (Flow of the 2 Sessions)**

#### **General Instructions**

- Participants and staff must maintain at least 6 feet of distance from all sides during the activity except for unavoidable and approved situations.

- Participants must be placed in working groups small enough to provide for proper social distancing.
- Each working group should maintain appropriate distance from other working groups.
- Any equipment used should be regularly disinfected during the activity. This equipment should not be shared between working groups. **After a working group has used the equipment, that equipment must be thoroughly disinfected before being used by a different group.**
- Indoor activities can be conducted up to a maximum of 50% capacity for the area of the facility being used.

### **Session One – 12:00-2:00PM (9-11-year-old boys & girls)**

- All participants (and spectators) will enter through the main doors to the Arena.
- All that enter the Arena must first complete a COVID screening (temperature & questions)
- After COVID screening, participants will move to one of four registration tables in the foyer of the Arena to complete registration
- At the registration station, participants and spectators will be assigned a specific area/basket. They are to report to the seating area near the basket where they were assigned and sit in the stands until called down to the floor when the competition begins.
- All those that enter the main floor area of the Arena will be ask to select a seat and use only that seat during the entirety of the session.
- There will be four baskets used for this competition (The four side baskets which will provide good viewing and appropriate spacing from the other baskets.)
- Competition Flow
  - One participant at each basket seating area will be called to their area basket, warm up, and begin shooting free throws as instructed.
  - Three volunteers will be assigned to each basket, one of them will be assigned as the “rebounder.” The rebounder will wear non-latex gloves.
  - Two additional participants will be seated in chairs (appropriately distanced) on the main floor near the basket that they will shoot. When the “next” shooter is called up from one of the “on deck” chairs, that chair will be wiped down with disinfectant before the next participant is call down from the stands to sit in the chair awaiting his/her turn.
  - When a participant has completed his/her free throws, they are to return to the seat in the stands where they sat before being called down to the floor.
  - Four basketballs will be assigned to each basket. (2 girls, 2 boys)
    - After each participant completes their free throws, the ball used will be spray disinfected.
    - While it is drying, the next participant will use the other properly sized ball to begin warm up for their competition.
    - The “rebounder” will change gloves (or spray disinfect them) between each participant.

- First place winners in each category will shoot 25 free throws for the state competition. One per basket.
- Awarding of Medals at the end of each session.
  - Medals come in packages and the packages will be cleaned before the event begins. Medals will be removed and they will be placed on a table which will also have been disinfected. They are a medal attached to a ribbon designed to hang from the neck.
  - A winner will be called up and a volunteer will hand the medal with ribbon to the winner. The winner will place it around their neck before moving the area designated for a photo to be taken. One volunteer will be designated as the person that will hand the medals to each winner.
  - Once the medal attached to a ribbon is in place around the winner's neck, the winner will move to the designated area for a quick photo. The photographer will be masked, 12 feet away, and work efficiently to get the photo of the winner.
  - Winners will return to their seat immediately after getting their photo taken.
- Conclusion of Event
  - Participants and spectators will be dismissed to leave the building by section.
  - All will leave via the south doors of the main floor (opposite of where they came in) and exit through the exterior doors nearest (boys basketball/track coaches office or training room office) their side of the stands.
  - Seating and all other high touch services will be spray disinfected inside of the main floor of the Arena after the main floor area is evacuated and before the participants and spectators from Session Two are admitted.

### **Session Two – 2:30-4:30PM (12-14-year-old boys & girls)**

- All participants (and their one spectator) will enter through the main doors to the Arena.
- All that enter the Arena must first complete a COVID screening (temperature & questions)
- After COVID screening, participants will move to one of four registration tables in the foyer of the Arena to complete registration
- At the registration station, participants and spectators will be assigned a specific area/basket. They are to report to the seating area near the basket where they were assigned and sit in the stands until called down to the floor when the competition begins.
- All those that enter the main floor area of the Arena will be ask to select a seat and use only that seat during the entirety of the session.
- There will be four baskets used for this competition (The four side baskets which will provide good viewing and appropriate spacing from the other baskets.
- Competition Flow
  - One participant at each basket seating area will be called to a basket, warm up, and begin shooting free throws when instructed.

- Three volunteers will be assigned to each basket, one of them will be assigned as the “rebounder.” The rebounder will wear non-latex gloves.
- Two additional participants will be seated in chairs (appropriately distanced) on the main floor near the basket that they will shoot. When the “next” shooter is called up from one of the “on deck” chairs, that chair will be wiped down with disinfectant before the next participant is called down from the stands to sit in the chair awaiting his/her turn.
- When a participant has completed his/her free throws, they are to return to the seat in the stands where they sat before being called down to the floor.
- Four basketballs will be assigned to each basket. (2 girls, 2 boys)
  - After each participant completes their free throws, the ball used will be spray disinfected.
  - While it is drying, the next participant will use the other properly sized ball to begin warm up for their competition.
  - The “rebounder” will change gloves (or spray disinfect them) between each participant.
- First place winners in each category will shoot 25 free throws for the state competition. One per basket.
- Awarding of Medals at the end of each session.
  - Medals come in packages and the packages will be cleaned before the event begins. Medals will be removed and they will be placed on a table which will also have been disinfected. They are a medal attached to a ribbon designed to hang from the neck.
  - A winner will be called up and a volunteer will hand the medal with ribbon to the winner. The winner will place it around their neck before moving to the area designated for a photo to be taken. One volunteer will be designated as the person that will hand the medals to each winner.
  - Once the medal attached to a ribbon is in place around the winner’s neck, the winner will move to the designated area for a quick photo. The photographer will be masked, 12 feet away, and work efficiently to get the photo of the winner.
  - Winners will return to their seat immediately after getting their photo taken.
- Conclusion of Session Two and the Event
  - Participants and their spectators will be dismissed to leave the building by section.
  - All will leave via the south doors of the main floor (opposite of where they came in) and exit through the exterior doors nearest (boys basketball/track coaches office or training room office) their side of the stands.
  - Seating and all other high touch services will be spray disinfected inside of the main floor of the Arena after the main floor area is evacuated.

## Cleaning schedules

- All areas of the Arena are cleaned and sprayed with disinfectant each evening as a part of the regular cleaning protocols.
- All items and equipment to be used for this event will be sprayed again after set up.
- We have detailed procedures for cleaning during, between, and at the conclusion of each session listed in the Activity Specific Instructions section above.
- All seating and high touch surfaces throughout the Arena will be spray disinfected once more at the end of the event.

### **Positive Cases and Staff or Guest Showing Symptoms Procedure**

- If a positive case is identified among any participant in this event/activity, that person must be removed from participation and told to self-isolate. IF the confirmed participant regularly had close contact with anyone else involved in this event/activity, those individuals must also self-isolate.
- Any participant who experiences any of the COVID-19 symptoms (listed below) should self-isolate until the below conditions are met:
  - In the case of an individual who was diagnosed with COVID-19, the individual may return when all three conditions are met: At least 24 hours passed with no fever (without use of fever reducing medication), the individual has improvement in respiratory symptoms, and at least 10 days have passed since the symptoms have appeared.
  - In the case of an individual who has symptoms that could be COVID-19 and does not get evaluated by a medical professional or tested for COVID-19, the individual is assumed to have COVID-19 and the individual may not return to campus until the same three step criteria listed above has been met, or until the individual obtains a note from a medical professional clearing the individual based on an alternative diagnosis.
- Any participant living with someone who experiences any of the symptoms of COVID-19, whether they have a positive COVID-19 test or not, should isolate for two weeks. If they do not experience any symptoms in those two weeks, they can return school sponsored activities. If they do experience symptoms, they must remain in self-isolation until the conditions outlined above have been met.

### **COVID-19 Symptoms for Screening**

- Cough
- Shortness of Breath or difficulty breathing
- Chills
- Repeated Shaking with Chills
- Muscle Pain
- Headache
- Sore Throat
- New Loss of Taste or Smell
- Diarrhea
- Fatigue

- Feeling feverish or a measured temperature greater than or equal to 100.0 degrees Fahrenheit.
- Known close contact with a person who is lab confirmed to have COVID-19

**This is a youth, girls and boys, regional free throw shooting contest being run by the Knights of Columbus. We have partnered with them for many years. David Pels, the contact for this event, has worked with us to help ensure that the safety possible event (for the participants, spectators, and NCHS community) can be run.**
