I have asked State Membership Director, Immediate Past State Deputy Ron Faust to make some adjustments to our

However, with and annual attrition rate of nearly 1,000 deaths and 500 suspensions or withdrawals that number does not achieve the growth we need to perpetuate this Holy Order. Our revised and achievable benchmark is 1,600 new members. Having new members to revitalize your Council enables your legacy and Fr. McGivney's Mission to survive. Your responsibility is to get your Council to Double Star or at least Star Council intake. The Supreme Council will waive the per capita assessment for 2017-2018 for every Council attaining Star status this year. Every Council matters every member matters. Your retention efforts are securing a significant reduction in that suspension and withdrawal number. Keep up the great effort to be "Precious Blood Brothers" to your fellow Knights.

Why are you a Knight of Columbus? Will you make a difference that will stand solid for you part in this inspiring task? If not you then, who? If not now then, when? All that God asks is that you do all that you can. Are you doing all that you can? Go make a difference!

Dear Brothers,

We have now entered the 100th year since Our Lady appeared in Fatima, Portugal. The anniversary is May 13, 2017. Many people are wondering if

God may do (or allow) something soon to "shake us up" (I wrote about it HERE – this is the most "shared" article I have ever written).

As we watch terrorism rising up everywhere around the world, relations between nations in steep decline, a false economy ready to collapse, morality at an all-time low, pre-born babies murdered by the millions, marriage redefined for the first time in all of civilization, adult men allowed to share a bathroom with little girls, religious freedom under assault, corruption and collusion rampant within our government, and confusion in our Church ... people are asking, especially as we enter this centennial year of Fatima, "WHAT DO WE DO NOW?!?!"

The answer may lie more in "God's style." What is "God's style?" Throughout salvation history, we know that no matter how far we stray from God, He always wants to give us every opportunity to return.

My brothers, I believe it's time for us to do the "Nineveh Thing." I am referring to the biblical story of Jonah who warned the Ninevites, and they believed and repented. "Championship Performance!"







WI KC Helping People with Intellectual Disabilities Committee Update

The annual meeting on the WI KC Helping People with Intellectual Disabilities Committee was held in January. The ID Committee along with the State Officers evaluated 60 applications seeking \$266,401.59 in funding. The ID Committee distributed 5 Diocesan Educational Grants to the Bishops totaling \$12,500. Year 6 of a 6 Year Pledge to Badger Camp was dispersed for \$8,000. The total of the requests was \$266,401.59 of which \$145,572.58 was distributed, and \$120,829.01 was denied. 60 total grants were acted on with 48 groups

being fully or partially funded. The Committee worked very hard to do the best we could to wisely dispense the \$145,572.58 the councils of the state made available through the yearly ID Drive. A full list of approved groups is available on the state website.

Reminder to File Annual Tax Returns

[The following are selected excerpts from Supreme's online ODR. The following does not constitute legal and/or tax advice. If you have any questions regarding the filing of tax returns for your Council or Assembly, please consult with a professional tax adviser.]

Tax Compliance For Councils In The United States

The Internal Revenue Service (IRS) requires the Supreme Council and each of its subordinate councils, assemblies, and chapters in the United States (referred to collectively as councils) to file an annual informational tax return (IRS Form 990, 990EZ, or 990N). purposes of tax compliance, the Knights of Columbus encompasses not only the Supreme Council, but also its Accordingly, all councils in the subordinate units. United States may be recognized by the IRS as "fraternal lodges" for purposes of the tax exemption granted to fraternal benefit societies under Section 501(c)(8) of the Internal Revenue Code. This means that revenues received by a council for fraternal, recreational, or charitable purposes are not subject to federal income tax. Although the filing requirement is relatively simple, many tax exempt organizations in the United States have neglected to comply with it, resulting in the revocation of their tax exempt status.

It is very important that all councils comply with the annual IRS filing requirements. Failure to comply with the IRS filing requirement will ultimately lead to the revocation of a council's tax-exempt status. Those councils that have had their tax exempt status revoked should apply for reinstatement as quickly as possible to avoid potential tax liabilities. From the date of the IRS revocation notice to the date of IRS reinstating the council's tax exempt status, the council will be considered a taxable entity and therefore liable for any taxes accrued during that period of time.

State officers, Grand Knights, and Financial Secretaries should carefully review the other entries in the Tax section of the Officers' Desk Reference for more detailed information and instructions on council tax compliance. If you have additional questions or would like to obtain a reinstatement package, please contact the Home Office Legal Department via email at tax.ein@kofc.org.

Although the Knights of Columbus Legal Department is able to provide general guidance, we recommend that councils, assemblies, and chapters that have more complicated tax returns consult with a professional tax adviser.

You will need to have all facilities available for 8 -10 weekends.

Dates should run from early February through April.

Note: Bowling shall run continuous weeks except during the EASTER Triduum.

Accommodations must be available nearby that match the number of bowlers and guests each weekend.

Councils may team up with another council for joint bids

Your clubrooms should be available Friday, Saturday and Sunday each weekend of the tournament.

There is no bowling scheduled to begin later than 3:00 p.m.


