District deputies and the state leadership team gathered in Normal, Illinois in December for the annual midyear meeting. The purpose of the meeting is to check the course set in July for progress in growing the Knights of Columbus presence in Illinois. As the journey for this fraternal year began in July, district deputies gathered then to launch a new year with a focus

on helping councils succeed. *That is our mission!* Key ingredients we believe contribute to successful councils are (1) building good working relationships; (2) developing effective communications; and, (3) planning. Supreme Council shares the same mission by providing leadership guidance and instructional material to help grand knights and district deputies in the performance of their duties. New this year is an Illinois district deputy guidebook that provides a supplement to Supreme Council material; and, it includes helpful checklists for district deputies. Our caution to leadership at both diocesan and district deputy levels is *that these resources alone are not enough to help councils succeed; it also takes regular personal contact and review of the material and planning to really succeed!*

At this midyear meeting, leadership from each diocese participated in a more interactive discussion on how to help councils succeed. We reviewed approaches in relationship building among the councils; changes in communications and, progress made thus far. We demonstrated how easy it is to present the first degree such that all councils can do it! In fact two Columbian Squires state officers unexpected were ready to experience the first degree and we degreed them as part of our planned demonstration only with them as real candidates! This was a new approach in the agenda of our meeting that allowed us to clarify some misconceptions and take note of improvements needed. Many commented favorably on the concept and made a couple of suggested improvements which will be made the next time we gather for this purpose. That is what you need to do in your councils: try new approaches; make adjustments and then try again! Imagine how far you can go if this is done with your district deputy and his diocesan assistant! *The future is in your hands!*

What can we do to succeed?

The definition of success differs from one person to the next; and, so it is helpful to have a standard measure of what success really means. The traditional measure of success is STAR council achievement. It can also be at various levels of the Illinois Spirit program. These measures are well rounded in that they take into consideration all of the key elements that ensure that a council is meeting the mission of the Knights of Columbus. An Illinois mission statement was prepared with input from grand knights, district deputies, and elected state officers a couple

of years ago as part of developments for a strategic plan. A full copy of that mission statement with goals and objectives is included in the Illinois district deputy handbook which has affectionately been called the "Big Blue Book" and most recently "The Play Book". If your district deputy hasn't reviewed that with you, ask him to do so. The book is also on our website at www.illinoisknights.org

The "Play Book" provides a ready source of reference for programming, charities and recruitment planning. Other resources available to plan for success include the Surge With Service booklet; grand knight handbook; and, other Supreme Council material. Again, there is no replacement for experience which comes in the form of your diocesan leaders. Please use them because they want to be used!

So what are those well rounded elements that are the keys to success? It would be simpler to say that if a council used the Illinois Spirit planning guide [Illinois SP-7] and the Columbian Award form {Supreme Council form SP-7] as planning tools, you will have you'd see them all, thought they can generally be summed up as follows:

- Charity is a fundamental criteria and a foundation upon which our order is founded. It is definitely part of our mission; and, both the Illinois Spirit SP-7 and Columbian Award form serve as planning tools to ensure this criteria is present;
- Interesting program activities provide opportunities for every Catholic man and his family to practice their Faith
 and have some fun too; again Illinois Spirit SP-7 and Columbian Award form serve as planning tools to ensure
 this criteria is present;
- Recording results including charitable and program activities timely and accurately i.e., semi-annual audits;
 Supreme SP-7; Illinois SP-7; Survey of Fraternal Activities, etc. ensures that you document your successes;
- Promoting fraternal benefits and informing members about the order's insurance products that help to protect their families represent our origins and Father McGivney's dream;
- Payment of both Supreme and State per capita represent modest contributions to an organization that provides much more than what those dues can provide; and,
- Recruiting and retaining your membership, by making sure that the entire list of criteria just shown before this one is in place and refreshed regularly!

We will gather the state family in fellowship and fun; recognize the accomplishments of our councils; prepare for the final lap of the fraternal year i.e. May and June as we surge with confidence to even greater heights! Thank you! Thank you! Across our great jurisdiction, nearly 1,100 coats were distributed to children of families less fortunate to afford to purchase on their own! While our jurisdiction has participated in the Coats for Kids program in recent years, the state officers agreed to expand the program to a jurisdiction-wide project! I wish to thank the state officers for being agreeable and supporting this new initiative to purchase 4 cases (12 to each case) of coats for each diocese; that posed the seed of 48 coats for each diocese totaling 288. That is when the diocesan leadership and our local councils, chapters, assemblies and ladies auxiliaries joined hands in purchasing an additional 62 cases of coats for distribution; that totaled an additional 744 coats! The decision on where and how to distribute the coats was left to the diocesan leaders which included the membership of their diocese; each diocese was to select two locations designated for distribution. What a great example of unity of purpose! All for one [purpose] and one purpose for [all] who needed our help. I am so proud to be a Knight of Columbus and to be a part of a great jurisdiction as ours!

Some additional good came to our Order as part of our project to get coats to children who needed them. Charlie Daniels, diocesan chairman (the rock) of the Belleville diocese was handing out coats at a high school and began talking to the principal of the high school who was a former member of the Knights of Columbus. After some talking with the gentleman, Charlie took an application from him to rejoin our order! Way to go Charlie! In Chicago, Dale Smith, diocesan chairman (the rock) of the Chicago Archdiocese strategically worked with his diocesan team to select St. Ambrose parish as the site for coat distribution. His team is working with a group of men to reactivate an old council that one of our 90 year old members, Rubin Gaines, sought assistance with the effort. The pastor, Father "Boom Boom" Washington is a young priest who is very actively working to bring his Faith Community to more meaningful participation in the parish life. He welcomed the Coats for Kids project and is excited about getting his council back on track! It was truly a good day to do great things in the name of the Lord!

Dear Brother Knights,

Let us pray for one another throughout our Lenten Journey, which we begin on Ash Wednesday. May this season help us grow in faith, hope and love, and prepare us for a worthy celebration of the Sacred Triduum and Easter.

As you receive this message, we will either be preparing for Lent or have already entered into the journey of forty days. The significance of the number forty has many biblical references. The forty days and forty nights of rain that cleansed creation and began a new hope and promise for humanity. Moses was forty years in Egypt another forty years in the desert and the final forty years of his life leading the people as they wandered in the Wilderness that helped shape them into the nation of Israel. Twice Moses spent forty days on Mount Sinai before receiving the Tablets of the Law. Twelve spies reconnaissance the Promise Land for forty days. Elijah was forty days at Mount Horeb. Ezekiel laid on His right side for forty days symbolizing Judah's sins. Jonah was sent to warn the people of Nineveh that they had forty days in which to repent. As most of you know the 39th annual March for Life has just taken place. The DGK and his wife from my Council which happens to be my son and daughter-in-law took part in the March. Here is a short recap of their trip:

While our trip might have been delayed due to weather the spirits and desires of the 1000 plus teens, adults, Clergy, and Religious from the state of Illinois were not suppressed. We then joined hundreds of thousands of people in participating in the 39th annual March for Life, in Washington D.C. Erica and I were blessed in being with an incredible group of people from the Diocese of Joliet including thirteen teens from our high school youth group at Immaculate Conception Church in Morris.

As we arrived in Washington D.C. we were joined by our Auxiliary Bishop Joseph Siegel. It was truly an honor to watch as he and 3 teens from the Diocese placed a wreath in honor at the Tomb of the

Unknown Soldier. This was then followed by a Mass at the Basilica of the Immaculate Conception celebrated by Cardinal Daniel DiNardo, which began with a forty minute procession of Seminarians, Deacons, Priests, Bishops, Archbishops, and Cardinals, with many from the state of Illinois including: Francis Cardinal George, Bishop R. I hope everyone enjoyed and very blessed and happy Christmas season and that 2012 is off to a good start. By now you have received a letter from me detailing how to submit resolutions for the upcoming 2012 State Convention. The information is also available on the state council website, on the State Convention information page. All resolutions must be in my hands by March 30, 2012 to be considered at the state convention.

In a previous newsletter I provided several FAQs that pertain to how tax laws apply to the Knights of Columbus at the council level. Here are a few more FAQs, including one relating to insurance.

Question: Are Knights of Columbus councils and assemblies exempt from state sales tax?

Answer: Generally, state legislatures grant state sales tax exemptions or state or local property tax exemptions only to charitable organizations recognized by the IRS under Section 501(c)(3). Since the Knights of Columbus is not recognized as a charitable organization under Section 501(c)(3), councils and assemblies are not generally eligible for a state sales tax exemption, although the exemption may be available in certain states.

Question: Are donations to Knights of Columbus councils and assemblies deductible on the donor's income tax return?

Answer: No. Donations to Knights of Columbus councils and assemblies for fraternal or social purposes are never deductible and most donations for charitable purposes are not deductible. In certain limited circumstances, donations for charitable purposes may qualify for a deduction under IRC Sec. 170(c)(4), the so-called pass-through charitable donation exception, provided that the recipient of the donation is recognized as a charitable entity under Section 501(c)(3). Knights of Columbus

officers should understand that compliance with Section 170(c)(4) requires the council or assembly to file accurate accounting records with their tax returns in order to permit donors to claim a lawful deduction on their tax returns. See IRS instructions for Form 990, Form 990-EZ and Schedule A (Form 990, 990-EZ, 990-PF). Donations under IRC Section 170(c)(4) must be reported by filing Form 990 Schedule B. Donations of \$250 or more must be acknowledged as required by IRS publication 1771. Only charitable contributions by individual taxpayers may be claimed as deductions under Section 170(c)(4); non-person taxpayers, such as corporations and partnerships, are not legally permitted to claim a deduction for charitable donations under this provision.

Question: Do councils, assemblies, and home corporations need insurance?

Answer: Yes. All councils and assemblies should have adequate liability insurance coverage. The Supreme Council does not provide insurance coverage to councils and assemblies or to home corporations. The Supreme Council has arranged for liability insurance to be purchased by the councils through R.C. Knox & Company of Hartford, Connecticut. Councils should contact their State Deputy for information on how to apply. Home corporations that are associated with any Knights of Columbus unit are independent corporate entities and are not covered by council insurance policies. Accordingly, all home corporations building associations) (including all should make arrangements for adequate liability insurance coverage.

Keep in mind that when it comes to tax issues with your council, your best option to handle things correctly is to secure the services of a local tax accountant. The

information offered here is a good general guidance, but it should not be considered an official source on which to base tax decisions that affect your council. Contact your tax professional for specific guidance.

In order to be successful you need to plan. You need to determine what your goal is; whether it is a pancake breakfast, anniversary dinner, membership recruitment drive or First

In certain cases we do need to be able to react fast to get the results that we need, but proper planning will lead to success.

ID Drive 2012: As a reminder, all past ID Chairmen have been deleted from our database. The Grand Knights will be asked to complete a new form for the ID Chairman and send it to the State Office.

This form is available on the State Website under the Charities Tab. Then click on the title "ID Drive" to view and download the Chairman as well as any other form you may need. Also note, the ID Report and Request for Distribution Forms can be completed on line using the Excel format. Save to your computer and the send it to donna@illinoisknights.org as an attachment. We record receipt of this form on our "Report Log" in the column "IDCH". Our early spring mailings for the 2012 ID Drive will be mailed to the Grand Knight or ID Chairman of record. Be sure your name has is on record at the State Office.

General Liability Insurance: The State Council Office is aware that many towns require permits for the ID Drive which are given on a 'first come first serve' basis. The permit requires a copy of the ID insurance form. The last 2 years we have had difficulties because our insurance policy does not begin until 7/1/2012. We can issue a 'Transition Letter' to the municipality explaining this issue. When the new policy is issued, those who received a letter will be sent the new Certificate of Insurance A copy will also be sent to the Council Chairman or Grand Knight requesting the certificate.

Charity Goals: Each Financial Secretary will be receiving a letter listing their Charity Goals and funds collected as of 1-31-12 for their council. Additionally, they will receive a listing of all the donors in their council to the Newman Apostolate Program. We ask they be sure to share this information with their Grand Knight, Program Chairmen and membership. This should aid every council in attaining their Charity goals by the end of the Charity year (June 30th, 2012). If our records do not agree with your disbursements, please contact the State Office immediately at 815-935-2262, 8AM-4PM Daily, to reconcile the differences.

The 1728 "Fraternal Survey' Report is due now and have been emailed to the State Office in record numbers this year. If completing this form by hand, however, be sure the council number is correct and written clearly and contains the proper signatures. A copy should be sent to Supreme, The State Deputy (c/o the State Office), and the District Deputy. This form can be completed on-line at the Supreme Website and copied to the appropriate parties' email addresses before clicking the Submit button.

Newman Solicitations: The 2011-2012 Newman solicitation has been mailed. Returns are arriving, but sadly, we have received a number of cards marked **DECEASED!**

Remember when a member passes away, fill out a form 100 and submit it to Supreme. Additionally, some members have *moved* and for each envelope returned to us because of a change of address, the State is charged 45¢ It only cost us 15¢ to mail our solicitation! To prevent this from occurring, when you change your address, please send us a *change of address form* so we can save that 45¢
