MISSOURI KNIGHTS OF COLUMBUS BOWLING ASSOCIATION

Suggested Guidelines to follow for Councils submitting Proposal to Host 2017 State K. of C. Bowling Tournament – Mail Proposal to Assn. Secretary Bill Cairns No Later than OCT. 14, 2016.

- 1. Obtain, in writing, commitment from Bowling Center for dates (October 21-22 and October 28-29, 2017).
- 2. Obtain, in writing, from Bowling Center a guaranteed lineage rate that will be charged for each three game event. (i.e. If the Center charges 2.25 per game, the 3 game rate would be 6.75.) Remember, gentlemen, the expenses are constant. The Prize Money and the Lineage Fees are adjusted. The lowest per game rate guarantee you can get from your bowling center is very important insofar that the prize money would be higher.
- 3. Commitment from your local bowling center as to the allocation of space and office facilities for the Association Secretary on the two-weekends of the 2017 tournament.
- 4. Send in the number of teams your Council has entered in the 2016 State K. of C. Tournament.
- 5. Send in the number of teams your Council plans to enter in the 2017 State Tournament.
- 6. Send in a brief description of your community, hotel availability, the bowling center you are going to run the tournament thru (number of lanes, center location area, distance from Council Hall), Hotels, Catholic Churches, etc.)
- 7. A letter from Grand Knight of Council submitting bid.

SPONSORING COUNCIL'S RESPONSIBILITIES:

- To name a Brother Knight, or Knights, who will act as the Coordinator between the Council, Bowling Center, and the State Association.
- 2. Above mentioned coordinator, or authorized replacement, will act as a "Guide" to Association Secretary for "inspection" of bowling center to be used, if Council awarded the Tournament.
- 3. Above mentioned coordinator to also be qualified to answer any questions Association Secretary may have as tournament draws nearer to actual date.
- 4. Extend the courtesies of your Council, and of our great Order, to Association officer as he visits your community in "finalizing" the tournament.
- 5. All publicity, such as printed posters, promotional materials, postage for letters to Councils to promote the 2016 tournament, etc., are the responsibility of the Council. (Entry forms, and tournament final score-sheets are the Association's responsibility.)
- 6. If the Bowling Lanes to be used by Council for tournament DOES NOT HAVE AUTOMATIC SCORING MACHINES, it is the host Council's responsibility to furnished competent and qualified scorekeepers for all Tournament bowling.
- 7. Council must submit a deposit check of \$300.00 to the Missouri K. of C. Bowling Association as "earnest money" to guarantee a successful tournament, consisting of at least 45 teams of 5-bowlers each. If 45 or more teams bowl in the tournament, the deposit will be refunded to the Council entirely on completion of the tournament. If less than 45 teams are entered, expense fee of \$10.00 per team under the 45 will be deducted from the deposit check, and the balance returned to the host Council.

BENEFITS TO CONSIDER WHEN HOSTING A TOURNAMENT:

- Council receives nothing from the actual bowling entry fee. However, any souvenirs, raffles, dinners served at the Council Hall, activities at the Council Hall on the two week-ends, program advertising booklets, and all donations made by individuals or organizations of the community go 100% to the Council. (There is no reason why a "hard-working" Council can't make several thousand dollars profit on this event.)
- Brother Knights from all across the State of Missouri would be coming into your community for two week-ends, and your Council would hold "bragging rights" for hosting a great State Council Activity for the GREATEST FRATERNAL ORDER IN THE WORLD.



IMPORTANT! - - - READ CAREFULLY THE RULES AND INFORMATION GIVEN BELOW.

UNITED STATES BOWLING CONGRESS MORAL SUPPORT SANCTION provides high score protection for those who have established membership in the Congress prior to participation in this tournament. Allows for the participation of those not affiliated with the Congress without payment of any dues. Unaffiliated teams and individuals wishing to secure high score protection may do so by paying \$21.00 per bowler with their entry.

PRIZE AND ENTRY FEE: The charge is \$17.00 per man per event, divided as follows: Prize Fee \$4.75, Bowling Fee \$8.25, Tournament Expense \$4.00. PRIZE FEE WILL BE RETURNED 100% IN PRIZES. Prize ratio according to USBC Rule No. 308 or better.

ALL EVENTS: Entry in All Events is optional with each individual bowler and will be on the handicap basis and the cost will be \$2.00 per person divided as follows: Prize Fee \$1.75, Tournament Expense .25¢.

ENTERING AVERAGE:


- 1. The Previous Season's highest USBC winter league average based on 21 games must be used.
- 2. A bowler with no previous winter season average for 21 games, shall use his highest current winter league average, based on a minimum of 15 games, as of October 10, 2016.
- 3. A bowler with no previous winter average, or current winter average, SHALL ENTER AT HIS LAST SEASON BOWLED AVERAGE; if over 170 will enter at 170.
- 4. If none of the above apply, a bowler with K of C Tournament experience will be assigned an accumulative K of C Tournament average based on a minimum of 15 games. Minimum average will be 125, Maximum average will be 170.
- 5. All other bowlers with no past tournament or league experience shall be entered at 125.
- In addition, the tournament manager prior to the entrants bowling may assign a higher average in accordance with the figures established by tournament rules.
- 7. Rule* c rule states in part: Failure to use the proper average or make a correction prior to completion of the first games of a series shall disqualify score if submitted average is lower than actual average or base prize winnings on submitted average if it is higher. Each bowler is responsible for entering his own correct average no matter by whom it was submitted. Refer to USBC Rule 319A-3.
- 8. The Annual Tournament of the Mo. Knights of Columbus Bowling Association shall be conducted on a Handicap Basis. Each entrant shall receive a handicap of seventy-five percent (75%) of the difference between his previous season's highest 2015-2016 League Average and two hundred, ten (210) pins for each game entered.
- MULTIPLE PARTICIPATION: Multiple participation WILL BE ALLOWED IN ALL 3 EVENTS. No more than three (3) players on the same team can place more than once in the Prize List for position standings. May cash only once in the Doubles with Same Partner. May cash only once in the Singles, with Highest Place to be paid. When a bowler competes more than once, his FIRST APPEARANCE SHALL COUNT TOWARD HIS ALL EVENTS SCORE.
- **BOWLING LINE UP:** Be sure to list the names in the order you wish them to appear on the official score sheet. SCORE SHEETS WILL BE PREPARED AND HANDICAPPED IN ADVANCE ACCORDING TO POSITIONS AS LISTED ON ENTRY FORM.
- **SUBSTITUTIONS:** When necessary substitutions may be made by notifying the tournament secretary at least 30 minutes before the time scheduled to bowl. Any bowler entered in the team event ONLY and having bowled cannot substitute in the two men and singles AND QUALIFY FOR THE ALL EVENTS.

SPECIAL RULES:

- Any person bowling on a team who is NOT a member of the Knights of Columbus, he and the other members of that team will be barred from future tournaments, and
 he and the members of that team will be reported to the United States Bowling Congress with recommendations that they be disqualified from participation in organized
 bowling.
- "Premature termination of the tournament brought about by war, national emergency or emergency causes relating thereto or therefrom, fires, strikes, lockouts, labor
 difficulties or other reasons beyond the control of Missouri State Council Knights of Columbus, shall cause the foregoing prize schedules to be prorated in accordance
 with the number of entrants who have bowled in each of the respective events up to the time of termination." A bowler may not bowl either Singles or Doubles only.
 Must bowl both events.
- 3. You will bowl three (3) games in each event on a pair of lanes assigned by the tournament secretary.
- 4. Bowlers who participate in this tournament must be dressed in a neat and presentable manner, and the manner of dress is to be determined by the tournament committee.
- 5. Plagues will be awarded to the members of each winning team in each event.
- 6. USBC Rule No. 319E is Waived.
- 7. If at any time of entry the entrant has a current season's average of 21 or more games and is 10 pins or more higher than the previous season's average, the bowler must use this current average for entry in the tournament, USBC Rule No. 319A-2. A bowler who has qualified for a prize of \$300 or more in any event in a tournament within the 12 month period must report his actual score, position and amount won to the tournament management at time of entry in the tournament for possible rerating. USBC Rule No. 319D, Such rerating must be accomplished before the entrant bowls and if not accepted the entry fee shall be refunded. Failure to comply with either of these provisions shall be cause to forfeit tournament entry fee and prize winnings.
- 8. NO REFUND OF ENTRY FEE FOR CANCELLATIONS MADE AFTER OCTOBER 14, 2016.
- 9. BOWLERS NEED NOT BE FROM THE SAME COUNCIL. However, they must be a member in good standing of the Knights of Columbus, Missouri Jurisdiction, with current dues paid in full by entry deadline.
- 10. Entry Deadline may be extended but not beyond October 29, 2016, as to the discretion of, and arrangements made with, the Association Secretary.
