NOMINATIONS OF DELEGATES TO THE SUPREME CONVENTION

I would ask the State Advocate to come to the podium.

State Advocate

We will now begin with the selection process for delegates to the Supreme Convention in Baltimore. August 6-8, 2018.

The Oregon State council is entitled to 2 insurance Delegates and 3 associate delegates. Additionally, the State Deputy and the Immediate Past State Deputy are included as delegates. This makes a total of 7 delegates from Oregon.

It's important to note that you must arrange and purchase your flights to Minneapolis. You will receive per-diem for the days attending the convention. As a rule, you will incur other expenses as well...not too much different than our State Convention. When in Baltimore or any Supreme convention, you must attend all the meetings. This isn't a Supreme sanctioned vacation! You're expected to be at all the organized meetings and functions if the convention is going on.

NOTE Article III, Section 1: "No member shall be elected as a Delegate at Large to the Supreme Convention who has been previously elected as a Delegate at Large three in the preceding five years."

Tellers Committee please takes your place and be prepared to write the names, so we can all see on the big screen.

When making a nomination...Please come to the microphone...loud and clear, state your name and council number. Then announce and place in nomination the Brother you would like to nominate and indicate if he is an Insurance or Associate member.

Nominations are now open from the floor, for those Brother Knights that would like to be a delegate to the Supreme Convention.

-----Start Nominations...

(After all the nominations are in, ask all those nominated to come forward for recognition)

Thank you. Brothers, you can be seated.

The Supreme Convection ballots are on the back of your convention book. Please rip out that page and vote for your 5 chosen delegates. If you do not have a book or a ballet or if you error, raise your hand and ask for another ballot and the Warden will get you a new ballet. Again, <u>only list 5 names</u>...If there are too many names on your ballot it will be up to the committee to discard it.

The first five candidates with the highest number of votes will be the delegates based on their insurance and associate status. The next seven candidates with the highest number of votes will be the alternates, again based on their insurance and associate status. The last several years we had alternates attend a Supreme convention.

So, don't be too worried if you're in the bottom seven...you might get there anyway.

Vote now please ...

We need the DD or another person from the District to collect the ballots from the district. Count your ballets and be sure you have them all.

DD's then come forward and line up in numerical order...1 to 23.

The DD presents his stack of ballets to the teller and announce how many ballets he gave to the teller.

The teller will then confirm the count and the State Secretary will also confirm the count based on the number of eligible delegates that scanned in.

Only after all have verified the count does the teller place the ballets in the ballot box.

Once all Districts have deposited ballots, the tellers will begin counting the votes and inform the SD of the ballot count.
