Each subordinate council represented by only one delegate will have only one vote.

During the votes, it is important that each delegate be seated in his assigned seat so the ballots can be distributed properly. Your strict adherence to this request is appreciated and will help the voting go smoothly. I will now ask that those who are not delegates please move to the area behind the delegates.
