Subject: 2019 Resolutions Committee Report

The Resolution Committee, in accordance with the State By-Laws, reviewed all submitted resolutions for consideration during the 111<sup>th</sup> Annual Oregon State Meeting to be held April 26<sup>th</sup> to April 28<sup>th</sup> in Lebanon, Oregon.

The Committee would like to thank all the Councils that have submitted resolutions. A total of 8 resolutions were submitted this year; 6 for the purpose of nominations and require “No Action”, 1 regarding the observation of October as Catholic History Month was “Accepted”, and 1 for amending the age requirement to join the Knights to 16 was also “Accepted”.
