# State Deputy's Message

I WANT TO start by wishing you and your families a happy and blessed Easter. As a State Council, we are having one of the best years in a very long time. We are currently -2 Net/Net in membership, so we are bringing members in as fast as we are losing them to death, which is great news. We have already met a number of our State Circle of Honor Goals for the first time in many years.

However, there is one goal we need your help with. The Knights of Columbus were formed to help men to protect their families, and our Fraternal Benefits program does just that. One of the goals that we have as a State Council is for 150 councils to promote and attend at least two Fraternal Benefits Nights with a minimum of seven members. The last report from Supreme showed that we had only 66 Councils meet this requirement. Promoting and attending two Fraternal Benefits Nights is the requirement for the Founders Award, and one of the requirements for the Star Council Award. I am asking for your help to meet this goal. Between the State Council virtual events on 4/26, 5/31, and 6/28, and Supreme Webinars on 4/13, 5/23, and 6/27 it should not be difficult for Councils to meet this requirement. I recommend that councils put on a watch party, let your Field Agent know that you are doing so, and then invite the Parish in addition to your council members. Collect contact information for each attendee and share that information with your Field Agent or General Agent. The General Agent and Field Agents are even willing to provide in-person Fraternal Benefits Nights. There really is no reason that every council should not meet this requirement and qualify for the Founders Award.

I would also challenge every council to fill out and submit an SP-7 Columbian Award Application, so they can document their Faith, Family, Life and Community programs. Active councils should have no trouble qualifying for the Columbian Award. In most cases, it is just a matter of documenting the programs that you already participate in.

One of the biggest challenges that many councils are facing is getting men to step up and lead. Most men who join the Knights of Columbus do so in order to make a difference in their parishes and communities, but when it comes time to step up and lead, they become reluctant for fear of ending up in a position for several years. It is time to change this. We need to encourage our members to "Put Out Into the Deep" and Volunteer to lead their Councils.

A quick look at the numbers reveals the following:

- ► There are 34,000 Knights in Wisconsin
- ► We have 300 councils that run about 20 events, meaning that they require 14 Officers, 16 Directors, and 20 event coordinators/chairmen. This menas there are 15,000 opportunites available to lead.
- ► We currently have 61 Districts in need of a District Deputy and Warden, which creates another 122 Leadership Opportunities.
- ► We also have opportunities for State Officers, State Directors, and Diocesan Coordinators. There are 53 positions for the Membership Team, 66 for the Program Team, 25 for the Support Team, 14 for Fraternal Team, as well as five Diocesan Directors and seven State Officers.

The sum of these positions accounts for only 50% of the Knights of Columbus in the State of Wisconsin. Clearly, we need more men to "Step Into the Breach" and lead, and we need to support those who do step up. If your Council is having problems finding leaders, it is time to recruit some new men. New members want nothing more than to be involved and to make a difference.

We are about to celebrate the Easter Season, a time of renewal. I pray that the Lord will give each of us the courage to Put Out Into the Deep, Step Into the Breach, and to lead our Councils, Districts, and the State Council.

# State Chaplain's Message

DEAR BROTHERS AND Sir Knights, As you read this newsletter, the Church is entering into Holy Week. Jesus' passion and death are the result of careful planning by His Heavenly Father from all eternity. The mystery of Jesus' passion is also the result of real human choices. The events of the Passion transpired because of choices by disciples like Peter and even Judas along with Jewish leaders and even Romans like Pilate. The Son of God came into this world at one unique moment in history. The people had to make the choice either to serve Him or to condemn Him. At that moment Jesus was condemned for the sins of His people and for the sins of the whole world, including our own.

Our salvation depends on our answer to this fundamental question. Do we serve Jesus? Do we honor and worship his Holy Name? We have this duty, to honor Jesus in every person. Just like Jesus, you and I showed up here in this world. We are here at a unique moment in history. We have to make a choice. Are we going to honor and serve our God in our own bodies? We are made in the image and likeness of God. Jesus is the Image of the Invisible God. He is God made visible in human form. Are we going to live our lives for Jesus Christ or not? Will you let Jesus Christ be the center of your life right now? These are few moments that we have to serve, to honor, and to worship Jesus Christ. Will you take up your cross and serve Jesus?

We often still fall short just as the apostles did. We experience condemnation, death and destruction in our world, in our flesh, and in our own nation. Jesus commands us to love our neighbors as ourselves. This is why it is always a grave sin to look the other way. We cannot turn a blind eye and allow our fellow humans to destroy innocent human life. In each person, born and unborn, we have that same option presented. Do we serve Jesus, or do we condemn Him again?

Last year, we celebrated victory for human life as the unjust Roe v. Wade decision was overturned. Immediately, Wisconsin's good and just law outlawing abortion went back into effect. The forces of evil are not going to give up just like

that. On April 4, Wisconsin has an important race for Supreme Court. My job is not to promote or endorse candidates for elected office. My job is to get people to heaven and keep them from committing a mortal sin that could damn them to hell. If someone in the state of Wisconsin launches a campaign that entirely is run on a plan to abort innocent babies, it would be a mortal sin to give any material support to that effort. Whether it be by money, advocacy or voting, material support in an effort to legalize abortion is a mortal sin. The fact of elective office being at stake does not change the morality of that act. This is basic Catholic moral theology. We are not permitted to directly participate in the mortal sin of another. That's what people do when the advocate for abortion in any of those ways I just mentioned.

It is not my job to endorse candidates, but it is my job to convict Catholics and warn them when it comes to sin. Sometimes different job descriptions overlap over the same ground. That is often the case in politics. Is there a Supreme Court candidate making this race entirely an effort to legalize abortion. You have to study carefully and decide. Are you a follower of Jesus Christ? Or will you condemn fellow humans to death in the womb? You have to decide. There couldn't be more at stake in your decision. I'm praying for you.

At our convention, we approve many resolutions, and one of these will affirm our commitment to defending life in the womb from the threat of abortion. Jesus rose from the dead so that he could give us new life. I pray that this Easter will bring a strengthening of faith in Jesus and his mercy. The Risen Jesus released forgiveness of sins, imparting sacramental grace to his apostles to forgive sins. There is mercy even for the great sins of our generation. Be restored to Jesus Christ through faith and especially through sacramental confession. I look forward to sharing the good news of Jesus with you at our convention in Green Bay.

AS WE ARE in the midst of Holy Week and the culmination of the Lenten season with the Easter Sunday Mass—I wanted to remind all of our Councils of two outstanding opportunities to engage and welcome our new RCIA candidates and encourage others who have drifted to return back to the Catholic faith.

Now, I ask you: Does your Council send a congratulatory Card and/or gift to these newest members of our Church? Do you welcome their families to a celebration of Thanksgiving for them joining the Church and invite them to join our Order? These are individuals that are on-fire for their faith, and often can be outstanding future leaders in your councils. Please consider reaching out to these individuals in the month of April to welcome them with open arms. Furthermore, parishes are often filled with many unfamiliar faces for Holy Thursday, Good Friday, Easter Vigil, and Easter Sunday. Are we welcoming and engaging these individuals? Do we approach those that we don't know to try and build a relationship with them and find out if they are 'new' to the area or 'returning' to the Church?

As I chose the title of this article as 'Re-Birth' it is because during this Lenten season of reflection and almsgiving, some individuals that have possibly drifted away from the Church may return. It may be the Gospel readings and Homilies during this season that bring them back to their Faith. Many individuals that 'drift' away from the Church were once as a youth, individuals that would go to Mass with their families. Sometimes it is their family that may bring them back to Church—sometimes it is the passing of family members that bring them back to their Faith. As we grow older, we may find those things that were once apart of our lives as 'missing' and go back to them. As youth, it was a much simpler time for us all—as we didn't have the busyness of daily life, work and family and other priorities that would pull us from things we once enjoyed or did.

As a comical aside to relate to this 're-birth' or 'born again' theme, I will reflect upon something that I hadn't really 'enjoyed' since I was a kid, finding it as something I enjoy again. As a child up until I became a teenager, I used to enjoy watching WWF (now WWE) wrestling on Saturday mornings—as much a weekly routine

for me as going to Church. A a child of the late 80's to early 90's, some of these characters at the time seemed mythical in ways. My friends and I were drawn in and we would talk about it at school the following Monday. As I grew older and realized that it was all 'fake' and 'scripted', I immediately lost interest. In the past year, I had started watching documentaries on some of the wrestlers that I grew up watching, and even ran into former Wrestler Bret 'The Hitman' Hart just by chance at a random encounter in Nashville (and was able to get a picture with him). As my wife was also watching these shows with me, she suggested one evening that we watch them again. All of a sudden, at something that I knew that was 'scripted' on the outcome, the storyline and characters drew us in again. We had to return each week to see how all of this would unfold. We were hooked! We even invite our friends over now to watch Wrestlemania. Something that I would've scoffed at only a few months ago, I'm now enjoying again as an almost-middle-aged man, and I'm amazed by the others who still enjoy it as well. It brings back fond memories from my childhood—and from this much 'simpler' time that I had in my life.

Now, what's the point of this personal story? Quite simply—something that was once apart of your childhood or life at one time, can easily come back into your life in mysterious ways. Someone who has 'fallen' away from the faith, should be embraced and welcomed when returning. Like the prodigal son, we should be happy of their return, not critical of the time they spent away or the person they were in the past. We all have a history, it's what we make of our future that should be of utmost importance to us in inviting new men into our councils. This is what we are called to do as Knights: evangelize the faithful. Continue to ask and engage even those former Catholics that you know, as one day they may too be welcomed back into the church and into our Councils. Maybe too these individuals will be reminded of that 'simpler' time in their life—where weekend mass was very much a part of their weekly routine. ## State Treasurer's Article

BROTHER KNIGHTS, THANK you to the many Councils that have paid their October Per Capita billings. We have a small number of Councils that have yet to send in payment, which was due November 30th. If you have not yet sent in payment, please do so now.

The next State Per Capita billing will be issued on April 1st. They will be sent via email to Council Financial Secretaries using the email address we have on record. Because State uses QuickBooks Online for its accounting, the emails come from QuickBooks. The emails received might include QuickBooks or Intuit in the email

address and it is possible that a Financial Secretary might not recognize the email address and choses to ignore or delete it. It is also possible that the email might go into the Financial Secretary's Spam folder. So, please be on the watch for it. Sometimes the emails bounce back because the Financial Secretary's email address of record is no longer active. In that case, we reach out to the Council's Grand Knight.

Occasionally there is confusion between Per Capita invoices sent by Supreme and those sent by State. The status of invoices from Supreme is reported monthly on their Council Payment – Summary and Payment Coupon, which is available to the Council's Grand Knight and Financial Secretary via Supreme's website. This report only reflects the status of Supreme's Per Capita billing. Unfortunately, the status of State Per Capita billings is not available online. To compensate for this, statements are periodically sent to Councils that have outstanding balances.

# State Advocate's Message

**BROTHER KNIGHTS, WE** are over the half-way point of our fraternal year. There are still 40 councils who have still not submitted Form 185. This form is essentially the roster for your council's team, please work on this.

As of today, according to Supreme, 70 councils still have not submitted Form 365. As you know this is a list of your directors who will help your council succeed. It is instrumental in providing Supreme with a list of individuals who need to be Safe Environment Compliant. Let's work on this, please. On your 365 you must have the following positions filled: Membership, Program, Community and Family Directors.

The next topic of concern is our Safe Environment Status. Needless to say without Form 365 and 185 Supreme cannot issue training invitations or track how a council is doing in becoming Safe Environment Compliant. It is critical that all councils become compliant for many reasons. We need to ensure that we provide a proper environment for those we deal with as well as ensuring that we do not allow situations to occur that can hurt others as well as ourselves. Of the 4 positions that require SE compliance there are many councils that have 3 of the 4 satisfied. 12 councils are compliant with many in the pending status. As you may notice this is down from last month. In many cases renewal training was required but the member did not complete it.

There are still 28 councils who have not submitted form 1728. This form tells the state, supreme and yes, the IRS how many hours and dollars the organization has given for that year. It is important that we maintain a good showing in this area to maintain our tax status.

It is not too late to register for the convention, I encourage you to do so.

It is tax time, depending on your council's reporting year you may need to get this form in soon. <u>Here is a link to the EZ version of the IRS form.</u>

### **Marketing & Pope Emeritus Benedict XVI**

In a recent article by Emily Ricci, Owner of Gloriam Marketing, a Catholic marketing and creative agency serving parishes, businesses, and ministries, she wrote about marketing lessons from Pope Emeritus Benedict XVI. Her article outlines three lessons we can learn from Pope Benedict: Teaching, Audience, and Humility. I wanted to share these with you.

#### **TEACHING**

There is no question that Pope Emeritus was a brilliant teacher, to the point that many are already calling for him to become a Doctor of the Church. A marketer cannot overstate the benefits of being a good teacher. Marketing relies on persuasion, which often involves education. You cannot convince someone to do something with which they are unfamiliar; thus, good marketing is rooted in instruction. Being knowledgeable on a subject - and being able to explain it well - establishes expertise and trust. What would be the fruits that would come if we emulated Pope's style in our council marketing efforts - by being teachers first and marketers second?

#### **AUDIENCE**

Related to his teaching, mainly through writing, Pope Benedict XVI was known for his ability to relay complex theological doctrine and truth in an approachable manner. He was a champion of the truth, so he recognized that he did not need to convince his fellow clergy and theological scholars of these truths. Instead, he wrote in a way that was understandable to his flock, the people of the Church.

Likewise, as marketers, we sometimes need the reminder that our audience does not know everything we do. Are we preaching to the choir or the sheep when we market?

#### **HUMILITY**

One of the biggest concerns I hear from Councils is that marketing is at odds with humility. Look at Jesus' example, how He was the most humble person who ever lived, and yet talked about Himself a lot in the Gospels. And now we have another great example, with many calling Pope Benedict XVI's resignation one of the most humble acts by any pontiff. And yet, how he retained many aspects of his papacy throughout his resignation caused a lot of stir at the time. For example, he kept the title of Pope and the white clothing because he insisted that his Petrine ministry did not end with his resignation but just changed. His resignation illustrates an important aspect of humility: Being humble doesn't mean rejecting or diminishing who one is in God, but instead recognizing the proper order of God and man. We can be most humble when we step fully into who God has called us to be and do our work for Him - and that sometimes means telling others about it.

Pope Benedict XVI, pray for us.

# State Registration Information

IT'S THE BEGINNING of State Convention season, which means it's time to send in forms before their deadlines and register for the state convention. There have been updates to the State Convention Site when it comes to registration. We'll look at these changes and some common mistakes people make when signing up.


- ► Go to the WI State Council Website.
- Click on the green registration button.
- ► From here, it is **preferred** that you fill out the online Pre-Registration Form, but you also print out the <u>Registration</u> <u>Form</u> to send into the office.
- ► Note the blue bar at the tops of each page: Agenda, Registration, Hotel. These are live links on the website that will help you plan your trip.
- ➤ On the registration page, you will notice a new "Restart Registration" button. If you started your registration but were not able to finish it, as long as you at least saved your email address, you will be able to continue where you left off. Just enter your email address and then click.
- ▶ If, however, you have completed your registration but want to make changes it will take you to a different page "Registration Change Request". This allows you to fill out a text box to tell the state office what you would like to change. That may be "I need another ticket for the State Deputy banquet", "I need two more working lunch tickets", or "I have to cancel as something unexpected came up". Please be detailed in your text as that will enable the state office to address your needs quickly. Farther down on this page you'll also see your initial registration, so you know what was originally chosen.

Why a text box? Simply put, once you submit your registration it cannot be modified online. However, notes can be added to your registration at the state office. With that, if you add meal tickets or activities, we'll ask you to send in a check to cover the cost. Or, if you cancel a meal ticket, the state office will then know to provide a refund. Please note that only the state office can see these notes, and your reservation page will not update. We will send you an email in reply to your Change Request, so you have a record. Please see the image for a reference.

► A common error on the first page of the online registration form is people fill out the information page but don't click on the gold "Continue" button on the bottom. They then come to the State Convention and wonder why they don't have tickets. Be sure to enter the security code found in the box on the right, then click on "Continue".

- ▶ On page two you can choose some available activities. The Working Lunch is the business meeting lunch for the delegates and other men attending this meeting. The women are welcome to attend the Ladies Brunch and Program. Once activities are chosen, they will appear at the top of the page and you'll see the total amount owed. Now choose the green "Complete My Registration" button for payment. Choose your payment type and the next page allows you to review your registration. If something is not correct, choose "If you wish to choose a different payment method…," which will take you back to the last page of registration. Once everything looks good and you've chosen your payment type choose "If this is correct, "Click here to Complete Your Registration". - ► If you didn't choose any activities, choosing the green "Complete My Registration" button will take you directly to the summary page and you'll receive a confirmation email. In either case, I recommend you bring the summary page to the registration table at the state convention.

GRAND KNIGHTS AND Financial Secretaries, please check your Prospect lists in Officers Online at a minimum of once a week. If you have men showing there, CONTACT them (you may have to call, text, or knock on a door in addition to email). INVITE them to your Council meetings and activities and get to know them. While you are together, invite them to attend an in-person or online **DEGREE** ceremony. After completing the degree, PROCESS them into your council. If the member does not wish to join your council, please REJECT him and select the appropriate reason. Then please contact me so I may take the appropriate action based on the reasoning. DDs and DMCs, please follow up with your councils.

#### **REQUIREMENTS:**

- ► Every man who joins online needs to access kofc.org/ joinus from a compatible device, personally complete the online application testifying to all the attestations, and submit the online application himself.
- ▶ When possible, the member should use his own compatible device.
- ▶ The member must use their own valid email address when completing the online application.



#### NOT ALLOWABLE:

- ► Completing the online application for a member even if they have asked you to do it for them.
- ► Collecting information from a proposed member on a form 100 or prospect card and using the information to sign the member up for online membership.
- ► Creating an email account for a member so they can complete the online membership process.

#### **NEW MEMBER PROCESS:**

Follow the standard procedures for a new e-member as with all new members:

- ► Completed Form 100, or assigned e-member status in Prospect tab of Officers Online (OO).
- ► Admission committee vetting.
- ► Council action (voting) see Guidelines for Online Voting - Motions if holding virtual meetings
- ▶ Degree Member must take the degree prior to being transferred into a council.
- ► Process the new 3rd degree member into your council via Form 100 submission or, Online form 100 using the Candidate tab data entry and transfer, or e-member transfer using the Prospect tab. **REMEMBER:** If you use either the Prospect tab or the Candidate tab to process your new members, do NOT submit a mailed paper or scanned pdf of the form 100. It just confuses the issue and might result in duplicate entries. Use only one of the available methods.
- ▶ Update degree status by entering degree dates for 2nd & 3rd degrees in Member Management. This is not an automatic process.
- ► Share this QR code with your prospects. +

### PKD & Culture of Life Contributions

IT'S PKD AND CoL donations season. I'd like to review how a council can verify what they can contribute for each and where to send payment.

As you know, PKD or Penny a Knight a Day supports Catholic Education across the dioceses of Wisconsin. Your contribution stays in your diocese, and a check is provided by the State Council each year to your bishop to be used in supporting your local Catholic schools.

PKD is calculated by multiplying \$3.65 (a penny each day of the year) based on the number of members for each council as of July 1st minus Inactive and Exemption (formerly disabled) members. The amount due for your council can be found on the State Council Website. To get there, type WIKOFC.com into a web browser and it will forward you to UKnight for the Wisconsin St Council, or use this <a href="Link">Link</a>. Scroll down the main page to Penny-A-Knight-A-Day where you'll

see the fearless Knight in armor. Click on "Read More..." which will open a window, then choose "Click here to view document". This will bring up a pdf listing all councils in the state and the amount of PKD Funds each council may contribute. As council checks are deposited you will see the date at the top of the pdf update and you can verify your contribution has been received.

For Culture of Life (CoL), amounts due are calculated similar to PKD except the rate is \$3.50 per member. To look up what your council can contribute, again go to the State Council webpage, but this time click on a *new button* this year called "State Council Resources" positioned in the top central quarter of the main page. This will take you to a new page and Culture of Life is right near the top. You can see last years contributions and the pdf for this year. The amount is a combination of donations from the CoL

mailer that went out in November and your council contributions. Both the PKD and CoL donations are listed on member dues each year but are not required to be paid by members or councils, yet highly encouraged. CoL contributions help fund grants to Pro Life services, agencies and programs across the state.

Checks should be written to Wisconsin State Council Knights of Columbus, or WI State Council Knights for short, and sent to the State Council office:

If you sending in amounts for both they must be on two different checks as it's a violation of WI State Council policies to co-mingle funds.

I ask each council during its next meeting to watch the video "The Eucharist: Source of Our Healing." Then begin planning how your council will support this important endeavor in the coming year.


#### TIME TO SUBMIT FOR THE COLUMBIAN AWARD (SP-7)

THE COLUMBIAN AWARD recognizes excellence in your council's programming and charitable outreach. To earn this award your council must conduct and report programs in each of the four program categories (Faith, Family, Community, and Life) for a total of 16 program credits, with four in each category. A completed Columbian Award Application (#SP-7) must be received by the Supreme Council office by June 30 in order to earn this award. There are no required programs.

The Supreme Council has designated certain programs as featured programs in each of the program categories. When your council conducts a featured program and satisfies the associated requirements it will receive two credits towards that program category on their Columbian Award Application (#SP-7). The featured programs for each category are listed below.

> FAITH - Refund Support Vocation Program (RSVP), Holy Hour, Spiritual Reflection, Into the Breach **FAMILY** - Food for Families, Family of the Month, Family Prayer Night, Family Fully Alive **COMMUNITY** - Coats for Kids, Habitat for Humanity, Global Wheelchair Mission LIFE - March for Life, Special Olympics, Ultrasound, Pregnancy Center Support (includes Aid and Support After Pregnancy – ASAP

Remember to file your Form 10784's with Supreme and the State Forms address. It's important for tracking and assisting

Councils with their program operations and needs. It also helps to fill out and get in that SP7 due in June and on the road to Star Council!

As I'm writing this, I've just returned from Madison and the judging of the History Books and State Service Program Award applications. There were some really good Books and Program entries – you'll see them at the Convention. Unfortunately, there were many others that could have contended for awards had more effort been put into content, proofreading, formatting their entries. Also, as is the case for such things as Medallion Awards, Family of the Year nominations, outstanding programs, etc., so many Knights, families and programs go unrecognized or honored because Councils don't bother to submit the applications, do the "paperwork." Hopefully, we can reverse that trend in 2023-24.

- ► Learning the five steps in the engagement cycle and how they relate to one another, ultimately leading a member to go through them again.
- ▶ Discovering tools that will help address deficiencies in your council's current member engagement as based on your councils engagement score.
- ▶ Understanding that retention issues result when a council has failed to engage a member and show the value of his membership. These issues can be overcome by discovering where this breakdown occurred.

### **ICON UPDATE**

The St. Joseph Icon has been traveling around our state now for a little over a year and has been in 52 districts already with at least 200 Councils. We are nearing the end with only 15 Districts remaining to share the Icon between its Councils.

There seem to some repeated questions that I receive regarding the program. The most common one is do we have to exchange the ICON on the set date. The answer is to work this date out between the two Districts Deputies the receiving on and on passing it on. Each District has the icon for roughly 30 days so even in the most extreme case every council should be able to have the Icon for several days. Discuss the mater between your selves and try to get a date near the expected transfer date that is convenient for both Districts.

The second question is should I order anything in advance. This I suggest you discuss with the District that has the ICON before you. Initially the packages with the ICON were well stocked but the supplies do gradually diminish. The supplies are free from Supreme and can be ordered with a code attached to the ICONS. But it takes time to ship the items to you so I strongly suggest your order them ahead of time. A listing of items can be found on the Supreme web page.

The state convention is coming up in April to Green Bay I'm hoping that one of the four Districts 11, 60, 81, or 87, that will have the Icon can bring it our State Convention. If all four ICONs show up we can have them paraded at our Annual Mass with the Bishops.

On a final note remember to file a form #10784 Fraternal Programs Report Form. Supreme does keep track of these forms and reports to me how many were submitted from our State for the Icon Program. Currently only about 10% of the Councils that should have had the ICON have submitted it.
