The Degree exemplar team lead by SK Paul Schaefer, conducted one Patriotic Degree Exemplification hosted by Assembly 3749 at The Church of St. Mary in Tulsa, on November 16, 2019. The Degree exemplar team lead by SK Garth Christian conducted one Patriotic Degree Exemplification hosted by Assembly 3150 at Holy Family in Lawton on February 01, 2020. The next two exemplifications that were scheduled on April 18, 2020 at St. Monica, in Edmond, hosted by Assembly 2004 and June 13, 2020 at St. Andrew, in Moore, hosted by Assembly 3070, were cancelled due to the Corona Virus Pandemic.

I want to thank my Marshals and the entire 4th Degree Exemplification team for their outstanding support to the Oklahoma District. Past State Deputies' Meeting 115th Oklahoma State Convention April 11, 2020

As a result of "Stay at Home" guidance triggered by the Coronavirus pandemic, the 2020 Past State Deputies' Meeting was conducted "online" prior to the virtual state convention. Meeting participants were able log into the GoToMeeting website using a computer or smart device. A dial-in option was also available for participants to use.

Immediate Past State Deputy John Pierce called the meeting to order at 11:00 am, Saturday, April 11, 2020. Our Worthy State Chaplain, Rev. M. Price Oswalt opened the meeting with prayer and Past State Deputy Bob Melko lead the participants in the Pledge of Allegiance.

A roll call was conducted. The following were in attendance – State Chaplain Rev. M. Price Oswalt, IPSD John Pierce, PSD Bob Melko, Supreme Treasurer & PSD Ron Schwarz, PSD Dan Hogan, PSD Paul Weigl, Supreme V.P. of Hispanic and Ethnic Development & PSD Jose Jimenez, PSD Richard Schulte, PSD Dale Harrison and PSD Robert Basolo. State Deputy Matthew Maly participated at the beginning of the meeting. SD Maly left the meeting at the conclusion of his remarks.

Those not able to attend – VSM & PSD David Roewe, PSD Buster Fisher, PSD Willard Patocka, PSD Robert Novotny and PSD Leroy Jech.

The State Chaplain provided remarks to the attendees. Father Oswalt commented on the present situation the world finds itself in by reminding us that all things have a beginning, middle and end; and we are in the middle and that this will end. Father reminded us of the words of St John Paul the Great, that through all Scriptures we are reminded to "be not afraid". Father shared with us some words of wisdom from the Papal Preacher, Father Contalamessa, who preached for Pope Francis on Good Friday, about whether or not God was the cause of the epidemic, or whether He was just trying to get our attention and that He can bring good out of evil, if we cooperate with His Grace in these moments.

Supreme Treasurer Ron Schwarz and Supreme VP of Hispanic and Ethnic Development Jose Jimenez provided an update on Supreme activities in response to the nationwide "Stay at Home" advisory. All Supreme business is being conducted from homes of staff members using various social media applications. Supreme will be hosting an online Charity, Unity & Fraternity Exemplification to all jurisdictions on Thursday April 16, 2020. In addition, 2019-2020 jurisdiction goals for Circle of Honor will be adjusted considering the limitations everyone is encountering during the current pandemic. Based upon the current jurisdictional statuses, Oklahoma is very well positioned to achieve Circle of Honor again this year. At this point the Supreme Convention is still scheduled for early August in Washington, DC. All are hopeful that the current restrictions will be lifted in time to allow the Supreme Convention to proceed as planned.

The minutes for the 2019 PSD meeting were distributed to all attendees prior to this meeting for review. No additions or corrections to the minutes were reported by the attendees.

State Deputy Matt Maly provided and update on the activities of the State council. He mentioned that many of our councils remain active while observing social distancing and abstaining from group

gatherings as recommended by government officials. Councils have participated drive through Lenten fish fries and drive through Stations of the Cross in support of our parish priests. The State Council recently discovered several cases of N-95 masks that were placed in storage after the 2013 tornado recovery effort. Most of the masks were provided to the Center of Family Love and St Ann's assisted living center for the protection of staff and residents. Some masks were also given to Norman Regional Hospital and local volunteer fire departments and other first responders.

SD Maly provided further information on the upcoming virtual Charity, Unity and Fraternity Exemplification hosted by the Supreme Council and he also reported that the State Council is preparing a team to conduct virtual exemplifications to meet the needs of our councils during the current meeting restrictions. We have received permission from the Supreme Master to host a virtual 4th Degree Exemplification.

In preparation for the virtual State Convention SD Maly sent a letter to all State Officers, DD's, Directors and Chairmen that their annual reports must be submitted to the State Secretary by April 12th so they can be posted on the State Website for review by the delegates prior to the virtual state convention. The Supreme Council has selected a conference call system to be used to conduct the convention that allows delegates to participate and vote by phone from their homes. Only delegates will be invited to call in on this system. To allow participation in the convention by non-delegates the State Council will simultaneously host a GoToMeeting session. This will allow PSDs to have a voice on the floor for making motions and nominations. The virtual state convention will be held Saturday, May 9, 2020 from 3:00 pm to 4:30 pm CDT. All invitees will be receiving a letter from the State Council with detailed instructions regarding connecting to and participating in the convention proceedings.

Given the limited time allowed for the convention, the proceedings will only involve the minimum actions required to meet the obligations of the By-Laws. To assure full compliance with the By-Laws the Supreme Council issued modified By-Law requirements that have been approved by the Supreme Council Board of Directors to allow the conduct of state conventions in this manner. A copy of the Supreme directives addressing the modified rules and procedures was forwarded to all PSDs with a current e-mail address.

Hopefully the current social distancing and gathering restrictions will be lifted prior to our 2020 Organizational Meeting, scheduled for the weekend of July 10, 2020 through July 12, 2020. If so, the PSDs will be invited to attend a PSD banquet on Friday evening July 10th. Once the details of the 2020 Organizational Meeting are finalized, invitations will be sent to the PSDs.

PSD Schulte provided an update on the activities at the Center of Family Love. The Center went on lockdown in early March, prohibiting visitors on the campus for the protection of the residents. So far, no residents or staff have contracted the Covid-19 virus. The annual Gala scheduled for Saturday, June 20, 2020 has not been canceled – yet. We are hopeful the restrictions will be lifted in time to allow the Gala to proceed as planned. The "go – no-go" decision will be announced on or before the virtual state convention. If the Gala is a "no-go" the raffle will still be held. As a result, PSD Schulte emphasized that the State Council and local councils need to continue promoting the raffle and selling tickets to provide critically needed funds to the Center.

Old business was discussed. A motion was made by PSD Hogan and seconded by PSD Schulte to approve last year's meeting minutes. There was no discussion and the motion passed. At the conclusion of the

vote the State Chaplain noted that an approval vote on past meeting minutes is not required by Robert's Rules of Order. It is sufficient to ask for and adopt any additions or corrections to the minutes. Another item of old business was addressed by PSD Hogan. He stressed the importance of councils providing financial support to our Knights of Columbus foundation to assure the availability of funds for critical repairs at the Center. PSD Schulte reported that presentations were made to the councils at the 2019 Organizational Meeting and the State Workshops explaining purpose and importance of supporting all fund-raising programs for the Center. Special emphasis was given to the annual Intellectual Disabilities fund drive that provides critical funding to the Foundation.

There was no new business discussed.

The floor was opened for general comments and discussion. PSD Schulte asked about the status of the state scholarship program. So far, this fraternal year scholarship donations amount to \$1,000.00. Typically, most of the annual scholarship funding is collected from the councils at the state convention. Given the plan for this year's convention, the State Officers are considering inviting all Grand Knights to the July Organizational Meeting and to receive scholarship donations from the councils at that time. Since the closure of St Gregory University, a modified scholarship program was developed. There is a concern that many of the Grand Knights do not understand the new program and, consequently, there appears to be a lack of interest in conducting council fund raising events for the scholarship program. IPSD Pierce will provided a copy of the current scholarship program write-up to the PSDs for review and comment. The concerns raised by the PSDs will be communicated to the State leadership team.

Prior to closing the meeting with prayer, IPSD Pierce asked for any prayer intentions the participants would like to share with the group. Prayers were requested for: Ruby Rheims wife of Texas DM Don Rheims who passed away after contracting the Covid-19 virus; Fred Lueckenhoff, brother-in-law of RJ Schulte who passed away and for his family who have not been able to have a funeral Mass as a result of the pandemic; Theresa, niece of Father Oswalt who is a flight attendant for an international airline and who is currently detained in Germany as the result of an illness (non Covid-19).

State Chaplain, Father Oswalt, closed the meeting with prayer. IPSD Pierce adjourned the meeting at 12:10 pm.

OKLAHOMA KNIGHTS OF COLUMBUS FOUNDATION REPORT

Worthy State Chaplain, Worthy State Deputy, Worthy Supreme Representative, Worthy State Officers, Delegates and Brother Knights, assembled here for this the 115th Annual Knights of Columbus State Convention in Edmond, Oklahoma on this the 26th day of April 2020.

I want to inform each and every one of you who are members in good standing of a council in good standing with the Oklahoma State Council, that you have a voice and a vote at this Foundation meeting.

The By Laws of the Foundation state that it was organized exclusively for religious, charitable, scientific, and educational purposes and I feel that the board meets and follows these guidelines.

The Foundation Board is controlled by a nine man Board of Directors. Six are elected to a three year term. Three are members by virtue of their State Offices. The elected members are President Willard Patocka, Vice President Paul Weigl, Secretary/Treasurer Jerry Schmitz, Counselor Dale Sligar, and Trustees Maurey Campbell and Garth Christain. The State Officers are State Matthew Maly, State Secretary Dennis Kunnanz, and State Treasurer Christopher Victor. The State Chaplain Very Rev. M. Price Oswalt is an ex-officio member. At this meeting we will elect two members to replace the expiring terms of Garth Christain and Paul Weigl for three-year terms.

The main purpose for the Foundation is to provide facilities for the Center of Family Love. The Foundation is also responsible for the Investment of these additional state council funds: Pennies For Heaven, 365 Club, Special Charities Fund, and the Scholarship Fund which includes the Al Wheeler Scholarship Fund.

This past year the Foundation paid out \$121,271.00 for Ultra Sound, Disaster Relief, Pennies for Heaven Scholarship, Center of Family Love Scholarship, and replacement of an air conditioner at Center Of Love in St. Michael's Building.

Since the Foundation owns the land and buildings of The Center of Family Love, we are the landlord and therefore are responsible for the major items of repair and maintenance of all campus buildings and group homes.
