This council meets at the Santa Fe Family Life Center and serves Our Lady's Cathedral parish and has members at other parishes as well.

This council transitioned to virtual meetings immediately when the pandemic hit. It was able to continue the financial support of a number of charities which it has supported on an on-going basis. It has returned to in-person meetings with a virtual component for those members who do not yet feel safe attending these meetings.

Much of the work of this council has centered around the operation of the Santa Fe Family Life Center. The pandemic necessitated the suspension of services of the center. The Center partnered with SSM St. Anthony's to make protective equipment for use in hospitals. The Center is now open for normal activities but they were unable to host some of the charitable activities that they normally do.

This council is financially sound and has a strong leadership team but lacks support from many of its members. There has been no membership growth this year. Council reports are up to date.

I project that this council will not earn Star Council this fraternal year.

This council has had some struggles as a result of the pandemic but has responded well. The Grand Knight was a health care worker who was assigned to COVID 19 patients. The pressure of his employment and the long hours he was working necessitated that he resign from the grand knight position. The deputy grand Knight was elected to complete that term of office. Another member accepted election to deputy grand knight, so that council activities could continue.

Council members called parish members to check in on them and to invite them back to Mass when we were open for public masses. All council members were called to check with them and see if they had needs that the council could assist with.

The council treasury got depleted when the normal fundraising events could not be held, but enough funds were retained to insure that state and supreme obligations could be met for the current fraternal year and the beginning of next year.

Monthly meetings were suspended for a short time but in person meetings have resumed with a virtual component so that those members not feeling safe in public meetings could still attend.

The council has completed several charitable activities and has held two in person exemplifications of Charity, Unity and Fraternity with another planned for May. The council has a net gain of 16 members, 200% of quote, but will likely suspend some delinquent members before the end of the fraternal year.
