## GOSPEL WITHOUT BORDERS

Bishop Anthony Taylor has ordered copies of the DVD documentary, "Gospels Without Borders," for all parishes in the diocese and encourages that they be used for study and discussion during Lent 2012, which begins on Ash Wednesday, February 22.



The documentary is a cooperative venture of Catholics, Baptists, Methodists, and Presbyterians. It explores the issue of immigration from a faith-based perspective and focuses on the issue in Arkansas and four other states: Arizona, North Carolina, Alabama and Iowa. The documentary presents the current situation but does not offer solutions or suggestions on immigration reform.

Bishop Taylor was interviewed for the film and some of the footage was shot in Arkansas parishes. "This is not intended to be a political effort," said Bishop Taylor. "Our role is to preach the truth in season and out of season. Jesus in Matthew 25 in his parable, 'The Last Judgment,' says that we will be judged on the welcome we give or do not give the stranger. He makes it clear that we will be judged on how we treat the stranger in our midst. I'm trying to get as many people to heaven as I can."

This is another opportunity for leadership by the Arkansas Knights of Columbus, who have established a reputation for protection and assistance of the powerless, especially in pro-life

efforts, the Campaign for Persons with Intellectual Disabilities, and Special Olympics. Some of our Councils have already rallied to the support of immigrant families who were in economic difficulties or in danger of being treated unfairly in their areas.

The film comes in two versions: the short version is 31 minutes long and in a panel discussion format, recommended for junior and senior high students. The longer version is 53 minutes long and designed for a four-week study during Advent or Lent. Support of this study by Knights in their parishes will accentuate at the local level themes in Supreme Knight Carl Anderson's 2009 book, Our Lady of Guadalupe: Mother of the Civilization of Love, and also provide context for the pilgrimage of the Lady of Guadalupe image in the diocese.

Worthy Financial Secretary:

I write to you regarding a matter of utmost importance to the Catholic Church in the United States. On January 20th, the Department of Health and Human Services (HHS), made a final decision that would force Catholic institutions to provide health insurance that includes all FDA-approved contraceptive methods and sterilization procedures, including several drugs that cause an early abortion by interfering with the implantation of a newly-conceived human being. This mandate poses a very serious threat to the religious freedom of Catholics and Catholic institutions.

You will recall that the delegates at our 129th Supreme Convention in Denver last year unanimously passed a resolution pledging our support for freedom of conscience in health care. Now is the time to make that pledge of support a reality.

The United States Conference of Catholic Bishops is urging Catholics and all citizens to contact their elected leaders to let them know they want religious liberty and rights of conscience restored and the administration's contraceptive mandate rescinded.

Please encourage all Knights and their families in your jurisdiction to send an email to their elected representatives in Congress by visiting [www.kofc.org/rights](http://www.kofc.org/rights). Sample language has been provided urging elected leaders to co-sponsor the Respect for Rights of Conscience Act (H.R. 1179 / S.1467). This bi-partisan legislation will ensure that federal mandates do not penalize or discriminate against religious believers.

The Knights of Columbus will never waver in our opposition to any governmental action or policy that forces our citizens to violate their deeply-held moral and religious convictions.

Worthy State Chaplain, State Deputy, Past State Deputies, State Officers, State Directors, District Deputies, Insurance Agents and Brother Knights

It has been an honor to serve the State Council this year in promoting Membership to our Councils in our order.

Membership is very important to the continued growth of our Councils in the State of Arkansas. The State Deputy and Membership Chairman work with the District Deputies and Grand Knights and Council Membership Chairman in trying to achieve the goals of each Council for membership. Also each Council is looking at achieving goals for Star Council, Father McGivney, Founders, and Columbian Awards.

The membership goal for Arkansas this year was and is 400 with a net of 275. We have gained 153 new members but we need 247 new members to attain our membership goal without any further losses. Let's continue recruiting and working on membership. We can get 250 new members by June 30, 2012. We also gain membership opportunities for new Councils and round tables in the State of Arkansas.

Some recruitment encouragement items are:

1. Contact your Pastor and get a list of all Catholic men in the Parish over 18 years old.
2. Schedule a phone-a-thon with your Council's Officers
3. Work up a list of prospective members from your Parish list and get several persons to help call prospective members.
4. Invite the prospective members to an Open House that you have scheduled with food and informational material, plus talk about the Knights of Columbus and what they do in their fund raising activities and their fund activities, and bring form 100's for them to sign.
5. Help the new members make new friends in the Council by introducing them to all Brother Knights. Friendship in the Knights is very important.
6. Also make your current members along with new members feel important in the Council meetings.
7. Get your new members active and involved in the various programs in your Council and they will start helping your Council grow if they become involved with programs. By showing interest to the members confirms your commitment to the membership and will increase their willingness to assist in the programs for the Council, Church, and Community.
8. Remember that your new members will be your Council Leaders and you need to help them achieve knowledge of your Council activities and Officer requirements. Without new members working up the ranks of your Council Officers, they will have a tough time understanding the programs and responsibilities.

The State Deputy and I ask you today, to go out and promote the Knights of Columbus and recruit new members into your Councils for the next six months. We can only ask but you can achieve those goals.

More on defunding Planned Parenthood.

Just this month a young woman from Texas was faced with the harsh truth about Planned Parenthood and their real motives.

This University of Houston Texas student discovered she was pregnant and was in need of regular medical attention.

The Planned Parenthood super center is located very close to the university, so her parents suggested that she go into the center for a regular checkup since their daughter had no health insurance.

I suppose they were naive, but little did they know that their young daughter would be in the hands of pro-abortion advocates.

The student, alongside her fiancé, walked into the abortion clinic thinking that Planned Parenthood would help.

To their surprise Planned Parenthood staff at first refused to do anything unless she paid for the medical exams upfront. Finally after a two hour wait, a Planned Parenthood employee asked the student a question she never imagined.

"Do you want to have an abortion if you're pregnant?" asked the Planned Parenthood employee.

When the student and her fiancé made it clear that she was not there for an abortion, she was summarily dismissed and invited not to return.

It is not hard to imagine how many other pregnant young women walk into a Planned Parenthood facility seeking medical help, but lacking conviction in tough circumstances, allow themselves to be enticed to kill their babies -- a decision that they will regret for the rest of their lives.

Clearly the financial plug needs to be pulled from Planned Parenthood.

One million taxpayer dollars a day to this abortion giant is one million dollars a day too much.

Now both the pressure to cut the budget, combined with the outrage over Planned Parenthood's tactics make this a perfect time to end tax funding of abortion.

Please call House Speaker John Boehner at 202- 225-0600 and urge him to include in any budget agreement the Pence Amendment, which would cut off all taxpayer funding of abortion providers.



## **ARKANSAS KNIGHTS OF COLUMBUS FAMILY OF THE YEAR IN 2009-2010 SUFFERS LOSS**

Wife of Sir Knight Brian Swisher, mother of Daniel Swisher and Sir Knight Michael, Gail Swisher passed from this life on January 1, 2012 at Circle of Life Hospice in Bentonville, Arkansas after an amazingly courageous battle with breast cancer for over (14 years).

Glenda Gail Cathey was born in Batesville, Arkansas on August 19 1952, the daughter of George and Charlene Cathey. She graduated from Greenville High school in Mississippi in 1970. She earned a Bachelor of Science in nursing from Northeast Louisiana University in 1974 and her Master of Science in Nursing from University of Alabama in 1984.

She worked for Arkansas Support Network for persons with disabilities in Northwest Arkansas, from 1997-1999. She was a driving force for people with disabilities serving in many capacities for 15 years with Arkansas Support Network. She volunteered and was active in both her sons Boy Scouting journey, with both achieving Eagle Scout rank. She served as Director of Nursing at Bates Hospital in Bentonville and Dallas County Hospital in Fordyce and worked in acute care at Northwest Health Systems in Bentonville. In 1995, Gail joined NWACC Department of Nursing as an instructor. For 11 years, Gail volunteered as a nurse at Camp Barnabas where son Michael attended each summer.

She would bring church youth and nursing students to camp as volunteers. Gail and her family attended St Stephen Catholic Church in Bentonville. The Swisher family was named the Arkansas Knights of Columbus Family of the year in 2009-2010. Gail is survived by her mother of Rogers, husband of 25 years Brian; sons Daniel and Michael of Bentonville and her brother Nathan Cathey of Washington. She is preceded in death by her father.

Her funeral was held Friday, January 6, 2012 at 10:00 AM in St, Stephen Catholic Church, Bentonville, with Monsignor Scott Marczuk officiating. Her visitation was Thursday from 5:00 PM until 7:00 PM, at Rollins Funeral Home Chapel, with a Rosary at 6:30 PM.

## **OUR LADY OF GUADALUPE FRAMED IMAGE TOUR**

Cardinal James Francis Stafford, Major Apostolic Penitentiary Emeritus, and archbishop of Denver emeritus, was the principal celebrant at Votive Mass of Our Lady of Guadalupe on Wednesday, August 3rd, at the Supreme Convention in Denver, Colorado. Knights of Columbus state deputies stood before the altar at the end of the Mass holding their jurisdiction's framed image of Our Lady of Guadalupe, as Msgr. Eduardo Chavez explained the new Marian Prayer Program in which the images would be hosted by local councils worldwide



during prayer services. The Guadalupe images were blessed by Pope Benedict XVI and touched to the tilma of Juan Diego which bears the miraculous image of Our Lady of Guadalupe. In addition, the frames of the images were sealed with soil from Tepeyac hill in Mexico, where Our Lady's appearances took place. The new Knights of Columbus Marian Prayer Program will take place throughout the Order and lead into the second international Guadalupe Festival to be held at the Los Angeles Coliseum the weekend before the 2012 Supreme Convention. Supreme has blessed our state with two Our Lady of Guadalupe images and prayer books. Our jurisdiction has been separated by districts into two, East and West. The East District's (ED) consist of District's 03, 01, 13, 11, 07, 02 and 05. The West District (WD) consists of District's 10, 04, 08, 14, 09, 12 and 06. Our Lady of Guadalupe image will pilgrim through each district for at least one month starting with District 03 in the ED and District 10 in the WD. Each case containing the image of Our Lady of Guadalupe has a LOG BOOK in the side cover of the casing. This log must be filled out each time you have a prayer service/rosary and/or any gathering honoring Our Lady of Guadalupe. Please ensure the log book is kept with each image. We must return both set's at the end of the pilgrimage.

The District Deputy's will be responsible for ensuring the Our Lady of Guadalupe image pilgrims through their district. The District Deputy's coordinate with each Grand Knight the dates their council will have the image in their parish. Each Grand Knight will need to coordinate with their parish pastor's to ensure the image is displayed, at least one prayer service with the accompanied prayer books is made at each parish, one Rosary is said by the Knights and it is kept safe. Again, please ensure the log book is filled out for each event. The host council will then contact the next visiting council for date and time of delivery of Our Lady of Guadalupe image, prayer books, and log book. Please follow up with each Grand Knight receiving the Our Lady of Guadalupe image to ensure they are on schedule. Once the last council in your district is concluding their time with Our Lady of Guadalupe image, the DD will be responsible for contacting the next District Deputy to coordinate hand off.

The following is the schedule of the two pilgrimages:

I will be following up with each District Deputy at the beginning and end of each month to ensure we are on schedule. Our mission is to have both Our Lady of Guadalupe image's at our State Convention in April, at which a prayer service will be held on Sunday morning.

Please ensure all the prayer books are placed back into the traveling case with each Our Lady of Guadalupe image for the use of the following council. There are prayer cards which may be given to those who attend a prayer service, although limited. One of the follow up questions during my call will be the quantity of prayer cards left. I pray we can receive more from Supreme. We will see.

May Our Lady of Guadalupe keep you safe and watch over our pilgrimage of her image throughout our Arkansas Jurisdiction.
