### Reminders

Forms: The February Audit (#1295) is due on the 15<sup>th</sup> of this month. Also due is the IRS form 990 (most councils can do it online with the postcard format). **Don't let this slide, if you lose the status to file this form it is a nightmare to re-establish eligibility.** If you have not yet sent in your Council Fraternal Survey (#1728) it is overdue (1/31). Same for the Special Olympics report.

**Meetings:** Supreme and State Per Capita charges have been assessed and are currently due.

We are currently in the planning stages for 2 very important meetings, the Sate Convention at the end of April and the Patriotic Degree Biennial Meeting at the beginning of April. Delegate Credential Forms for the State Convention can be found on the State Website (<a href="mailto:kofcri.org">kofcri.org</a>) and are due to State Secretary Joe Carrignan (<a href="mailto:statesecretary.rikofc@gmail.com">statesecretary.rikofc@gmail.com</a>) by April 13th. All per Capita payments must be current in order to seat your delegation. Resolutions must be submitted to State Advocate PJ Shea (<a href="mailto:sheapi517@gmail.com">sheapi517@gmail.com</a>) by March 1st.

In addition to the above item, State Secretary Joe Carrignan notes Per-Capita bills were sent out a few weeks ago, if your council has not received their invoice, please reach out to your DD, or directly to him. Delegate forms for the state convention are on the state website, remember council percapita must be paid for your council delegate to be seated. Finally, Insurance bills will be emailed to your Grand Knights and FS later this week, beginning next week. Again, if you don't receive them, please reach out to SS Joe directly. Remember EVERY council needs to carry liability insurance pursuant to Diocesan mandate. The state council takes out this insurance for all its subordinate councils and it is the cheapest insurance at this year's cost of \$2.09 per billable member.

Biennial Meeting forms have been emailed to the Navigators & Comptrollers, return to the Executive Secretary (<a href="mailto:iklmc.tracy@gmail.com">iklmc.tracy@gmail.com</a>) by February 29<sup>th</sup>. Resolutions for the Biennial Meeting must also be sent to the Executive Secretary by February 29<sup>th</sup>.

Safe Environment: We are now well over halfway through the year. If you have not yet achieved Safe Environment Compliance, PLEASE get it done now. The training doesn't take long and is the most important thing we can do for our youth. And both the Supreme Council and the Diocese of Providence require it in order to work in our parishes (& our youth). This not only protects our youth, but it also protects your Council.
