



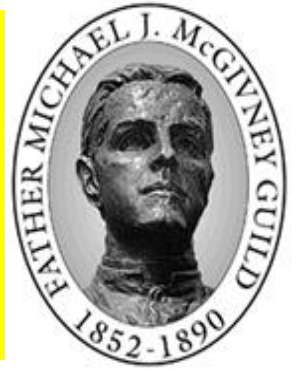

The chief task in life for all of us is to do what God wants us to do. It isn't always easy to find this out. God obviously doesn't think it would be good for us to know this automatically; otherwise we would be born with a label.



Those who take this search seriously pray for knowledge of God's will all their life. The focus of the prayer is different at different stages: first, how am I called to spend my life; and along the way, what am I to do now?

I would like to call attention to three vocation prayer formulas. The first one I learned from Bishop Albert L. Fletcher when he visited our church in Clarksville for Confirmation. Very simple and to the point: "O God, help me to know what you want me to do."

The second is in the Sacramentary used by the priest at Mass. It is a prayer by Pope Clement XI (1700-1721). This seems to cover everything: "Lord, I want to do what you ask – in the way you ask – for as long as you ask – because you ask."

The third was found in the clothing of Franciscan Father Mychal Judge, chaplain of the New York Fire Department, when he was killed by falling debris as he entered one of the smoldering Twin Towers on 9/11/01 to rescue people: "Lord, take me where you want me to go – Let me meet whom you want me to meet – Tell me what you want me to say – And keep me out of your way."

Awards that are also given by the Arkansas State Council include:

- Council that made the largest Per-Capita donation to Persons with Mental Disabilities. (No entry form required)
- Council that made the largest donation to Persons with Mental Disabilities. (No entry form required)
- District Deputy of the Year. (No entry form required)

Basis for judging and criteria:

Remember, these awards are based upon ONE project or activity conducted by the Council in the 12-month period between the state conventions, and not upon a series or accumulation of activities in a particular section of the Service Program. (Consider the following areas when judging a project or activity)

1. **Nature of the Activity.** Does it demonstrate the objectives of the Service Program – Catholic, family, fraternal, service?
2. **Participation of Membership.** How many members participated? What percentage of the entire membership participated?
3. **Results.** What were the benefits derived from sponsorship of the project? How did the results affect the Church, community, council, family, youth or **Pro-Life**?
4. **Program Originality.** Was the project something new?
5. **Committee Planning.** How effective was the program organized? How much detail was involved in staging the event?
6. **Delegation of Responsibility.** How many members served as workers? Planners? What type of organization was established for the implementation of the project?
7. **Publicity.** How effectively was the program publicized throughout the area – radio and television, local and diocesan newspapers, and council newsletters?

Please take the time to look in your Surge with Service Booklet for service ideas in each of the six categories and use your Council Report Forms Booklet for the STSP form to make copies. Remember that you will need a separate STSP form for each of the six Service Activity categories. You will also find instructions on the State Website. State Awards will be presented at the Arkansas State Convention Banquet. Winners of each of the Service Awards and Family of the Year will be entered in the Knights of Columbus International Competition. While you are in your Report Forms Booklet, please remember to fill out your SP-7 form for your Columbian Award. That form must be submitted to Supreme by June 30, 2011.

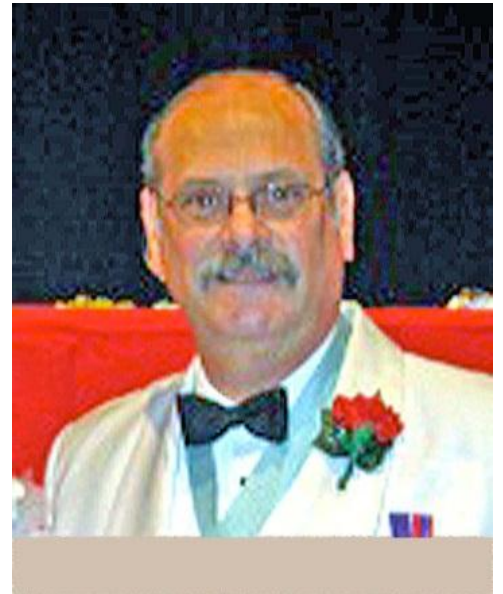

Candidates for State Office:

The accepted Rules of Conduct for a candidate seeking a state office states that all candidates must be nominated by their local council in the form of a resolution. Letters sent to other councils must come from the candidate's home council and be signed by the Grand Knight. It is improper for a candidate or council to "advertise" a candidate in any public location before or during the convention. This rule will be strictly adhered to and enforced for this convention. The Council may send a copy of the resolution to the Newsletter and the website, arkofc.net for publication. The candidates may be advertised in the hospitality rooms at the convention or by word of mouth anywhere.

STATE SECRETARY'S REPORT
MICHAEL KIEFFER
ON HONORARY MEMBERS

On August 5, 2010, at its annual convention in Washington, D. C, the Supreme Council of the Knights of Columbus voted to amend Section 118(c) of the Order's Laws by adjusting the annual payments for Honorary Members. Formerly, the annual payment was fixed at \$10.00, which included State and Supreme per capita charges and levies. As amended, the annual payment for honorary members will include the Supreme per capita charges (\$3.50), the Catholic Advertising assessment (\$1.00) and the amount of the annual State council per capita charge.

Arkansas State Council per capita is set at \$6.00 for all but college councils.

So if Supreme per capita and Catholic advertising are added along with State per capita, you get a total of \$10.50 for the maximum dues for an Honorary Member.

Honorary Member is a member who has attained the age of 65 and who has been a member for 25 consecutive years.

Honorary Life Member is a member who has attained the age of 70 and has been a member for 25 consecutive years and those who have been members for 50 consecutive years regardless of age. Honorary Life Members are exempt from dues, per capita and Assessments. See Laws of the Order or Financial Secretary Handbook for more detailed explanation.

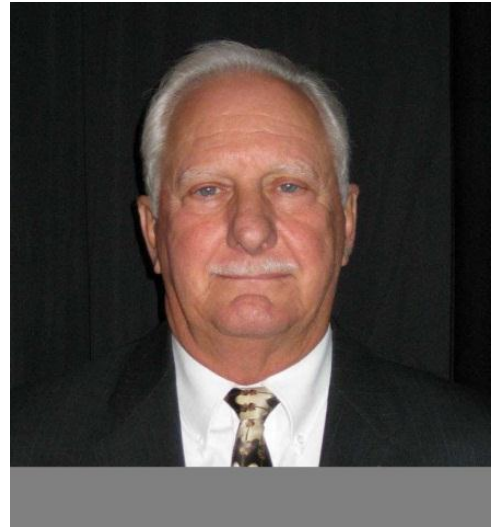
The IRS has increased the earnings limit and form requirements on tax exempt charities filing forms 990 and 990EZ from \$25,000 to \$50,000.

The change reads in part: "Small tax-exempt organizations whose annual [gross receipts](#) are [normally \\$25,000 or less](#) (\$50,000 for tax years ending on or after December 31, 2010) may be required to electronically submit Form 990-N, also known as the e-Postcard, unless they choose to file a complete Form 990 or Form 990-EZ."
