STATE DEPUTY CHARLES KETTER

Brother Knights:

I want to thank Districts 06 and 12 for a great convention in beautiful Rogers Arkansas. What a



great job this committee has done. There is never a dull moment in Northwest Arkansas with so much to see and do. When you get time stop by and personally thank our Worthy State Treasurer, Adrain Dominguez and two of the best District Deputies in our order, Mike Young and David McCall. Our order is so much richer because of all our District Deputies.

We have a terrific job before us today and the rest of the year. Thanks for the great job you men are doing this year recruiting. We are close to our goal of 410 new members. Please I urge to not let up but find new energy to ask one more good Catholic man to join our brotherhood.

I want to ask for the help of the Strong Right Arm of the Church today as we respond to the call of Bishop Taylor, Msgr. Friend and your future priests. As most of you know we have committed to the huge task to raise \$187,000 for the House of Formation in Little Rock. You're State Officers, Past State Deputies, District Deputies and Program Chairman met with Msgr. Friend and discussed the project and in a unanimous decision the Knights in Arkansas would sponsor the chapel in the house. What better place for a young man to discern than in the chapel built by the Knights of Columbus. I am quite certain there is another Michael McGivney in waiting. There was a need at that time for an immediate donation to secure a

\$50,000 grant from the Catholic Extension Society hence the need to cash in the Certificate of Deposit's we had on hand. I knew that you my brother Knights would not say no to increasing vocations in Arkansas. At this time we have 35 Seminarians in Our Diocese. There will four new priests ordained this year to celebrate the Eucharist. As the money comes in from the councils activities in their parishes we will replace the Certificate of Deposit funds. It is your convictions as the leaders of your council that will replace the Certificate of Deposit's and help make the Knights of Columbus chapel a reality. Don't let the Minimum be your Maximum.

We have talked for the last couple of years about the need for liability insurance. We are not covered by liability insurance from the Diocese. We the officers have found a plan to cover the entire Jurisdiction of Arkansas. If we consider all the Knights our brothers then we have the responsibility to see that everyone in the state is covered. I know that those with council homes have liability insurance but when you leave your home building for a Free Throw or soccer event you are no longer covered. Most of the councils use the parish facilities for Lenten Fish Fries, Pancake Breakfasts etc. We ask your support for an increase in Per Capita from Six Dollars to Ten Dollars with \$2.50 going to the liability insurance and the \$1.50 to help with the rising cost of travel for your officers and program chairmen. We have not raised Per Capita in ten plus years. Don't let the Minimum be your Maximum.

Listening to our Supreme Knight and our Bishops we have a very grave challenge before us. The church has seen challenge before that is the attempt to silence the voice of freedom of religion. We are the labors in the vineyard who have been challenged by our government to see if we committed to religious liberty. If this is important to you, and I pray it is, we need to let our legislators know that we are committed to pro-life. We must protect LIFE from conception to natural death. We as Christians should NEVER be required to pay for birth control, infanticide or euthanasia. Life is a gift from God and not the government.

You my brothers thru the Baby Bottle campaign have helped place two Ultra Sound Machines to help those considering abortions to view their baby and finally it is really a life to be shared with the whole world.

We have very few councils participating in the youth activities provide by Supreme. It is very important that we involve our youth in church activity and let them know that they are very special and need in the church. So I challenge you my brothers to do all you can to recognize the youth in your parish for all they do.

Finally as I close my terms in office I want to thank everyone who has made this a life changing experience for me. The past State Deputies have been such a source of knowledge and help. Thanks to every one of you. Also as I have said so many times the District Deputies have been my eyes, ears, arms and feet. Thank-you for all the hard work you do. The dedication of my program chairman will never be matched. You my friends are a blessing to all your brother

Knights. I am not going away but will always be here as working part of the Strong Right Arm of the Church. May God Bless and keep everyone of the over 7,200 men who call themselves Knights in Arkansas.
