The Knights of Columbus is grateful for the good work and sacrifice of those members who serve as permanent deacons. While acknowledging their valuable contribution to the life of the Church, the Supreme Council has consistently rejected proposed changes that would give to permanent deacons the same or similar rights, duties, and privileges within the Order as are currently given to priests. The Eucharistic character of the Knights of Columbus essentially requires that council chaplains must be priests. This policy is consistent with the idea that the council chaplain is a successor to Father McGivney and it recognizes the Order's longstanding devotion both to the Eucharist and to the priesthood. The last major statement on the role of deacons in the Order was passed by the [Supreme Council in 2001](#).

While a council may decide to exempt any member from the payment of dues, the Laws of the Knights of Columbus make no provision for an automatic dues exemption for deacons as it does for priests and members of religious communities. See Section 118(d) of the Laws of the Knights of Columbus. It is generally understood that the different treatment accorded to priests and deacons with respect to the payment of dues is based on an economic rationale. Specifically, deacons ordinarily hold full-time non-ministerial jobs with salaries that are more or less commensurate with their education, experience, and responsibilities. The priesthood is also a full-time job, though the salaries for priests generally do not allow for very much disposable income. In light of this economic reality, the Order has expressly granted priests an exemption from the payment of dues. The fact that deacons do not enjoy this statutory accommodation does not reflect a lack of appreciation or respect by the Order.

CHARLES CARROLL OF CARROLLTON

COUNCIL NO. 701

BY-LAWS

ARTICLE I

Section 1. This Council shall be known as CHARLES CARROLL OF CARROLLTON COUNCIL NO. 701, Knights of Columbus.

Section 2. The initiation fee shall be 15.00 except that for applicants under 26 years of age it shall be 10.00 and for Priests and religious it shall be nil. One-half of the initiation fee shall accompany the application but it shall be refunded if the application is rejected.

Section 3. Each member shall pay annual dues. The dues shall be payable quarterly in advance at the first regular meetings in January, April, July and October. The annual dues of members shall be 25.00, except honorary members who shall pay the sum of State and Supreme Council per capita charges and levies, and honorary life members who shall pay nothing. A reduced rate of dues for insured members under 26 years of age may be established, but it shall not be less than 3.00 per year. Except as stated above, the dues of associate and insurance members shall be the same.

Section 4. The Financial Secretary shall receive annual compensation, payable in quarterly installments at the end of each quarter, from the council an amount equal to 8 percent of the moneys collected on account of dues from both insurance and associate members.

ARTICLE II - Elections

ARTICLE IV - Meetings

Section 1. The monthly business meeting of the Council shall be held on the first Monday of each month, at such a time and place as the Council may designate. Eight members shall constitute a quorum at business meetings.

Section 2. All meetings of the Council shall be presided over by the Grand Knight, who will ascertain from the Warden if all present are possessed of the current membership card.

Section 3. The order of business and procedure for all regular business meetings of this Council shall conform to Section 125 of the Laws of the Order.

Section 4. Special business meetings can be convened: (1) by vote of the Council at a preceding regular business meeting; (2) by direction of the Grand Knight; (3) by the Grand Knight upon the written request of seven members stating the object of the meeting. Due notice of special business meetings and their purpose shall be given to each member in the usual way and no other business shall be transacted at any such meeting.

Section 5. The following shall be the order of business and procedure at special business meetings:

1. Call to Order
2. Warden's Report on Membership Card
3. Prayer
4. Roll Call of Officers

Section 3. No money in excess of 400.00 shall be paid or transferred from the Treasury of this Council, (except such moneys as the Council is called upon to regularly pay for its current expenses and as provided by the Laws and Rules of the Order or for purposes approved by the Supreme Council or Board of Directors), unless by a two-thirds vote of the members present and voting at a regular business meeting held subsequent to a regular business meeting at which notice in writing of a resolution of intention to pay or transfer such money and the purposes and amount to be paid or transferred shall have been given and regularly read.

Section 4. All bills shall be presented to the Recorder and by him read to the Council before being referred to the Board of Trustees. In case a bill is not approved by the Board of Trustees, it shall be referred back to the Council for action.

Section 5. The sum of 2,000.00 shall be paid from the General Fund to the Financial Secretary and shall be known as the Relief Fund. A Relief Committee shall be composed of the Grand Knight, Financial Secretary and Treasurer and shall investigate the case of any brother who is reported to be in distress or in need of relief. If, in the Committee's judgment, the case is one deserving of assistance, the Committee shall have power to draw from this Relief Fund such reasonable sum of money to afford assistance as the circumstances of the case may require, provided that in no single case shall more than 500.00 be paid out without reference to and approval by the Council.

ARTICLE VIII - Funerals, Etc.

Section 1. Upon the death of a member in good standing, the Memorial Committee shall give notice to the members and, if time permits, shall request them to assemble and pay their respects to the memory of the deceased at a time and place to be indicated in such notice.

ARTICLE IX - Miscellaneous

Section 1. These By-Laws may be amended by a two-thirds vote of the members present and voting at a regular business meeting held subsequent to a regular business meeting at which a resolution in writing providing for such amendment shall have been read and notice of the proposed amendment shall have been given to the members in writing or in the council publication at least five days prior to the second meeting.

Section 2. Procedure and debate shall be in accordance with the Laws and Rules of the Supreme Council, the Supreme Board of Directors, these By-Laws and the Rules of Parliamentary Law known as "Robert's Rules of Order."

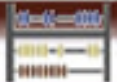

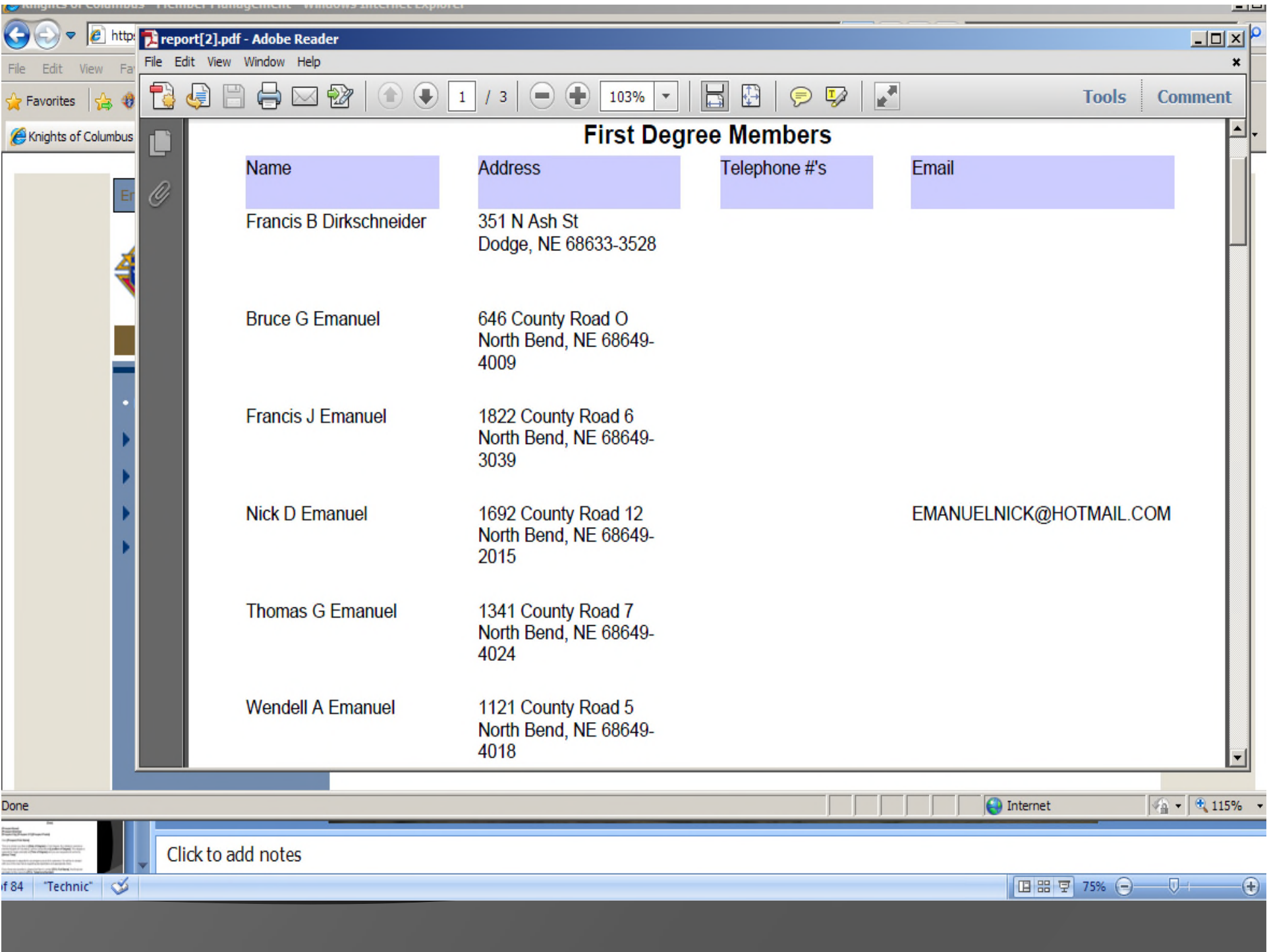
