Building a Bench

Brothers,

Thank you for electing me to the position of State Deputy. It is truly an honor to serve you. I know that being elected as your State Deputy will bring a new set of challenges and opportunities. I thank you for giving me this opportunity and I hope that I live up to your expectations. Following our current State Deputy Corey Coonen will be a challenge, as he set a high standard of service to the membership of this Jurisdiction. These past 2 years, in addition to

Working Full Time, Getting Engaged, and Getting Married, our State Deputy attended hundreds of meetings, made thousands of phone calls, and sent thousands of emails. He was relentless in his efforts to help our Councils Grow and Serve more people.

His tireless efforts led the State Council through the difficult Covid Pandemic. At a time when other service organizations saw membership drop by half, Knights of Columbus membership in Wisconsin dropped by less than 10%. At a time when parishes are struggling to make ends meet, our State Deputy implemented membership incentives that provided additional charity resources to councils. Worthy State Deputy Corey Coonen, thank you for all of your Leadership over these difficult 2 years.

As we look to the future, we have a lot of work to do.

Many of you know that I have been involved in a Leadership Role with the Boy Scouts for many years. A question that we ask in Leadership Training is: How do you eat an Elephant? One bite at a time. The key here is that you just need to make a plan, and then get started. Another area that we focus on is setting goals. Always set your Goals High. We would never have put a man on the moon if we believed those that said it was not possible. We got to the moon by setting a high goal and then pursuing it with passion.

If we aim low, meeting the goal is almost guaranteed, but we gain little. If we aim high, plan, and keep working towards a goal, we will accomplish more. It comes down to being willing to take a chance and aim high rather than choosing the easier lower goal.

Over the next 2 years, I will be challenging our State Team, Diocesan Teams, District Teams, and Council Teams to set high goals and work towards them. Some of you will challenge this saying we are asking too much. Others will take on the challenge, and be surprised by the results. I am asking that you take the challenges as they are presented, so that together we can grow the Knights of Columbus in the State of Wisconsin.

As Knights, our programs need to revolve around our Catholic Faith. That is what sets us apart from other Service Organizations. Every Program that we do must be based on putting our Faith in Action.

Our Parishes need help getting men and their families back to church. As Knights, we need to be leading in these efforts.

Our Bishops have asked for help with the Eucharistic Revival. As Knights, we will be there to lead and support these efforts, starting with the Eucharistic Processions on June 19, as well as Holy Hours throughout the year.

We also need to be leaders in our parish efforts to Evangelize and Go Make Disciples.

As Knights, we must always be forming ourselves in the Faith. To that end, over the next year we will work to grow our Faith Development programs across the State, and to include both Clergy and Lay Brother Knights on the Faith Committee.

We will also be looking to grow membership and participation in the Life Committee, adding resources to that committee to add focus on the areas of Adoption, Suicide Prevention, Service to those with Disabilities, and Mental Health Awareness.

We will be looking to evaluate and grow programs in the areas of Community and Family as well.

That brings us to our next challenge. As you look around at our current team of District Deputies, Diocesan, and State Coordinators, two things stand out. Many of them are very experienced, and most wear more than one hat. Many of these leaders are reaching that point in life where they need to step back due to health issues. As they do, it is no secret that our bench is thin.

Our lack of a bench starts at the Council Level. Councils need to take time to get to know their members, their interests, passions, and motivations, and then invite these brothers to utilize their talents in the areas where they will be most productive. In too many Councils, a handful of Knights are carrying the load, with the rest sitting on the sidelines. This leads to situations where brothers are reluctant to step up for fear of having to do everything. I am asking for your help in correcting this situation. I am asking that every Council take steps to invite more brothers to share the load, by inviting them to take on leadership roles, especially our younger members. To build a bench for the future, we need every Council to help by inviting more men to carry the load.

At the State Level, we will look to develop and deliver the leadership resources and training that these new leaders will need.

I plan to challenge our State and Diocesan teams to double the number of men serving in Leadership positions such as District Deputies, State Coordinators, District Wardens, and Diocesan Coordinators. We will leverage our GOTO committee to help identify men that can lead, and then inviting them to be part of our teams. By inviting others to lead, we can avoid burnout and build a bench for the future.

Imagine the new energy our Councils, Districts, and State will have, when every Council doubles the number of men involved in leadership positions. I know that this is a big ask. I am asking for your help in making this happen to secure our future.

Brothers, again I thank you for the giving me the opportunity to serve as your State Deputy. Working Together we will grow the Knights of Columbus in the State of Wisconsin.

Campaign for People With Intellectual Disabilities

One of the most popular and successful fundraisers conducted by state and local councils for the benefit of people with intellectual disabilities involves collecting donations outside stores and on street corners. In appreciation, the donor is offered a piece of candy, such as a Tootsie Roll. The high visibility of this program has led to the campaign being referred to as the "Tootsie Roll Drive."

The nickname is understandable, but misleading. The Knights of Columbus has no official tie to Tootsie Rolls or their manufacturer. In fact, many councils participate in the same fundraising drive, but distribute other items. References to this program should highlight the good the money does, not advertise a candy bar. For these reasons, this project must be promoted as the "Campaign for People With Intellectual Disabilities" rather than the "Tootsie Roll Drive."

Campaign for People With Intellectual Disabilities (Tootsie Roll Update)

Hopefully some of the good you are doing for others is your council is conducting the annual Tootsie Roll Drive to assist those with Intellectual Disabilities. I know many councils mentioned at the State Convention their drives were happening in May. That is awesome news!

Some councils are waiting until June or sometime later this year. Feel free to run the drive in your community when you feel you will get the best response. Multiple councils mentioned they go with the opening weekend of fishing. My own council goes with the same weekend as the State High School Rodeo Finals which are held in Richland Center each year. Does your community have an event which

increases the number of people at your collection locations? Does any other organization collect on that weekend in your community?

Whenever you hold your drive, please fill out the Council Disbursement Form which can be found on the Wisconsin Knights of Columbus website. All money returned to me before July 1 will be returned at the Fall Meetings. Any money received after July 1 until February 1 will be returned at the end of February.

There will be a change in the Intellectual Disabilities program in the next fraternal year as Bennie Green from 3492, Richland Center will take over as the director of the program. I will be mentoring Bennie over the next year to make sure the program gets back to the place of prominence it held before the pandemic. Council PKD and Culture of Life Contributions

It's that time of year again where PKD and CoL collection will come due. I'd like to review how a council can verify what they owe for each, and where to send payment.

As you know, PKD or Penny a Knight a Day supports Catholic Education across the dioceses of Wisconsin. Your contribution stays in your diocese, and a check is provided by the State Council each year to your bishop to be used in supporting your local Catholic schools.

PKD is calculated by multiplying \$3.65 (a penny each day of the year) based in the number of members un each council as of July 1st for each member of your council minus Inactive members and Exemption (formerly disabled) members. Last year this article incorrectly indicated to remove honorary life and exemption members; consider this a retraction. The amount due for your council can be found on the State Council Website. To get there, type WIKOFC.com into a web browser and it will forward you to UKnight for the St Council, or use link https://uknight.org/StateCouncilSite/index.asp?CN=US&ST=WI. Scroll down the main page to Penny-A-Knight-A-Day where you'll see the fearless Knight in armor. Click on "Read More" which will open a window, then click on the red button on labeled "Council P.K.D. Contributions As Of xx/xx/xxxxx" date. This will open a PDF of a spreadsheet where you can look up your council and see what you owe. As checks are deposited you will see the updates and verify your contribution has been received. This is the current hyperlink for those of you who like to bookmark these key pages https://uknight.org/StateCouncilSite/article.asp?ID=51

For Culture of Life (CoL), amounts due are calculated similar to PKD except the rate is \$3.50 per. To look up what your council owes, again go to the State Council webpage, but this time click on the gold button "State Forms" under the picture of the Brother Knight praying the Rosary. Scroll about half way down the page to Community, then sub title Culture of Life, then click on Culture of Life Council Fund Donations FY 2021-2022 (xx/xx/xxxx) date. {The link to this page can change so the best way to access this is to follow the above instructions} A PDF of a spreadsheet will open allowing you to look up your council's Donations and Amount above or below goal. The amount is a combination of donations from the CoL mailer that went out in November and your council's contributions. Both the PKD and CoL donations are listed on member dues each year but are not required to be paid by members or councils, yet highly encouraged. CoL contributions help fund grants to Pro Life agencies and services across the state.

Checks should be written to Wisconsin State Council Knights of Columbus or WI State Council Knights for short. Payments should be sent to the State Council office: Knights of Columbus, 4297 W Beltline Hwy, Madison WI 53711.

OR CODE



What is this? According to WIKIPEDIA, this is called a "QR code" (an initialism for quick response code) is a type of matrix barcode (or two-dimensional barcode) invented in 1994 by the Japanese automotive company Denso Wave. A barcode is a machine-readable optical label that can contain information about the item to which it is attached. In practice, QR codes often contain data for a locator, identifier, or tracker that points to a website or application. A QR

code uses four standardized encoding modes (numeric, alphanumeric, byte/binary, and kanji) to store data efficiently; extensions may also be used.

The Quick Response system became popular outside the automotive industry due to its fast readability and greater storage capacity compared to standard UPC barcodes. Applications include product tracking, item identification, time tracking, document management, and general marketing.

A QR code consists of black squares arranged in a square grid on a white background, which can be read by an imaging device such as a camera, and processed using Reed-Solomon error correction until the image can be appropriately interpreted. The required data is then extracted from patterns that are present in both horizontal and vertical components of the image.

This perticalar QR code directs users to kofc.org/join webpage where prospective new members can learn about the Knights and join as an "E-Member". Can you think of ways to utilize this code to invite new members into your council?

Grand Knights and Financial Secretaries, please check your Prospect lists in Officers Online at least once a week. If you have men showing there, CONTACT them. INVITE them to your Council meetings and activities. While you are together, invite them to attend an in-person or online DEGREE ceremony.

After completing the degree, PROCESS them into your council. It is as simple as entering the degree date (or council approval date for a prior member or transfer in) in the field and clicking the TRANSFER button. If the member does not wish to join your council, please REJECT him and select the appropriate reason. Please note the bold above. I have noticed recently a number of previous online members who have been transferred into a council who are taking a degree online and stating they have no degree, or are still an online member.

REMINDERS:

REQUIREMENTS:

- Every man who joins online needs to access kofc.org/joinus from a compatible device, <u>personally</u> complete the online application testifying to all the attestations, and submit the online application <u>himself</u>.
- When possible, the member should use his own compatible device.
- The member must use their own valid email address when completing the online application.
- There is a new (as of 02-22-22) process in joining online. Instead of having to enter a verification code (a source of error), after the member completes and submits the first page of the online join process, which include his email address, he is sent an email to verify the email address. That email will contain a clickable link (available for only 24-hours) to complete the join process. Should he fail to act within the 24-hour window, he will see an error message and must restart the join process.

NOT ALLOWABLE:

- Completing the online application for a member even if they have asked you to do it for them.
- Collecting information from a proposed member on a form 100 or prospect card and using the information to sign the member up for online membership.
- Creating an email account for a member so they can complete the online membership process.

PROCESS:

Follow the standard procedures for a new e-member as with all new members:

- Completed form 100 or assigned e-member status in Prospect tab of Officers Online (OO).
- Admission committee vetting
- Council action (voting) see Guidelines for Online Voting Motions if holding virtual meetings
- Degree Member must take the degree prior to being transferred into a council.
 - Process new 3rd degree member into your council via Form 100 submission or Online form 100 (Candidate tab) entry and transfer, or e-member transfer (Prospect tab).
 - <u>REMEMBER:</u> If you use either the Prospect tab or the Candidate tab to process your new members, do NOT submit a mailed paper or scanned pdf of the form 100. It just confuses the issue. Use only one of the available methods.
- Update degree status by entering degree dates for 2nd & 3rd degrees in Member Management.

Brothers,

I write this having just returned from the State Convention at Chula Vista Resort in Wisconsin Dells, energized and ready to close out the 2021-22 Fraternal Year in grand fashion. As we progress through May and June, let me remind you of a few points to help conclude the year successfully.

First of all, try to meet or exceed your membership goals these last 2 months if you haven't already done so – have every Council bring in at least 1 new member – every Council active! Next, be sure you've participated in and promoted at least 2 Fraternal Benefits

Nights. Check the Supreme and State websites or with your Field or General Agent for details. Next, check to see that your forms are all in – 185, 365, 1728 – very important! Reminder that your 185 will not be accepted if no Grand knight is listed and your 365 must include Membership, Program, Community and Family Directors as well as a Retention Chair. You also need to get your Child Safety Training Requirements completed. All of these are needed to qualify for Star Council, which should be the goal of every Council!

When these are all taken care of, as well as being in good standing with Supreme, then you need to get your Columbian Award form (SP7) in well before the June 30 deadline. Prior to that, you should have been submitting Form 10784s to Supreme and the State Forms address for each of the programs (Faith in Action and other major programs) you completed during the Fraternal Year. This helps them to track Council progress through the year and evaluate whether programs listed on the SP7 qualify for the award and whether they may count for 1 or 2 credits if they are a "Featured Program" (e.g., RSVP, Coats for Kids, Food for Families, Pregnancy Center Support, etc.). NOTE: to qualify for the Columbian Award, your SP7, must have 16 credits, not just 10 as was the case the last 2 years! Be sure that you have 4 qualifying Supreme, State or local programs in each of the 4 areas and that if you want a "Featured Program" to count for 2 credits that you have met minimum requirements for that. Best to turn in your SP7 early so that it can be evaluated and amended as needed. Check with me if you have questions.

Another major area to close out the Fraternal Year is to complete and submit your Wisconsin Outstanding Council Award form checklist. Download a copy from the State website, fill it out with your officers and directors and submit it to the State Forms address no later than July 15.

Other forms due by June 30 include:

- A) 2022-23 Form 185 to Supreme and State Forms address
- B) Form 2630 Roundtable Annual Report to Supreme and State Forms address
- C) Form 1748s for RSVP, Food for Families to Supreme and State Forms address

- D) All Councils should have their 2021-22 PKD and State Culture of Life Fund donations collected and into State Office by June 30. If you have questions as to how much you need to meet your 100% of Council quota, check with State Office or the State website.
- E) ID Drive collections and reports should be into State Office by June 30 to receive their refund checks by fall.
- F) History Books submitted only to qualify for the Outstanding Council Award should be into me by June 30.

As to general program reminders, I would note that continuing to do fundraisers for Ukraine Refugee Assistance is especially in order here in May and June, as are the Eucharistic Processions for Father's Day to start off the USCCB Eucharistic Revival. See the Supreme website for more information. Continue with your St. Joseph Icon prayer services if it is scheduled for your District. Finish up with your spring Soccer Challenge and get your reports into Supreme and your Diocesan Program Coordinator when completed.

I'd also like to congratulate all those who received awards at the Convention for their hard work during the year (e.g., Membership Awards, Medallion Awards, History Book and Program Awards, DD Awards, etc.). I would especially like to congratulate the State Family of the Year – the Doug and Amy Miller Family from Council 1709 in South Milwaukee. Also, kudos to Kenosha Council 973 and GK Dr. David Kreutz who won the State Service Program Awards in the Faith, Family and Culture of Life categories as well as the Division III State Deputy Trophy! Congratulations also to All Saints Council 4240 in Menomonee Falls (GK Donald McInnes) for winning the Community category for the Service Program Awards as well as U.W. Madison Catholic Center Council 6568 (GK Jose Montoya) for winning the Leave No Neighbor Behind Award. Congratulations also to Holy Spirit Council 4648 in Brookfield (GK Doug Wildes) and Quad County Council 9546 in Birchwood (GK John Kinnick) for earning the Division II and I State Deputy Trophies respectively. 

Culture of Life Update

Dear Brother Knights,

Ever since May 2, 2022, when the leaked United States Supreme Court draft opinion on Dobbs v. Jackson Women's Health Clinic surfaced, the pro-abortion contingent has been dog-whistling for their thugs to come out to harass and intimidate pro-lifers all across our nation. I'm not talking about an actual dog whistle, but a subtly aimed political message intended to embolden the most extreme pro-abortion idealogues.

It is a Federal Felony to harass or intimidate a justice of the court on any case, yet abortion backers have been standing outside the private residences of Justice Brett Kavanaugh and Chief Justice John Roberts and forcing Justice Samuel Alito and his family to be relocated to an undisclosed location!
