Per Capita Resolution Update from State Advocate Paul Lang

As of the date of this message, we have received just over 28% of all council votes. In the message, I requested that one vote per council, either from the GK or the FS, would be counted. Brothers, we have a short time frame to get your votes submitted. Sept 10th is the deadline for final returns to be submitted. I am confident that I will see more returns from our brothers state-wide. This is an opportunity for your input to assist us in making a

decision that will impact all state councils.

- I need ONLY ONE VOTE PER COUNCIL, GKs and FSs of each council; please communicate among yourselves as to who will respond to me with the vote per each council

Official Notice – Diocesan Meetings

Due to the uncertainty surrounding the Covid 19 Virus and social distancing requirements, we **will not** be having Diocesan Meetings this September. This has a number of implications:

- Diocesan Program Coordinators will need to communicate electronically (e-mail and virtual meetings) with the Councils in their Diocese to share Diocesan Program Plans.
- The Supreme Council will offer a number of Virtual Trainings for Grand Knights, Financial Secretaries, Membership Directors, and Program Directors. Councils should take advantage of these trainings when they are offered.
- The Wisconsin State Council will offer additional training opportunities to supplement the training offered by the Supreme Council.
- Handouts that would normally be distributed at the Diocesan Meetings will instead be posted to the State Website.

The Council Charity Grant checks from the Charity Raffle will be mailed to Councils via First Class mail.

District Deputies will attend a Diocesan Huddle with the State Officers and other District Deputies from their Diocese in September. Awards, Raffle Tickets, and Lifesavers will be distributed to District Deputies at the Diocesan Huddles. District Deputies will then deliver these materials to the Councils in their respective districts. Councils should work with their District Deputies to arrange for Award Presentations and delivery of Charity Raffle Tickets and Lifesavers.

Protecting our Brand



Brother Knights of Columbus,

I would like to take this opportunity to highlight some of the protocol established by Supreme Knights of Columbus for using our branding, as it has been brought to my attention on numerous occasions where we promote other entities outside of our organization to advance their financial services, which is a direct violation of our Supreme Rules . The name and emblems of the Knights of Columbus are among its most valuable assets. For this reason, the Order has registered them as trademarks in the various countries where it is active. In addition, the Order has numerous other marks, many of which have also been registered. The registered and unregistered trademarks and service marks

(collectively the "Marks") are intellectual properties that belongs to the Knights of Columbus. Proper use of the Order's Marks, including its name and emblems, is a critical element of protecting the Knights of Columbus brand ("brand" is a broad term that encompasses an organization's name, emblems, trademarks, service marks, and reputation). Protecting the Knights of Columbus brand is one of the most important responsibilities of any Knights of Columbus officer.

The Order's Marks do not belong to subordinate councils or other branches and divisions of Knights of Columbus (collectively "Subordinate Units"). Subordinate Units may use the Marks only with the express written permission of the Board of Directors. Home corporations, which are independent legal entities, may not use the Order's Marks under any circumstances. Similarly, individual members of Knights of Columbus may not use the Order's Marks, except in connection with approved activities of a Subordinate Unit or the Supreme Council, as set forth below.

Section 162.11 of the Laws of the Order provides the basis for comprehensive management of the Order's brand, including its Marks, by the Board of Directors. As set forth in Section 162.11, any member using the name of the Order or his membership in Knights of Columbus in connection with any business or social or other enterprise, without permission of the Board of Directors, is subject to discipline, including fine, suspension, and expulsion from the Order. As a general policy, the Board of Directors does not permit and will not authorize any member or any subordinate council or assembly to enter into any contract, agreement, or informal arrangement, or to use one's membership in the Order, in connection with the promotion of any goods and services other than the financial products and services offered by the Knights of Columbus. Section 162.11 of the Laws of the Order prohibits members from "using the name of Knights of Columbus or [their] membership in the Order in connection with any business, or social, or other enterprise, without permission from the Board of Directors." In addition, the Board of Directors has explicitly prohibited the use of all Knights of Columbus publications, websites, mailings, membership lists, and other facilities for the purpose of promoting, endorsing, selling, or advertising any product, service, or enterprise other than the Order's insurance program.

The purpose of this policy is to preclude the use of, among other things, the Order's name, emblems, events, meetings, membership lists, and facilities to promote goods and services other than the financial products and services offered by the Knights of Columbus. The Board wishes to minimize the risk that anyone would draw the mistaken conclusion that the Knights of Columbus (a) has endorsed the good or service being offered or (b) has guaranteed the integrity of that good or service. Obviously, the Board cannot make any such endorsement or guarantee about any good or service other than those offered by

the Knights of Columbus. The Board also wishes to avoid any business association that might expose the Order to liability if a good or service does not meet a customer's expectations.

Prohibition on Promotion of Financial Products and Services

The mission of the Knights of Columbus is two-fold: to confirm men in their Catholic faith and to ensure the financial security of members and their families. It is for this reason that the Order has both a fraternal program and an insurance program. Through its councils, the Order offers members the opportunity to engage with fellow Catholic men and deepen their faith. Through its financial products and services, the Order offers members the opportunity to provide financial security to their loved ones. These two components are integral to the founding vision of Venerable Fr. Michael J. McGivney. It is for this reason that the Laws of the Order strictly prohibit members from using their membership or the name and emblem of the Order to promote financial products and services offered by companies other than the Knights of Columbus. The relevant sections of the Laws are Section 162.11 and Section 162.24.

Pursuant to Section 157.1, the above prohibitions apply not only to individual members but also to councils and assemblies. Councils and assemblies, therefore, must also refrain from promoting financial products and services offered by companies other than the Knights of Columbus. This means that councils and assemblies should not accept sponsorships or advertisements from entities that promote competing financial products and services, including any form of insurance. Councils and assemblies must also refrain from inviting insurance agents and financial advisors representing other firms to promote their products and services at council meetings.

Failure to follow the aforementioned requirements undermines the mission and work of the Knights of Columbus. It is a serious violation and is punishable by fine, suspension, or expulsion from the Order.

Silver Rose

Each year, from early March through mid-December, Silver Roses are stewarded by Knights of Columbus councils along routes from Canada to Mexico. Every stop the Silver Rose makes throughout the pilgrimage is a rosary-centered occasion for Knights, parishioners and community members to pray for respect for life, for the spiritual renewal of each nation, and for the advancement of the message of Our Lady of Guadalupe. The Silver Rose program demonstrates the unity between Knights of Columbus in Canada, the United States and

Mexico, through a series of prayer services promoting the dignity of all human life and honoring Our Lady.

The Silver Rose was in Wisconsin from July 11 – August 15, 2020. During this time, the Rose traveled 1282 miles. Thank you to Silver Rose Chair Dennis Bednarek for putting together a schedule on very short notice, the 30 Councils that hosted services, and the 706 faithful that attended these services.

Membership

Lately, I've been bumping into some confused Knights, working on **Membership Growth** in Wisconsin. They seem to think they are "volunteers" for the Order; the more accurate description is that we are ALL *"servants"* of our **Lord**, **Jesus Christ**, as well as the mighty right arm of our priests, ready to "serve" them as best we can. When I think of myself as a "servant," my mind is right, and my actions are in sync with the "calling" I feel to "invite" men to become Knights of Columbus. I volunteer at the pancake breakfast, but I *SERVE* my pastor, my state officers, and my fellow Knights.



COVID has been quite a hurdle for us but I remember hurdling in high school track and here is what I know... **you can jump over them, run around them, or run through them.** We can and MUST do that with these COVID restrictions as well.

If a traditional or DELTA Membership Drive is not in the cards right now, you can contact people you know that want to **grow** the Knights of Columbus. There are people who *know men who have a servant's heart,* men destined to be more than they are right now and are looking for the means to accomplish great things.

We need to start by talking to our Pastor and the Parish Secretary/Administrator to find men who are already in the parish, who are already doing things to help others, and who are not a Knight yet. Furthermore, our own members know other men who deserve to be a Knight of Columbus. We can contact them by email or phone or by ZOOM to get those names.

Father is in a tough place right now... a declining attendance at masses has been made worse by COVID restrictions. Fewer parishioners are willing and/or able to help the parish, but the list of needs keeps growing. We need to help Father understand that a growing and vibrant KC Council means a stronger parish with more men participating in their family's spiritual health and growth! "Father, we want to help you – can you please help us do so?"

With Father's permission, get a list of men (RCIA people, new parishioners, members of other service groups, HS seniors, etc.) from the parish roll; *with Father's help*, draft a "Father needs you!" letter to encourage men to become a Knight. That same letter can be modified and sent to men referred by your own members, naming the referring member in the letter. All of these letters need follow-up calls and emails, and your Field Agent is a terrific resource to make that campaign a roaring success!

They can grow in their faith and become better men, better husbands and fathers, and better Catholics. We can find those quality prospects in ways we have done (Membership Drives) and in ways that are new (Seek Father's help), but we need to find those men, invite them to become Brother Knights. Online Membership Tools

Online membership is just one more tool you may use to process new members into your council and grow membership in your council and the Order. Note: To properly access the Prospect tab of Officers Online (OO), please disable any pop-up blockers and restart your browser before logging in. Here is a summary description of the Online Member process. Links are provided in lieu of repeating the available information.

Please see the document entitled <u>Online Membership - Use of Landing Page</u> at the top of the State Forms page of the state website:

The first 11 pages deal with the Prospect Landing page (an electronic form 921A Prospect Card) of the Delta Church Drive process.

Pages 12 through 18 deal with online membership and actions by the prospective member.

Pages 19 through 20 refer to actions by the SD, MD, or OMC.

Pages 21 through 25 refer to actions by the council, GK or FS.

FAQs About the New K of C Exemplification gives insight to the online degrees.

Instructions for Online Exemplification came out in April and describes the process and procedures.

You may wish to watch this webinar <u>Training for Online Exemplification</u> from April 8 where the online degree was introduced.

Follow the standard procedures for a new member – Completed form 100 or e-member status, admission committee vetting, council action (voting) <u>Guidelines for Online Voting - Motions</u>, degree, and form 100 submission, or online candidate form transfer, or e-member transfer. See this video for training on use of the <u>Candidate Tab</u>.

For online degrees, Supreme has suspended scheduling online degrees, but does include the <u>On</u> <u>Demand</u> link, to take an online degree at the candidate's convenience. The State officers are also providing regularly scheduled online degrees. See the <u>Degree schedule</u> page of the State website where you will find links for him to register for the state ceremonies. He may do this at any time by using the <u>On Demand</u> link to the supreme ceremony and filling the registration form, and watching the ceremony in its entirety. It is encouraged that his family watch it with him (25-30 minutes). Here is the schedule and registration links for the upcoming state degree ceremonies.

Provide the appropriate link to the prospective member, as the member must do the registration process himself. Be sure to provide him with your council number to enter on the registration form.

Once the new member has successfully completed an online degree, he may be able to print a certificate and provide that to you, but Supreme or the state Ceremonials director should notify you of any members who have completed the degree. That notification may take a day or two for processing, but will include the date of the degree. The FS then processes the member into the council – again, form 100, candidate tab of OO, or in the case of an e-member, transfers him in via the Prospect tab of OO. The latter two methods by entering the degree date on the appropriate tab of OO and clicking 'Transfer'. Once added to the council roster, the FS enters the 2nd & 3rd degree dates in Member Management (MM) of OO, and any other pertinent information on the MM pages. The FS also issues a membership card in the council and invites the member to the next meeting.

Supreme will credit the council a pro-rated portion of the dues paid by an e-member similar to any other transfer (142). For other member types, the FS collects the appropriate dues from the member. The 1842 survey is passed on to the GK and Program Director in order to get the new member active in the council where his interests lie. Encourage the new member to work toward the Shining Armor award.

Please utilize the tools made available to you. They are there to assist you and make your tasks easier.

Programs



Brothers,

With September, we are 3 months (1/4) of the way into our 2020-21 Fraternal Year. By month's end, will you be 25% of the way to reaching your program and membership goals for this year? You should be! If so – great; if not, it's time to get moving. Many Councils have let 6 months slide by due to COVID inertia. As I said last month, we need to lead – to be as active as possible in the parish and community. Most of our programs can be done either live or virtually. Meetings can be done live if possible, virtually or both. If you can't meet at church, find another spot where you can social distance as needed along with virtual connections. Continue to implement the programs suggestions I made last month.

Supreme has advised that some programs can be done outside in parking lots, parks, yards, etc. PPK, Soccer, Free Throw can be done at any time – not just in the usual time frame. Parents or schools can video the shots/attempts being taken and send in/verify the results. Essays and posters can be done at home as well as in school or CCD. Coats for Kids can be given to the recipient organizations or schools to hand out. ID Drive and LifeSavers can be done throughout the year, with the recipient organizations helping to staff tables at businesses or street corners.

Remember that the Into the Breach video series and men's study groups revolving around them should be the basis for all your programming this year. Nearly all our Faith in Action and Leave No Neighbor Behind programs involve Knights stepping into the breach to provide the answer to faith, family, charitable, etc. challenges we face! You can download from the Supreme website or order all the information and supplies you need for your fall programming. Check it and use it often as well as the State website.

More information will soon be coming out regarding PPK, the Culture of Life Essay Contest topic and the results of the statewide survey on Free Throw and Knowledge Contests. The Catholic Citizenship Essay Contest theme is on the Supreme website: "Discuss How Trusting in God During a Difficult Time Has Helped You or Someone You Know Find the Strength and Hope to Endure It." Due to the COVID issues we have extended the deadlines this year so that Culture of Life essays are now due to Councils from the schools or students by **December 1**, rather than November 1 as before. Catholic Citizenship essays are now due to me by **January 10**, rather than November 30 as before.

The True Meaning and Keep Christ in Christmas Poster Contests will run as usual, with January 1 and January 15 due dates respectively.

Order your materials from Supreme for your October Church Drives and other membership activities. Work with your Field Agents and General Agents to start setting up those Benefits Nights at your parishes. Be sure to get your 185, 365 and Audit in if not already done and remember to file your Form 10784 with Supreme and the State Forms address for all programs when completed except those with their own special form like RSVP or Food for Families.

Finally, plan to promote the October 31 Beatification of Fr. McGivney as widely as possible. Plan a major Council or parish event. Congratulations to all Councils who earned Star and/or Wisconsin Outstanding Council honors. Those, along with other State and Supreme awards should be coming to you this month or early October. Online Fraternal Programs Report Form 10784

Supreme is moving from the PDF version of the 10784 to an online version. The plan is for the online version to be used for all programs but that may not happen entirely this fraternal year. It is supposed to handle six of the family programs today.
