

Celebrators of Christmas Need Advent I am always amazed at what people want, but don't do what is necessary to get it. I want a job, but won't get

to work on time. I want more pay, but I won't get the education or skills to advance.

Christmas is a gift package of great joy. For the family, Christmas celebrates family bonds—even to the point of reconciliation. Christmas offers real joy—reaffirming the reality of a divine savior. Christmas offers peace—a peace this world could give and a peace the world cannot give.

Celebrating Christmas is not like walking into a fully stocked department store, where managers have chosen from the world's goods thousands of items which we can easily buy with little effort on our part. To celebrate Christmas in mind and heart, we have to give some time to mind and heart issues.

Advent is the season for looking at mind and heart issues for Christmas.

For instance, we could better equip the mind by learning more about the infancy narratives of Matthew and Luke right at the beginning of the Gospels. We could learn more about the Christmas feasts of St. Stephen, the first martyr of the Church on the 26th; the feast of St. John, Apostle and Evangelist on the 27th; the Holy Innocents on the 28th; the Holy Family on the Sunday after Christmas; Mary Mother of God on January 1st, a day of obligatory observance because of the feast, not because it's New Years; Epiphany January 6th, the celebration of which we have the Sunday after this date. The Church traditions of Christmas are rich with learning and meaning.

We could better equip the heart by receiving the Sacrament of Reconciliation (Confession) during the Advent season, bringing God's forgiveness to our broken lives. We could consider carefully our family ties, and devise ways to strengthen them, or restore them if necessary. We could move from "obligatory" parties, to meaningful visits with those whom we truly care for. We could wait through Advent and then celebrate a season that begins with Christmas and ends with Epiphany.

However you choose to celebrate Advent and Christmas, as ever I wish you Peace Always. Fr. Dennis Mullen

Yes my brother Knights we are in the positive. As of the end of October we have brought in more members than what we have suspended so far this year. Thank you to all recruiters that made this possible. We have brought in 266 new members this year so far. We have suspended 220 members. So if we were only concerned about those two numbers we would be doing well. However there is another number that is taking away our growth in membership. The amount of

deaths of our order is also a number that takes away members of our order. We have lost 222 members to death so far this year. Death of a member is nothing we can control. However we can control the amount of members in our councils to keep active members coming in and making an impact into our local communities. With all of us using ONE MEMBER, PER COUNCIL, PER MONTH as our guide, we can overcome these loses and grow the order and grow the activities that are needed in our local areas. (continued page 3)

(State Deputy - continued) Another resource for your council is the Knights of Columbus General Agents. Ken Sosnowski, Joseph Molosky, Edmund Knolmayer, Daniel Baxter and their teams of Field Agents are trained in recruitment. Both the State/Diocesan Membership Team and General and Field Agents want your council to be successful, not only in recruiting but also in the programing your council runs in your parish, community, schools and with the youth. These programs may be successful today, but what about tomorrow? If we do not grow our membership these programs may not have the manpower to help all those who are in need.

I would like to thank the councils that have recruited new members for the "Fall Harvest Membership Incentive". The Wisconsin jurisdiction did not do as well as I would have like to but we had our strongest recruitment month for this fraternal year so far. Our monthly goal is for 119 new members each month and we recruited 103 new members or 87% of our goal. Congratulations to the Superior Diocese who achieved 117% of goal – 14 new members and the Green Bay Diocese was 100% of goal – 25 new members. The dioceses of La Crosse, Madison, and Milwaukee each had their best recruiting month this fraternal year. Madison 98% of goal 22 new members, La Crosse 79% of goal – 17 new members and Milwaukee 66% of goal – 25 new members. Remember "One Member – Per Council – Per Month"

On December 7<sup>th</sup> and 8<sup>th</sup> we will be holding the Mid-Year District Deputy Meeting. Grand Knights, Financial Secretaries and members; when you see your District Deputy this month please bring any questions or concerns to his attention so he can communicate them at this meeting. The District Deputy will be contacting councils who have not turned in their 185-365 forms and their council audits. These forms will be collected by the State Officers. As a reminder get your Sentiments for Seminarians to your District Deputy. He will bring them to the DD Meeting December 7<sup>th</sup> and 8<sup>th</sup>. We will get the items collected to the Diocesan Vocation Director in time for Christmas distribution.

(Membership continued) The next few months you can earn extra VIP points from now until January 31 with the Supreme "Catch Up" program. Recruit for double points to "catch up to your council's ONE MEMBER, PER COUNCIL, PER MONTH. Remember it is easier to recruit to a scheduled first degree date than to just having a degree when you have a candidate.

#### BLITZ in REVIEW

According to the fraternal activity planner we were suppose to have an order-wide recruitment drive in October. All District Deputies and Membership Coordinators were asked to get results from this drive. After this was done, I needed to compile this information and send it to the State Deputy by October 31. Then the State deputy had to send this data to the Supreme Program and Membership Consultant by November 1. This report is needed to see a few things. First it is to see how many members each council has gotten in. The other items on the form are Transfers, candidate prospects, member prospects, and when your next first degree is. This information makes it aware on how much help the State, Diocese, District, and Council need in Membership support and information on how vital it is to keep recruiting.

We did not do a very good job in reporting this on time. We have only had about 20% reporting this on time. This is something we need to improve on. We have another order-wide blitz coming up in March. Please keep this in mind and make a special effort to hold a recruitment drive on or before March. The District Deputies will be going through the form and what is needed for the order-wide blitz in March.



#### "CATCH UP! --- ONE MEMBER PER COUNCIL PER MONTH"

In the months of November, December and January you have the opportunity to "CATCH UP" with our Order-wide goal of "ONE MEMBER PER COUNCIL PER MONTH."

In keeping with this goal, by Jan. 31, 2014, your council should have recruited seven new members. If your council recruits at least seven new members (including reactivations, reapplications, readmissions and reinstatements) by Jan. 31<sup>st</sup>, your council will receive 2,000 points for each member recruited in November, December and January. Furthermore, for each additional member recruited above the seven, your council will receive 4,000 points.

For example, if a council has already recruited two members prior to Nov. 1, 2013 and they end with nine members by Jan. 31, 2014, they will receive 2,000 points X 5 (5 members to get to 7) plus 4,000 points X 2 (2 members above the 7): 10,000 points + 8,000 points, for a total of 18,000 points.



We encourage you to take advantage of this opportunity to grow your council and at the same time reward your most active recruiters by sharing the VIP points among them. Points can also be redeemed for something your whole council will appreciate; such as BBQ aprons, new flags, officer jewels, or KofC road sign. - Good families are those that are continuing to do the work of Jesus Christ.
- Nominations should be assembled into binders, up to a 2 or 3 inch size binder.
- Include photos of family members participating in activities.
- The selection committee uses only the information provided to make FOY selections.
- Include letters of recommendation from their Pastor and other Community leaders.
- Involve the family in gathering nomination information, they are the best source.
- Glean scrapbooks for information on selected families.
- Please don't expect the family to fill out and prepare their own nomination.
- Last year one diocese did not participate in the Family of the Year program.
- Last year many nominations consisted of only 2 sheets of paper.
- Take some time in your council meetings to talk about the Family Programs.
- Ask your Family Committee how they are doing on their nominations for Family of the Month and Family of the year.
- Honoring families and publicizing who they are and what they do will encourage other families to become Knights of Columbus families.

# A Special Message from the Supreme Council General Agents:

#### The pitfalls of replacing coverage

We all know the old adage, "the grass seems greener on the other side of the fence." When it comes to replacing your existing Knights of Columbus life insurance with coverage offered by another company, the adage holds true. Perceptions are deceiving. A move to *the other side of the fence* might seem like a good one, but it can leave you with less *green* in your wallet — in some cases, a lot less. That's why it pays to remember another old saying, "Read the fine print."

There are many reasons to keep your existing coverage in force, whether that coverage is with the Knights of Columbus or with another company. We'll focus on the potential pitfalls of replacing coverage here — pitfalls that an agent trying to convince you that the grass actually is greener might neglect to mention.

First, all life insurance contracts contain a *contestability period*, which allows the insurer to contest claims made for a period — typically two years — after the contract is issued. Chances are this is no longer an issue with your current coverage.

Second, it's unlikely that you can obtain the same amount of coverage, for the same premium, that you were able to obtain with your existing contract. The two factors that determine how much you'll need to pay for life insurance coverage are age and health. Certainly, you're older now than you were when you took out your current coverage. There's no way around that one. And you have to ask yourself, has your health changed during that time? Is your blood pressure the same? Your cholesterol? Have you gained weight? All these factors can affect the amount of coverage you'll get for your premium dollar.

If someone encourages you to replace — or worse, drop — your existing coverage, please call us. We'll show you how your existing coverage is working for you and why replacement is rarely in your best interest.

#### Council Liability Insurance

Following up on last month's article, for the protection of your council and your Brother Knights, I remind you that it is necessary that each council carry liability insurance. The amount to carry will vary and should be discussed with your insurance agent. At a minimum you will need to carry enough to satisfy the requirements set forth by each Diocese for any and all users of Church property.



There are several ways to procure the needed coverage. Here are three options that your council might look into for acquiring the needed liability coverage.

First, a former DD from the LaCrosse Diocese has written:

Brother Knights,

I thought you might be interested in something I initiated in an effort to help cut expenses for our councils in District 26. This is especially helpful for smaller councils where a \$300.00 insurance bill can cut pretty deeply into the general account.

I called a couple of the local insurance agents and pitched the idea of one liability policy for all the councils in our district. I got a positive response from **Rural Insurance** and ended up talking to the underwriter over the phone. All I had to do was collect some information for her. She needed to know the number of members in each council and what activities were undertaken by each council in a calendar year. We now have a liability policy that costs each of our four councils \$115.00 per year as opposed to the 300 plus that they were paying.

Local councils are asked to sponsor prayer services in parish churches and other locations before sending the image to a neighboring councils. Contact your District Deputy to schedule your Marian Prayer Program.

- Each image will come in a specially designed carrying case, which will allow the image to be safely transported throughout the jurisdiction
- Inside the case will be a log book for that image. Each time a council conducts a prayer service, the number of attendees should be noted in the log book.
- Throughout the program, the State Warden will periodically ask for updates on the number of services and the number of attendees...these completed log books will be the only means to access that information.
- A supply of Immaculate Conception Prayer Books and Immaculate Conception Prayer Cards for each image will be provided. These will come in a sturdy plastic briefcase, again to allow safe transportation throughout the jurisdiction. Supreme has also post electronic versions of these books and cards to the Order's web site at <a href="https://www.kofc.org">www.kofc.org</a>. These supplies will not last the duration of the program, you'll be able to order additional quantities at any time through our State Warden... please allow about two weeks for delivery.

# Wisconsin Knights of Columbus Charities, Inc.

The restrictive and unrestrictive financial activity in this fund is low this year for its seven years existence. Restrictive council donation funds for the purpose of funding Wisconsin Special Olympians are still accumulated and distributed through this entity. However, deposit and distribution of other corporate or individual acquired funds through this entity are nearly non-existent.

The entity holds non-restricted funds, which are available for direct or matching-grant applications for qualified purposes. At June 30, 2013, the unrestricted balance held amounted to \$21,221. Since then, one direct grant application was approved amounting to \$1,000. Currently, the only source of funds adding to the non-restricted balance are net proceeds from Supreme held Christopher Funds and bank account interest income. For the 2012-13 fiscal year, net proceeds increasing the non-restrictive fund balance was \$2,558. A similar amount of net proceeds will be added to the current non-restrictive fund balance from 2013-14 operations, if no other grant is approved for distribution.

The entity's board of directors administer non-restrictive funds. Councils or members may apply for a grant not to exceed \$2,500 for a qualifying purpose under the categories of religious, education, scientific or charitable, as defined by the Internal Revenue Service. In applying for a non-restrictive fund grant, complete the 'Direct Grant Request Form', provided in the <u>Wisconsin Book</u> and file it with myself or the State Office.

Recently, the Supreme Treasurer, Logan T. Ludwig issued Charitable Giving Accountability Standards. One of them indicates that Knights of Columbus affiliated entities, should distribute at least seventy-five percent of funds dedicated for their purposes. This entity's board of directors are available to consider qualifying grant requests in meeting those needs.
