

# State Deputy's Message



Our Bishops are asking all Catholics to Vote NO of Question 6 in the upcoming General Election. Question 6 or "The Nevada Reproductive Rights Amendment" on the November Ballot aims to overturn current Nevada Law to make unrestricted abortion a constitutional right. As Catholics, we must vote NO!

What does this mean for Nevada?

-- No Limit: An abortion may be performed up to the moment of birth.

-- <u>No Physician Required</u>: Non-physicians can perform abortions in unsafe and unregulated facilities.

-- <u>No Parental Consent</u>: Underage women can have an abortion without parental knowledge or consent.

As Catholics, we cherish God's gift of life from the instance of conception to the moment of natural death. We cannot allow outsiders to exploit Nevada by making it an abortion hub for the nation.

Vote NO on "Nevada Reproductive Rights Amendment." A NO Vote will not change the current Law in Nevada. The amendment allows any practitioner/health care provider to perform abortions.

What Is a Healthcare Provider? By Elizabeth Davis, RN Updated on August 16, 2024 -- Fact checked by Marley Hall

A healthcare provider is a person or entity that provides medical care or treatment. Healthcare providers include doctors, nurse practitioners, midwives, radiologists, labs, hospitals, urgent care clinics, medical supply companies, and other professionals, facilities, and businesses that provide such services.

The term "healthcare provider" is sometimes incorrectly used to refer to a health plan or health insurance company. However, an insurer or health plan administrator does not deliver care. Instead, that entity pays the person or other entity that provides the care (assuming the service is covered by the plan and you've met your responsibilities in terms of referrals, prior authorization, and costsharing).

This article explains what you need to know about healthcare providers and how their services interact with your health insurance plan

Who Are Healthcare Providers?

The healthcare provider you're probably the most familiar with is your primary care physician (PCP), who gives you primary care services like screenings, vaccinations, and routine exams. There are also specialists that you see when you need certain specific medical care.

There are different types of healthcare providers. Any type of healthcare service that you might need is provided by one of them. Not all healthcare providers are physicians or doctors. Here are examples of non-physician healthcare providers:

- The physical therapist that helps you to recover from your knee injury
- The home healthcare company that provides your visiting nurse (the nurse is also a healthcare provider)

- The durable medical equipment company that provides your home oxygen or wheelchair
- Your pharmacy
- The laboratory that draws and processes your blood tests
- The imaging facility that does your mammograms, X-rays, and magnetic resonance imaging (MRI) scans
- The speech pathologist (speech therapist) who works with you to make sure you can swallow food safely after a stroke
- The outpatient surgery clinic where you had your colonoscopy done.
- The specialty laboratory that does your DNA test
- The urgent care center or walk-in clinic in your neighborhood shopping center
- The hospital where you receive inpatient (or in some cases, outpatient) care
- The air or ground ambulance company that transports you to the hospital in an emergency.
- The emergency department staff who stabilize you in the event of an accident or serious illness

Would you let your physical therapist remove your appendix, tonsils or operate on another part of your body? With this amendment he/she can perform abortions on your child without your consent, but your children cannot receive vaccines without parental consent. Which is more dangerous to your child's health and life?

As Catholics we have a moral obligation to VOTE NO on Question 6.

# Message from the State Chaplain

Dear Brother Knights,

I have just returned from New Haven, CT at the State Evangelization and Faith Formation (EFF) Training along with Tom Melton, our State EFF Chair. We discussed the COR Initiative that Supreme has asked every council to undertake.

So, what us the goal and purpose of COR? COR exists to form and strengthen Catholic men in faith and virtue, in their relationship with Jesus Christ and with each other as missionary disciples through prayer, formation, and fraternity. The goal of each meeting is to provide men to encounter Christ (to be evangelized), to strengthen our bonds of brotherhood, and prepare for the courageous mission of evangelization.

COR is Latin for heart and has been inspired from St. John Henry Newman's motto: "Cor ad cor loquitur" or "Heart speaks unto heart."

As missionary disciples and practical Catholics, as brother Knights we are called to put our Catholic faith into action. As an Order we do a lot of charitable works, but these works in themselves will not get us to heaven. What gets us to heaven is having a personal relationship with Jesus Christ and sharing that relationship with others. Then maybe have a basket where you ask those attending to write some intentions that they would like prayed for, and then at the end of the event, pray over the basket of intentions and offer your own and you are doing COR.

During the next few months, Tom Melton and I will offer suggestions of activities you can do as a council and parish. Also at the mid-year meeting in Reno, we will be talking about COR in greater detail. Until that time, what I am asking each council to do is to appoint a Council EFF Director. This is different that the Faith Director you currently have in your council. Let your District Deputy know who that person is so that Tom and I, and Supreme can send them information to help them in their position. Each Council EFF

# Message from the Seminarian RSVP Coordinator

Worthy Leaders,

As the Seminarians have gone back to school, I want to provide you with the updated RSVP tracking worksheet that I put together for this year. Once again I am asking for your help. We are very fortunate now to have six Seminarians in the North and 12 in the South. We need to pray for these men and help them financially.

Clearly, we need priests and we need our priests to understand the Knights are focused on supporting them, now and after they are ordained. The RSVP program is designed to be a good start in showing how much we appreciate them. Remember for every \$500 you send to one seminarian, Supreme sends you back \$100. So, it costs \$400 to send \$500.

I sent a tracking log to the GK's and FS's for the Councils. If I need to resend, please let me know. Look at the top of the tracking log. You will find the name and a photo of each Seminarian. You will also find an address where each will be continuing his journey to the priesthood.

The first part of the RSVP Program is to send personal messages to each seminarian telling him that he is important to us, and we are praying for him and appreciate his sacrifices. I am asking each Council to highlight a seminarian every month. Mention him in your newsletter and on your website. Ask your Council members to send him a note or card. Consider placing a notice in the parish bulletin asking your parishioners to do the same.

One way to guarantee that all seminarians receive notes and cards each month is to match your District number to the Seminarian number at the top of the tracking worksheet. Thus, District 1 starts with Seminarian one, District 3 with Seminarian three, and so on. Then next month, move on to the next Seminarian. I have included photos of each Seminarian. Use these to highlight the Seminarian of the month. The point is, Seminarian need to understand that they are appreciated by every Knight. It does not matter if your council is sending funds that month.

Clearly the second part of the RSVP program is financial help for personal needs. The diocese pays for education and room and board, but not for such things as toiletries and other incidentals.

I am asking each Council to advise me of how much money they anticipate sending during the year and to which Seminarian. The tracking part of the worksheet helps me see that the funds are balanced among the Seminarians and balanced over the course of the year --- which is a concern shared by both bishops. Tracking avoids a "feast and famine" situation with lots of funds coming at Christmas and nothing the rest of the year. So, I am asking that you provide me with the proposed funding, and in what month your Council can support which seminarian(s).

Tracking allows me to respond with suggested alternatives to keep things balanced as needed. We have had situations where one seminarian received several thousand dollars, while two others received nothing. And trust me, they talk to each other.

Consider placing a note to the parish bulletin stating that parishioners can make contributions to seminarians through your Council. Explain \$500 / \$400 aspect so that if you support five seminarians, you will be able to help a sixth from the Supreme Rebate.

Remember the more the parish knows about what the Knights are doing, the more it helps in recruiting.

# Knights in Nevada History

### More on the 4th Degree Formation History

#### POLITICS IN PLAY

The Fourth Degree's patriotism, conceived and developed in opposition to several forms of anti-Catholicism, was based on the compatibility between Roman Catholicism and American democracy. This patriotism was energized by the 1959 election of Pope John XXII and the 1960 election of John F. Kennedy. Two anti-Catholic caricatures were thus exposed as shams. The warm, good-hearted openness of Pope John dispelled the anti-Catholic myth that portrayed papal power in terms of world conquest; while the generally esteemed leadership qualities of John Kennedy put to rest the bias that a Catholic President could not be loyal to American democracy and Roman Catholicism.

In his famous address before the Greater Houston Ministerial Association, Kennedy referred to Communism ninety miles from our shores and to the impoverished children he had witnessed in West Virginia, but those issues were "obscured by the religious issue, because I am a Catholic and no Catholic has been President". In opposition to Kennedy was a long line of Protestant leaders, led by Norman Vincent Peale, who had been organized as the National Conference of Citizens for Religious Freedom a few days after Kennedy announced His decision to run for the Democratic nomination. One Protestant pastor remarked that Khrushchev and Kennedy were comparable, as both were "captives of a system," an echo of Paul Blanshard's Communism, Democracy and Catholic Power. In 1960 Blanshard published God and Man in Washington, an allusion to the book written by the leading Catholic conservative, William F. Buckley, Jr., God and Man at Yale. Blanshard challenged Kennedy to state his position on Canon1374 obliging parents to send their children to Catholic schools under pain of excommunication. Though Blanshard understood that few bishops rigidly enforced canon law on this issue, he was relentless in exposing the contradiction. He later was convinced that Kennedy was indeed a separationist, and in a book edited by him, Classics of Free Thought, Blanshard included Kennedy's address to the Houston Ministers' Meeting.

In his address to the Houston ministers, Kennedy responded to the Protestants. "I believe in an America where separation of Church and State is absolute... where no church or school is granted any public funds or political preference...I believe in a president whose views on religion are his own private affair, neither imposed on him by the nation nor imposed by him as a condition of holding that office." Kennedy assured his audience that he believed in a "Presidential office that is not limited nor conditioned by any religious oath, ritual or obligation."

Mobilizing volunteers is always a challenge. Following the time-tested SMART (Specific, Measurable, Achievable, Relevant, and Time-Bound) planning method will help smooth the way to the successful implementation of your goal.
- Second, I will ask you to please send me an update of the Programs you are currently doing and additional ones you plan to do this current Columbian year. I will be glad to keep you informed of your progress towards your goals. I would also request each District Deputy to collect data regarding programs from the Councils under their jurisdiction. This will also give the DD's the opportunity to assist those Councils who are having difficulties to get their programs going.
- Third, I will encourage Councils to take pictures of the participants and recipients and collect testimonials from recipients about the benefits they receive from the programs. Their testimonials will be sent to Bro. Dave Varon for publication. Also, publish these photos and testimonials in your parish bulletin. Submit these when doing your form SP7. This is a breeze if you methodically and diligently collect the data as you go along.

 Fourth, I intend to ask our State Deputy to recognize and award Councils which have the best and the most successful programs implemented.

They will be judged based on a standard criterion:

- -- How many members of the Council were involved?
- -- How much time, talent and resources did they contribute?
- -- Who benefited?
- -- How many were served?
- -- Did this lead to growth in the council membership?

Your success no matter how small is like opening the floodgates for more successes. Celebrate it and recognize your members for a job well done. Be generous with compliments but be slow in criticism.

Please remember to do these:

a) Officers Chosen for Term, Form 185

b) Form 1728 - Review of last year's activities and plan for future activities. It is always advisable to plan this at the start of the new Columbian Year. It will also give your Council a chance to identify deficiencies and incorporate new (if any) requirements.

c) Stay on top of your program implementation. Find out why it is not going according to plan and make corrections as necessary.

d) Collect all the data needed as described in (D), take pictures and get testimonials if you can from the beneficiaries. Make a report about your activities to your DD for his comments. This report will be submitted to the Supreme to be considered for the Columbian Award.

Here's an acronym to remember - PECS

- P = Plan
- E = Execute
- C = Collect
- S = Report/submit

# Question 6: The Right to an Abortion



A constitutional amendment to protect access to abortion will appear on the Nevada ballot this November as Question 6. This amendment establishes the right to an abortion in the Nevada Constitution. The Nevada Catholic Conference (NCC), in conjunction with the Archdiocese of Las Vegas and the Diocese of Reno opposes this amendment.

Nevada Right to Life spokesperson Krystal Minera-Alvis described the ballot question as misleading, given that abortion rights are already codified in state law. "As an organization, we stand firm on the fact that this amendment is unsafe and dangerous for women of all ages," Minera-Alvis said in the statement. (Source: PBS.org)

# Wildfire Couldn't Stop Council 13842



A fast-spreading wildfire, dubbed the Davis Fire, broke out Saturday, Sept. 7, around 2:30 p.m. The fire consumed 6,500 acres and at least 14 buildings. For a time, Interstate 580 was closed in both directions from Damonte Ranch Parkway in south Reno to College Parkway in Carson City; it reopened to traffic on Sunday morning. Washoe County Sheriff's office ordered mandatory evacuations of hundreds of homes. Power was cut for more than 18,700 NV Energy customers in the Washoe Valley area south of Reno "to prevent further ignitions and protect first responders," the utility company said.\*

Then came Sunday morning. The Knights of Council 13842 had promised a pancake breakfast for 250 hungry parishioners. Three Knights showed up for duty --- one with only three hours of sleep, he was evacuated at 1 a.m. (The usual crew is a dozen or more.) The Knights were all veterans at breakfast routines. One baked sausages, another stirred pancake batter and the third set up serving bins, griddles, coffee and juice dispensers. One Knight called out in despairation "Where is Fr. Rodel when we need him?" Fr. Rodel, a frequent help in the kitchen, could not make it, so the Knight called his wife (the Knight's, not Fr Rodel's). Lady Stephanie arrived a half-hour later and immediately went to work making scrambled eggs --- 24 12-inch frying pans worth (roughly 360 eggs!).

A crisis was averted. The skeleton crew of Knights and Lady Stephanie served breakfast on time. GK Jody Gunderman reported that several parishioners who had spent the night in an evacuation center, said this was the best pancake breakfast they have ever had.

Later after clean up, Lady Stephanie had some advice for the Knights, "Gentlemen, if you are going to stand for several hours and prepare scrambled eggs -- don't wear 2-inch high heel shoes. My feet are killing me." The Lord has turned all our sunsets into sunrise.

## Bringing Drink to the Thirsty



Often referred to as the "Super Bowl of BBQ Rib Competitions," the 2024 Best in the West Nugget Rib Cook Off was held in the heart of downtown Sparks, NV from Wednesday, August 28 to Labor Day, Monday, September 2. It was also the eleventh consecutive year that Ponderosa Council 4928 has volunteered as AAT-certified beverage servers under Nevada state law.

This year's event experienced near perfect end-of-summer conditions: no pandemic; no triple-digit temps, no torrential rain; no air quality alerts; no mud-soaked Burning Man attendees, just the aroma of BBQ on the grill and thirsty customers in lines. The crowds were record setting. On one evening shift alone at one of our stands, we served over 1,000 lemonade orders, along with plenty of bottled water, soda, beer and adult beverages. It was well worth the effort.

From 11:30 a.m. until 1 p.m. lunch is served each Wednesday at the Newman Center adjacent to the UNR campus. On Sept 4 and Sept 11 the Knights of Columbus Council 13842 provided wholesome meals. "The kids loved it," said Chuck, a Center volunteer. "They have a meal plan at the University cafeteria, but who wants the same thing everyday? This is a chance for something out of the ordinary."

Volunteer Keli Wilson said these weekly lunches started with a call from Bishop Daniel Mueggenborg. He wanted to introduce the newly remodeled Newman Center to the students. "We need to tell them it's okay to be a university student and Catholic at the same time," he said. The Bishop designated Our Lady of Wisdom church, which is part of the Newman Center, as a ministry to the students and not a local parish. He appointed Fr Bobin Babu administrator of the church.

Lunches started three weeks ago when Keli Wilson brought in lasagna and French bread. She expected 40 students; 70 arrived. Last week, worthy Knights Tom Gurgui, John Murphy and Jody Gunderman served up pulled pork sandwiches, baked beans and coleslaw. They expected 70 students; 93 arrived. This week SK Jody Gunderman and Lady Debbie cooked up 16 pounds of spaghetti with meat (and meatless) sauce, and sweet Italian sausages. PGK Don Eberlein provided garden salad and French bread. Keli Wilson provided dessert -- your choice of peach or berry cobbler with vanilla ice cream. Ninety students were expected; 123 arrived and made short work of the offerings.

Worthy Knight Lee Hernandez said that during lunch the Bishop took him to the front door of the Newman Center. He showed him the picnic tables outside which were crowded with students eating spaghetti lunch. "This is working," said the Bishop. "Two years ago we had 30 student members of the Center. Today we have more than 400."

# Letter from Bishop Mueggenborg after the Holy Spirit Mission

Blessed Sacrament might have been miraculously spared. Unfortunately, the intensity and duration of the fire had completely destroyed the Tabernacle and all its contents. The heat was so intense that it actually fused metallic pieces together. As such, nothing remained of the Blessed Sacrament.

Our next effort was to recover important documents and sacred vessels from the office safe and the sacristy safe. We did retrieve some intact documents from the office safe but, unfortunately, the sacristy safe was unable to endure the fire. Most of the contents were severely damaged or destroyed. This includes the historical Sacramental records of the Mission. We did recover parts of the Monstrance, a Chalice and the Holy Oil stocks - but even these were badly damaged.

Because of this, I especially ask your help in reconstructing these lost Sacramental records. Please supply copies of any Baptism, Confirmation, or Marriage certificates you might have so that Father Arlon can reconstruct these records. If you do not have original certificates, then please submit any other documentation you may have so we can substantiate the important sacramental history, which will be necessary as people seek further Sacraments.

Additionally, I want to thank and recognize Brother Hall, our new Superintendent of Catholic Schools, whom I have appointed as supervisor of Bishop Manogue High School, for generously offering the Bishop Manogue Chapel for the congregation of Holy Spirit Mission to use each Sunday. I believe that this location will give you a stable place for Sunday worship and will help your community to preserve its unity as you plan your future.

I hope you know of my personal support of you. I trust in the words of scripture when Saint Paul tells us, "we know that all things work together for good to those who love God, who are called according to his purpose" (Rom 8:28).

I trust that God, who has been accomplishing good work in you and for you, will bring it to fulfillment. I hope that you share that trust and confidence as well, and that the experience of this tragedy may become a source of deepened faith, greater commitment, and blessing for your community.


### 2024 Ponderosa Council Soccer Challenge

In August, six Diocesan seminarians, several discerning candidates, our newest priests, Fr. Rodriguez and Fr. Walsh, plus Tom Malone of the Office of the Bishop, all traveled to the Sooner State for a period of spiritual retreat of quiet reflection and prayer in support of priestly formation. While in Oklahoma City, OK, the participants pictured above visited the Blessed Stanley Rother Shine. The ties to Bishop Daniel were strong.

Both Bishop Daniel and Fr. Stanley Rother were born in Okarche OK. Bishop Daniel entered Oklahoma State University (OSU) to pursue a science degree. However, in the spring of 1981, he served at a Mass in Oklahoma celebrated by Fr. Rother. On July 28, 1981, Fr. Rother was murdered in Guatemala by a right-wing death squad. On December 1, 2016, Pope Francis officially recognized Fr. Stanley Rother as a martyr for the faith. He was the first martyr from the United States and the first U.S.-born priest to be beatified.

In time, Bishop Daniel graduated from OSU with a bachelor's degree in science and entered the seminary. He was ordained in 1989 and installed as the Bishop of Reno in 2021.





The Holy Spirit Church, located half-way between Reno and Carson City -- about 16 miles from Lake Tahoe, is a mission church of St. Rose of Lima Church. It was established in 1971, closed for a time, and re-opened it as a Tridentine Mass center. The Church contained some traditional Catholic art, including a mural behind the altar depicting the 1937 vision of Sister Lucy of Fatima. About 50 people attended the two Masses on Sundays. The Holy Spirit Mission Church was the only place in the Diocese of Reno where Mass was said in Latin. On Saturday, September 7, 2024, Holy Spirit Mission burned to the ground. 




