Americans' Abortion Opinions Remain Consistent



Demonstrating relative consistency year-over-year, a new poll from one of the most esteemed polling organizations confirms that a majority of Americans, including a majority who identify themselves as "pro-choice," think that abortion in the United States should be restricted, even beyond current federal policy and the laws in many states.

The polling, conducted by the Marist College Institute for Public Opinion and sponsored by the Knights of Columbus, is now in its 14th year, and continues to demonstrate that, far from extreme positions calling for unlimited abortion on-demand, three quarters of Americans hold a unified view that limitless abortion is not a preferred route for national policy.

"Amidst the harsh political divides in our country, clear bipartisan majorities support abortion restrictions and do not want their tax dollars paying for abortion abroad. Our polling has shown consistently over the past decade that policies that promote abortion on demand paid for by taxpayers are divisive and out of step with American public opinion," said Carl Anderson, Supreme Knight of the Knights of Columbus.

"The American people show consensus and restraint on this issue, and we hope that our elected officials and policy makers will heed this call for unity when there is far too much that divides us in our politics today," Anderson added.

The poll demonstrated that while a slight majority (53%) of Americans would still identify themselves as "pro-choice," three out of every four Americans (76%) believe that significant restrictions — even beyond those presently existing — should be placed on abortion in the United States.

"The sense that we should be more restrictive on abortion and not less can be a point of building consensus — even across political and religious divides," Anderson said.

Not a religious issue

Far from demonstrating a religious divide on the matter, the Marist poll, which queried a random segment of individuals between January 11th and 13th, 2021, included 55% of respondents who identified as not practicing any religion. Among those who identified as not practicing a religion, 64% indicated that they thought abortion access should be significantly limited.

Those self-identifying as Catholic made up 22% of respondents, though only 46% of those individuals said they were practicing their faith.

Republicans, Democrats, and Independents agree

Similarly, agreement on questions of restriction stretched beyond party lines. While larger percentages of Republicans (85%) and Independents (76%) would press for significant restrictions on abortions, even among Democrats, 55% believe abortion should be at least limited to the first three months of pregnancy, if not more restricted.

All told, a large majority (77%) of those who identify as pro-choice and a full 78% of self-identified Democrats said that they believe laws in the United States can be crafted to protect both mothers and their unborn children.

Mexico City Policy and Hyde Amendment have support

Similar consensus across political and religious lines appeared in the poll on the subject of taxpayer funds going to pay for abortions. Among those polled, nearly six in ten Americans (58%) oppose using tax dollars to pay for a woman's abortion. A majority of independents (65%) and a notable proportion of Democrats (31%) oppose taxpayer funding of abortion. This would seem to demonstrate agreement that measures such as the Hyde Amendment, which restricts federal taxes going to pay for abortion services in the US, should remain in place.

Likewise, a full three-fourths of those polled (77%) either oppose or strongly oppose American tax money going to support abortion in other countries. This too would seem to portend strong support for keeping in place the so-called Mexico City Policy, which limits federal funds from being put to use for abortion support abroad.

Methodology

This survey of 1,173 adults was conducted January 11th through January 13th, 2021, by The Marist Poll sponsored in partnership with the Knights of Columbus. Adults 18 years of age and older residing in the contiguous United States were contacted on landline or mobile numbers and interviewed by telephone using live interviewers. Survey questions were available in English or Spanish. The samples were then combined and balanced to reflect the 2017 American Community Survey one-year estimates for age, gender, income, race, and region. Results are statistically significant within ± 3.7 percentage points. There were 1,012 registered voters — the results for this subset are statistically significant within ± 3.7 percentage points. There are 253 Catholics — the results for this subset are statistically significant within ± 7.5 percentage points. The error margin was adjusted for sample weights and increases for cross-tabulations.

My Brother Knights:

By the time you read this, we (Nevada State officers) will be conducting the planning meeting (on February 2 & 3) for our State Convention to be held on May 14, 15 & 16, 2021. I propose that we arrive early on Friday, May 14th settle in our rooms, enjoy the view of Lake Tahoe and prepare

to conduct our "Spiritual Retreat" that will last for 2 hours. We can schedule these sessions after dinner. The Theme: "Saint Joseph as the model of Catholic Husbands, Fathers, & Knights".

Pope Francis declared "a special year dedicated to Saint Joseph from December 8, 2020 - 2021". As your State Chaplain, I intend to share my personal Spiritual thoughts & reflections on Saint Joseph, husband of Mary & foster-father of Jesus. My monthly State Chaplain's message will focus on diverse topics for the next 5 months. Reminder too that on February 17th (Ash Wednesday), we begin the Season of Lent.

My personal LIFE, my JOURNEY & my STORY had been guided by Saint Joseph not only as the Patron of the Universal Church but also as my personal protector and guide. There are several elements (realities) that converged in my life: 1) my birth place was in San Jose City, Nueva Ecija in the Philippines; 2) my early years of academic formation was at Saint Joseph School under the Franciscan Sisters of the Immaculate Conception and the Missionary of the Sacred Heart Fathers; 3) there were a number of Seminaries but I ended up going to "San Jose Seminary" for 12 years (1959-1971) under the Jesuits; 4) as a Diocesan Priest, I belong and am incardinated to the Diocese of San Jose, Nueva Ecija whose seat is the Cathedral of Saint Joseph.

Are all these mere coincidences? Or are they signs pointing to the reality that Saint Joseph guided me all throughout my life? Joseph, husband of Mary and foster-father of Jesus; the just & silent man who was completely open to all that God asked for him to do; the carpenter who was simply obedient to God, many times taking place in dreams - from taking Mary as his spouse; protecting the child Jesus from the wrath of Herod; migrating to Egypt with his family; returning and settling in Nazareth. All these have parallels and similarities in my life.

Thus the Latrin words "ITE AD JOSEPH" - translated "GO TO JOSEPH" became my priestly emblem and motto. Then and now, in the undetermined number of years of quiet faith and courage, in moments of uncertainty and urgent need, especially in periods of calm and discord - my Priestly vocation has been inspired and shaped by this 'dictum" to be God's instrument of LOVE, MERCY, JOY & PEACE.

Building for the Future

When you join the Knights of Columbus, you are joining a well established organization that has been around for 129 years since its founding in 1892 by Blessed Fr. Micheal J. McGivney. Today, it has more than 1.9 million members around the world. Like many organizations that has been in existence for many years, it has accumulated a wealth of essential knowledge and information about leadership training, team building, and recruitment and retention of members. These are important tools that you can use even in your life - be it in pursuit of your personal, financial, career, business and interpersonal relationships goals. What makes your job more challenging is the fact that you have to be extra careful not to offend anybody and at times be extra diplomatic because you are dealing with Volunteers instead of paid employees. This job will give you the opportunity to use every ounce of your leadership skills and put it to good use.

With paid employees they are expected to do their jobs and put in 8 hours of work, because if they do not perform according to expectations, they can get fired. In a paid job, you can use the salary and bonus incentives to motivate employees to improve their performance. With volunteers, that is not the case. You cannot threaten to fire them for not showing up or force them to do charitable work if they don't want to. They control their time. You cannot force them to work more than what they are willing to do. It is not like in the military, where you are told what to do and you do it or else you get charged with insubordination. This is where the challenge comes in. How to motivate them and get them to walk the extra mile. The best way is to take the following steps:

- 1) Explain to them what the task is about. The clearer the better.
- 2) Why your council is doing it.
- 3) When the work is to be done.
- 4) Where is the work to be done.
- 5) How much work is involved? How many people are needed?

Send out a sign up sheet for the volunteers showing their name, phone number and how many hours they are willing to put in. When you get the sign up sheet, meet with your volunteers and start planning how you will do the task.

- 1) Identify how many tasks are involved. List them all down.
- 2) Assign the task to your individual volunteers.
- 3) Ask them for their feedback and discuss the best ways of doing the task.
- 4) Decide your start date and estimated date of completion.
- 5) Meet with your leaders and review progress against your plans
- 6) At the completion of the project, make sure to complement all volunteers. Let them know that you are proud and appreciate what they have done.



The reward for volunteers is the appreciation of the work they have accomplished giving their volunteer time. There is also their feeling of satisfaction knowing that they have accomplished something that benefited their Church, their Community and their Council. Team building is a process. It is not a one time deal. Working together as a team and accomplishing your goal one at a time will fuel the enthusiasm of your members and make it easier to ask for volunteers the next time another project comes around. Small success provides a building block that leads to bigger successes.

Success in doing "Faith in Action programs" leads to:

- 1) **Improved Morale** Success leads to higher level of participation and failure leads to high turnover and a negative effect on morale. (less volunteers)
- 2) **Sense of Pride** Create a bond with the organization and its culture. When the Council succeeds due to a project in which the member took part, he is more likely to feel pride and his morale will improve. It could be effective and older members can even motivate new members to want to do more which can start the trend toward Increasing retention.
- 3) Happy and engaged members are more likely to pass those feeling to others.
- 4) **Familiarity** with things that the organization does due to training and actual participation. Getting to know his fellow volunteers. Seeing how enthusiastic they are. How much fun they are having.
- 5) **Recognition** Usually members wants recognition for work they have done when they actually do the work and not much later. Simple praise can do wonders to member motivation and retention.
- 6) **Leadership** Building leadership helping them learn to see different viewpoints when situation arises which will help them manage multiple opinions on a group setting. Teaching them to set goals and try to do their best at everything. Helping the members maintain a positive attitude when others make things difficult and telling them they can not achieve something.
 - A) Create a new you (Change role from Follower to Leader?)
 - B) Same or different.(Change your image. How do people see you now?)
 - C) Move the egg. (How to you move the egg without doing it yourself?)
 - D) Lead the blindfolded. (Can you lead with blindfolds?)
 - E) Charity support planning for fund raisers (How do you do a fund raiser?)
 - F) Planning strategies (How do you plan your strategies?)
 - G) Volunteer roles (How do you get people to volunteer?)
 - E) Untangle human knots (How do you resolve conflicts?)
 - H) Just listen (Finally learn to listen)

7) **Lead by Example** - Through Vertical and horizontal delegation is sometimes necessary to accomplish a given task, nothing is more inspiring than seeing a leader that is engaged and leading by example. It is hard to convince others (especially volunteers) to do work if they don't see you making an effort to help.

- A) Get your hands dirty
- B) Follow the Chain of commands
- C) Listen
- D) Follow-up

8) **Delegate** - After you have defined the task, have your list of volunteers, let the group choose a leader among themselves. This is a good opportunity for future leaders of the Council to get trained in in the art of goal setting, planning. organizing, prioritizing, delegating, monitoring and accomplishing the task. It also provides the opportunity to develop trust and interpersonal relationships, teamwork and camaraderie with your team members.

9) Leadership Training - Leadership training is a process like team building. Leadership succession in the Knights of Columbus was designed in a such a way that Members usually starts at the bottom of the leadership roll. As they serve and become familiar with their duties and responsibilities and participate in discussions of matters affecting the council, they not only learn the protocol, the role of the other Officers, and the process of decision making. The Grand Knight is usually succeeded by the Deputy Grand Knight, the Deputy Grand Knight by the Advocate and so on down the line. This was done for obvious reasons: The Grand Knight trains the Deputy Grand Knight who is expected to succeed Him at the end of his term the Deputy Grand Knight trains the Advocate who will succeed him and so on down the line. The continuity of the council programs along with the support groups are maintained with little or no visible learning curve to overcome.

10) **Take Advantage of all Available training resources that the Knights of Columbus offers**. Webinars, literatures, Knight line. Most importantly,

11) **Stay Active and stay in touch**. Develop a calling tree. Buddy system works. Peter and Joe are neighbors. Both are members of the Knights of Columbus and goes to the same Church. Joe attended a meeting the night before and found out that their Council is holding a take out fish fry dinner. He decided to volunteer. The next day he saw Peter and asked him if he was doing anything? He said not much so Joe told him about the Fish Fry fund raiser of their Council and asked him is he wants to come and help.

Develop a Calling Tree is another way to stay active and in touch.

- A) Do a mapping of your members.
- B) Print out a list of your members.
- C) Sort them out according to locations or zip codes.
- D) Group them out in sets of 5 members.
- E) Assign each member to call 5 members each then instruct.
- F) The next 5 to call 5 members each etc. until you have covered All of your members.
- G) Purpose of he call:
 - 1) Inform them of things their Council is doing.
 - 2) Remind them of the next scheduled meeting.
 - 3) If the meeting is done on-line, show them how to join the meeting. Using their Computer.

A Message from the State Retention Director

Brother Knights,

Just a reminder you should be preparing to send your first Knight Alert Letter (KA1) 30 days later Feb 15 (Feb 1st) -and mail to each delinquent member if payment is not received. KA1 must be signed by Grand Knight.

- The FS will provide the Retention Committee a list of delinguent members using the MM Retention Committee Report
- The Retention Committee must contact the delinguent member. This is done by Phone, email, mail or in person.
- The Retention Committee Member must provide the Grand Knight with a written report on each member who was contacted Using the Conservation Report.

Your council should have established a retention committee to examine reasons why Knights become inactive and let their membership lapse. This committee plans programs to conserve the council's membership and anticipate and solve problems that may cause membership suspensions. The deputy grand knight should be named to the position of retention chairman and his committee be composed of the council's trustees. After discovering problems, the committee should work with council officers to remedy them.

The financial secretary should provide the retention committee with a list of members in danger of being suspended. Contact these members and discuss their reasons for being inactive. Urge them to become active again. The financial secretary can also furnish a list of suspended members. Contact former Knights who still meet membership eligibility requirements and ask them to rejoin.

Councils should be recruiting lapsed members just as you would new prospects. Sell the organization to former members. Ask them what they enjoyed most about their participation in the past. Keep questioning on a positive basis. Emphasize the aspects of the organization the member is most likely to miss in allowing his membership to lapse. Work on getting these members back into the Faith in Action Programs.

When we are successful in bringing new members into the Knights of Columbus, we are also giving them the opportunity to learn and put into practice the virtues of Charity, Unity, Fraternity and Patriotism, while strengthening their faith and putting it into action, thereby making our organization respond better to the ever increasing needs of our communities.

Patience - Yes, indeed. You need a lot of patience. They say, "A great reward is waiting for those who have the patience to wait," or " a Continuous drip of water will in time break the hardest of stones."

Persistence - A good recruiter have to be persistent. You will encounter a lot of no's before you get to a yes. But there is virtue in being persistent and never giving up. Think of it as mission of evangelization - bringing more people back to church during and after this pandemic.

Determination - If you stay focused and determined to reach your goal, you will eventually reach it. "If at first you don't succeed, try and try again." Self determination in life makes us all learn what it is we can achieve if we push ourselves to the limit of what we are capable of.

Have the right equipment - Just like going to war. You don't go to war without your gun. When you go to war or any other endeavor, your purpose is to win and to win you should always have the right preparation and the right equipment.

Practice - Preach what you practice and practice what you preach. When you approach a potential prospect be sure to know what you are talking about. Learn about what the Knights of Columbus stands for, our history and our achievements. Give them a copy of our brochure. This will help you remember what you learned about the Knights of Columbus.

Understand the Process - The process of recruiting is simple. Have them fill out a form with their Name, Address, Age, Marital Status, Phone Number and E-mail address. After giving you the information, enroll your recruit on-line: www.kofc.org/join. Let him review the information for accuracy and then submit it. The enrollment fee is free until June 30, 2021 by using the promo code MCGIVNEY2020.

Put in hard work - This is also known as **Prospecting**. Here you can do what I do. I go to my phone book or contacts on my cell phone and make a list of 5 to contact. They could be my son, my cousin, my neighbor, my former classmates, etc., then I will call or e-mail to ask them to join the Knight of Columbus - that simple. If they say no, then ask them why not. Also explain to them the exclusive Insurance benefit that the Knights of Columbus offers to members only.

In 1958 he married Barbara Schmid, wife of 61 years. They had three daughters, Rochelle, Ann, and Therese. And now his family has expanded to include three grandchildren.

Upon leaving the U. S. Air Force, he worked for Kaiser Steel as a Metallurgical Lab Technician for eight years. During this time, he received his G.E.D. from Fremont High School in 1965, and in 1973 Sir Knight Howard received an AA Degree from Chaffey College, Rancho Cucamonga, CA, in Industrial Management.

In 1975 he relocated his employment to General Motors and worked as an Assembly Manager until 1981. Then joined ROLM/Siemens for ten years as a Production Manager and Administrator. In 1991 he and his family relocated to Cary, North Carolina for work with IBM as a Contracts Manager. There he Joined the Knights of Columbus and received his First Degree in October of 1992 and subsequently his Second and Third Degrees in 1995.

In 2001, upon his retirement, they moved to Sparks, Nevada. Their new Parish was Holy Cross Catholic Community. There, Sir Knight Howard Richner transferred to the Ponderosa Council 4928, receiving his Fourth Degree in April 2005 joining the K of C Brothers of Bishop Manogue Assembly 612.

Sir Knight Howard has served his Assembly as the Comptroller since 2012. He has been the "Financial Rock" and a "Go To" resource of our Assembly operations.
