# State Membership Director's Message

Worthy State Deputy,

I want to thank you for the opportunity to serve as the State Membership Chairman. Under your guidance Nevada has had a great year in both membership and programs. A special thanks to the Grand Knights and members that made Nevada so successful last year. Membership wise we ended the year:

- First in the Western region.
- Second of the 50 U.S. States behind South Carolina.
- Seventh in the Order of the 75 Jurisdictions.

We welcomed 515 new brothers in the Nevada knight's family for 145.48 percentage of our goal. There are now 6908 brother knights in Nevada surpassing our goal of 6900.

The past year is history, it is unchangeable, it is on the future that we must concentrate our efforts. Our goal next year that was set by supreme is 500 new members. The state goal for net/net is 400 or 7300 total knights in Nevada for us to reach 10,000 by 2030. Can we do this? Yes, you did it last year and with active participation the 6908 brother knights we can and will make it happen. If just 10 percent of the knights in Nevada add one new member that would be 690.

We are currently working to institute three new councils, St John's in Overton, St John Neumann in N LV and St Peter Canisius in Sun Valley. These three new councils should result in over 100 new knights.

Again, starting on July 3rd I will be sending out bulletin notices for you to put into your parish bulletins. I would like to develop some of these notices around events, programs or projects that your council has completed. So, if your council has completed a program or project, please send me two or three lines about the event, program or project along with a photo and I will send you back a notice about it for your bulletin and to other councils so members of our parishes can see what Nevada Knights are doing.

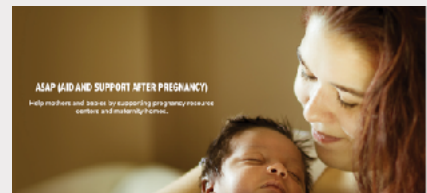

## Message from the 365 Club Chairman

Brother Knights,

The Nevada State 365 Club Program is continuing to provide financial assistance to all Brother Knights & families. The 365 Club Rules and Regulations contain the procedures in order to request assistance. Procedures have not changed since being adopted at the Annual State Convention on May 6, 2000 in Sparks, NV and amended on May 7, 2005 in Reno, NV and are now part of the Nevada State Council By-Laws and Standing Rules.

In the past, copies of the 365 Club Rules & Regulations were distributed to all Grand Knights attending the Annual State Convention. Upon election of their new Grand Knight, it was the responsibility of the Past Grand Knight to pass the packet to the newly elected Grand Knight.

As the 365 Club Chairman I found this was not always being done at the Council level; I started receiving phone calls from Grand Knights asking for copies. I found by emailing copies to Grand Knights was easier than giving out hard copies at Conventions. I am always available by either a phone call, texting or email.

In order to expedite the process, I request the Grand Knight to call or email me prior to submission to ensure all necessary documentation is completed properly. This has helped by allowing the 365 Chairman and Committee members to review and process the request to the State Deputy well within the required time period of 30 days. On the average most requests are received, reviewed and processed within one week or less.

This 2023 Fraternal Year there were 25 Councils (48 active Councils) contributing a little over \$7,800 to the 365 Club Program. Our goal continues to have all active Councils to help support the program, who in turn helps to provide financial assistance to Brother Knights & families in need.

As the 365 Club Chairman, I want to thank our State Officers, District Deputies and Grand Knights for their support.

## Knights History

### More About Manogue

Bishop Manogue's career, referred to as the "Miner Bishop", was more like the typical California pioneer who came to the West to get rich in the mines, but got out as soon as he could and made his fortune and future by "mining the miners". For Manogue becoming a priest and a bishop was not a way to milk gullible miners but was like others who preferred a life of commerce or professional life or service to the tedium and uncertain results of mining. In 1858, he presented himself to Archbishop Alemany, who sent him to the famous seminary of St. Sulpice in Paris. He quickly shook off the dust of mining (although he would remain close to the miners for much of his life) and resumed the seminary studies that had been interrupted.

In the seminary his mentors, the Sulpicians, were diocesan priests who had trained clerics since the seventeenth century. In addition to the course work in dogma, morals, and scripture, the Sulpicians also imparted a highly introspective and ascetical spirituality to their charges. Each priest was expected to maintain a busy schedule of pastoral duties: saying Mass, hearing confessions, teaching catechism, and counseling the laity. Every day as well the priest was also expected to spend some time in meditation and examine his conscience. The various sufferings of the pastoral ministry, loneliness, rejection, indifference, and lack of results were to be linked with those of the suffering Christ.

While in Paris, Manogue also learned much about the role of a church in a large city. It was during his years of study that Emperor Napoleon III and his assistant Georges Haussmann literally remade the city, creating broad avenues and boulevards, improving public works (the famed city sewers), and planting trees. Perhaps an inspiration for the Sacramento as it is known as the "City of Trees". Likewise, local churches contributed to this urban renewal with restorations of older deteriorating structures and the building of elaborate new temples. Manogue saw the beginnings of Theodore Ballu's Church of the Holy Trinity. When he returned to Paris on a rest vacation in 1873, he visited the finished church whose elaborate façade presided over a vast plaza. This later became the model for Sacramento's Cathedral of the Blessed Sacrament.

## **Knight in the Light**

### **Sir Knight Charles C. McCloskey, PGK, PFN, Nevada State Special Events Coordinator**

I was born the 4th son of Ronald Edward McCloskey, and Jimmie Earlene Carter, my father was of Irish and German descent my mother Indian and Italian. The first 3 boys were born strong and healthy, I was born a fighter with severe spinal meningitis and pneumonia. I would spend the first 18 months in the hospital fighting for life. My father, a fighter himself, would come to the hospital every day and go into the Chapel and pray his son might pull through, the doctors would tell him to go and raise his other 3 boys, as Charles wasn't going to make it. He would never give up and at 18 months I would go to stay with my Great Grandparents until I was strong enough to come home.

As I grew, we were brought up in the Catholic Church, attending Sunday Mass and Saturday Catechism. Fully Baptized and Confirmed we were taught to respect the church and everything she stood for. I joined the Boy Scouts at 11, and by 15 I had received the Catholic award as well as my Eagle Scout Award, they taught me to respect the country, God, and family. Shortly after the family moved to Long Beach, Ca; it would be just my parents and I. Both my parents were working at this time, so I became self-sufficient. I went to work at 15, in a small café in Belmont Shores as a dishwasher. I joined a Scout Troop in Long Beach and continued my work through community service and the local church. I would Graduate with Honors from Wilson High School and get accepted at Humboldt State University in Arcata California. I've always loved the forest and country living. I left home just before my 18th birthday and moved onto the Mobile Home Park on Campus. I began my studies in Forestry Science, this was about the time the Green Movement started. Highway 101 runs all through the Northwest Coast, I lived right off 101, soon the lumber mills that decorated the Highway would shut down and the economy was not strong. I changed my major to Speech Communications. I joined the Debate Team and would travel to the Northwestern States to compete, winning many honors along the way. I met my wife at Humboldt and married in the Catholic Church in Marysville Ca in the fall of 1979. We stayed in the North for another year, and then moved back to Long Beach near my family, and to Long beach State University. I began cooking graveyard at Denny's and going to school during the day. After about 1 year I left College and moved on to Chief Auto parts as a Store Manager, my wife would become in charge of the vault at the Long Beach Press Telegram.

I joined a Men's Mentoring group, we would meet once a week at the local Denny's, discussing life as knew it, sharing bible readings, and mentoring. In 1980, I broke out with severe Psoriasis, covering all areas of the body. The doctors told me the immune system had been destroyed by spinal meningitis, it had settled on my spine and nerves leading to the brain. After several years of treatment, in 1985 I was driving home from work, I had picked up my wife, and was heading home. I had developed a severe headache which had become very common, that afternoon I had a severe headache and was going home to relax, I went into

a violent grand mal seizure, my wife managed to stop the car and get help. I was rushed to the hospital and kick started a few times, the doctors managed to get me stable, and 10 hours later I would come back around. I didn't know what had happened and the next morning tried to leave the hospital, the doctors and nurses would not let me, a few hours later my wife and parents would show, and the doctors explained what had happened. I would spend the next 2 weeks in the hospital, but in the end, they could not tell me what caused it and felt it was from the nerve damage as an infant. I was put on heavy medication, told I couldn't drive and was given the papers to go into state disability. On Monday morning I was back at work. I would suffer severe seizures over the next 10 years.

We wanted children but the doctors told me with the spinal meningitis as an infant I couldn't have children, so after many years of praying and talking to people, I received a phone call one night from a friend, who told us of a lady in West Los Angeles, she was here from Guatemala 8 months pregnant and could not keep the baby. The next afternoon we drove into West LA to meet her, through an interpreter we arranged to adopt the baby, and build a safe home for the infant. About a month later November 10th, 1988, we would receive a call to come to the hospital, the mother was brought by Ambulance and about 2am Christopher Charles McCloskey would arrive. The doctors knew he was being adopted and brought him out to my wife, 2 days later he would come home to his new family. Our lives would change dramatically, my Assistant Manager's wife became his babysitter while we worked.

My wife's family had settled in Las Vegas, homes were much cheaper, the community was small at the time, so we packed up and came to Las Vegas. I would begin working in the Automotive Service industry, my wife would go to work for Citibank. The second year in Vegas we would buy our home in Northwest Las Vegas. My son would be baptized at St Joseph Husband of Mary, and years later would be Confirmed. We began working with the Boy Scouts when my son turned 8, he would go through the program and I would serve as his cub master, and then on to scouting as a scoutmaster. We would travel all over as he progressed, our favorite was the Sea Base out of the Florida Keys. At 16 he would receive his Eagle award 30 years after I had received mine.

About this time, I began having severe headaches in the back of my head, along with severe sinus infections. After months of testing, I was sent to an infection specialist. The doctor would put me on home IV's. New scans were run, and eventually, an infected cyst was found in the back of the brain, the doctors recommended surgery, I would be in the hospital for a week, then 2 weeks of recovery at home. The cyst was bigger than they thought, after surgery, I would remain for almost 2 weeks, then go home. This whole time I had put my faith in the Lord, he had gotten me through several close calls in the hospital before. I was at home on bedrest, when the sutures broke and fluid poured out, I was rushed back to the hospital, and back into surgery. I would spend the next 2 weeks in the hospital having tests after tests done, after 2 weeks the neurosurgeon determined the brain, and the spine was not talking to each other and therefore the brain fluid was building up and not draining. Eventually, tubes would be put into the back of the head down the spine and out to drain. 2 weeks later I would return to work. Once again, the Lord had pulled me through. I was a good bowler at the time, coached Jr Bowling, as well as coached and managed the Jr Gold, literally the PBA of Jr Bowling. After the surgery I could no longer bowl, the spinal meningitis had brought on its next round Psoriatic Arthritis, by now I was seeing an Arthritis immune specialist. Psoriatic Arthritis would permanently damage my body, destroying cartilage, muscles, and nerves. My wife couldn't handle the condition I was in, not being able to work for long periods, constant doctors, and the problems they brought on. After nearly 40 years of marriage she left and filed for divorce, I tried to bring her to counseling with me. The church offered us counseling, but she refused. So, a Divorce was granted by the state, but the Catholic Church does not recognize divorce. After about 3 years I would be granted an annulment by the Diocese.

Once my wife left, I returned to the Church in 2008 St Joseph Husband of Mary would become my sanctuary, I would meet Don Thompson, he would bring me into the Knights of Columbus. After about 6 months he needed someone to manage the Church Kitchen for the Knights, I volunteered and would take on several meals a year for the Knights, the Church and more. I would serve all positions in the Knights including 4 years as the Grand Knight, at the same time I joined the Assembly and would serve all again eventually as the Faithful Navigator. In 2012 my mother would be diagnosed with lung cancer, I would spend one weekend a month in Yucca Valley, taking my mother to chemotherapy then spending the weekend cooking and taking care of my parents, before returning home on Monday to return to work. In 2014 my mother would pass away from cancer; The Knights of Columbus would travel from Las Vegas to perform the funeral in all their majesty. My father had lots of health issues himself so I would go out once a month for 3-4 days, do his shopping, pay bills, and just make sure he was secure.

In 2016 I would start my own Food Truck Business in Las Vegas, dedicated to my Italian Heritage, along with a trained Italian Chef from Italy. Ciccio and Chucks Great Italian Food Truck would be born. We served the community for about 3 years, traveling with the truck, catering, and cooking for hundreds. Unfortunately, after 3 years the psoriatic arthritis would again rear her ugly head, stepping out of the truck, my right knee buckled and would fall onto concrete and break my right knee. The doctors tried to rebuild the knee, but it had damaged the cartilage and nerves. After 4 surgeries I still have lots of nerve and muscle damage, it has now turned into Neuropathy in both feet and hands. I would be forced to sell the truck.

I was still traveling to California to secure my father, however, in 2019 his cancer and other issues would take him down and he would pass away in July of 2019. As his executor I would spend the rest of the year in California at his home settling his estate and selling the property.

Today, I live in the same home I bought 30 years ago, my son is married and has 3 beautiful daughters. I deal with my health issues but keep pushing forward. I serve as the kitchen Manager for St Anthony of Padua, Faithful Navigator and now serve with the Nevada State Knights of Columbus as the Special Events Coordinator. The doctors tell me I can't work so now they have me on Disability/SSI, I try to help with the church and whatever they need. Today I also serve through Homebound Ministry and deliver food to the needy.
