### Solidarity with Ukraine

Brother Knights,

The situation in Ukraine is dire and worsening. The people of Ukraine, and our brother Knights and their families in that nation, need our help.

I call upon all Knights to join me in praying for peace in Ukraine, and especially for the safety of our more than 1,800 brother Knights and their families who suddenly face the danger of war. Please also join me in responding to the recent <u>appeal</u> of Pope Francis to join him in prayer and fasting for Ukraine on Ash Wednesday, March 2.

In addition to our prayers, the Knights of Columbus Supreme Council has committed \$1.5 million for immediate distribution to support Ukrainian refugees, including Ukrainian Knights and their families. We will be working with our councils in Poland as well as the Latin and Greek Catholic Churches in Ukraine to provide humanitarian assistance.

Knights of Columbus Charities has launched the Ukraine Solidarity Fund for this purpose, and the Supreme Council will match all funds up to \$500,000. #### To whom it may concern:

As of July 1, 2021, the Nevada State Legislature has ruled that all Nevada charitable organizations who will offer charitable lotteries and/or games to the public must submit an annual registration and proof of their current non-profit status to the Nevada Gaming Control Board. Additionally, registered organizations which distribute more than \$100,000 in total prizes, must then submit an application for approval to the Board for each remaining charitable lottery or gaming event occurring within that calendar year.

The Board has received your application to conduct Nevada charitable lotteries and/or games for the 2022 calendar year and your organization is approved to operate these non-profit events as defined in Nevada Revised Statutes 462. For all previously submitted requests to fundraise after July 1, 2021, the former fee structure is no longer applicable and your check will be destroyed, not cashed.

Worthy Brother Knights of Nevada,

I am sure you agree that it is quite remarkable that we are witnessing war in Europe in this day and age. The outcome is uncertain and potentially far-reaching, and that fact can certainly drive us to worry about our safety and economic security. I ask that you not fear as we can place our worries

at the feet of our Lord Jesus Christ and simply say, "Jesus, I trust in You." Know that God can, and will, turn evil into good in His time, and that we need to keep praying for, and believing in, a good outcome.

We are also at the precipice of Lent. In a way, having this European conflict should drive home the need for prayer and fasting during Lent. Let's put our faith into action. There are plenty of Knights of Columbus programs that enable this from rosaries to Helping Hands, but I want to highlight a couple others. First of all, March 19 is the Solemnity of St. Joseph, husband of the Blessed Virgin Mary which provides a good opportunity to talk about the Pilgrim Icon (Faith category), as this year's icon is St. Joseph. Also, typically during Lent we have opportunities to do fish fries. Fish fries are more than just selling meals on Fridays. You can use these gatherings to promote the Stations of the Cross, membership recruiting and other prayer gatherings.

Pilgrim Icon (Faith): Every few years, the Knights of Columbus selects an icon of a saint whose patronage is particularly inspiring to Knights and their communities. Following the year of St. Joseph, the Knights selected him as this year's icon. St. Joseph carried out his mission of raising, guarding and preparing Christ guietly, courageously and faithfully. For that faithful work, St. Joseph was rewarded - not with seeing the fruits of his labor in this life, but with the incomparable prize of glory in heaven. Our jurisdiction has one of these icons which can travel from council to council and serve as the centerpiece for prayer services in parishes throughout the State. Spread devotion to St. Joseph and pray for the courage to stand up and carry out our mission of protecting, defending, and raising future generations. The included booklet contains hymns, prayers, and readings to reflect on St. Joseph. Contact me or the State Deputy to reserve the icon; first-come, first-serve recognizing there could be logistical challenges as we are a large jurisdiction. St Joseph, pray for us!

Fish Fry: The beginning of Lent is March 2nd and during Lent we are obligated to fast and abstain from meat on Ash Wednesday and Fridays. Many parishes and councils host fish fries as fund raisers, but if you consider a different emphasis for these dinners, you can fit it into nearly any FIA category depending on how you accompany it. The Knights suggest two other reasons for holding a fish fry. 1) To promote the Stations of the Cross on Fridays during Lent and 2) attract new members. Actually, you should be able to easily accomplish both with a fish fry. Work with your pastor or talk to another council for advice if you don't know where to start. This is also a great community activity as you promote fellowship while serving these Friday meals.

As with all Supreme-built programs, you can scale these to the size of your council as they are designed to give the Knights of Columbus an opportunity to bring awareness to these causes. I encourage you get something started and to expand on those efforts every year. Participants don't have to be Knights either... the idea is to get the whole community involved. And don't forget to fill out the Form #10784 online to make sure your council gets credit for, and Supreme gets feedback on, the project (It only takes seconds to fill out).

#### **EXEMPLIFICATION LEADS TO EVANGELIZATION**

Exemplification prepares us for the work of evangelization that follows and spells out the mission of the Knights of Columbus as clearly as possible in the following definitions: This Knights of Columbus ceremony advances new and existing members through the lessons of Charity, Unity and Fraternity required of a Third Degree member. These ceremonies, are known as exemplifications. Putting this words into action exemplifies these virtues.

Exemplification also means providing examples about something like the life of St. Joseph, Our Blessed Mother and Jesus as written in the Bible.



According to the gospels of Matthew and Luke in the New Testament, Mary[b] was a first-century Jewish woman of Nazareth,[2][3] the wife of Joseph, and the mother of Jesus. Both the New Testament[c] and the Quran describe Mary as a virgin. According to Christian theology, Mary conceived Jesus through the Holy Spirit while still a virgin, and accompanied Joseph to Bethlehem, where Jesus was born.[5]

Mary has been venerated since early Christianity,[6][7] and is considered by millions to be the holiest and greatest saint because of her extraordinary virtues as seen at the Annunciation by the archangel Gabriel. She is said to have miraculously appeared to believers many times over the centuries. One great example was the appearance of our Lady of Guadalupe to Juan Diego on December 12, 1521. This led to the conversion of thousands of Indigenous Natives to Catholicism. The Eastern and Oriental Orthodox, Catholic, Anglican, and Lutheran churches believe that Mary, as mother of Jesus, is the Theotokos (Mother of God). There is significant diversity in the Marian beliefs and devotional practices of major Christian traditions. The Catholic Church holds distinctive Marian dogmas, namely her status as the Mother of God, her Immaculate Conception, her perpetual virginity, and her Assumption into heaven.[8]

Mary also has the highest position in Islam among all women.[10][11][12] She is mentioned in the Quran more often than in the Bible,[13] where two of the longer chapters of the Quran are named after her and her family.[14]

According to Catholic and Eastern Christian teachings, at the end of her earthly life, God raised Mary's body into heaven; this is known in the Christian West as the Assumption of Mary.



Joseph was not the biological father of Jesus, but he fulfilled the role of his earthly father by protecting and providing materially for the needs of Mary and Jesus, and by being the spiritual head of the household, guiding, along with Mary, the formation of the young Jesus.

# The paternity of St Joseph

Speaking of Joseph's role in the early life of Jesus, Fr. Anthony\* said: "The Jewish father played an enormously important part in the life of the son because he embodied the spirit of the covenant." St Joseph's fatherhood, he said, "with all its depth is of immense value to the world because within our society there is a crisis in the whole nature of paternity, which embodies the spirit of commitment, willingness to sacrifice for the good of his children, to endow them with values and prepare them for love in their own lives."

Twenty five million children are growing up without fathers in the home. That's 40% of the kids in America. As reported by the Center for Children and Families: 40% of all live births in the US are to single mothers; 90% of welfare recipients are single mothers.

If exemplification is providing examples to prove a point, then the example of Mary's obedience to the will of God and Josephs acceptance of his role as Father to Jesus shows us the path to leading our lives as good Catholic parents. Taking responsibility for our own actions, getting married, providing for the welfare and well being of our family, and sacrificing for the good of our children.

Who was St. Joseph? Was he just a passive, incidental figure in the drama of salvation? On the contrary, in every way that Jesus needed a father, St. Joseph was that for him. And how overwhelming it must have been for Joseph to be asked to stand in the Father's place! No man has

ever been asked to do so in such an unthinkable way. Every priest, and certainly every man who is a father (biologically or otherwise), should take this to heart.

Caster's book provides a unique, in-depth presentation of Joseph from the perspective of the evangelical counsels and the theological and cardinal virtues. Each section begins with an explanation of what each counsel or virtue means and then shows how Joseph models it for us.

The descriptions of St. Joseph's life and character found in this book, while rooted in the Scripture passages that mention him, are chiefly inspired by Jesus, who spent the majority of his life at home with Joseph and Mary. For years, the three of them lived, prayed, celebrated, studied, and shared, all the while uniting their lives more intimately with God's own. Those years in Nazareth were a real preparation for the foundation upon which Jesus would build his saving ministry. And as much as Joseph and Mary offered Jesus, he offered them an ever-expanding awareness of the God that had changed both their lives. The reciprocity of love that perfectly defines the home in Nazareth is the very pattern for all family life—and therefore of the Church itself.

Let Fr. Gary Caster introduce you to the man who risked everything to care for Mary and her Son, safeguarding them from harm and cherishing them with a pure and true love. Joseph was a flesh-and-blood testimony of what it means to live according to the Father's will with one's mind and heart centered on Christ.

This is why the Knights of Columbus had chosen our Virgin of Guadalupe (Our Blessed Mother Mary) and St. Joseph as examples and role models upon which to pattern our behavior as parents. We, as parents in turn set the example of hard work, dedication to family, instilling family values Like praying the Rosary, Going to Church on Sundays and holidays of obligations, and practicing the lessons of Charity, Unity, Fraternity and Patriotism that we have learned.

**St. Joseph**, (flourished 1st century CE, Nazareth, Galilee, region of Palestine; principal feast day **March 19**, Feast of St. Joseph the Worker **May 1**), in the New Testament, Jesus' earthly father and the Virgin Mary's husband. St. Joseph is the patron of the universal church in Roman Catholicism, and his life is recorded in the Gospels, particularly Matthew and Luke.

# **History of the Knights of Columbus**

# Our Tonopah and Goldfield, Nevada Origin Officially Documented at the Tonopah History Museum

The large Shingle Style house stands near the end of the town grid on the slope of Mt. Brougher, commanding a sweeping view of Tonopah. It is a well-executed example of a style rear in Nevada.

A massive stone foundation, built into the hillside, supports the building. Its rambling, asymmetrical plan is contained by the shingled walls under broadly spreading roofs. Entry is under a large porch held up by stone piers. The rear of the building has another deck supported in the same manner. The architect is unknown, the house is one of Tonopah's most architecturally prominent residences. Its original owner, George A. Bartlett, a lawyer and later a U.S. congressman, lost the house in the Panic of 1907. After serving as the Knights of Columbus Hall for decades, the residence is vacant and in disrepair. The word is that it has been purchased again and will undergo a restoration. The Tonopah History Museum now has the historical documentation on display telling the story of the Knights of Columbus presence in Tonopah and Goldfield from 1906 to 1941.

**Remember:** The message Blessed Michael McGivney continues to have for us, who carries on the work he began 140 years ago, when he gathered a group of Catholic men in the basement of St. Mary's Church in New Haven, CT.

While at St. Michaels, and later, at St. Ann parish in Dayton, Nevada I was privileged to serve as State Chaplain for four different State Deputies. This was a fantastic experience. I learned much not only about the Order but also about our Faith.

Conventions, State and Supreme, were opportunities to know the Brother Knights at their best. In 2010 Supreme invited all the Chaplains to Rome for the closing of the YEAR OF THE PRIEST. The Columbian Squires program is designed to help develop leadership skills in our young Catholic men. It encourages participants to pattern their lives after the Youth Christ by putting their faith in action in support of our Church and our communities – and they do so while enjoying food, fun and fellowship.

The Fr. Art Herkowski Columbian Squires Circle 5686 is sponsored by the Knights of Columbus Ponderosa Council 4928. It is the only Columbian Squires program in northern Nevada. In 2017, it won the prestigious Brother Barnabas Award for its Operation Toy Box program, one of only 25 Circles to be so recognized for outstanding activities out of 1,600 Columbian Squires Circles worldwide.

It has been over two years since our Governor issued pandemic masks and social-distancing mandates, the Bishop issuing Diocesan Covid rules, and the pastor of Holy Cross Catholic

#### THE SPROUTS INITIATIVE REVISITED



\Neither snow nor rain nor gloom of winter stays our goal to feed those in need.

Sometimes, when just a few knights make a program successful month-after-month there is tendency to take their efforts for granted. It's human nature to focus on larger and/or more unique service initiatives. The Sprouts initiative is just one of those everyday programs ... actually, it's a tri-weekly program.

Recently, the Sprouts Initiative experienced some staffing setbacks due to snow birding, family events, health and/or medical issues. In each instance, new member knights and family have stepped up to meet the need. It only requires a pickup truck or van and preferably a team of two to load and deliver food for families per event day.

While Ponderosa Council 4928 members and family have been the primary volunteers, Our Lady of the Desert Council 12877 have done yeoman's work in volunteering their time and effort in the fight against hunger by help delivering fresh, perishable produce and dairy product to where the need is greatest.

The numbers vary widely from week-to-week due to the seasonal variation of available donated perishable produce and dairy product and the need locations. In general, Sprouts Initiative volunteers donate approximately 12 hours, traveling approximately 70 miles to deliver approximately 1,350 lbs. of food per week.

The goal of the Knights of Columbus featured Food for Family programs is to ensure that as few as possible go to bed hungry each night. The on-going success of the Sprouts Initiative goes a long way to help attain that goal.
