




Fatherless Churches by Aaron Taylor,

Almost fifty years ago, when the Catholic Church unveiled its new rite of Mass in the Sistine Chapel, Cardinal John Heenan, then Archbishop of Westminster, remarked that if the Church used the new liturgy in ordinary parishes it would "soon be left with a congregation mostly of women and children." In 1967, Heenan could proudly assert that in his country "not only women and children but also fathers of families and young men" regularly attended Mass.

Whether or not the liturgy played any role in subsequent patterns of church attendance, Heenan's predictions have come true, and the drop in male church attendance has not been confined to the





These facts and figures provide useful background to discussions about the role of women in the Church that we've become increasingly used to hearing since Pope Francis ascended to the papacy in March last year. Only last month, the Holy See moved to end a discussion that had begun about the possibility of appointing women as cardinals. "I don't know where this idea sprang from," the Pope <u>explained</u>, "whoever thinks of women as Cardinals suffers a bit from clericalism." Responding to the Pontiff's <u>call</u> for renewed reflection on the feminine dimension of ecclesial life, the Vatican's newspaper, *L'Osservatore Romano*, has inaugurated the New Year by beginning a series of articles focusing on the "theology of women." Lucetta Scariffia, the editor, <u>explained</u> that this "open question" is "central to the Church today."

In and of itself, reflecting on the prospects for a theology of womanhood is a good thing. As John Paul II noted in his <u>Letter to Women</u>, "women's dignity has often been unacknowledged and their prerogatives misrepresented; they have often been relegated to the margins of society and even reduced to servitude. This has prevented women from truly being themselves and it has resulted in a spiritual impoverishment of humanity." As the Creation narrative in the Book of Genesis suggests, without an adequate view of each gender, we lack an adequate concept of human nature as a whole. It is in his recognition of "woman" that Adam recognizes himself as "man" (Gen 2:23).

But theological considerations do not sufficiently account for the popularity of novel ideas like women cardinals (which, though it may have been slapped down for now, will almost certainly resurface). Evidence shows that the three groups least likely to be active Christians today are men, young people, and the poor. *Mutatis mutandis*, this means that those most likely to attend church are affluent, educated, middle-aged women. In other words, the same demographic group which dominates almost all church congregations in the English-speaking world is the group most likely to benefit from an idea like female cardinals. If a church has almost no attendees except women, it is understandable that ideas about new theologies of womanhood and new gender-inclusive ecclesial structures are going to seem much more urgent than they would in a Church with a healthier gender balance.

The claim that what the Church really needs at this juncture is a theology of manhood might seem outrageous at first. After all, in many major Christian churches there are plenty of roles that men are free to enter which are completely closed off to women. Surely the last thing hierarchically male-dominated churches need is more men bloviating about their own masculinity?

Yet most boys are not called to be bishops, priests, deacons, or pastors when they grow up. Most boys will become husbands and fathers. The West, and the United States in particular (which has the third highest divorce rate in the world) has been undergoing a crisis of fatherhood for decades, a crisis which appears to be deepening and the (continued on pg. 5)

consequences of which we have only really begun to suffer. President Obama has spoken movingly about his own father-less upbringing and has established a <u>National Fatherhood Pledge</u> to encourage fathers to take responsibility for their families. The "first step in piety," John Calvin once said, is "to know that God is a father to us." The crisis in religious practice in the Western world is intimately related to the crisis in fatherhood, since it is from God, as St. Paul tells us, that all paternity on this earth is named (Eph 3:15).

A <u>study</u> of Swiss churchgoers commissioned by the Council of Europe found that if a mother attends church regularly but the father is non-practicing, only 2 percent of their children will attend church regularly in adult life. If the roles are reversed, with the father attending regularly and the mother non-practicing, the figure for regular attendance shoots up to 44 percent (higher even than the figure when both parents attend regularly). Another <u>study</u> found that when an American mother converts to the faith, there is a 17 percent chance that the rest of her family will follow. When the father alone converts, this figure rises to 93 percent.

It is praiseworthy that despite falling attendance rates among men, many women have steadfastly kept the faith and have often made valiant (if sadly ineffective) efforts to pass it on to their children. But the way to ensure that future generations of women continue to discover the joy of life in Christ is not by making token appointments. It is by ensuring that the Church has an adequate theology of maleness and of fatherhood, by ensuring that daughters see their fathers going to church and living lives of faith—which, incidentally, is also the way to ensure that future generations of boys might find their way back to the churches that current generations of men are leaving in droves.

Life and Times of an Abortion Protester/ Prayer

While saying a rosary, often with others around holding signs, or a crucifix, it is joyful to hear the words of encouragement. They usually outnumber the "FU's" and middle fingers, although if the ratio was the other way around one "God Bless you outnumbers a dozen of the others. Richard, who is 84, is the warrior with his large crucifix and shield of Our Lady of Guadalupe waving to passing motorists with a smile. Tony is patient. Mike is stoic with his "Baby Disposal" sign at the entrance to "Fortress Abortion," so named by the SF Chronicle. Santina is prayerful, with her Holy Land rosary. Mary is defiant with her loud voice to "save your baby."



These are common occurrences, with the large signs of "Abortion...Stops A ...Beating... Heart, the 40 wooden crosses in a row, with rosaries around, the dirt and rock crosses on the ground, the sidewalk chalk life-size pictures drawn daily, as if it was the tide that washed them away. Following are the events that assure all that God is with us.

A couple of months ago a car was pulling out and a young man in the rear seat heaved a big gulp at Tony on the sidewalk. Unfortunately for the occupants his window was rolled up. The car sped away amid profanities. I found out last week this accidental dousing of the interior has occurred at least twice.

Today I pulled up to park right in front and everyone was gone. I noticed 4 women in their smocks walking down the drive towards the sidewalk. After parking I got out, expecting confrontation, and they had disappeared. Poof. 50 yards back to the clinic, must have been on the run. A couple of minutes later the baby extractor pulled up, opened his window, gave me the finger, and spewed profanity at me, during the 4th decade of the Sorrowful mysteries from 25 yards away, in public. I guess medical school doesn't teach common courtesy.

A couple of weeks ago a car cut across the sidewalk and pinned Mike and his sign against the fence. It took him a while to figure out how to get around on the sidewalk. And that was enough for 5 police cars to immediately show up, as if there was a terrorist incident. The investigation, interviews, watching their film, concluded with the common warning for us not to block the driveway. Later a small car careened off the road, just missing 2 people, and bowled over those large signs. A 911 call was made, but when the dispatcher was told the address, we were told to file a complaint. No officers ever showed up. So Mike, being retired law enforcement, showed up the next day with cinder block sign supports. If that car tries it again we can follow his leaking motor oil.

Meanwhile, there is little business being done. We have visited at different times and the parking lot is mostly empty. The business is just hanging on, and our prayers over years and years are slowly being answered.

STATE CHAPLAIN: FR. ALBERT FELICE-PACE, O.P.

Are you one of the engaged Catholics?

I like to read novels, books on spirituality, books that help me grow as a Catholic priest and books that help me relate our Catholic faith to others. Recently when I was helping in a parish, a gentleman came and showed me a book titled "The Four Signs of a Dynamic Catholic" written by Matthew Kelly. I enjoyed reading some of his books such as A Call to Joy and Rediscover Catholicism. His books appeal to all Catholics.

I was curious about the book describing Dynamic Catholics. So I ordered a copy and enjoyed reading it. I would like to share briefly his suggestions of how to become a Dynamic Catholic.



He did some research to see how the catholic population is engaged in their church, examining in particular volunteerism and financial contribution. Both are significant signs of engagement. He found out **that 7% of Catholic parishioners** are doing almost everything in their faith community and paying almost entirely for the maintenance and mission of the parish. That leaves 93% Of disengaged Catholics.

In his findings, conducted by The Dynamic Catholic Institute, Mathew discovered four signs that are practiced by the 7% of engaged Catholics. These four signs are: **PRAYER, STUDY, GENEROSITY AND EVANGELIZATION**. When one look at the four signs, one can say that is so simple, which is true. But to put each sign into practice is more difficult. I am going to share briefly what Matthew found out about each sign.

PRAYER: I am sure when you read the word prayer, you will say, yes I do pray. So what is the difference between the 7% engaged Catholics and the 93% of the disengaged ones? **Dynamic Catholics have a daily commitment to prayer.** God is a personal friend to these people. They seem to have a structured way of praying such as praying the Rosary each day, attending daily Mass, pray with the scripture daily, He found out that engaged Catholics give a great importance of having a time to pray, a place to pray, and structure to their prayer.

STUDY: Dynamic Catholics are continuous learners. Matthew discovered that Dynamics Catholics spend fourteen minutes each day learning more about their faith. They see themselves as students of Jesus and his friends. They believe that Jesus teaches them through the Scripture, Christian tradition and the Church. They listen to Catholic CDs, watch DVDs about the faith, and tune in to Catholic radio and Television programs. They go to retreats more regularly. They are eager to learn more about their faith.

GENEROSITY: Dynamic Catholics are generous. They are filled with a spirit of service and are generous stewards of their time, talent and treasure. They are generous not only with time and money, but most of all with their love, appreciation, praise, virtue and encouragement. They see generosity as the heart of Christianity. So they are generous lovers, they are generous parents, they are generous with their colleagues at work, and they are generous with strangers that cross their path. Generosity is a way of life for the 7% engaged Catholics, a way to bring God's love into the world.

EVANGELIZATION: Dynamic Catholics invite others to grow spiritually by sharing the love of God with them. Although Catholics are timid about evangelization, engaged Catholics do and say things to share a Catholic perspective with the people who cross their paths. They evangelize in their own way, such as sharing a book about spirituality with others, give a Catholic CD to members of their families, They are constantly trying to help people develop vibrant spiritual lives by discovering the genius and beauty of Catholicism. Engaged Catholics know that sharing their faith with others is a natural flow from the first two signs. They generously share their spirituality whenever and wherever the opportunity emerges. They want others to experience the love relationship with God.

I ask you to reflect on these four signs. Ask yourself if you can say that you (and your family) belong to the 7% of engaged/dynamic Catholics, or are we still with the 93%, the disengaged Catholics. If every Knight works hard to be part of the 7% group, we will see a great renewal in our councils, in our parishes, in our families. I ask you to work towards that goal – to be fully engaged Catholic.

I highly recommend this book "The Four Signs of a Dynamic Catholic" by Matthew Kelly. You can purchase it from Amazon online. Read it, reflect on what Matthew has to say to each one of us and put it into practice. Vivat Jesus



The Emblem of the Order

was on a mission. I also wanted to know what the emblem represent.

I joined the Knights of Columbus in December 1992 during my junior year at Niagara University.

After I graduated from Niagara University in May 1993, I transferred to my new home council in Chittenango, New York, St Patrick's Council 10924. I finally received my first badge as member and I was a happy camper! My name was spelled correctly (amazing), the council's name and number was on it, and of course the emblem of the Third Degree is right in the center of the badge.

When I showed my badge to a friend of mine, the questions he asked, "What does these symbols stand for?" "Do they have any meaning to it?" I'll be a dirty name because I had no answers for him. I did not know. From that point on, I

Back then, there was no internet, AOL was not available at that time. I did the research "old school" style. I went to the public library and used an encyclopedia. For those who do not know what an encyclopedia is, "Google" it! And there it is, I found the answers I was looking for.

So in this article, it's dedicated to the new members so they will not be in the same predicament as I was in. It's dedicated to us more seasoned members. As a reminder to reflect on the symbolism of the emblem!

"The Emblem of the Order" came into existence during the second Supreme Council meeting on May 12, 1883. It was designed by Supreme Knight James T. Mullen.

The first thing many people may notice is a shield mounted upon the Formee Cross. The shield is associated with a Medieval Knight. The Formee Cross is the representation of a traditionally artistic design of the Cross of Christ. Through the Cross of Christ, we received all graces of redemption procured for mankind. This represents the Catholic spirit of the Order.

There are three objects mounted on the shield of our Order. A fasces standing vertically, an anchor and a dagger or short sword. The fasces, a bundle of rods bound together around an ax with the blade projecting, is from the Roman days. It's symbolic of authority which must exist in any tightly-bonded and an efficiently operating organization. The anchor in the mariner's symbol for Columbus, patron of the Order. The dagger or short sword was a weapon of the Knight when engaged upon an errand of mercy. The shield expresses Catholic Knighthood in an organized action. The letters K of C proclaims this specific form of activity.

The color red is the symbol of **Faith**. Our belief in Christ, in the redemption and in the knowledge and the love of Jesus Christ.

The color white is the symbol of **Charity**. It is also the color of the Eucharistic Host. The pledge of God's Eucharistic presence among mankind, of the infinite love God has for mankind and the overwhelming affection which the God-Man has for each individual.

The color blue is the symbol of **Hope**. It is the color of Our Lady's mantle, in which she wrapped her beloved Son, through Whom came salvation to a sinful world.

Hope, faith and charity are the three theological virtues of the Holy Spirit!

I would like to give thanks and credit to the Knights of Columbus Kansas State Council for the materials I used in my research. Yes, I "Google" for the information. I could not find an encyclopedia in the public library!

I must comment on the Family of the Month program. In spite of all of the




the families whose hard work make this a family organization. That means that less then 15% of the councils in the state report to supreme their choice for Family of the Month. I certainly hope that there

It only takes 10 minutes every month and could be the best 10 minutes for recruitment and retention that you ever spend. Please honor those women and men who keep our families an

integral part of THE KNIGHTS OF COLUMBUS.

I would like to thank those councils who continue to put together events that keep alive our family values. Without our families cooperation and support we would not be able to accomplish the great things that we do as an order.





STATE MEMBERSHIP DIRECTOR: DAVID RYAN

We have had a good year in membership growth but not a great year. We can still make it a great year with a real strong finish between now and June 30th. As of March 21 we were number 38 in the order in net gain at 43.9% of goal. We still need 165 more new knights to make the goal with no more losses. In the intake category we are number 15 at 71.4% of goal and where we really shine is in net/net gain where we are number three in the order at 222% of goal. So we still need to work hard to make this a great year and put Nevada in the top ten in all categories that supreme looks at for membership.

Two councils earned the 52,000 award points from supreme by every council officer recruiting one new member by December 31. They were San Lorenzo Ruiz council 13392 and Grand Knight Gerry Rockwell with 14 new members and 350% of quota and St Joseph Husband of Mary council 10442 and Grand Knight Charles McCLoskey with 23 new members and 121% of quota. Council 13392 has qualified for the new triple star award.

Other councils that have made or exceeded their membership

quota are: Council 4997 Reno at 111%, Council 8078 Boulder City at 133%, Council 10577 Stead at 125%, Council 10780 Pahrump at 125%, Council 13944 Incline Village at 116%, Council 14144 Las Vegas at 160%, Council 14544 Las Vegas at 109%, Council 14820 Las Vegas at 125% and Council 15061 Las Vegas at 125%.

The following councils are on track to make quota and star council: Council 5693 Las Vegas and 12543 Las Vegas. Councils that can still make star council with a little work are: Council 2511 Elko, 2828 Las Vegas, 3741 Henderson, 7322 Reno,

8282 Las Vegas, 9102 Las Vegas, 12543 Las Vegas, 12690 Laughlin, 12877 Sparks, 13456 Henderson and 13824 Reno.



Potentially, we have 24 councils that could make star council this fraternal year which would be one of our best years yet. However on the down side we still have five councils who have not recruited one new member yet this year. This is unacceptable as there is no reason that councils cannot recruit at least one new member per fraternal year. Per the

census that I have received for the dioceses there is not a parish in Nevada where we have a council where 100% of the eligible catholic men are knights. Until you reach that point there are eligible men in your parishes you can ask and get to join.

The State Deputy is only asking you to actively recruit new members from within your communities. If we all work as a team we still can put Nevada in the top ten in all three categories this year. We have been moving up in the standings but now is crunch time where we

need that extra effort by all our brother knights to recruit a new member before the end of this fraternal year. We are so close to making the state goal of being in the top ten that we don't need a herculean effort but just have each council recruit an average of one new member per month for the rest of this fraternal year. God Bless.



How I met my dearest friend, Ed Gutierrez

(aka Uncle Ed)!

My wife and I first met Uncle around 2004. I was ushering at La Virgen De Guadalupe Catholic Church in Bunkerville, NV, when this nice older gentleman entered the church. As Usher, I seated him and talked briefly with him. He was visiting from Southern California. After mass, my wife and I were eating breakfast at the Casablanca coffee shop when in walked Ed by himself. We invited him to join us. We hit it off instantly! There was a kindness in this man that you felt immediately, a warmth that touched us within our hearts and souls. Having lost his wife, Josephine, a few years earlier, Ed would visit his daughter frequently, driving back and forth from LA alone. Ed was about 85 years young at the time. His daughter was also having a difficult time; her husband was gravely ill and shortly after, passed away. A year or so later, Ed moved to Mesquite to live with his daughter permanently, as she was going through chemotherapy. It became our ritual every Sunday after mass to have breakfast together. From that time on, we were family.

Ed and I both love music, particularly jazz and blues. Ed was an accomplished musician that played the tenor saxophone most of his adult life. He would visit at my home and listen to my collection of music while we talked. When Ed found out that I was involved with the Salvation Army Kettle Program, he volunteered to play his sax while I rang the bells. He has been doing this ever since.

Ed knew I was a Knight and eventually I talked him into becoming a Third Degree Knight when he was in his late 80's. When we asked if he would like to become a Fourth Degree Knight, he said he was too old. However, we brought up all the many organizations he belongs to and attends frequently and said that "too old" wouldn't fly. So Ed at age 92 is becoming a Fourth Degree Knight along with me on 22 March 2014.

He is constantly giving of himself to other people and charities of all kinds – The Salvation Army, the Senior Center, Mesquite Veterans Center, Highland Manor Convalescent Home, La Virgen De Guadalupe Catholic Church, the American Legion, and the Knights of Columbus, just to name a few. The word "no" does not exist in his vocabulary. He is an inspiration to all of us with his endless love of giving and caring for others.

The U.S. Conference of Catholic Bishops (USCCB) designated the Washington-based facility dedicated to Pope John Paul II as a national shrine.

Beginning on Sunday, April 27, the day set by Pope Francis for Pope John Paul II's canonization, the shrine will be known as the "Saint John Paul II National Shrine." It will mark the occasion with liturgical celebrations, a reception, and a gathering of young people.

"The American bishops are pleased to reflect the love of Catholics in America for John Paul II by designating this location a national shrine," said Louisville Archbishop Joseph Kurtz, who signed the bishops' decree today as USCCB president. "This national shrine is truly America's fitting tribute and remembrance of his legacy."

The Knights of Columbus took ownership of the facility in 2011 to create a shrine dedicated to John Paul II and his contributions to the Church and society. Currently known as the Blessed John Paul II Shrine, it is located on the site of the former John Paul II Cultural Center at 3900 Harewood Road in northeast Washington.
