#### A Message from the Supreme Knight

#### **Brother Knights:**

We are all aware of the troubling events that are occurring today, including attacks on statues of historical figures such as Abraham Lincoln, Frederick Douglass and our Order's namesake, Christopher Columbus. Statues of saints have also been vandalized, including those honoring St. Junípero Serra, St. Louis and even the Blessed Virgin Mary, and houses of worship and other religious symbols have been attacked. These are not merely attacks on statues and history. They are increasingly attacks on Catholics and people of faith.

In the late 19th century, the Knights of Columbus took its name at a time of intense anti-Catholicism. Our founding members wanted to show that Catholics played an essential role in the exploration and development of America since its earliest days, and that a Catholic could be both a good citizen and a good Catholic.

However, anti-Catholicism persisted. In the 1920s, the Ku Klux Klan tried to stop Columbus Day celebrations and opposed Columbus statues simply because Columbus was a Catholic. We opposed the KKK then and have continued to stand up against bigotry directed at Catholics and others.

We stood up against the persecution of Catholics in Mexico in the 1920s, spoke out for the Jews of Germany in the 1930s and worked for religious freedom behind the Iron Curtain during the Cold War. Today, we are rebuilding Christian communities in the Middle East that were targeted for genocide. Each of us can be proud of our history of standing up for the most vulnerable among us.

While our faith calls us to be respectful of different perspectives, acts of vandalism are crimes against all who cherish democracy and mutual respect. The Knights of Columbus remains firm in its condemnation of all forms of racism and violence, including political violence. With churches, statues, and religious symbols subject to vandalism and attack, we call upon elected officials and leaders at every level to defend the religious freedom of all.

Dear Brother Knights:

I am sharing with you the THREE GOALS that I gave & mentioned during our Nevada Organizational Meetings, for Northern Nevada (Diocese of Reno) on July 18th and for Southern Nevada (Diocese of Las Vegas) on July 25th.

For the Fraternal Year (July 1, 2020 - June 30, 2021), my proposed THREE GOALS as your State Chaplain are:

First, we are going to continue the Spiritual Formation component in our Order. I plan to organize and conduct at least TWO Days of Recollection or Retreat (3-4 hours) one during the season of Advent (in December) & the other during the season of Easter (in the month of May). These days of Spiritual Reflections are open for your spouses and family members to attend. By strengthening our "personal faith", we can comprehend, understand and appreciate our diverse outreach programs and activities as Knights of Columbus.

We need to work hand in hand and walk step by step with our Bishops, Pastors, Priests, and Chaplains especially during these trying times.

**Did you know:** that Worthy Past State Deputy Richard (Dick) Cutting, of the Bishop Manogue Assembly 50 in Sacramento, CA proposed the 365 Club concept that was adopted by Supreme. And in 1999 the welfare of our membership in Nevada was addressed by the establishment of the 365 Club to render assistance to Brothers and their families who find themselves in need. This program initiated at the beginning of the fraternal year; asked all our Brother Knights and their families to voluntarily participate in the 365 Club by saving one penny a day.

# WPSD Sir Knight David W. Strait, PSD, PFN and PGK 2002-2005

David W. Strait was first elected as State Deputy at the annual meeting held in Carson City in May of 2002 after serving one term as State Secretary, following one year as State Treasurer, and one year as State Warden. Sir Knight Strait joined the order May 3, 1993 taking his first degree at George Holly Hall at St. Francis De Sales of Las Vegas and joining Fr. Francisco Garces Council 5693 where he remains a member.

David was born the third child and first son of Wayne and Paula Strait on May 23, 1948 in the town of Red Oak, in Montgomery county, Iowa. The Straits operated a family farm in Adams County, Iowa where both mother and father had grown up. The nearest town and school district at Corning, the Adams County Seat. That is where David, his sisters, his brother, and his parents went to school, and all graduated from Corning High School.

Growing up as a farm boy, he helped his father with all the chores associated with raising cattle, pigs, chickens, and horses, and raising crops of corn, hay, oats, and soybeans. He played the French horn in the school band and sometimes played a trumpet or a sousaphone in the marching band. He sang in the school chorus and in the church choir, and he earned a letter wrestling on the Corning varsity wrestling team. Wayne Strait (his father) served as a Deacon at the First Presbyterian Church in Corning, and David was active in Presbyterian youth programs though his school years. After graduating in 1966 he entered college and graduated from lowa State University with a Bachelor of Architecture degree in 1971. David went to Denver, Colorado to begin a career. While working as an intern architect in his first job he met Kathy Sena, daughter of Frank and Edna Sena, native of the Denver metro area and a devout Catholic. They were married the following year at Holy Cross church in the fall of 1972. The Straits had two young daughters, Gretchen born in 1973 and Rachael born in 1975. They began attending mass at the Queen of Peace parish in Aurora, Colorado, and David became a confirmed Roman Catholic in 1978.

The Straits were soon to become involved in a newly forming parish, St. Michael the Archangel, and in a new program called "Small Communities of Faith" in their neighborhood in Aurora. Their lives were soon to undergo a dramatic and drastic change. David accepted a job working in Saudi Arabia for Saudi Arabian Airlines, and in the spring of 1980, they packed up, put their house up for rent, and moved the family to Jeddah where they lived and worked and traveled for the next eight years. In April of 1988 they traveled back to Denver. Gretchen was now of High School age and eager to go into tenth grade as a real American teenager. Rachael entered eighth grade, and both girls were happy to put their expatriate life behind them. After a year of searching David found work at the Nevada Test Site. For the next six years he worked for Reynolds Electric & Engineering Company (REECo), the prime contractor at the test site. The family joined the Saint Francis De Sales parish and became active, first in the "Renew" program, and later in the Knights of Columbus. On May 3, 1993 David took his first degree at Holly Hall, St. Francis De Sales. Cliff Swartzell, who had recently been recruited during the "Renew" sessions that year, invited David to join, and Cliff

signed on as his sponsor. At the next meeting, GK George Jackson asked David to fill the position of outside guard and take on the role of Family Director. Given a "Surge with Service" program guide, David embarked on a new career and vocation in the Knights of Columbus.

By Christmas that year, Kevin Hazy was elected to replace George Jackson who had resigned for health reasons. David was asked to serve as a project chairman for a "Luau" fund raiser that Kevin had proposed to remedy a dwindling council treasury. The Luau was a success! David was then elected Deputy Grand Knight for the following year.

Brother David was elected Grand Knight in 1995 and served two years in office. The council won the Star Council Award during his first term. Sir Knight David served as Faithful Navigator of the Msgr. John J. Lambe Assembly 611, St. Francis de Sales Church, Las Vegas.

In 1997, State Deputy John Youngman asked David to serve as State Program Director. In 1998 he was appointed as State Administrative Assistant. The following year he was elected to the office of Nevada State Warden.

After going through the respective chairs of the state officers, he was elected to three consecutive terms as State Deputy. Five new councils were added to Nevada during David's tenure as State Deputy. Councils 13392 (Las Vegas) and 13456 (Henderson) were chartered by his second term, and councils, 13691 (Las Vegas), 13754 (Mesquite), and 13842 (Reno) were chartered during his final 2004-2005 term as State Deputy.

David finished his career as a State officer after serving as Immediate Past State Deputy from 2005-2007.

WPSD David Strait is remembered by many knights for his role Conferring Officer in the Third Degree and his other performances in First and Second degrees. Fourth Degree Knights will remember him for his presentation as Expositor of the Constitution. He has remained active in ceremonial positions for over twenty-two years now.


