# **Online Exemplifications**

Dear Brother Knight,

As the world reels from the coronavirus crisis, the Knights of Columbus continues to serve: providing the charitable, spiritual and financial resources relied on by so many.

Early action at the Supreme Council headquarters meant that we began working remotely in mid-March, ensuring the health and safety of our workforce, and the continuity of our business operations with minimal disruption. Our employees are putting the "home" in "home office," as they continue their work with the utmost commitment and excellence.

The Order's agency force has also embraced working virtually. Agents continue to meet and advise members about their insurance and financial needs, but now they do so online through secure Skype appointments. The financial services and products we offer are important in normal circumstances; they are vital during this pandemic.

The Knights of Columbus remains financially strong. On April 6, Standard and Poor's ranked life insurers on their ability to weather the coronavirus storm. Of hundreds of life insurers in North America, the Knights of Columbus was one of only six to earn the top ranking.

Responding to the pandemic, in March we launched a new initiative - "Leave No Neighbor Behind" - and councils worldwide are already implementing it, providing critical support in neighborhoods and parishes, donating blood, and ensuring that no one is forgotten. The Supreme Council has also launched a multimilliondollar campaign to support food banks in the United States and Canada, and we are providing a financial lifeline for dioceses as well.

These efforts complement the countless ways that brother Knights are helping the sick, the hungry and others in need. Our charitable work in North America is so significant that the White House has asked for regular updates on our relief efforts.

During this pandemic we have also adapted from in-person meetings to having councils conduct essential business remotely. The Supreme Council has also provided a platform to allow every jurisdiction to hold a virtual state convention. The means of connecting has changed, but our proud tradition of faith in action has not.

Our actions have been a powerful witness, and a recent degree ceremony, held online, produced the largest number of new members from a single event in our Order's history. The Supreme Council is hosting our new

# More Than 2,000 Men Join KofC Amid Pandemic

Men continually seek ways to step into the breach to assist brother, parish and community during the coronavirus pandemic.

#### More than 2,000 men joined the Knights of Columbus during the first ever online Exemplification of Charity, Unity and Fraternity held on April 16. The

exemplification was hosted digitally by the Supreme Council as a unique opportunity for men to join the Order in a time of social distancing and minimizing mass gatherings.

In his introductory remarks to the exemplification, Supreme Knight Carl Anderson emphasized that the Knights of Columbus' principles – charity, unity and fraternity – are "needed now more than ever."

The online event took just under 40 minutes and nearly every jurisdiction in the United States and Canada was represented. Pennsylvania, Michigan, Texas and California were among the jurisdictions with the highest new member totals.

"Catholic men in our state, even during these times, want to belong to an organization like the Knights of Columbus to help others," said William Chasse, the state deputy of Michigan, on the Order's opportunity to increase its charitable impact. "The more that join the more we can help."

Pennsylvania State Deputy Mark Jago was pleased with the turnout, saying it's "not surprising that Catholic men want to join us in our mission to serve others, especially now."

Riley Quinlan was one of those men, joining the Knights during the first ever online exemplification.

"I was interested in joining the Knights to get involved with a specific church community, joined by likeminded Catholic men of faith," Quinlan said. "I wanted to connect with God through a community I can routinely serve. I am interested in helping out where I can during the challenges presented by COVID-19."

In addition to new men joining, more than 7,000 first and second degree members were able to obtain their third degree, and thousands more Knights and family members were able to observe and support the candidates. The new, public exemplification debuted earlier this year, with the first taking place at St. Mary's Church in New Haven, Conn., where the Order was founded.

This historic online event was organized by the Knights of Columbus's newly formed Fraternal Excellence Department lead by Retired Navy Captain Tom McCaffrey.

The Knights of Columbus is also adapting its charitable outreach during the COVID-19 pandemic, launching the new program "Leave No Neighbor Behind." The program encourages Knights to lead their families,

protect their parishes and serve their communities through a variety of charitable initiatives that also keeps members safe.

Members of the Order have access to state of the art insurance and investments benefits, as well as the opportunity to put their faith in action in order to leave no neighbor behind in a strong, Catholic fraternal setting.

## **Revised Criteria for 2019-2020 Council Awards**

Worthy Knights of Columbus Leaders,

The coronavirus pandemic impacted fraternal operations and activities. Many councils that might have qualified for council awards may be unable to meet the criteria because of circumstances beyond their control.

Our goal is to recognize those councils that were on track for success before the crisis and those that are continuing fraternal operations despite pandemic restrictions. Accordingly, the following criteria revisions are instituted to make council awards more achievable in the current fraternal year:

#### (1) Columbian Award (Programs)

- · Conduct at least 10 program activities (reduced from 16)
- · At least 2 activities in each program category of Faith, Family, Community, and Life
- · At least a total of 2 additional activities in program categories of your choosing
- The program categories no longer have specific "Required Programs"

#### (2) McGivney Award (Membership)

• Achieve Revised Membership Goal (40% reduction from original quota)

#### (3) Founders Award (Insurance)

- · Host a virtual or in person benefits seminar with the field agent before June 30, or
- · Achieve Revised Insurance Goal (50% reduction from original quota)

#### (4) Star Council Award

- · Payment of Supreme assessments and per capita are not required
- All other Star Council requirements (reports, safe environment, etc.) remain in effect

Note: We will discuss these revised criteria in detail during the next webinar this Thursday, April 30, at 8:00 PM EDT. Registration information will be sent separately.

The coronavirus pandemic greatly increased the need for charitable works. In challenging times, good leaders step forward and make great things happen. I encourage you to think outside of the box, be creative, and help others get through this terrible pandemic. Our **Leave No Neighbor Behind** program is a great place to start making a difference.

Please do your best to achieve these revised criteria for council awards. The Supreme Council looks forward to recognizing your accomplishments.

# A Message from the State Warden & Membership Director

Worthy Brother Knights,

First, I like to mention that next year's convention will be in Las Vegas, at the same location that was scheduled for the 2020 State Convention and it will also be the first weekend in May. The mid-Year convention will be held in Mesquite, in mid-December.

For the State Officers and DDs, I know that this convention wasn't what we expected but we made our way through it and there's no question that next year will be a better year for us here in Nevada and for people around the world.

I'd like to also to mention our all-important membership numbers. For this year, we are still #1 in the United States and #9 in the jurisdiction. Our intake has been 307 through Wednesday, April 29. That's only 53 members needed, to reach the quota set by Supreme of 360 new members.

My personal goal was much higher for the year, but I am very proud of our results to this point. I also believe there is no reason that we can't find those last 53 members before the year is out. I know that our churches will still be closed through the month of May, but I recommend that all of our councils visit the Supreme website and order the Delta Drive Package for recruitment. That would put us in good shape when we return back to our churches in June when we can make a big push for recruitment through the end of the Columbian year.

Any new council members to the E-membership program will receive a \$15 credit off of next year's per capita. Please keep this in mind, as it is a good incentive to continue bringing in new members.

As always, I will be available to help anyone who needs. We only need two new members per counsel to make the circle of honor which will put the State of Nevada in a prominent place at the convention in Washington, DC. I can't tell you how proud I am of all the hard work through a very trying year. The GKs and DDs have done a fantastic job to make us this successful.

Lastly, in July, on either the 11th, the 18th or the 25th, the State Officers will be doing DD, GK and FS training. We'll finalize the dates soon, once we learn of the Parish opening, to organize the dates.

#### **State Health Services Chairman Annual Report**

It is a pleasure to serve the Knights of Columbus (KofC) as the Health Services Chairman for the State of Nevada. Many of us feel overwhelmed with the daily barrage of information concerning the coronavirus pandemic and the new challenges it creates. Our prayers are with the families and friends affected, the healthcare community, our first responders, the military and all providers of essential services during these challenging times. It is also important to comment on the Ethos of the Knights: Charity, Unity, Fraternity and Patriotism as it relates to Health Services activities at the local, National and worldwide.

The pandemic is caused by the novel coronavirus officially named SARS-CoV-2, which causes the Coronavirus Disease 2019 (COVID-19). Our Nation willfully implemented mitigation. As we continue to self-isolate, to protect our most vulnerable; we are instructed to wash our hands, not to touch our faces, to wear masks (if appropriate), to avoid gatherings of more than 10 people, and to maintain social distancing of 6 or more feet. Cleaning surfaces with disinfectants is also recommended.

For your safety, some homemade mixtures are NOT advised. Bleach and vinegar produce toxic chlorine gas. Bleach and ammonia produce a toxic gas called chloramine. Bleach and rubbing alcohol make chloroform, which is highly toxic. Hydrogen peroxide and vinegar makes highly corrosive substances peracetic/peroxyacetic acid. Please follow CDC and OSHA guidelines, be safe – life is precious.

We are united in support of the sanctity of life in many charitable ways. The Knights recently donated the 6th ultrasound machine to First Choice Pregnancy Services. Most women (upwards of 80%) seeing their unborn baby chose life. Food donations resulted in more than 90,000 lbs. of food donations to Catholic Charities and the St. Therese Center. In recent years, the wheelchair program helped procure thousands of wheelchairs to the disabled in need.

Life begins at conception and ends with NATURAL death. In February 2019 Senate Bill 165 (assisted suicide) was thankfully derailed, undoubtably in some measure by actions the KofC and the Catholic Medical Society. One tenant in the Hippocratic Oath is "above all, do no harm". When there is hopeless or futility of care, patients can be palliated and kept comfortable. Their family can be consoled as their beloved transitions from this life. Assisted suicide is mentioned only to be condemned. It further contributes to the erosion of the moral fabric of society and further denigrates our families and communities. Should the Bill be revived, pray we will not support this horrible initiative.

The Knights affect a positive change in the world-feeding the poor, tending to the sick and protecting the gift of life. Many of our Worthy Brothers are serving in the military in support of the COVID-19 pandemic. Continue to pray the Rosary. Your prayers, selfless devotion and support is appreciated.

#### **State 365 Program Chair Annual Report**

Worthy State Deputy Toni Pascua,

Following report submitted for the 2018 – 2019 365 Club Program. I'm happy to report the program is operating very well, numerous requests for assistance were submitted & processed within a timely manner. From July 2019 through March 2020 the 365 Club Program processed \$7,397.56 to Brother Knights/families requiring financial assistance. In most cases

applications were reviewed & approved well within the required time period of 30 days. On the average most requests are received, reviewed and approved within one week or less.

However, we continue to encounter problems with some Grand Knights who are not aware of the proper procedures to follow in the 365 Club Rules & Regulations as established by the Nevada State Council. In most cases Grand Knights were not given the 365 Club packet by their outgoing Grand Knight after council elections. However, upon request, I will continue to email copies to Grand Knights & remind them the process is very confidential and strictly between Grand Knight and Brother Knight in need. To help expedite the process I request the Grand Knight to call or email me prior to submission to ensure all documentation is completed properly.

Funds to support the 365 Club Program are voluntarily donated by members/families of the Knights of Columbus within the Nevada Jurisdiction on a yearly basis. This past year, 26 out of 41 active councils donated a total of \$10,772.40; our goal is 100% participation by all active councils for Fraternal year 2020.

As Chairman for the 365 Club Program I want to thank all District Deputies and Grand Knights who helped to make the 365 Club Program a huge success this past year, also, our State Deputy, State Secretary & State Treasurer for their support.

# State Historian Report and May 2020 "Knight in the Light"

Brother Knights – As we continue in this time of evolving new normal, in multiple ways, please pray for the wisdom and guidance from our Lord Jesus Christ to help those who are tending the sick and seeking a vaccine.

Other updates are as follows:

- 1. I am continuing to work with the District Deputy's and Grand Knight's to appoint a respective Council Historian, for this new Columbian year and going forward. The Council Historian will assist the State Historian in reaching into the respective Council archives for access to the significant events or activities of the Council and Brother Knights. In some Councils this role will reside with the Grand Knight, due to size of Council membership. Please be prepared to discuss who is best suited for this position in your Council. As always, this is your chance to tell and record your Council's continuing story!
- 2. In concert with our new Worthy State Deputy Toni F. Pascua and myself, we recommend Councils setting up a "cloud based" storage system for each Council's records, photos, activity accounting, etc. The continuity of record keeping can then be documented/updated over the continuing "Columbian Year" by the Council Historian.
- 3. To accomplish the infill of Past State Deputy's Biographical information, from 2000 to the current Columbian year; I will continue to work with resources from Supreme and PSD Ray Gardea to collect and archive this information. As mentioned before, we have received Biographical information for a few PSD's.

#### Knights of Columbus History Fact:

#### **Columbian Squires Circle – Nevada History**

A history refresher on the Columbian Squires:

The KofC is the parent organization for the Squires, which was preceded by the "Boy Life Bureau" in 1923, established under the direction of Brother Barnabas McDonald, FSC, together with Supreme Director Daniel A. Tobin on August 4, 1925 for boys from 10 to 17 years of age.

Their motto is: ESTO DIGNUS (Be Worthy).

At that time there was a national interest in youth in the United States, as reflected by the development of the Boy Scouts and Big Brother organizations. Brother Barnabas had gained a national reputation for his pioneering work with delinquents and orphans. He said, "The supreme purpose of the Columbian Squires is character building".

To date: Columbian Squires are in eleven countries and have a membership of approximately 25,000. Squires have fun in sharing their Catholic faith, help people in need, and enjoy the company of friends in social, family, athletic, cultural, civic and spiritual activities. Through their local circle, Squires work and socialize as a group of friends, elect their own officers, and develop into Catholic leaders independent of their respective sponsor Council.

The first Nevada Columbian Squires Circle was established in the 1960's and lost momentum. Father Art Herkowski re-established Squires Investiture, in Nevada, on September 1, 2014 under the Ponderosa Council, 4928.

Currently there are three active CS Circles in Nevada: Holy Cross CS Circle 5686, sponsored by Ponderosa Council 4928, in Sparks; St. Padre Pio Circle 4992, sponsored by St. Francis of Assisi Council 13456, in Henderson and St. Elizabeth CS Circle 5271, sponsored by Mother Seton Council 11029. SK George A. Minter is the State Squires Committee Chairman. Currently Supreme has suspended any new charting of Columbian Squire Circles.

#### **Biography:**

I joined the Knights of Columbus in 2 March 1970 in the Fr Walter O'Brien Council. I enjoy the brotherhood and many activities of the Council. Looking back over 50 years it seems like we did just about everything we do today; of course, a few things have been added. It seems like the Council adhered to "moving up the ladder" regarding positions. I stepped aside from this the first year because I was active with the "folk group" at church. I became a 4th Degree Knight in April 1972. Soon I would spend the next 20 years experiencing the K of C around the world. I attended Council and Assembly meetings and events in seven states.

In September 1972, I experienced the "old" K of C in New Jersey. They had a clubhouse, bar and were highly active, with great food. Northern Florida brought me in contact with a Southern K of C. They all knew each other and met often. Again, I did not plan on being in Northern Florida exceptionally long so was "just a member". 1976 I was off to Northern Alaska. Met with the Knights a few times. We did not have a council on base, and we were 25 miles from the nearest Council. Then in 1978 I landed in Las Vegas. I joined St Christopher's Council. Many of my K of C Air Force acquaintances were members there. I enjoyed the camaraderie and activities. I participated but just as a member though I did become an advisor to the State Deputy. I knew my days were numbered. Sure, enough in 1980 I was off to Hawaii. three years and a highly active council in Aiea. I must admit I remember the Assembly more. Still did not transfer out of the San Leandro Council and Hayward Assembly. The Hawaiian Knights were remarkably busy. They were always doing something. I served my three hardship years in Hawaii, then it was on to K. I. Sawyer AFB in the upper peninsula of Michigan, (really had little contact with the KofC which was 25 miles away in Marquette) from 1984-1986. Then it was off to Zweibrucken, Germany for two years, returning to the USA in 1988 and was stationed at Ellsworth AFB, South Dakota. Our Parish at Ellsworth was highly active, and we established a Council on Base. I was active in the founding of the council and held my first Council Officers seat. We had an active council. We tried to "Make it Happen". And it did.

In 1993 I joined my wife in Las Vegas. We experimented with many local parishes until joining Christ the King. I do not know why I did not reestablish my ties from the past; No one reached out. Well, that soon ended when. Les Lesicki wanted to know if I wanted to join the NEW Council being established at Christ the King. I told him "Yes" and became one of the founding Knights of 14144 on 21 September 2006. I started taking various positions on the council and was GK from 2010-2012.

Was not the best GK; Council was just getting started. 2013-2017 I was asked to be DD 9 for the State of Nevada. I believe I did excel as a DD. We became a guiding light. All our Councils excelled in awards. I was DD of the year for 2015! Wow! But it was only for four years. Time to move on to Membership Chairman for 2017 & 2018.

We excelled but did not reach our 6000-member goal by only two new Knights. 2019 I moved on to Retention Chairman for the State of Nevada. Our goal is to find out "WHERE ARE THE KNIGHTS?" Too many brothers have fallen by the wayside because no one showed an interest in them or they got demoralized. Hopefully all the councils can find "their brothers".

I have enjoyed 50 years of knighthood. We have accomplished many things over the years. Lots of dinners, awards, friendships and life experiences. Only regret is that **WE** do not all **DO** a little so a **FEW** do not have to do so **MUCH**. Let us pray for more **KNIGHTS** for strength. Let us pray for more KNIGHTS to share their talents with the People of God and make our churches **STRONG**.
