



So, let's GET STARTED!

Gentlemen we need to take action. We need to renew. We need to renew our councils and our REASON for being a Knight. GOAL: a strong council involved with growing a parish and individually growing in their Christianity. We are a Catholic Christian Fraternity of men who want a strong parish thru a strong bond. Many councils meet these standards; we all should.

PROGRAM

The program involves the whole council. The FS identifies those who have not paid., The Council knows who is not attending meetings or activities. So everyone WANTS the inactive knights to be Active.

The FS knows who's not paying dues etc. FS makes a list of non paying/ inactive knights. Lists are shared with the officers of the Council at the officers' meeting. We have inactive knights. 1. Known by proposer, 2. known by a council member, 3. known by FS as non paying. We want to SHARE our FRATERNITY with him. WE WANT TO LIVE OUR FRATERNITY!

- **1. Known by proposer:** The proposer must reinsert himself into the life of that inactive knight. The proposer has to be the ONE to contact these inactive knights. Why, because HE endorsed and sponsored them.
- **2. Known by an active Council member:** Time to reactivate the relationship. Reach out as a friend; eventually as a Knight. Bring him back to ACTIVITY; most Knights can do something. He will enhance his life and see a value in HELPING OTHERS.
- **3. Known as inactive/non paying brother knight:** Trustees to the rescue. Trustees take a list and tract down the inactive member and get to know him.Bring him back! If you need help; ask a brother knight to help.

OLD KNIGHTS. These may be the former breakfast cooks, tootsie roll passer outers, former Officers of the Council. Now they have medical/ physical problems. They may need a friend. A fraternal

buddy. A member of our council activity: phone calls, sedentary council jobs. They're still knights. They are OUR BROTHERS IN CHRIST.

LAST RESORT. We still want to retain our brothers and members of Knights of Columbus But..... if a Knight doesn't want to be an active Knight. Easy: Piece of paper. "I no longer wish to be a Knight of Columbus. Member #. Signed & Dated! Give to FS who will fax/send to Supreme. MEMBERS WHO RESIGN **DO NOT COUNT AGAINST US**. If we cannot find a Knight or we MUST eliminate a knight then this is done ONLY from July - October by the FS.

The above is the LAST RESORT. WE WANT TO RETAIN OUR MEMBERS!

In some instances we need to reestablish the Knights as a caring, loving, involved group of Catholic Christian Men.

State Historian Report and September 2019 Knight in the Light

Brother Knights; now that the Columbian year is well underway,

please send me your completed Form 185, Council Officers information, so I can establish strategic contact for our Columbian Year 2019-2020. Remember to include the name and contact information of your appointed Council Historian.

Other updates are as follows:

- 1. I am continuing to work with the District Deputy's and Grand Knight's to appoint a respective Council Historian, for this new Columbian year and going forward. The Council Historian will assist the State Historian in reaching into the respective Council archives for access to the significant events or activities of the Council and Brother Knights. In some Councils this role will reside with the Grand Knight due to size of Council membership. Please be prepared to discuss who is best suited for this position in your Council. As always, this is your chance to tell and record your Council's story!
- 2. In concert with our new Worthy State Deputy Toni F. Pascua and myself, we recommend Councils setting up a "cloud based" storage system for each Councils record's, photos, activity accounting, etc. The continuity of record keeping can then be documented/updated over the continuing "Columbian Year" by the Council Historian.
- 3. To accomplish the infill of Past State Deputy's Biographical information, from 2000 to the current Columbian year; I will continue to work with resources from Supreme and PSD Ray Gardea to collect and archive this information. As mentioned before, we have received Biographical information for a few PSD's.

Please use my email address: historian@nv-kofc.com to assist in adding any historic documentation, as indicated above, to capture the Nevada State history of our Fraternal Order. I look forward to continuing to work with my Brothers. Make this new Columbian Year the best year ever for your respective Council and Assembly.

A Nevada Knights of Columbus History Fact:

"One Nation Under God..."

The original pledge of allegiance took root in the late 19th century. In 1891, Francis Bellamy, the son of a Baptist minister and a former preacher himself, accepted a job with the family magazine Youth's Companion. Put to work in the magazine's promotions department, Bellamy was tasked with creating patriotic programs for schoolchildren ahead of the dedication of the Columbian Exposition

in October 1892, the 400th anniversary of Christopher Columbus's arrival in the New World, according to Smithsonian Magazine.

Bellamy knew he would need a salute to the flag. He felt strongly that a pledge should invoke allegiance, especially so soon after the Civil War. His original pledge read:

"I pledge allegiance to my flag and the Republic for which it stands — one Nation indivisible — with liberty and justice for all."

Tweaks came later. In one instance, the words were changed to "the flag of the United States" out of fear that immigrant children would not understand clearly which flag they were meant to be saluting, Smithsonian Magazine wrote.

It was not long before calls to insert "under God" gained momentum. Enter the Rev. George Docherty. The Rev. George M. Docherty, New York Avenue Presbyterian Church.

Born in Glasgow, Scotland, in 1911, Docherty was brought to the United States in 1950 to become pastor of the New York Avenue Presbyterian Church, a historic house of worship in downtown Washington that Abraham Lincoln attended. When Lincoln was president, the church held a special service on the Sunday closest to his birthday that he liked to attend, Matt Schudel wrote in The Post's 2008 obituary of Docherty. Docherty himself had not heard the Pledge of Allegiance until he heard his young son recite it.

"I came from Scotland, where we said 'God save our gracious queen,' 'God save our gracious king,' "Docherty told the Associated Press in 2004. "Here was the pledge of allegiance, and God wasn't in it at all."

Docherty had previously sermonized about the need to insert "under God" into the pledge, but he found his prime audience in February 1954, when President Dwight D. Eisenhower attended Docherty's service in honor of Lincoln's birthday.

"To omit the words 'under God' in the Pledge of Allegiance is to omit the definitive factor in the American way of life," Docherty said from the pulpit. He felt that "under God" was broad enough to include Jews and Muslims, although he discounted atheists.

"An atheistic American is a contradiction in terms," Docherty said in his sermon. "If you deny the Christian ethic, you fall short of the American ideal of life."

Calls to add "under God" to the pledge had been promoted by groups including the Knights of Columbus and a Veterans organization. But Eisenhower proved to be the audience the movement was missing.

The week of Docherty's sermon, bills were introduced in Congress to add the phrase, and Eisenhower signed the act into law on Flag Day — June 14, 1954.

"Knight in the Light"

Truly a cradle-to-grave Catholic Christian

PFN Sir Knight Thomas Francis Peacock, born April 23, 1950, of Reno, Nevada.

Tom was surrounded by family and raised in Fremont, Calif. Tom's parents were active at St. Joseph's Church, and with Holy Family Convent, both of Mission San Jose, Fremont, Cal. Tom and his siblings received their first sacraments at St. Joseph's.

He was an altar server; weddings and funerals calling for a matched set requested the four oldest Peacock boys.

Tom's parents regularly took their children to visit family members who had been called to religious life. His father's cousin is Sr. Mary Herbert Rafael (aka Sr Herbie) of the Holy Names Order, Campbell, Calif. His maternal grandmother's family contained several priests and nuns. One of Tom's



brothers was a Trappist for about a decade. One of Tom's sons was a seminarian for several years.

Tom's uncle was Fr. Frank Peacock, Diocese of Phoenix, Arizona. Some of the earliest photos of Tom show him in the arms of his uncle, who was a Franciscan seminarian in Santa Barbara, Calif.

The Peacock family was in Northern California for a century. His grandfather told his grandchildren all about the 1906 earthquake, which hit when he was 11 years old and living in San Francisco.

Schooling

Tom commuted to Bellarmine College Preparatory, Santa Clara, Calif. For high school. He ran track, played the flute in the school band, and performed in Charley's Aunt and The Music Man. He sat behind Dante Pastorini in Spanish class and raced against Lynn Swann, who was in an adjacent lane at one track meet.

Next came San Jose State. He ran track with Tommy Smith, John Carlos, and Lee Evans of 1968 Olympics history. (Years later Tom's children would attend high school with Dr. Harry Edwards' children. Dr. Edwards provided the idea for the black- gloved fists.) Tom wrote a column for the university newspaper.

(JIM: Interesting sidebar: He met his future wife, Deb, the summer of 1971 at the same time and place as Joe and Leslie Patti met.)

Tom received his Bachelors in Natural Science. Six months later he quit his job as a manager trainee for a pharmacy chain to enlist in the US Army.

Military career spanning 30 years

Tom's grandfather was a WWI veteran. His father and several uncles were WWII veterans, but Tom was the only one since then to spend more than 2 years in any branch of the military.

Tom spent his first year in the US Army in basic training at Fort Ord, Ca., followed by advanced training at Brooks Army Medical Center, San Antonio, Tx., which became his first permanent station. Well, that ended quickly—the powers that be decided that he was officer material. They didn't like his degree from San Jose State, so they sent him to East Tennessee State University for another. He breezed through that in one year, receiving a BS in Environmental Health. After two years of army service as an enlisted man, they gave his direct commission and sent him back to Fort Ord to command a medical detachment.

After six years of active duty, Tom was ready to return home. During these years he had moved from Fremont to Fort Ord to San Antonio to Johnson City, Tenn., to San Antonio, to Fort Ord to Fort Dix, NJ. His children were born in Oakland, Ca. at the naval hospital, Fort Ord's army hospital, and in Freehold, NJ. His oldest was ready to start school. It was time to settle for a while.

He bought a house within 10 miles of his parents and all his extended family and stayed put for the next 25 years.

But his military career did not end. He moved from the active army to the Army Reserve. He continued to travel for the military, with short-term assignments to Okinawa, Reno, NV, Mountain View, CA, San Francisco, San Antonio, Fort Bragg, NC, Glynco, GA, Fort Ord, Fort Hunter Liggett, and Hawaii. (He even got to train at the US Marines' Mountain Warfare Training Center in the Sierra Mountains.) He was part of the Army Medical Department and was also Civil Affairs qualified. He was on active duty in Mt. View, CA on 9/11. When he retired, he had 30 good years, with retirement benefits and had attained the rank of Lieutenant Colonel.

Tom's civilian career was with the Alameda County Health Department. He started as a restaurant inspector and blueprint reviewer. He quickly became a supervisor in the emerging field of hazardous materials remediation and oversight. During this time, he wrote a book: "Is it Safe to Eat Out?" (Yes, but only in Nevada and Florida.) He also earned his Masters Degree in Public Administration from Cal State Hayward. (All while raising 4 children and helping his wife at every step to earn her degree in engineering from UC Berkeley.)

Tom was still an active Roman Catholic Christian. During his active duty years, he served as an usher, a lector, and a lay Eucharistic minister at various duty stations. Once settled in Northern California again, in his home less than a mile from church, he was active in these roles once more. He joined the St. Edward's Men's Club, eventually serving as president of this service organization. He taught CCD to 6th graders. And his children attended the parish school, so there were service hours required of parents on top of everything else.

And he returned to his love of track and field. For 25 years he was a coach, more often than not, head coach of his parish team. He served 4 years as president of Mission Valley CYO

Track and Field. Tom and the head coaches made major changes to the way Sunday afternoon meets were run. Parents received such good training in officiating that they would be seen in later seasons officiating at the high school meets. Computers were added to "track" the runners and their times and distances. Children started wearing number bibs, which are standard equipment at all levels today.

The local high school coaches attended the Sunday meets to watch the children compete. Several told Tom that they appreciated getting freshmen on their teams who already had the basics with no bad habits; they arrived coachable. (And several coaches invited and accepted 8th graders practicing with their high school teams, to give them advanced training.)

Tom, with a friend, assembled teams from multiple parishes to compete in the Northern California Hershey Meets, held in San Jose, CA. where their relay teams were feared, because they were so good. He was the first track coach to about a half dozen children who became high school champions at the state and national level and received athletic scholarships for college. Several thanked him personally in later years.

Tom's volunteer work extended to science fairs, too. He and his wife were judges for the Newark Unified School District. They also judged the regional fair for Santa Clara County, with Tom serving as part of the US Army team of judges. After retiring from the health department and the US Army, Tom moved to Reno, NV. He stayed active with his civil affairs unit for a couple of years as a member of the Family Readiness Group. (He liked being part of the phone tree, calling stateside family members across the country to assure that they were coping with the deployments and had the local help they needed.) He discovered Facebook. He became a Eucharistic minister and sacristan at Our Lady of the Snows and a member of the Msgr. Patrick J. Connors KofC Council 4997. For several years, he was active in prison ministry, holding regular communion services at FCI Herlong and encouraging priests to come hear confessions. He also was a PFN at Bishop Manogue Assembly 612.

And Jim Kelly convinced Tom to join the Knights of Columbus.

JIM: Here's one you may not know about. Tom's mother, Marie was blind for the final 15 years of her life. She had retinitis pigmentosa. She had heard that there were these 10 commandment monuments at some churches, and she decided that she wanted to have one put in at a Catholic church. She found out that the church she was attending, St John the Baptist, Folsom, CA had a priest who would not allow this, because it was too controversial. She didn't agree – the streets around the church were not major arteries, but she didn't fight it as he was the priest. Her husband John told her "You are an old blind Portuguese lady; what can you do?" She called Tom. Tom knew all about Project Moses. He contacted the Northern California Chapter President and the General Agent. When the dust settled, Marie's check had not only paid for one monument, but jumpstarted fund-raising that ended up covering the costs for 4 monuments and their installation. Along the way, the Northern California Chapter gave her a plaque giving her all the credit for the first 2 monuments. The Peacock family was notified of and invited to

the dedications for all 4 monuments, then sent photos of the Bishop of Sacramento blessing them, with Knights in full regalia in attendance.

Afternote:

Tom's mother, Marie, died Sept 2012 and was buried at Veterans Lawn, Mt Calvary Catholic Cemetery, Citrus Hts, Ca. Tom died June 2017 and was buried in the next row. Tom's father, John, died June 2019 and was buried with his wife, near his son Tom.

As always, I must begin by thanking you for your courage, compassion and witness standing for innocent human life – most particularly the unborn. Today, more than ever, these helpless little ones need us to speak for them.

In 2013, Nevada Right to Life sponsored the inaugural Camp Joshua Nevada, Life and Leadership Institute. This three-day long camp, held at the 4H Camp at Lake Tahoe, trained 25 high school students (from seven high schools) and 15 college/young adults. By all metrics, it was a huge success. Each camp has grown. In October, we will sponsor our sixth such camp.

As you can well imagine, the cost of this camp is high, yet the benefit to our community is also high. Graduates of our camp have taken their places in the pro-life movement across Nevada and beyond. Their impact will be felt for the next several decades.
