The Supreme convention is coming up in early August and there are plans for a NATO (Nevada-Alaska-Tennessee-Oregon) hospitality room — To the best of my knowledge Nevada has never hosted a Supreme Hospitality room and we are planning the inaugural one for this coming convention. We have decided to share with some other states that do not normally have a hospitality room so that all of them can participate. This is one of the things Nevada would need to do to eventually host a Supreme Convention. The things that they have been asking for is 10,000 members, host hospitality rooms to show we can handle 1,000 to 1,500 guests for a couple hours and find a location that they will agree to. We are also in the process of drafting a proposal to present, after we accomplish some of the things they requested, to have a Supreme Convention.

The State Council is trying, with the Districts and Councils help, to get us functioning as a powerful group of Catholic men working in 40 (or more active councils) parishes around the state. This is the plan instead of 40 councils functioning as separate units with little coordinated effort to harness the power we would have as a united entity. In my 25 years as a Knight in Nevada I have watched many councils come apart over issues that would have been easily corrected if we had been working together.

We need the council retention teams (after they have tried to engage the men and retain them) to find out why members that are behind in their dues don't want to pay/stay-

Is it because:

They are not engaged with the council?

They do not feel there is value for their money?

They dislike or are in a fight with someone (or many) in the council? They actual are having financial difficulties.

If it is the last one the council should cover their dues. If they owe 5 years, or something like that, the council should make an effort to get them to pay this year and waive the past due in appreciation of them telling the council why they felt that it wasn't worth it, so we can address the issue. It usually boils down to the 4 things listed above, of course if they give a different answer we would love to hear those as well. We cannot fix what we do not know. So, take at least enough time to find out what the issue is before letting a man get away from the Knights and possibly the Church. The chance of maintaining a Catholic man as Catholic goes up if they are an active Knight in a healthy council. The other issue could be they moved, died, deployed military or we just have a bad address and the man we kick out doesn't know that they are delinquent.

By way of example my Father In-law was suspended twice - once while in Korea and once while in Vietnam.

Thank you for your help with the issue of member retention and engagement and all your efforts to make the Knights, the Church and your parishes great.

This year was indeed a great opportunity to meet/interact with the Auxiliaries-most of its members and Officers, gave an insight of the numerous projects, fundraising, volunteer, charitable works of family, fellowship and assisting the Knights of Columbus Activities.

Had the pleasure of attending numerous occasions/seasonal socials, invites and family/fundraising events surrounding the Knights of Columbus, and Ladies Auxiliaries' activities, as well as Statewide K of C/Auxiliary wide events.

Did the Installation of Officers for the various Auxiliaries and had had the chance to sit down in their meetings and answer some inquiries they had. Through the wonders of emails, we had the convenience of communicating with our auxiliary in the northern side of town, albeit the distance was in touch to whoever needs an answer or help.

The hard work and passion put in by these organization is no measurement by far to their dedication in pursuing their respective goals for the welfare of each of their council.

We were able to thresh out some gap between the insurance liabilities in conjunction with the Auxiliary project/ funds arising from a K of C event.

Together with our Committees, it has been the goal of the NSLA this year to reactivate inactive auxiliaries as well as to organize new ones. As we continue to maintain our existing Auxiliaries, we encourage the growth in membership as well to be able to expand in numbers.

To date, each Auxiliary has a steadfast membership from the smallest group of 14 members to an outstanding of which was 46 plus members and counting. An average of 4 members minimum for each Auxiliary was recruited within the year. That means a 10 per cent increase in membership growth, system wide.

For the Fundraising projects, a humble amount of \$200.00 was raised to a generous amount of \$8150.00 to *\$11,000.00 was donated to their parish/favorite charities. (*figure was rounded off from a single fundraising project of one Auxiliary).

May 4 - 6, 2018 St. Joseph's Parish Elko Council NV 2511

Friday, May 4, 2018

4:00 PM – **6:00 PM.** The detail schedule for the first day of the convention consisted of the following: Registration of Delegates, Pickup of Banquet/Lunch Ticket Pick-Up, Pick Up of Convention Shirts, Caps, State Ties, State Pin Sales, Seminary Education, 365 Club Check-In, and McGivney Guild. During this very pre-convention evening was surprised by Diocese of Reno Bishop Calvo, host Fr. Daniel Hussy and guest Bishop Thomas and Fr. John Mc Shane.

Meeting: 3:00 PM – 4:00 PM: PSD Association, Resolution Committee, Credentials Committee, welcome committee program will follow these meetings.

Saturday, May 5, 2018

6:00 AM – **7:20** AM Continental Breakfast – Mater Del Hall – St Joseph's Parish a nice breakfast was enjoyed by all attendees.

7:20 AM - Opening Prayer was given by the State Deputy Thomas Thorn and Rosary was led by the State Officers. The meeting was called to order by Nevada State Deputy Thomas Thorn.

The State went over some talking points which includes many of them. See State Website.

7:53 AM – 8:13 AM State Membership Director Ray Troik gave the State Membership Review and thanked the District Deputies and Grand Knights and all attendees on the great turn around the State Membership Recruitment effort has taken over these past six-month period, always keeping in mind our goal of a total state membership total of six thousand (6000) knights, by the end of the Columbian Year 2017. Brother Troik talked about the plans of jurisdictions similar in size and plans that have worked in building memberships. a very sound pep talks to the District Deputies and Grand Knights. The State Deputy reentered that Supreme does know that areas such has is below 50,000 population can adjust required membership quotes.

State Deputy read the State Audit Report: With these recommendations; State Secretary will be billing for membership quarterly; Reduce amount of monies held in Accounts such as 365 Club. Change present by laws to prevent unsecure transport of funds between convention sites.

The State Deputy called on Brother Stephen Melancon General Insurance Agent to speak on the state of the insurance within the order. Brother Melancon gave a very moving speech titled, "Adapt or Die" and how it relates to insurance today and went on to explain how coming together as Knights in a Fraternal way to protect our Families.

At this point of the meeting we stopped to acknowledge Father John McShane drove up from Ely, Nevada just to visit and bring blessings to the attendees. Father Mc Shane spoke to the assembly in a very inspirational and always up lifting manner as always when he addresses any of our meetings.

Brother Steve Schiwart, Co-Chairman of the Silver Rose Program gave a very interesting talk on the programs that bring in membership. From his experience. Brother Tom Ball State Retention Chairman, gave his Report on Retention, explaining required forms for a successful council participation. DD George Minter gave a very inspiring add on for retention. DD Charles Reifsnyder stated the he sees the use of the Retention Requirement as unnecessary. State Advocate intervened with an explanation, State Deputy intervened with his explanation and reasoning. As always PSD Strait reports and insights on Ceremonials is always in lighting. Director Strait further explained the new Admission Degree Program and many more essential for ever degree.

PSD and Master of the Fourth Degree David Ryan gave a report of the fourth degree which has really flourished under his leadership in Nevada. Approximately three new Assembly's has sprang up since our last State Convention. With the success of the Fourth Degree in Nevada, we are somewhat saddened because this will be District Master Ryan last convention as Master in Nevada his term will end in a very few weeks.

PSD Ray Gardea and Chairman of the 365 Club, gave a report on the 365 Club yearly payouts and requirements. Chairman Gardea further stated the success of the Club since available fund maximum has been raised to seven hundred and fifty (\$750) dollars a year per member in need of financial assistance. Ceremony for 35 Unclaimed Veterans

For those who didn't attend today, FYI about two weeks ago I received a notice that there was going to be a service for 35 veterans whose remains were unclaimed and had been virtually forgotten. In some cases, their remains have been sitting on a shelf for as much as 40 years. One even dating back to WWI, they were never claimed by their families.

While I was advised this was not a request for the Knights or our Color Corps, it was suggested it would be nice if we could get some members to turn out for the service that was scheduled for today. When I sent out the notice, I must admit I was hoping for about 20 brothers to show up. Well my worthy Brothers, I know like all those who attended, we have a lot to be proud of, with the true representation of our 4th degree patriotic purpose, we had a showing of over 60 Knights with wives who turned out. THANK YOU!

I am attaching some of the general pictures that I took with my cell phone. I have others with member who turned out but the email limits size of attachments, and I'll send more to those in attendance. I hope this helps all to see what a great job they did.

I want to mention what a first-class service this was, quite moving and very respectful. Clearly, each of these men were not forgotten. The hearse was escorted from the Bunkers downtown to the Veterans cemetery by at least 40 Vets on motorcycles with large US Flags. When it pulled up the military on hand acted as pallbearers removing a flag draped casket and placing it alongside on the side walk. After removing and folding the flag, 35 members of the military honor guard representing the respective branch of service stepped up removed the erne from the casket and placed it on one of two long tables in the front of the viewing area that was set up under a large tent. After the service, gun salute, and taps, each erne was removed from the table by the honor guard and taken over to one 35 open niches and placed inside with the name of each announced.

I wanted to pass on a little more information of what some may have missed today as it appears Nevada has something like another 140 more unclaimed veterans yet to be laid to rest this year. So, stay tuned for other requests to attend such a service for the unclaimed Veterans.



FREQUENTLY ASKED QUESTIONS

1. I don't have time to join another organization; why should I join the Knights of Columbus?

eMembership was designed to allow eligible Catholic men to join the Knights of Columbus online, through a streamlined, optimized process. eMembership provides you with a digital membership experience, which will help you to grow as a Catholic man and a Knight.

As a Knight, you can choose the projects to be involved in within your own community. You will receive regular updates from your state council regarding news and events in your area and be presented with frequent opportunities to work alongside brother Knights in local councils.

2. What are the requirements to join the Knights of Columbus?

Membership in the Knights of Columbus is open to men 18 years of age or older who are practical (that is, practicing) Catholics in union with the Holy See.

3. What is a practical Catholic?

A practical Catholic accepts the teaching authority of the Catholic Church on matters of faith and morals, aspires to live in accord with the precepts of the Catholic Church, and is in good standing in the Catholic Church.

${\bf 4.} \ If \ I \ join \ online, \ am \ I \ joining \ a \ local \ Knights \ of \ Columbus \ council?$

No you are not. When you join online you will not belong to a local council at first. Instead, you will become a member of the Knights of Columbus **state division** in your state of residence.

5. Can I join a local council?

Yes! Council-based membership is the best way to experience the Knights of Columbus. Prospective members can join local councils just as they always have. eMembers can transition to local council

membership, just as members from other local councils may transfer today. Transferring involves completing a membership form (Form #100) and going through the council admissions process. This includes meeting with council leaders and taking the First Degree ceremonial.

6. How does eMembership differ from membership in a local council?

Members who join online ("eMembers") are members of the Knights of Columbus who have not yet taken a First Degree or been admitted to a local council.

As a member, like all members of the Knights of Columbus, you will have the right to purchase insurance on yourself, your spouse and any dependent children. You will receive Columbia magazine, the free accidental death benefit (age restrictions apply), and are eligible for participation in the family fraternal benefit. You may also attend select local and state council events which are promoted by your state division.

7. What are the membership dues/fees for members who join online?

eMembership dues are currently \$30.00 per year across all jurisdictions. Dues are paid online to the Knights of Columbus Supreme Council and they cover both the member's state and supreme membership fees. If a member transfers to a local council, the dues are pro-rated to that council. Debit cards and credit cards are accepted as forms of payment by the Supreme Council.

8. Why eMembership?

This pilot program for joining the Knights of Columbus is the result of several years of research and reflection by the Supreme Council, which engaged state and local council leaders, as well as prospective members, through surveys and focus groups. This process identified several membership goals, including developing a new way to introduce men to the activities of our Order that would strengthen and benefit all councils and members.

Withdrawal Procedure

The Supreme Council values the membership of every Brother Knight. It is through their involvement that we are able to provide the tremendous amount of charitable services that we provide annually to the Church and our communities. That is why every council should work to conserve any brother Knight who is considering withdrawing his membership by making personal contact with them to see how we can help them remain a Knight.

Realizing that at certain times in a person's life, membership in various organizations may not be a proper fit for them, we need to look at how we attempt to retain members seeking a withdrawal, while leaving the door open for them to want to return in the future when their circumstances change.

Effective July 1, 2018, instead of holding each withdrawal request received for a 60-day period, the Supreme Council will instead send the individual an acknowledgment letter from the Supreme Knight, letting them know that their withdrawal request has been processed. This letter will detail how the individual can rejoin the Order in the future should they wish to do so in either a local council or as an E-Member online. The State Retention Chairman will be copied in each of these letters so that the state is both aware of the withdrawal and so that reinstatement efforts can be pursued locally.

It should be noted that the above-mentioned change to the Membership Withdrawal Procedure in no way effects the Supreme Council's Proper Billing Procedure to retain members in arrears.

It is our sincere hope that this withdrawal acknowledgment letter will let these men know that the Order will miss their contributions to our good works and more importantly, that we look forward to the day when they once again join our ranks either locally or as an E-Member.
