The meeting was very informative covering Online Membership, Ethnic Development, Outreach to Middle Eastern Catholics and our State Associate Chaplain Fr. Gerry Grupczynski was able to join us as well as Brother Marty Yzaguirre the Hispanic Development Director from Supreme. The Past State Deputies banquet had attendance of over 90 people and included music and a fine time.

In February the State Officers met to review this current fraternal year progress, plan the remaining part of the fraternal year and discuss the upcoming State Convention. The retreat was held in Mesquite and the Mesquite council setup for us to participate in Mass with the parish. Our meeting was successful and allowed the State Officers to catch up on the open items and have some fraternal time together.

The meeting where held in Reno/Sparks and Las Vegas (at Our Lady of Las Vegas). The Las Vegas meeting also gave me an opportunity to attend the St. Jude Council car show. Out of the 11 District 9 District Deputies attended and 4 potential District Deputies attended. Of the councils a little less than half of the councils were represented but we hope that in the following year more will participate in planning meetings.

Worthy State Deputy, State Officers, State Council members, and Brother Knights,

Since the launching of the new formation degree in late 2016 we have been retraining formation team members and reestablishing the Formation Degree teams. The souvenir Carolingian Crucifixes have been popular among our members. Although we have embraced this new format, we have been slow to properly report the degrees using the Form 450.

We continue to need improvement in planning major degrees in advance. We need to improve participation by all districts. And we need to communicate better about upcoming degrees.

The degree formats and media are improving. The Supreme Council has issued a new version of the audio-visual material for our Knighthood degree. I can't go into detail; however, I can say that technology continues to advance, and the latest releases are in a Power Point digital format that is both easier to navigate and easier to hear and see.

As always reporting is essential for every degree. More so for the "Formation Degree" because the Supreme Council is committed to replenishing the Carolingian Crucifixes that are given to the candidates as part of the passage through the degree. The "Formation" degree Staff Coordinator is the designated recipient of the replacement crucifixes, so if the degree is not reported properly, the crucifix inventory will be diminished.

We are still learning, but we have a treasure of dedicated Knights who truly love ceremonial work. None of us are getting younger however, so we must continuously seek new talent among our younger and newer members.

In this fraternal year we have Knighted a considerable number of priests and deacons. Their comments have indicated a high level of appreciation for the lessons delivered. I have been always impressed with the dedication and sacrifice of Brother Knights in performing degree work.

Annual Disaster Chair Report

Worthy State Deputy, State Officers, State Council members, and Brother Knights,

The past year has been a difficult one across the United States of America relative to natural disasters and violence against law enforcement, the public, places of worship and education. My message over the years, first as the Sate Community Director (2013-2015) and later as the State Disaster Coordinator (2016-2018), has been encouraging councils to become active in their local Community Emergency Response Team (CERT). We never know when the unexpected will happen. We always have to ask ourselves the question; What if?

On November 11, 2017, the day of the First Baptist Church shooting in Texas, and the St. Alphonsus Catholic Church shooting in Fresno, California, I sent an email to 57 leaders within the Nevada jurisdiction. Two attachments accompanied that email; the Safety and Security Guidelines for the Diocese of Boston and the Emergency Management Plan for the Church of the Brethren (non-Catholic denomination). Both documents outlined the need and potential benefits of a church safety program.

Tempus fugit, so about two years ago while responding to a call at my home parish, local law enforcement suggested that the parish consider starting a safety team to address issues within the parish and problems in the area that might affect our campus. Two non-Catholic officers volunteered their time to help with an assessment and made a presentation on the active assailant. Working within the guidelines of the Diocese of Reno and the Catholic Mutual Group (insurance) my home parish has instituted a safety ministry which works with the Pastor to help insure an enhanced safety environment for the Church. The ministry's goal is to increase parishioner awareness relative to safety issues such as earthquake, fire, winter storms, parking lot awareness and crime, etc. Over the past five months a second safety/hazard assessment has been done which resulted in repositioning security cameras, adding cameras, identifying and addressing parking issues (including overnight parking), and instituting a roving patrol of the parish campus before Mass and/or special events. Many other aspects of the Safety Ministry have been instituted. It should be said that the acceptance by the parishioners has been questionable to very positive.

Although the core leadership of our program includes mostly brother knights (5 of 6) however, ours is not a KofC program. We invite all parishioners who have an interest in safety to participate in this ministry. Recently, 24 parishioners signed up for first aid training through a local provider which was arranged and promoted by the Immaculate Conception Safety Ministry (ICSM).

I did a short survey of parishes (10) in the Diocese of Reno recently addressing safety. I called the Parish Office and spoke to whoever answered. My question was simple. After introducing myself and my role with the Knights I wanted to know if that parish had a safety team which would address emergencies such as fire or earthquake.

The results were:

Yes: 3

No: 5

No Response 1 no response to phone or email messages

Other: 1 "I'm not sure but the Knights must be working

on something."

All the "Yes" responses were parishes that have active programs in place. Some others had discussed the need for a safety program but decided it was not the time or they just didn't need one. I have not followed up with the "Other" response. Again, I wanted to know what the person answering the phone for each parish knew. I didn't contact all the parishes in the Diocese, but it was a mix of large metropolitan and small rural parishes. While attending a small training session in April one of the attendees shared with me that he had recently conducted an assessment for one of the rural parishes not on my list. This would bring the yes responses to 4/11. Overall, a 36% yes rate would indicate, to me, that continued emphasis on having a program and education as to why and how to begin a program exists.

I encourage every council to talk with their Pastor about a safety program. If a program is active I would like to know more about it. I am willing to share our specific ICSM information upon request. Again, I stress this does not need to be a Knights only program but rather a parish-wide activity. If you know someone who is interested in starting such a program (who is not a knight) please encourage them to follow-through with their thoughts. I know many members of the Order within Nevada are safety minded and are willing to help when needed. The importance of having a team is to insure people "respond" to events based on best practice techniques and not be "reacting" to situations with a "what do we do now" thought process.








Star Council Incentive

Are you aware of the Star Council incentive from Supreme?

If a council reaches Star Council status, Supreme refunds their Supreme per capita. As an example, if they have 148 members x \$4.50, it would be \$667.

If they suspend 72 member they save 72 x \$18.50 or \$1,332 or they save \$665 vs getting Star Council.

If you suspend 10 and hit Star you save \$185 in per capita and are refunded \$667 with a cost of \$1,147 for the 62 remaining or \$480 cost for carrying them.

The amount over a few years turns into making money and the others may pay if you find out why they are not engaged in the Council.

Does Your Council Retention Chair Know Why We Are Losing Brothers to withdrawal?

Please find out why they wish not to pay the annual dues to be a Knight and wish to withdrawal. I am looking for answers so let's limit it to:

- 1. Not engaged with the council activities
- 2. No longer Catholic

- 4. Not engaged with the other council members
- 5. No value for your money
- 6. Don't have the money

Let's have the Council Retention Committee figure these questions out and send you the answers, so we can compile them and come up with a plan to address whatever the issue is.

Withdrawal Procedure

The Supreme Council values the membership of every Brother Knight. It is through their involvement that we are able to provide the tremendous amount of charitable services that we provide annually to the Church and our communities. That is why every council should work to conserve any brother Knight who is considering withdrawing his membership by making personal contact with them to see how we can help them remain a Knight.

Realizing that at certain times in a person's life, membership in various organizations may not be a proper fit for them, we need to look at how we attempt to retain members seeking a withdrawal, while leaving the door open for them to want to return in the future when their circumstances change.

Effective July 1, 2018, instead of holding each withdrawal request received for a 60-day period, the Supreme Council will instead send the individual an acknowledgment letter from the Supreme Knight, letting them know that their withdrawal request has been processed. This letter will detail how the individual can rejoin the Order in the future should they wish to do so in either a local council or as an E-Member online. The State Retention Chairman will be copied in each of these letters so that the state is both aware of the withdrawal and so that reinstatement efforts can be pursued locally.

It should be noted that the above-mentioned change to the Membership Withdrawal Procedure in no way effects the Supreme Council's Proper Billing Procedure to retain members in arrears.

It is our sincere hope that this withdrawal acknowledgment letter will let these men know that the Order will miss their contributions to our good works and more importantly, that we look forward to the day when they once again join our ranks either locally or as an E-Member.
