## Message from the State Deputy



Dear Brothers,

With over half the year gone we have brought over 125 new men into the Nevada Knights of Columbus. Unfortunately, we have suspended over 100 Knights that we were not able to engage for whatever reason. When you subtract deaths and net transfers Nevada is in the negative as of this point. I know that as a group we want to support the Church and the Order and are in the process of figuring out how to get all Catholic men not only to join but to engage them so they stay and help us to be the strong arm of the Church and continue to do all the great works the Knights do throughout the world. It is my belief that if we "Start by doing what is necessary; then do what is possible; and suddenly you are doing the impossible." - St. Francis of Assisi – we will be able to have over 10,000 Knights in Nevada. With 286,000 registered Catholic men in the state that would be 3.5% of the men who identify as Catholic. Like St. Francis I am sure that we can do the "Impossible" if we start by doing what is necessary. I know it is rough for the Church and the Order right now and that we are attacked from inside as well as outside.

With that in mind I would ask that you remember the words of Paul Harvey that "In times like these, it is helpful to remember that there have always been times like these."

Our online membership has already reached its goal for the year however we will keep asking men to join us online as it is a way, they can check us out and get information and some benefits while they consider joining a council.

It is my pleasure to work with you this year and last fraternal year and I look forward to great things for the Nevada Knights, Knights as an Order and the Church going forward.

### Nevada State Council Representatives – Delegate Credentials

*109<sup>th</sup> Annual Convention of the Nevada State Council, May 4-5<sup>th</sup>, 2019 – Fallon, NV*

**The Nevada State Council By-Laws Article II MEMBERSHIP, Section 1[a]** states "The membership of the State Council, with the right to vote, shall be composed of the Grand Knight and a Past Grand Knight, actually residing in the State of Nevada, from each subordinate council in good standing ....."

[b] "If there is more than one Past Grand Knight, the subordinate council shall elect the one to represent it in the State Council. A subordinate council having no Past Grand Knight may elect one of its Third Degree members in good standing instead, as a representative of said subordinate council in the State Council. Each subordinate council shall elect alternates, who are members in good standing in the Third Degree, for its representation in the State Council."

**Section 2 Credentials [b]** "The Financial Secretary of each subordinate council will prepare and certify the credentials of the subordinate council's delegates and their alternates on the blanks furnished and affix thereto the Seal of the Council. The Grand Knight will countersign the credentials of the subordinate council's delegates and their alternates and shall forward the copy thereof to the State Secretary at least three (3) weeks prior to the time of the Annual Meeting of the State Council and he will deliver the original thereof to the delegates and the alternates."

## 2019 Assisted Suicide Bill Nevada SB165

**This is to bring your attention to SB165, the doctor prescribed suicide bill** that is being rushed through the Nevada legislature. The bill provides that a person over 18 years of age may request a doctor to give a prescription designed to end his or her life, if there is a diagnosis of a terminal illness, and, in the opinion of two physicians, the person will live six months or less.

While people may view this bill as allowing for personal choice to end's one life, **there are consequences that could actually take away from patients their choice to sustain their lives or to seek further medical treatment.** For example, in states such as Oregon and California that have enacted doctor prescribed suicide, insurance companies have denied payment for potentially life-saving medical treatments, offering instead to pay for assisted suicide. What will be next? Will people with disabilities be similarly vulnerable to pressure to utilize the assisted suicide option over funding for necessary equipment or treatment? And will the elderly face a choice to take a deadly poison so as not to be a burden on family?

In addition, Suicide among teenagers is on the rise; what impact would this bill have on young people struggling with emotional issues or with persons battling depression or suffering from traumatic brain injury? And what about the message to our veterans, approximately 20 of whom, nationally, are committing suicide each week? Do we give up on them? SB165 will also increase the number of non-doctor prescribed suicide. Oregon is the proof that when doctor prescribed suicide is passed, general suicides will also increase. In Oregon, the general suicide rate has increased by more than twice the national suicide rate in the fifteen years since assisted suicide was passed.

Please go to the official website of the Nevada Legislature, and click on the 80<sup>th</sup> Session (2019). Scroll down to "Share Your Opinion with Your Legislators." On the Select Bill drop down, click SB 165; go to "Your Opinion on the Bill" and click on "Against", and then fill in the "Your Information" section.

If you do not have computer access, you can call (775) 684-6800, and tell the person answering that you want to share your opinion on a bill, but do not have internet access.

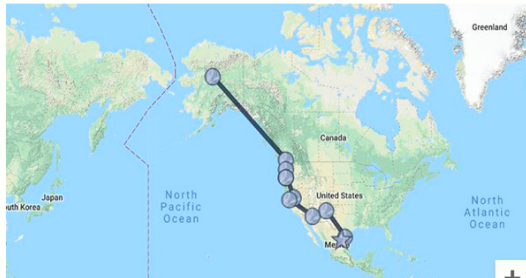
