Dear Brothers,

As a part of the new Faith in Action program and because I know the many good works the Knights of Columbus here in Nevada and around the world are doing I want to share a passage from chapter 7 of "**Dying to be Happy**" by Chris Stepien with you. This book is one of the books Dynamic Catholic gave me as a parish champion to share with my parish and the quote is

"Before you die, do you think the world will see another Mother Teresa? Could it be anyone you know? Will it be you? Why not? You'd be amazed what you can accomplish with God, if you're willing to do more than give lip service to your faith. The call to evangelize can seem overwhelming. But as we've seen, it begins with a single, brave step to walk the talk of the Gospel – and love Jesus by our actions- not just our words. As Christians, anything less is hypocrisy."

I hope that your experiences as a Knight and in life will give you

"compelling insights regarding those who Jesus speaks of, those who wear tattered clothing, the addicted, the sick and dying, the prisoner, the forgotten".

My hope is you will read this book and see in chapter 7 the many examples of professional athletes and others, some Catholic some not, that gave it all up to follow their faith and find strength for our journey in their actions. It includes a section on the founding of the Society of St. Vincent de Paul in 1833 due to a challenge in a college discussion about what the young Catholic apologist did other than talk about his faith. This direct question led him to seek to also put into action that which he said he believed previously by words alone. My purpose in sharing this with you is that I want the Knights of Columbus to cause this kind of transformational changes in the men they call Knights. Whether it is at the Admissions degree ceremonial or after 25 years of being a Knight or just before death I would love to know that the Knights of Columbus played a positive role in your walk with God and helped you put your Faith in Action.

Nevada this year has set our own goals higher to encourage inviting all our fellow Catholic men to join us in the Order. Nevada was one of the States honored with the Circle of Honor award and held our first ever hospitality room at a Supreme Convention after 108 years. I want to thank you men for all your hard work because it surly could not have been done without you.

You can access all the resource by visiting kofc.org/faithinaction directly or by clicking "Programs" once you visit kofc.org. Additionally, the Domestic Church section of the website has been updated to be foundational and supportive of Faith in Action. I hope that you enjoy this more streamlined website experience for programs and find the resources we've prepared, valuable.

Printed Resources:

We are finalizing the print versions of all 186 resources (in English) and have sent them to WebbMason (our print vendor) so they can begin the process of preparing them for print and ordering. The Supplies Online portal will be updated to reflect Faith in Action, allowing for greater ease of locating those resources. At this point, if councils are looking to order Faith in Action print resources the shipping of Faith in Action resources will be delayed. I will let you know once Supplies Online is ready.

Additionally, Councils will soon be able to order both the *Faith in Action Guidebook* (EN, FR, SP) for \$2.00 and the *Faith in Action Collection* for \$15.00, shipping included.

Alert Regarding Tax-Filing Company Soliciting Councils







As you are aware, the Internal Revenue Service requires that all Knights of Columbus councils, assemblies, and chapters in the United States file an annual informational tax return. For most councils, this should be a simple process of reporting annual income on either Form 990-N or Form 990-EZ. This past January we provided detailed instructions for complying with this legal obligation; that guidance is set forth below.

The purpose of this email is to notify you that an online tax-filing service, the corporate name of which is FILE990.ORG LLC, has been promoting its services to Knights of Columbus councils. This company charges \$39.95 for the mere filing of a completed tax return with the IRS, a transaction for which the IRS does not charge a fee. In other words, a council can file its own tax return directly with the IRS for free.

We have received multiple reports from members who received an email solicitation from info@file990.org, which they erroneously assumed came from Knights of Columbus headquarters. Accordingly, they used this tax-filing service and paid the \$39.95 charge to FILE990.ORG LLC. Although the text included in these email messages features the name "Knights of Columbus," this company is NOT affiliated with or endorsed by the Knights of Columbus. We encourage you to review the guidance set forth below so that your council can avoid spending money for an unnecessary service.

2017 Tax Information for KofC Councils and Assemblies

The purpose of this advisory notice is to remind councils, chapters, and assemblies in the United States of their legal obligation to file an informational tax return for the 2017 tax year, and to provide detailed instructions on how to comply with this obligation.

The Knights of Columbus, including all subordinate councils, assemblies, and chapters, (collectively referred to as councils) is a tax-exempt organization, recognized by the Internal Revenue Service as a fraternal benefit society under Section 501(c)(8) of the Internal Revenue Code. Notwithstanding our tax-exempt status, each council is required by law to file an annual informational tax return with the Internal Revenue Service.

Most councils will file the IRS Form 990-N electronic postcard (also known as the e-postcard). If your council's gross receipts are more than \$50,000 but less than \$200,000 and its total assets are less than \$500,000, you will need to file a Form 990-EZ. If your council's gross receipts are more than \$200,000 and its total assets are more than \$500,000, you will need to file Form 990.

What's New

Effective February 29, 2016, the IRS launched a new website for submitting Form 990-N (e-Postcard). Please refer to the Where to file section of this memo for more information.

Deadline to file annual return (all forms)

Each council must file its own tax return; there is no group or consolidated Form 990 filing. The returns must be filed by the fifteenth day of the fifth month following the end of the council's annual accounting period. For example, if your council's accounting period ends December 31, you must file a tax return by May 15 of the following year; if your council's accounting period ends June 30, you must file a tax return by November 15.







Alert Regarding Tax-Filing Company Soliciting Councils (continued)

Need more time to file a Form 990 (paper forms only)?

Extensions are not available for Form 990-N (e-Postcard) filers. Extensions are only available to paper filers (990EZ or 990). If you need more time to file the informational return, you must file a request for an extension at least one month before the due date. For example, if your council's accounting period ends December 31, you must file a request for an extension no later than April 15; if your council's accounting period ends June 30, you must file a request for an extension no later than October 15. Federal law imposes a penalty of \$20 per day, up to a maximum of \$10,000, for incomplete or late filings, unless you can show reasonable cause. You may download the form for requesting an extension from the IRS website:

Where to file

Effective February 29, 2016, the IRS launched a new website for submitting Form 990-N (e-Postcard) filings. The Form 990-N (e-Postcard) can only be filed online and you may do so by using the link below. All new users must complete a onetime registration even if you were previously registered under the old system. You will also have to register if you lost your previous sign on and password. However, if you registered and filed last year, you will not need to register again.

If the IRS website will not allow you to file a Form 990-N

If the council EIN number has been revoked for failing to file for three consecutive years, has recently been reinstated with the IRS, or is a new council, the filing system may not allow you to file a 990-N. A council cannot file a Form 990-N unless it is on the Supreme Council's Group Exemption List, which is updated annually by the Knights of Columbus Legal Department. If you are unable to e-file, please contact the Legal Department by email at tax.ein@kofc.org. You can also contact the IRS customer service at 1-877-829-5500.

Conclusion

In addition to the annual filing requirement, each council is also responsible for conducting its affairs in a manner that is consistent with what is expected of tax-exempt organizations. Failure to do so may result in a council losing its tax-exempt status.
