



Brother Knights,

Scheduling conflicts with Assumption High School have resulted in changed dates for both the State and Milwaukee Archdiocesan Knowledge and Free Throw Contests. The State Contests will be held at Wisconsin Rapids Assumption High School on Saturday, March 11, 2017. Free Throw registration will be 11 AM-Noon with competition starting shortly after Noon. Math and Spelling registration will be 11:30 AM-12;30 PM with competition starting shortly after 12:30. All contestants will need completed orange travel cards and all Free Throw contestants also need their own basketball for practice. Anyone who'd like to volunteer to help with either contest should contact Former Master Ron Shymanski (715-423-0939), State Knowledge Contest Coordinator Randy DeMars (715-271-4157, 715-832-1639) or me (262-633-7887).

As I stated last month, remember that your History Books were due to your District Deputy before February 15. Your Supreme Service Program Award Applications are due to State Office or me by March 1. These are for your best programs in the areas of Family, Youth, Council, Church, Culture of Life and Community. Be sure to include good documentation, pictures, supporting evidence; preferably in a binder or folder. I have received quite a few that are only the 1 application page and nothing else – no chance you will win a State or Supreme award with that presentation!

In February-March, you should be planning and carrying out your Order Wide Church Drives (March 11-19). Food for Families programs (40 Cans for Lent) should be ready to go. Supreme's Order Wide Council Admission Degree Drives Week is March 20-26 so you should have a Degree scheduled for timeframe. Council Outreach Week in honor of Fr. McGivney is March 27-April 2 (Founder's Day is March 29) should be when you plan to run one of your best Charitable Outreach Programs in the community, maybe a final push to sell Charity Raffle tickets, a Habitat for Humanity or Special Olympics or other service project, etc. Get your plans set now! Sites for your ID Drive should be in Process of being set. RSVP candidates being arranged, State Convention reservations being made, participation in the State Bowling Tournament; so much that we can and should be doing here in February and March!

And again, there's the bigger picture. I hope you're all working hard and with your DDs on a monthly basis to: 1) check your progress on the road to Star Council - get those new Associate and Insurance members in now. Work with your GAs and FAs to do so. 2) Check your progress toward the Columbian Award. Start filling out the form this month and add to it each month as projects are completed. 3) Remembering that 4 of those programs listed on the Columbian Award application this year must be Building the Domestic Church Initiative programs, how are you doing in this area? Have you already completed 4 or at least some of them? Are you meeting this area? Have you already completed 4 or at least some of them? James R. "Jimmy" Stachura Jr. June 15, 1986 - February 11, 2017

Wisconsin State Council and the Knights as a whole lost General Agent, Brother Knight Jimmy Stachura Jr. this month. I would like to share part of a letter I recently received written to Jimmy's father. The letter is from a wife of a Knight living in Merrill Wisconsin.

"I write to you with deep, deep condolences about the sudden death of your son this past week. I have been profoundly effected by the news so I would like to share with you a story with you, if I may.

Jimmy was our KC insurance agent for the last 5 years. We had him in our home at least once or twice a year. We always had the Pulaski connection with him even though we lived in Merrill. He was the nicest and most joyful, intelligent guy a person could know. We always looked forward to his visits. His sudden death has had a profound, I mean profound effect on me since I found out on Sunday morning from my brother. My weekly holy hour in front of the Blessed Sacrament was on Monday morning of this week. I prayed the Divine Mercy Chaplet, then the rosary for the repose of his soul and sat there in bewilderment wondering the state of his soul. I prayed in tears that God had mercy on him, and then I felt Jesus spoke to me:

"Tracy, I saved Jimmy's soul, but you have to have as many Masses said for him as possible."

So I'm spreading the word to you, and I hope you spread it to all you know. I'm not a mystic by any means, and rarely hear Jesus give me a message in my heart, but he planted a message this past Monday morning to bring me comfort and to pass the message on to your family. Let's storm heaven with Masses for years to come for Jimmy's benefit. It is

most precious gift we can give him right now."

Jimmy's service to the Knights and their families are testament of Father McGivney vision of the Knights of Columbus, please keep Jimmy in your prayers.

Wisconsin K of C State Charity Raffle

The Charity Request Form has been updated to improve granting of money which is raised by selling raffle tickets. You will find the new form on the State web site in the Forms area. Please download this new form!

As the State Charity Committee and the State Officers review every application, we look for many factors, but two key items are what is the debt and what is the need. Debt is often confused with what the bills total up to. For example, a \$100,000 house may burn down and the loss is \$100,000 plus the value of the contents, but if it was insured, the debt is much less. So, debt is not the same as bills. Need is how much they can't afford. If they have cash or other assets to pay the bills, then there is less need.

If the Knights had all the money that was asked for, we would not have to make the hard decisions of who gets how much. The fact is that the amount requested is 5 or more times the amount that is available. The changes to the form ask about "uninsured debt", whether financial assistance is being provided by extended family, and whether they can absorb the debt through home equity or retirement savings. These are hard questions to ask but if they are asking for money, you need to verify that they are truly in need. I have been in long conversations with fellow knights who have interviewed those in need and filled out the form. In one case, the couple had terminal They sold all their toys and were using illnesses. retirement income to pay for medical treatments. That is exactly what they were suppose to do. They hoped to have a long retirement free of illnesses so that they could

travel but that was not the Lord's plan. We gave them less than someone else who had a greater need. I have yet to have a Knight disagree with this argument, but certainly there has been both understanding and disappointment.

Other set of changes to the form ask about the council's involvement: how much cash was provided and whether a benefit will be held. They are meant to challenge your council to be as involved as you can be.

Lastly, I refuse the end negatively, so consider this: Isn't it truly amazing that the Wisconsin KofC's have this amazing fund? It certainly is. Hear! Hear! to the 1974 Knights who created it and Hear! Hear! to you Knights who sale raffle tickets that is the lifeblood of the Wisconsin Charity Fund! Please start to use the new form on the web site!

Advisory Notice

Brother Knight:

The purpose of this advisory notice is to remind councils, chapters, and assemblies in the United States of their legal obligation to file an informational tax return for the 2016 tax year, and to provide detailed instructions on how to comply with this obligation.

As you know, the Knights of Columbus, including all subordinate councils, assemblies and chapters (collectively referred to as councils), is a tax-exempt organization, recognized by the Internal Revenue Service as a fraternal benefit society under Section 501(c)(8) of the Internal Revenue Code. Notwithstanding our tax exempt status, each council is required by law to file an annual informational tax return with the Internal Revenue Service.

Most councils will file the IRS Form 990-N electronic postcard (also known as the e-postcard). If your council's gross receipts are more than \$50,000 but less than \$200,000 and its total assets are less than \$500,000, you will need to file a Form 990-EZ. If your council's gross receipts are more than \$200,000 and its total assets are more than \$500,000, you will need to file Form 990.

What's new this year

Effective February 29, 2016, the IRS launched a new website for submitting Form 990-N (e-Postcard). Please refer to the Where to file section of this memo for more information.

Deadline to file annual return (all forms)

Each council must file its own tax return; there is no group or consolidated Form 990 filing. The returns must be filed by the fifteenth day of the fifth month following the end of the council's annual accounting period. For example, if your council's accounting period ends December 31, you must file a tax return by May 15 of the following year; if your council's accounting period ends June 30, you must file a tax return by November 15.

Need more time to file a Form 990 (paper forms only)?

Extensions are not available for Form 990-N (e-Postcard) filers. Extensions are only available to paper filers (990EZ or 990). If you need more time to file your council's informational return, you must file a request for an extension at least one month before the due date. For example, if your council's accounting period ends December 31, you must file a request for an extension no later than April 15; if your council's accounting period ends June 30, you must file a request for an extension no later than October 15. Federal law imposes a penalty of \$20 per day, up to a maximum of \$10,000, for incomplete or late filings, unless you can show reasonable cause. You may download the form for requesting an extension from the IRS website.

Where to file

Effective Feb. 29, 2016, the IRS launched a new website for submitting Form 990-N (e-Postcard) filings. The Form 990-N (e-Postcard) can only be filed online and you may do so by clicking here. All new users must complete a onetime registration even if you were previously registered under the old system. If you registered and filed last year, you will not need to register again.

You can also access the IRS Form 990-N Electronic Filing System (e-Postcard) User Guide.

All paper returns should be sent to: Internal Revenue Service Center Ogden, UT 84201-0027

The website will not allow me to file a Form 990-N

If your council has recently been reinstated with the IRS or if your council is a new council, the filing system may not allow you to file a 990-N for your first year. A council cannot file a Form 990-N unless it is on the Supreme Council's Group Exemption List, which is updated annually by the Knights of Columbus Legal Department. If you are unable to e-file, please contact the Legal Department by email at tax.ein@kofc.org.

Forms and Other Information Available on IRS Website

Forms 990-EZ and 990 are available in the forms directory on the IRS website.

We suggest you visit the <u>IRS home page</u> for tax-exempt organizations. It is an excellent resource for council officers who have questions or need information regarding their federal tax obligations.

We also suggest you visit the <u>IRS web page</u> explaining the annual electronic filing requirement for small exempt organizations.

More information is also available on the <u>Knights of Columbus website</u>. Sign in under Officers and click on the "Forms" tab. By clicking on the icon next to "Form 990 Information" you will access a detailed memorandum on tax compliance, along with attachments.

Conclusion

In addition to the annual filing requirement, each council is also responsible for conducting its affairs in a manner that is consistent with what is expected of tax-exempt organizations. Failure to do so may result in a council losing its tax exempt status.


We have the schedule for the 2017 Silver Rose. We are again on Route 3 which starts in Manitoba on 5 March 2017.

- 3) Uniformity. What one team does is the same as all the other teams do.



In my last newsletter article, I indicated that I would be offering tips or ideas on how to make sure your Degree teams perform the best that they can. My first tip is . . .

PRACTICE. It does not matter if you have your part memorized or you read your part, you must practice. This should be done individually and as a team. If your team has not performed a Degree for 2 months or more, then you owe it to the candidates, to have a practice before the next scheduled Degree. If you team has not performed for an extended period of time, maybe having a couple of practices would be the right thing to do. Yes, you owe in to the candidates, but also, you owe it to your fellow team members. A practice is also a good opportunity to bring in new members and have them rehearse their part. Please, please, please, do not "throw" a team together, at the last minute just to "get it done". That is not fair to the candidates.

All the tips I will be discussing through these articles will try to improve the image of your teams as if through the eyes of the candidates.



SIMPLE SUPPER & STATIONS

Councils should partner with their parishes to sponsor a "Simple Supper & Stations" on Fridays during Lent. If your parish already prays the Stations of the Cross, ask your pastor's permission to serve a simple supper of meatless soup and bread to parishioners and attendees before or after the stations. This provides a communal opportunity for participation in the traditional Lenten observances of fasting and abstaining from meat. If your parish doesn't already pray the Stations together, ask your pastor if he would consider adding both the suppers and Stations to the parish calendar.

The prayers, mediations and hymns for Stations of the Cross can be found in The Way of the Cross: Traditional and Modern Mediations (<u>#363</u>), available online at <u>kofc.org/cis</u>. Copies can be ordered at knightsgear.com.


