

The Fortnight for Freedom: The United States Conference of Catholic Bishops has begun its fourth annual observance of the Fortnight for Freedom to raise awareness of threats to religious liberty. This year's theme is "the freedom to bear witness."



Supreme Chaplain Archbishop William E. Lori, Chairman, Ad Hoc Committee for Religious Liberty

Archbishop William Lori of Baltimore opened the fortnight at a June 21 Mass celebrated in the Basilica of the National Shrine of the Assumption of the Blessed Virgin Mary.

Recalling the Coptic Christians who were slain in Libya, he preached that "we should be inspired by their courage and renewed in our resolve not to let religious freedom in our country [or] be compromised by degrees until it all but disappears from our society."

"Religious institutions in the United States are in danger of losing their freedom to hire for mission and their freedom to defend the family," Archbishop Lori continued. "Endangered is the freedom of Church ministries to provide employee benefits and to provide adoptions and refugee services in accord with the Church's teaching on faith and morals.

"It is one thing for others to disagree with the Church's teaching but quite another to discriminate against the rights of believers to practice our faith, not just in word but in the way we conduct our daily life, ministry and business," he added.

Prayer for the Protection of Religious Liberty

O God our Creator, from your provident hand we have received our right to life, liberty, and the pursuit of happiness. You have called us as your people and given us the right and the duty to worship you, the only true God, and your Son, Jesus Christ. Through the power and working of your Holy Spirit, you call us to live out our faith in the midst of the world, bringing the light and the saving truth of the Gospel to every corner of society. We ask you to bless us in our vigilance for the gift of religious liberty. Give us the strength of mind and heart to readily defend our freedoms when they are threatened; give us courage in making our voices heard on behalf of the rights of your Church and the freedom of conscience of all people of faith. Grant, we pray, O heavenly Father, a clear and united voice to all your sons and daughters gathered in your Church in this decisive hour in the history of our nation, so that, with every trial withstood and every danger overcome—for the sake of our children, our grandchildren, and all who come after us—this great land will always be one nation under God, indivisible, with liberty and justice for all. We ask this through Christ our Lord. Amen.

All this happened while I was there praying, and I didn't even know it. Dan said, "I forgot to ask you to go, but God took care of that for me."

“The matrimonial covenant, by which a man and a woman establish between themselves a partnership of the whole of life, is by its nature ordered toward the good of the spouses and the procreation and education of offspring.” (1601)

“The intimate community of life and love which constitutes the married state has been established by the Creator and endowed by him with its own proper laws. . . . God himself is the author of marriage.’ The vocation to marriage is written in the very nature of man and woman as they came from the hand of the Creator. (1603a)

“Since God created them man and woman, their mutual love becomes an image of the absolute and unfailing love with which God loves man . . . And this love which God blesses is intended to be fruitful and to be realized in the common work of watching over creation.” (1604)

Brothers,

As we bring our 2014-15 Fraternal Year to a close, I want to thank all of you for the strong efforts you've put in over the last 12 months to strengthen both your Councils and our Honored Order! To those Councils who've done well this year in membership growth and insurance member additions, congratulations. Keep up the good work next year. To those Councils who recruited few or no members this past year, I challenge you to make every effort to do better in 2015-16! Remember, Star Council and Complete Council should be the goal of every Council.

Be sure that you have your Columbian Award, Food for Families, RSVP and Roundtable Report forms in to Supreme with copies to Tim Genthe, your DD, and your Diocesan Program Coordinator and/or me. Again, you're better off to scan and e-mail them rather than just sending them directly off the computer. Sending the copies can help to assure that you get proper credit in case of some error. You can also send in your 185s and 365s for 2015-16 as soon as your election is held and your Service Personnel are chosen. You should not wait until the July 1/August 1 deadlines to get them in.

Once that is accomplished, you should also immediately start planning your programming for 2015-16! Of course, it's important to finish 2014-15 strong, but we also need to start off 2015-16 strong! I've just returned from Dallas and the annual meeting of State Secretaries/Advocates, Membership and Program Directors. **There they continually stressed how very important it is for Councils to be strong and active in July, August and September – not to “take the summer off!”**

It was also repeatedly emphasized that Councils need to try new things/programs, not fall into the rut of the same ole same ole. That leads to complacency, stagnation; it also tends to become boring and irrelevant for many members! **You need to be open to new ideas and new leadership**, especially from your younger members!

So, if you are usually active during the summer, great. If not, break that tradition! Plan some family friendly activities for the summer months (picnic or BBQ, outing to a ball game or water park, trip to the beach, Knights Out With Their Ladies, etc.). Plan to do some charitable work (Habitat for Humanity, blood drive, work at the pantry or homeless shelter, help the scouts or at a youth camp, organize a group to help the elderly or disabled with yardwork, etc.). Plan a church/Council based function (Corporate Communion, Brat Fry, help out at the parish festival in a major way, help Father with some project(s) for the parish, etc.). And, of course, do some recruiting and 1st Degrees. Be visible in your parish and community. Invite parishioners and prospects to participate in these programs. The, have information on your Council and the Order there, especially with the new Form 100s and ask them to consider joining!

In conclusion then, I challenge you to get together soon, use those Fraternal Planners you've received for 2015-16. Plan out that calendar of activities for the summer months and for the year! Conclude this year and start off the next Fraternal Year strong! You'll be glad you did.

Charity Raffle - Council Charity Fund Request Form

There have been questions by councils on how to fill out the Council Charity Fund Request Form.

We raise funds through our State Charity Raffle. Those funds must be used for charitable purposes as stated in our Mission Statement which in part reads: “will help alleviate sorrow, ease financial burdens and restore hope to families and victims of accidents and illness. This fund will also be the source of funding for vocations.” Since the State Council returns 65% of the net charity funds raised back to the Local Councils to use for their local charity needs, the State Council must verify that funds returned to Councils from the State Charity Raffle are indeed being used for charitable needs.

The Grand Knight receives this form in his state convention packet which should arrive in January. He should take this form to his next officers meeting and fill it out with his Financial Secretary and Charity Chairman. Once completed and signed he should send it to the state office. Taking care of the form in this manner will assure that the State Office has it by the May 1st due date. The Amount Requested seems to be puzzling to some councils. We suggest that you use the amount you received the year before or you can enter the amount that you listed as to where you distributed the charity funds you received last year. You council should have a separate charity bank account, but if you do not, you need to show that you keep those funds separate from your general operating funds.



2015 Helping People with Intellectual Disabilities



The 2015 Helping People with Intellectual Disabilities is nearing the finish line and many councils have done an outstanding job.

The Diocese of Madison has already surpassed their 2014 total going into June. Three of the four remaining diocese are in good shape to increase their collection amounts in 2015 and as a state the numbers should be close to previous years. Below are some councils who did exceptionally well, broken down by diocese.

5 Councils were able to break the \$10,000 mark. Green Bay: 3955; LaCrosse: 1069; Milwaukee: 664, 1964, 3702.

14 councils were able to collect over \$1000 more in 2015 than in 2014. Green Bay: 719, 2836, 6464, 11305;

LaCrosse: 1069, 1558, 3492, 4697; Madison: 1637, 1909; Milwaukee: 722, 973, 4106; and Superior: 1762.

5 Councils more than doubled the amount they collected in 2015 over 2014: Green Bay: 6464, 11305; LaCrosse: 10158; Milwaukee: 722, 4106.

25 more councils increased their collection by more than 30%. Green Bay: 719, 2836, 2984, 5008, 5382, 10260; LaCrosse: 3249, 3492, 4697, 6585, 10774, 12183, 12662, 12673; Madison: 746, 1637, 1864, 1909, 4416, 6151, 10893; Milwaukee: 1709, 5438; Superior: 1133, 2066.

We are sad to report Jim Neubauer died on Wednesday, June 3, 2015 at home surrounded by his family. Jim has been a member of the ID Committee since 1988, serving as the LaCrosse Representative. He also served as his councils chair and in 2014 his Cashton council collected \$79 per member. Jim was a great asset to the committee and the order. He will be greatly missed by all those who knew him.

The ID Committee has been served by a good solid group of men for the last several decades: Chuck Simmons 1986-2015 Committee Member and State Director; Ray Dufano 2002-2015 Green Bay; Jim Neubauer 1988-2015 LaCrosse; John Bednarek 1996-2015 Madison; Jim Krupski 2001-2014 Milwaukee; Morris Marsolek 1988-2015 Superior. These men have served our state very well in their positions to assist those with Intellectual Disabilities. The 2015-16 ID Committee will have a very different look with only one committee member having served before 2014. The July report will talk more about the new committee.

In August the ID Committee will begin seeking applications from organizations seeking funds from the Wisconsin Knights of Columbus Helping People with Intellectual Disabilities Committee. Twenty-five percent of the net of money raised through the Tootsie Roll Drive, is disbursed through the state application process.

The Committee is looking for a letter from the organization stating: who is seeking the funding, who do they serve, how many individuals do they serve, what are they seeking funding for, how much are they needing, will they be able to complete the project if we are unable to fully fund their request.

The organization must sign and mail in the application. The local council can assist an organization in applying for the money but the council cannot apply for the organization. Fifteen (15) copies of the application need to be mailed to: Knights of Columbus Intellectual Disabilities Committee, Attn: Mark Jelinek, 120 N Park St., Richland Center, WI 53581. Applications need to be received by November 20. All groups who apply will be notified by the Helping People with Intellectual Disabilities in mid-January of the Committee's decision.





'THE KNIGHTS OF COLUMBUS SAFE ENVIRONMENT PROGRAM'

As with any new program we are often times presented with there will be confusion, frustration, and changes. The Safe Environment program was rolled out last Fraternal year, many Grand Knights and youth directors within our jurisdiction have completed the obligatory training some have not and some still have questions.

Supreme has an excellent resource to answer most questions regarding the Safe Environment program though the Supreme Advocate Officer Desk Reference which can be accessed through Officer Online. Here is a small sample of what you can find under the Safe Environment tab.

What is the Knights of Columbus Safe Environment Program?

The Knights of Columbus has no higher priority than the safety and well-being of the young people served through its programs and activities.

The Knights of Columbus Safe Environment Program is designed to protect young people served through Knights of Columbus programs and activities, including the Columbian Squires Program, from all forms of abuse.

Councils participating in official Supreme Council programs and activities are required to comply with all policies and procedures of the Knights of Columbus Safe Environment Program.

Knights of Columbus Safe Environment Program requirements are in addition to all of the safe environment/youth protection requirements established by local dioceses and parishes.

Why does the Knights of Columbus maintain a safe environment program?

- As the world's largest Catholic fraternal service organization, the Knights of Columbus has a responsibility to maintain its own safe environment program across all of the dioceses in which it is active around the world. This means that the Knights of Columbus has a duty to ensure compliance with its own safe environment program policies and procedures, including training and background check requirements.
- The Knights of Columbus maintains the highest standards for the protection of young people across all of its programs and activities within all dioceses in which the Knights of Columbus is active.
- The program helps assure families, dioceses and communities that the Knights of Columbus has done everything within its power to safeguard the young people served through its programs and activities.
The program helps protect the good name and reputation of the Knights of Columbus.

Who administers the Knights of Columbus Safe Environment Program? Who may I call with questions and concerns about the Knights of Columbus Safe Environment Program?

- The Knights of Columbus Safe Environment Program is administered by the Fraternal Services Department of the Knights of Columbus in partnership with Praesidium, an international leader in youth protection.

All inquiries regarding the program should be directed to the Knights of Columbus Safe Environment Program Line at 203-800-4940 or youthleader@kofc.org

How can someone report a violation of the policies and procedures of the Knights of Columbus Safe Environment Program, or suspected abuse, to the Knights of Columbus?

- Policy and procedure violations and suspected abuse should be reported to the Knights of Columbus Safe Environment Hotline at 1-844-563-2723.

Who must comply with the policies and procedures of the Knights of Columbus Safe Environment Program?

- Every person serving in a Knights of Columbus sponsored youth program or activity is required to comply with the program. Councils participating in official Supreme Council programs and activities are required to comply with all policies and procedures of the Knights of Columbus Safe Environment Program.

What about officers and fraternal leaders who directly or indirectly serve young people through Knights of Columbus programs and activities? Do they require special training and background checks?

- Yes. Members holding certain Board-designated leadership positions (state deputies, grand knights, faithful navigators, state Squires chairmen, state youth directors, youth directors, Columbian Squires chairmen, Squires chief counselors and Squires committee counselors) are required to complete Praesidium's Armatus© youth protection training.

In addition, members in designated youth leadership positions (state Squires chairmen, state youth directors, youth directors, Columbian Squires chairmen, Squires chief counselors and Squires committee counselors) are required to undergo a background check.

Which youth leaders are required to complete Praesidium's Armatus© youth protection training and undergo a background check?

Members duly appointed by their grand knight or state deputy to the following Board-designated youth leadership positions are required to complete Praesidium's Armatus© youth protection training and undergo a background check:

Which officers must complete Praesidium's Armatus© youth protection training?

Members holding the following Board-designated officer positions are required to complete Praesidium's Armatus© youth protection training: * State deputies * Grand knights * Faithful navigators (if their assemblies sponsor a Columbian Squires Circle)

Must state deputies, grand knights and faithful navigators undergo a background check?

No, unless he also holds a Board designated Youth Leader position.

How do I access the online training?

- Members in designated leadership positions requiring Praesidium's Armatus© online youth protection training will receive a username and password via email or regular mail.

Will diocesan training or training completed through an employer or any other organization be accepted as a substitute for Praesidium's Armatus© safe environment and youth protection training?

- No. Members serving in designated leadership roles must complete Praesidium's Armatus© youth protection training covering policies and procedures particular to the Knights of Columbus Safe Environment Program.
- Knights of Columbus Safe Environment Program requirements are in addition to all safe environment and youth protection requirements established by local dioceses and parishes.
- As the world's largest Catholic fraternal service organization, the Knights of Columbus is responsible for maintaining its own Safe Environment Program across all of the dioceses in which it serves. This includes ensuring compliance with its own safe environment training and background checks.
- The Knights of Columbus Safe Environment Program training modules contain certain policies and procedures specific to the Knights of Columbus that cannot be found in any other youth protection training program.
- These policies and procedures set forth uniform youth protection standards for members of the Knights of Columbus throughout the world.

The policies and procedures of the Knights of Columbus Safe Environment Program allow the Order to maintain direct responsibility for the compliance of Board-designated youth leaders and officers with required training and background checks to ensure the safest possible environment for the young people participating in the programs and activities of the Knights of Columbus.

Will prior background checks run by the diocese, a school system or any other organization be accepted as a substitute for a Knights of Columbus background check conducted by Praesidium?

- No. Only a Knights of Columbus background check administered by Praesidium will be accepted. Due to privacy laws, the Knights of Columbus may not obtain, review or otherwise rely on background checks conducted on members by another employer or organization.
- Knights of Columbus Safe Environment Program requirements are in addition to all of the safe environment and youth protection requirements established by local dioceses and parishes.
- As the world's largest Catholic fraternal service organization, the Knights of Columbus is responsible for maintaining its own Safe Environment Program across all of the dioceses in which it serves. This includes ensuring compliance with its own safe environment training and its own background checks.

Wisconsin Knights of Columbus Notes

- Just as other youth-serving organizations require their own background checks before individual persons are allowed to lead and/or otherwise participate in such organizations' programs and activities, it is the policy of the Knights of Columbus to maintain its own original background check on file for all members who serve in designated youth leadership positions relating to the Order's programs and activities.

The policies and procedures of the Knights of Columbus Safe Environment Program allow the Order to maintain direct responsibility for the compliance of Board-designated youth leaders and officers with required training and background checks to ensure the safest possible environment for the young people participating in the programs and activities of the Knights of Columbus.

Where can I find Knights of Columbus Safe Environment Program policies and procedures?

- Most policies and procedures of the Knights of Columbus Safe Environment Program are readily available for review in three publications: Knights of Columbus Safe Environment Program Grand Knight and Faithful Navigator Handbook (#5095), Knights of Columbus Safe Environment Program Youth Leader Handbook (#5096) and Knights of Columbus Safe Environment Program Squire and Parent Handbook (#5094).

- These three Knights of Columbus Safe Environment Program handbooks have been provided to state deputies, grand knights and faithful navigators (whose assemblies sponsor Columbian Squires Circles).

The policies and procedures contained within these Knights of Columbus Safe Environment Program handbooks are also covered in Praesidium's Armatus© youth protection training.

Do I ever need to renew my training and background check?

- Yes, every two years. All members serving in designated leadership positions requiring Praesidium's Armatus© youth protection training and a background check are required to renew both their training and background check every two years for as long as the member continues to occupy the designated leadership position.




Father McGivney Prayer

Important Tax Information for KofC Councils and Assemblies

As you know, the Knights of Columbus, including all subordinate councils, assemblies, and chapters (collectively referred to as councils), is a tax-exempt organization, recognized by the Internal Revenue Service as a fraternal benefit society under Section 501(c)(8) of the Internal Revenue Code. Notwithstanding our tax exempt status, each council is required by law to file an annual informational tax return with the Internal Revenue Service.



Most councils will file the IRS Form 990-N electronic postcard (also known as the e-postcard). If your council's gross receipts are more than \$50,000 but less than \$200,000 and its total assets are less than \$500,000, you will need to file a Form 990-EZ. If your council's gross receipts are more than \$200,000 and its total assets are more than \$500,000, you will need to file Form 990.

Deadline to file annual return (all forms)

Each council must file its own tax return; there is no group or consolidated Form 990 filing. The returns must be filed by the fifteenth day of the fifth month following the end of the council's annual accounting period. For example, if your council's accounting period ends December 31, you must file a tax return by May 15 of the following year; if your council's accounting period ends June 30, you must file a tax return by November 15.

Need more time to file a Form 990 (paper forms only)?

If you need more time to file your council's informational return, you must file a request for an extension at least one month before the due date. For example, if your council's accounting period ends December 31, you must file a request for an extension no later than April 15; if your council's accounting period ends June 30, you must file a request for an extension no later than October 15. Federal law imposes a penalty of \$20 per day, up to a maximum of \$10,000, for incomplete or late filings, unless you can show reasonable cause. The website will not allow me to file a Form 990-N

If your council has recently been reinstated with the IRS or if your council is a new council, the filing system may not allow you to file a 990-N for your first year. A council cannot file a Form 990-N unless it is on the Supreme Council's Group Exemption List, which is updated annually by the Knights of Columbus Legal Department. If you are unable to e-file, please contact the Legal Department by email at tax.ein@kofc.org

Conclusion

In addition to the annual filing requirement, each council is also responsible for conducting its affairs in a manner that is consistent with what is expected of tax-exempt organizations. Failure to do so may result in a council losing its tax exempt status.
