



Chaplain's Message

The colors of fall have been fantastic. I love watching how the trees turn color. It is also a bit sad to see the colorful leaves fall. I often times find myself wishing the fall winds and rain showers would just hold off another couple of weeks. And all too quickly we are left with the stark tree limbs lined against the blue sky. We who live in this part of the country where we have the advantage of seasons can see God's plan in His creation. We move through our lives in tune with the seasons. We see ourselves in the spring of life, full of vigor and vitality. We revel all summer long. We dress ourselves in the color of our memories in the fall. We accept the coldness of our stark winters. As a priest, I see families move through their seasons of change. The young couple, in the springtime of their lives, starts their family. The busyness of summer as families with children juggle jobs, soccer practice and church. The older couple, enjoying the fall of their lives, remembers and helps their children in coloring the lives of their grandchildren.

It is so timely that Pope Francis has called the World Meeting of Families during this spectacular season of color. Not only do we need to look at marriage and families but the vocations for all people. We pray for vocations thinking primarily of the priesthood, which is very good and very necessary, but we need to pray for our marriages which are under great spiritual attack. The evidence of this spiritual warfare is evident in the number of divorces and one parent families in our parishes today. Another piece of evidence is how the secular world is trying to redefine marriage, leading us away from the Biblical definition of this sacrament. We are becoming a society that defines everything through material, earthly terms when we should all realize that we were made for something more. Our home is to be a spiritual home. And if we accept that teaching then we need to be more diligent in understanding how we see this material world through spiritual eyes; wisdom given us by turning to our Lord in and through faith and trusting in His Goodness.

(State Deputy continued) Once again, if you are reading this, you are being called to a practical action to change the culture of our retention committees by helping them to call every Brother Knight twice a year; once on their birthday and once on the anniversary of their First Degree exemplification. Clearly, to maintain our Vocation to Fraternity in a practical way requires us to, on a personal level, keep the lines of communication open with our brothers to: 1) find out if they are OK; 2) ask if there is anything we can do for them; 3) let them know that their human dignity is respected (birthday call); and 4) that they are valued just as much today as the day they were exemplified into the First Degree of our Order (anniversary call).

If the prophetic vision of Saint John Paul II is to be trusted, we must act, and this simple action of maintaining our relationships with our brothers will bear great fruit. We need them. We need their prayers. Prayers are powerful!

(Chaplain continued) I try to imagine how Fr McGivney would view our families today. Cultures have changed so much, but one point is still important. We need to have our men be the Christian leaders in their families. As in Fr McGivney's day, they need to be the bread winners providing daily support but also looking to the future of their families.

Have you taken time to think how you will provide for your grandchildren?

Fr McGivney's vision carries on today in many ways. What has changed is the pressures and stress on a young man just beginning his family. We no longer have families living in one location where a young man can draw upon the wisdom of his father and grandfather. Families relocate all too often losing critical family ties. I wonder if the Knights could not be those mentors so desperately needed. Picking up on the call of Fr McGivney for a fraternal organization, can we not be there for these young married men? It would be a ministry of more than just offering advice but offering a ministry of presence. We can lead by example, step in with charity when needed, standing in solidarity, being with these young families just starting out. I also encourage all of you to consider the program endorsed by the Knights of Columbus known as "That Man Is You!" A program set up to teach men the teachings of the Catholic Church and to draw upon the wisdom of the greatest fathers of our faith, our Saints. No matter what age you are, this program will give you insights into changing our society and transforming our culture. You can do it! You can be Christ's hands and feet.

October brings so many programs that you should be working on - Lifesavers for Life, Culture of Life Essay Contest, Coats for Kids, Food for Families, etc. Your Punt, Pass, Kick and Soccer Competitions should be completed. I hope that you all have conducted a Charitable Service Program this month, a Church Drive and a 1st Degree! Your WRAP reports are due to your DD by month's end! Remember that every program is a chance to invite prospects/non-members to participate and, thus, a chance to increase your membership!

EVERY COUNCIL SHOULD BE A STAR COUNCIL which means 1 MEMBER PER COUNCIL, PERMONTH!

We can do this if we all work together!

Remember that the State Punt, Pass, Kick and Soccer Challenge will be on Saturday, November 1 at Columbus High School in Marshfield, 710 S. Columbus Ave. Registration/practice will be 10-11 AM with competition starting at 11 AM.

You should already be planning your Christmas Poster, Light Up for Christ, Keep Christ in Christmas programs as well as March for Life, Knowledge and Free Throw Contests, Corporate Communion, etc.

For this month, I'd like to focus on 1 of the 8 featured Supreme programs for 2014-15: Coats for Kids. Councils can purchase new children's coats from the Supreme Council for a good price or they can collect "gently used" coats from Knights and parishioners or purchase coats from a local store at a good price for distribution to needy kids. This program not only fills a vital community need, it's also an excellent way to build comradery among members and prospects! Seeing the joy that a new winter coat brings to a child (and their family) will help prospects to see the Knights as an organization they want to be part of! (I know - I've seen it!)

- So,
- 1) Make Coats for Kids a project for the entire parish or community.
 - 2) Assess the need in the community. Pastors and (Catholic) school principals can be excellent resources in identifying children who'd benefit from this program; also councilors and social workers, homeless shelters, etc.
 - 3) Determine how much of the need the Council can meet. For 2014-15, coats can be purchased from Supreme for \$220/case (12 coats in each case).
 - 4) Use Council funds or conduct targeted fundraisers to purchase needed coats! Councils or parish coat drives are great ways to supplement those purchased.
 - 5) Purchase the coats using the form on www.kofc.org/coats.
 - 6) Schedule a distribution date/time/location. Parish halls, school gyms or Council homes are good sites.
 - 7) Secure manpower; invite the entire Council/parish community to participate.
 - 8) Publicize the distribution among the recipients and local media.
 - 9) Host a "thank you" or "open house" reception for all volunteers who gave of their time and talent.

Let all, especially new members, know how much their efforts are appreciated! Let prospects know they're welcome and needed in your Council; then ask them to join!

Any Council that conducts a Coats for Kids Program and meets the minimum (8 cases/96 coats donated) participation requirements receives full credit for all Columbian Award Youth Activities requirements.

In conclusion, remember to use your Fraternal Planners and to read your Columbia Magazine monthly, especially pages 18-19 in the October issue which introduces Supreme's new "Building the Domestic Church" initiative with great information for families today!

This month, we are going to look at **HOW** it can be celebrated. Here are some ways to celebrate the event.

- Hold the outside and inside doors open and greet parishioners as the walk in
- Lead the rosary
- Read the readings
- Sing in the choir
- Distribute wine and communion
- Lead the congregation in the Our Marriage Prayer near the end of the mass
- Distribute Our Marriage Prayer materials after mass

It is recommended to start out by having the Our Marriage Prayer put in the bulletins for each of the parishes you support and have an announcement made in church. This provides a basic level of support without needing any knights involved at the event.

But in order to fully celebrate the Our Marriage Prayer event, having knights get involved doing any of the additional methods above only enhances the impression left on the congregation. The more knights that can be involved, the higher the recognition that the council cares deeply about the marriages and families within their church.



2014-2015 CHRISTMAS POSTER CONTEST

All students in Grades 1 – 4 in private or public schools or who are home schooled are eligible to submit entries. (Grades 5 & 6 may be included but only at the council level.)

Admittedly the theme “The True Meaning of Christmas” results in numerous scenes of the Holy Family in the stable. While this may compromise originality, a manger scene of high artistic quality will certainly catch the eye of many judges. Past winning entries have focused on the Baby Jesus, the Madonna and Child, or the Magi on their journey to Bethlehem. Others emphasized family gatherings, a country church on Christmas Eve, Peace on Earth or incorporated Christmas carols.

COUNCIL LEVEL

December 1st to December 15th Several councils recommended that the contest should begin after the First Sunday in Advent rather than before Thanksgiving. This later starting date corresponds with the season of Advent and makes the contest more timely!

Please use the official Identification Label found in the Wisconsin Book or on the KC web site. Be sure to fill in the COUNCIL and DISTRICT NUMBERS and the DIOCESE. Only FIRST PLACE WINNERS at the council level are eligible for Diocesan competition. Grand Knights/Contest Chairmen must record the winners’ names and the number of entries at each grade level on the official poster contest report forms or on your own spread sheet. Send them to the Diocesan Program Coordinator by Dec. 30, 2014. This later deadline enables councils to display their posters at Christmas parties, or other venues if they wish.

DIOCESAN LEVEL

Diocesan Program Coordinators are obliged to send their 1st and 2nd place winners along with the DIOCESAN total number of council participants at each grade level to the State Poster Contest Coordinator by January 15, 2015. Diocesan awards should be mailed to the winners and the results should be sent to each District Deputy to be forwarded to participating councils.

STATE LEVEL

The 12 winning posters will be displayed at our 2054 State Convention. State awards and these posters will be mailed to each winner.

From the Desk of State Advocate - Jack Wrbanich **Warning: Not Protecting our Brand is Killing your Council**

What is "Branding" and should you be concerned?

Business defines *Branding* as "The process involved in creating a unique name and image for a product in the consumers' mind, mainly through advertising campaigns with consistent theme. Branding aims to establish a significant and differentiated presence in the market that attracts and retains loyal customers."

Chris Joseph from Demand Media describes successful branding as taking on "the form of a recognizable symbol to which consumers easily identify, such as a logo. Common examples include the Nike "swoosh," the golden arches of McDonald's and the apple used by Apple Computers. Logos typically appear on all products in some form and are used in advertising and promotional campaigns. The most successful symbols allow consumers to identify a product or company even if the name is not visible."

Does successful branding then become that image which we want to portray? Supreme Advocate Officer Desk reference says that "using the emblem of the Knights of Columbus in connection with other business, or social, or other enterprise, without permission of the Board of Directors is prohibited (Section 162.11)" (counterintuitive to good business practice). "Section 162.11 of our by-laws also state that "The purpose of this policy is to preclude the use of, among other things, the Order's name, emblems, events, meetings, membership lists, and facilities to promote goods and services other than the financial products and services offered by the Knights of Columbus. The Board wishes to minimize the risk that anyone would draw the mistaken conclusion that the Knights of Columbus (a) has endorsed the good or service being offered or (b) has guaranteed the integrity of that good or service. Obviously, the Board cannot make any such endorsement or guarantee about any good or service other than those offered by the Knights of Columbus. The Board also wishes to avoid any business association that might expose the Order to liability if a good or service does not meet a customer's expectations."

The mission of the Knights of Columbus is to be always consistent with Catholic values and doctrine, we do this through a system of subordinate councils, along with regional, national, and international convocations, to raise up, support and encourage a fraternity whose members are practical Catholics united by their faith and by the principles of charity, unity, fraternity, and patriotism; through common worship, charitable works, meetings, and rites of initiation, to form its members in Catholic faith and virtue; to render pecuniary aid to its members, their families, and beneficiaries of members and their families; to render mutual aid and assistance to its sick, disabled, and needy members and their families; to promote social and intellectual interaction among its members and their families; to promote and conduct educational, charitable, religious, social welfare, war relief, public relief, and other activities; and to unite members in their Catholic identity and the practice of their Catholic faith.



The VGSC identifies five issues it deems to be non-negotiable issues and instructs the reader on how to narrow down the list of candidates to those who are acceptable based on the non-negotiable issues. The VGSC does not directly or indirectly make reference to any specific candidate, political party or election. Therefore, the content of the VGSC, standing alone, is not political campaign intervention because the VGSC does not support or oppose any specific candidate for public office. --Internal Revenue Service, Addendum to Letter 3609P, May 2, 2008

Lift High The Cross

Did you know that according to the Alan Guttmacher Institute 2000-2001 survey, 27% of all abortions in the United States were performed on Roman Catholics? This means that Roman Catholics are the SINGLE LARGEST denomination of Christians who abort their children. When you go to Mass this weekend, look around you.
