Suicide: Devils and Angels

Oregon has allowed assisted suicide since November 1997. According to the Oregon Health Authority, 245 people died in 2020 from ingesting the lethal prescriptions given to them by their caregivers. From 1998 to January 22, 2021, 1,905 people have been allowed to take their lives under this law.

Compare that to Chen Si of China, who has convinced more than 400 people not to take their lives. Since 2003 he has spent each weekend patrolling the Nanjing Yangtze River Bridge, a notorious landmark for suicide attempts. Safe Haven Laws in Oregon

Safe Haven Laws allow a parent to anonymously surrender their unharmed infant to a designated Safe Haven provider within a specific time after birth. Each state has its own unique Safe Haven law. While each law has similar components, the age and location restrictions differ per state.

The Oregon "A Safe Place for Newborns" law allows a birth parent (mother or father) to leave a newborn infant at an authorized facility. As long as the baby is 30 days old or younger, is handed to someone working there, and shows no signs of abuse, there will be no legal consequences for making this choice. An "Authorized facility" is one of the following: • Hospital

- Doctor's Office
- Birthing Clinic
- Police Station
- Sheriff Office
- Fire Department

No appointment is necessary to leave the baby. The individual leaving the child does not have to give identification, but will be offered a health information form for the child which may be filled out then or later.

The authorized facility is required to notify the Department of Human Services of the abandoned infant within 24 hours of receiving the child. The Department of Human Services is deemed to have protective custody of the infant from the moment the infant was left at the facility. The child will be placed in foster care.

If the parent changes his or her mind about leaving the baby, the parent may seek custody in court. Ability to seek custody will be limited to the time before the court makes a decision to end the parental rights.

Keeping Communion Holy

New Mexico state Sen. Joe Cervantes was denied Communion on July 17 at a church in Las Cruces for his promotion of abortion. His reaction?

"I was denied communion last night by the Catholic bishop here in Las Cruces and based on my political office. My new parish priest has indicated he will do the same after the last was run off. Please pray for church authorities as Catholicism transitions under Pope Francis."

Other lawmakers have shown support for Cervantes.. One challenged the bishops to "dare" to deny him Communion and another suggested revoking the church's tax-exempt status.

Cervantes later stated: "I won't have any problem finding a place to receive Communion. In fact, I look forward one day to receiving Communion at the same parish where President Biden does." He also said another Catholic diocese in New Mexico has offered to give him Communion. This is a sad commentary of the state of Church leadership in the United States as fellow members of the USCCB are unable to come to a cohesive policy about handling Catholic politicians who lead our country deeper into abortion.

A coalition of pro-life groups including *Students for Life* of *America* and *March for Life* conducted a world-wide contest for the design of a flag to represent the pro-life movement. With two feet (child), two hands (mother), two stripes, and two main colors, it emphasizes the TWO lives present in a pregnancy and the love the pro-life movement shows to both.

Breaking News - Theodore McCarrick

On July 28, 2021, formal Cardinal Theodore McCarrick, who was laicized in 2019, was criminally charged with the sexual assault of a minor in 1974.

The Vatican received criticism for laicizing McCarrick instead of sentencing him to jail time. It was assumed the 91-year old former cardinal was free from secular criminal charges due to statutes of limitations. However, because McCarrick is accused of committing the assault in Massachusetts and because he left the state, Massachusetts law allows criminal charges to be filed for the incident that occurred 47 years ago.

McCarrick, who is currently living in Missouri, has been summoned to appear at Dedham District Court in Massachusetts on August 26. McCarrick's attorney stated "we will look forward to addressing this issue in the courtroom." Catholics concerned about the scandals which have erupted throughout the Church are looking forward to the trial as well, although possibly for different reasons.

McCarrick has at least one connection to Oregon. In 2008 the University of Portland awarded then-Cardinal McCarrick an honorary degree. On July 30, 2018, the University issued a statement rescinding the degree, citing both the seriousness of the allegations made against McCarrick and the impact on the campus community.
