22th Annual "Just Ask" Fund Raising Campaign

Knights of Columbus 2015 Arkansas State Campaign For Persons With Intellectual Disabilities Paul M. Leonard, Chairman Year End Report for Calendar Year 2015 Filed: April 30, 2016

Fellow Brother Knights,

The final results of the 2015 Campaign For Persons With Intellectual Disabilities (formerly known as The Tootsie Roll Drive) are in. Once again, our state councils were able to raise more money for charitable purposes than we did the year. We exceeded 2014's total amount by over \$5,000. This undoubtedly was the result of all the hard work and effort expended by those 20 councils which participated in this year's campaign. This was the third year in a row in which the Arkansas State Council was able to raise over \$70,000 for charitable purposes across our state.

For the 2015 calendar year, the grand total raised was \$78,737.42. Of this amount, almost \$67,000 went to the local charities of each council's choice. In March 2016, the former state grand deputy, Mike Kieffer, and myself presented a check in the amount of \$11,810.61 to this year's State Council charity of choice, The ARC of Central Arkansas. The recipients expressed much gratitude and excitedly informed that the check we had presented them with the largest they had ever received from a charitable organization.

Of that achievement alone, my fellow brothers, we should all be proud. The check which we presented to The ARC of Central Arkansas will be used to help fund their 2016 summer camp which is a vocational camp as well as a one-week opportunity for persons with intellectual disabilities to be able to enjoy nature and the outdoors.

I was particularly pleased that quite a few councils which had participated in both the 2014 and 2015 campaign showed an increased amount from what they had been able to raise in 2014. Some of these increases were substantial in nature. I would like to take the time to single out two councils: Hot Springs Village, Council# 10208; and Bella Vista, Council# 9514, both of whom showed large increases from what had been raised in 2014. St. Bernard Council, Bella Vista, ended up raising over \$13,000 while the Daniel Patrick Sullivan Council, Hot Springs Village, raised an astounding amount of \$26,471. However, by no means should we overlook The Monsignor Adam A. Micek Council, Council# 8410, Harrison, one of our state's smaller councils, which was able to generate over \$6,334 from their fund raiser. Put into perspective, that was almost \$80 raised per each council member.

When the campaign began, I tried to stress to every council in my e-mails that it was not much how much money each could raise but that an effort be made by all to participate. Most importantly, the annual Campaign For Persons With Intellectual Disabilities fund raiser would be an opportunity for those councils which participated to practice the Knights of Columbus' virtues of charity, unity and fraternity. We have a great group of councils here in Arkansas. Brothers, continue to keep up all that good work!

As of 1 April 2016, 13 U.S. jurisdictions have over 200 Squires. 6 jurisdictions have 100-199 Squires. Order wide, the strongest growth of the Squires program continues to be in the Philippines.

This fraternal year, Supreme has announced changes to youth programs sponsored by local Knights Councils. 




