

#### **Duckpin Bowling**

Duckpin bowling is a variation of 10-pin bowling. The balls slightly larger than a softball and lack finger holes. The pins, while arranged in a triangular fashion identical to that used in ten-pin bowling, are shorter, smaller, and lighter than their ten-pin equivalents which makes it more difficult to achieve a strike. For this reason, the bowler is allowed three rolls per frame (as opposed to the standard two rolls per frame in ten-pin bowling).

"My wife Sue's sister Carol met her husband Steve in 1972 while they were both in the Peace Corps. When they married, they settled in Santa Fe, New Mexico where Steve's family has lived for centuries. They purchased (with a mortgage loan) a traditional, 100 year old, adobe home. Over the next seven years, they adopted four beautiful children Helena, Jesse, Donisia and Daniel. Steve built a successful law practice and after ten years decided to run for election to the District Judge seat in Santa Fe.

With a grass roots campaign...a real family effort...Steve became the first person with

Spanish speaking heritage to be elected Judge in that district of New Mexico.

The kids grew and Carol and Steve often came to visit us back here in Maryland for family vacations.

They put a lot of sweat equity into their house, expanding it to make room for the kids, while maintaining the integrity of the traditional architecture.

It was about this time of year back in 1998 when Sue and I were awakened at 1am with a phone call.

Our kids were of college age back then so when the phone rang at 1am we went from peaceful slumber to acute anxiety in a couple of heartbeats. It was Sue's Mom on the line. Her message was, "Steve is dead". He had ridden along with his son Jesse on a trip to Albuquerque to register for college classes. On the ride back to Santa Fe, a man driving from the opposite direction suffered an epileptic seizure. His car jumped the median strip and pierced Jesse's head on. Jesse was seriously injured. Steve was killed instantly leaving Carol a widow with four teenagers.

During the adoption process, Steve and Carol had repeatedly been expected to have personally acquired and maintained life insurance in addition to whatever happened to be offered by Steve's work at the time.

Before he died, at age 46, Steve had personally put into place, a life insurance plan that paid Carol tax free death benefits of \$1,000,000 plus. Carol was able to stay in that adobe home, and complete the children's education. Today Carol is a very happy grandmother of six. After the kids moved on, she took a job as a mediator for the same court where Steve had sat. She retired this past spring, and she is able to come back East to visit us several times a year. She always brings a grandchild or two with her.

Whether our children are adopted or not, having sufficient, personally owned, life insurance in place is what responsible, loving husbands and fathers like Steve do. So please

### 40 days for life campaign coming to an end

The 40 days for life campaign has ended. I am currently waiting for the official count of babies saved, but at the count was in the 700-800 range. While it is difficult to have an official count, these are the people who left a facility or actually told the participants that they had changed their minds.

This year it seems that there were more and more confrontations with 40 day from life prayer participants. All of these people answered with prayer and patience.

One particular group in California put together a coalition called “Clergy for Choice”

Some of the “Clergy for Choice” intentions:

- Day 5: Today we pray for medical students who want to include abortion care in their practice.
- Day 18: Today we pray for all the staff at abortion clinics around the nation. May they be daily confirmed in the sacred care that they offer women.
- Day 27: Today we give thanks for abortion providers around the nation whose concern for women is the driving force in their lives.
- Day 40: Today we give thanks and celebrate that abortion is still safe and legal.

How should we respond to that? The 40 days for life response :”Let’s all pray for all of those who’ve convinced themselves that abortion is a moral “choice” – and for all who are deluded into believing that lie.”

## Abortion to be outlawed in North Dakota

As of writing this North Dakota is poised to be the first state to outlaw abortions in the United States. The legislature in ND has passed the following bills and awaiting the Governor to sign:

HB1305 – A ban on abortion based on gender and genetic abnormality

HB1456 – Ban an abortion if a heartbeat is detected

SCR4009 - The inalienable right to life of every human being at every stage of development.

The Bills still under consideration but passed in the ND Senate:

- SB2303 – Ensures that the protection that our criminal laws afford to victims of crimes extends to all human beings born and unborn
- SB2305 - Demand that abortion doctors have admitting privileges to hospitals
- SB2368 – A ban on abortions when babies can detect pain

“We are intending that it be a direct challenge to Roe v. Wade” state Sen. Margaret Sitte (R), the sponsor of the personhood initiative, said after Senate passage.

While this is going on in North Dakota, Alabama has passed 2 bills that limit abortions and will also be a direct challenge to Roe V Wade.

In late February, state legislators overrode Democratic Gov. Mike Beebe’s veto of the Pain-Capable Unborn Child Protection Act, which bans abortions after 20 weeks on the grounds that they inflict pain on their unborn victims.

And one week later, they overrode Beebe’s veto of the Arkansas Human Heartbeat Protection Act, which bans nearly all abortions after 12 weeks of pregnancy. The “heartbeat bill” is named after its supporters’ argument that unborn babies deserve legal protection once a heartbeat can be identified on an abdominal ultrasound.

Pray that these states will be successful in the courts and finally we will have a victory over Roe V Wade.

Your Home Corp Board of Directors continues to make visible and behind the scenes improvements to your Council Home. In the past several weeks, 3/4s of the building's roof system has been replaced or repaired. A new porch, stairs, and railing have been installed leading to the State Council Office. The floor in the main building has been totally stripped, broken tiles replaced, waxed, sealed, waxed, waxed, and buffed to a high gloss!!! Improvements to the inside water system include an infrared bacteria filter and, soon, a water softening system.

We are making regular payments to the restroom renovation loan and now, most of our monthly loan payment is going to principal rather than interest.

Hall rentals have been steady and there are several more rentals scheduled in the coming months. We even have a reservation for a date in 2014!!! A new tri-fold has been published and is available to anyone visiting the Home or upon request.


