Overview

An ultrasound machine offers a woman a “window into the womb” that gives her the ability to see her unborn child, to hear his or her heart beating, and to recognize the miracle of the life within her.

Background

Putting their faith into action since the founding of this program in 2009, have funded roughly 100 machines per year, through the efforts of state/provincial and local councils, as well as through contributions to the Knights of Columbus Culture of Life Fund. These ultrasound machines are saving lives daily!

Ways to Fund an Ultrasound Machine

Councils have raised funds through “Laps 4 Life,” special collections at parish Masses, baby-bottle boomerang drives, special dinners, raffles, live and silent auctions, car shows, oyster roasts, pancake breakfasts, bingo, donations for a “free” breakfast after Mass, a mailing to council members, and many, many other activities and events.

How it Works

When a Knights of Columbus state and/or local council raises 50% of the cost of an ultrasound machine for a qualified pregnancy center, the Knights of Columbus Supreme Council will provide funds to cover the other 50% of the cost.

Mobile Units, Too!

If a Knights of Columbus council raises the full cost of purchasing and/or modifying a vehicle i.e. — RV, van, bus, truck, etc.) for use as a mobile ultrasound unit, the Supreme Council will provide up to 100% of the cost of the ultrasound machine to be used in that vehicle.

Qualifying a Pregnancy Center

To qualify a Pro-life pregnancy center, among other requirements, must be approved by the local Catholic diocese, must have a physician as its medical director, and must operate on a “limited medical model,” using the ultrasound machine to confirm pregnancy.
