

The laws that the Pharisees do follow, they make public display of their actions, in order to garner the praise of the people. They want to be seen as great among the people.

## *"The Souls of the Just are in the Hands of the Lord."*

Jesus on the other hand had earlier told the people that "my yoke is easy and my burden is light." Jesus tells the crowds, and us, that to be truly great among the people, we must be the servants of others. Then, our greatness is truly a reflection of the only Great One, Jesus Christ, who came to serve, not to be served. We have only one teacher to show us how to serve, Jesus Christ, who is our Lord. 

# SUPREME KNIGHT'S MESSAGE

Gathering at the Saint John Paul II National Shrine in Washington, D.C., for the first celebration of St. John Paul II's feast day as a saint, hundreds of guests had the opportunity to attend celebrations and tour the new permanent exhibit. With 200 Catholic schoolchildren attending the Mass for Young People, the Shrine also opened its doors to members of the media for touring and interviews.

Special guests to the shrine included Archbishop Mieczysław Mokrzycki, archbishop of Lviv, Ukraine, who served as personal secretary to John Paul from 1996 to the pope's death in 2005.

Also attending the day's event was Supreme Knight Carl Anderson, who worked closely with St. John Paul II on a number of projects, including the founding of the U.S. session of the Pontifical John Paul II Institute for Studies on Marriage and Family. Shrine Executive Director Patrick Kelly was also on hand to answer questions about the exhibit.

The shrine itself is an initiative of the Knights of Columbus, and houses one of the major blood relics of St. John Paul II. The new "A Gift of Love: The Life of Saint John Paul II" exhibit is a unique 16,000-square-foot permanent tour de force that invites visitors to journey through nine galleries that trace the life, papacy and teachings of Pope John Paul II. The multimedia experience includes unique artifacts, audio-visual components and engaging interactive displays in a setting that inspires deep reflection on one



of the major intellectual, spiritual and historical figures of the 20<sup>th</sup> century. The exhibit focuses both on the events that shaped him and those he shaped: from his childhood to his youth in Nazi-occupied Poland, to his ministry as priest, bishop and cardinal during the Communist period, to his election to the papacy in 1978 and the subsequent remarkable, dynamic program that he oversaw as pope for the next 26 years, including the great lessons

of his poignant final days.

The new exhibit was designed by Gallagher and Associates – notable as the designers of the Sant Ocean Hall, at the National Museum of Natural History; the Gettysburg National Military Park and Visitor Center; and the Ronald Reagan Presidential Library.

Earlier this year, the U.S. Conference of Catholic Bishops designated the facility as a national shrine to highlight it as a national place of prayer that would also afford visitors the opportunity to learn about and reflect upon John Paul's life and mission. Pope Francis, through the Vatican secretary of state, said that "the Shrine will open wide its doors to the countless members of the faithful from the United States and abroad who remember Saint John Paul with gratitude and affection, and who trustingly seek his intercession and assistance."



An understandable, but misleading nickname. Worthy of note is the fact that the Knights of Columbus has no official tie to Tootsie Rolls or their manufacturer. In fact, many Councils participate in the same fundraising drive, but distribute other items.

**THE “CUP OF JOE” BREAKFAST PROGRAM**



Wednesday 29<sup>th</sup> of October is the day our Council and other Parish Ministries will packed the “historic” 400 bags of breakfast, for delivery to a homeless shelter in North East, Washington, DC. This Program may be an ongoing service commitment, or a one-time program for our Council to participate in. But one which should be gratifying, in that it's a service of healthy breakfast to our neighbors who may otherwise not have that meal. The Catholic Charities Website aptly summarizes this function:

*“Cup of Joe is a breakfast-packaging program that serves men and women in Catholic Charities' shelters. It is a wonderful service that provides a sustainable option for breakfast to a population who desperately needs it. Over 1,000 people stay in our shelters every single night, and the program helps to provide a breakfast to anyone who asks for it as they leave the shelter each morning. It takes a lot of volunteers to make this effort a reality though*

**Marian Title for November**

***Our Lady of Kibeho***



The apparitions of Our Lady of Kibeho began on November 28, 1981 in the African college of Kibeho, Rwanda. The Virgin Mary repeatedly appeared to Alphonsine Mumureke, NTHALIE Mukamazimpaka, and Marie Claire Mukangango. The apparition identified herself in the native Rwandan dialect as “*Nyina wa Jambo*”, (“*Mother of the Word*”) which is synonymous to “*Mother of God.*”

The apparitions communicated various messages to the schoolchildren, urging the people to love each other, and warning of an apocalyptic vision of Rwanda descending into violence and hatred, foretelling the 1994 Rwandan Genocide. In 2001 the Holy See released a declaration approving the apparitions. The Marian sanctuary at Kibeho was named “*Shrine of Our Lady of Sorrows*” in 1992, two years before the genocide. An estimated 500,000 pilgrims visit the site every year.

#### *Faith and the Ballot Box*

On November 4, 2014, people across this nation will have an opportunity to vote for those who will represent them at the federal, state and local levels. The work of these representatives, who will enact the laws and regulations under which we live, will significantly affect our lives for years to come.

The challenges before the nation are serious, highly political, and profoundly moral. There is the continuing destruction of unborn children through abortion and new efforts to eliminate the elderly through euthanasia and assisted suicide; movements to coerce Catholic health care, education, and social service ministries to violate their religious beliefs; efforts to undermine marriage as the permanent union of one man and one woman; and restraints on religious liberty and the exercise of individual conscience; among others. Many compelling moral concerns are dealt with at the state, as well as national level, and so votes cast for state senators and delegates can be as important as the votes for national office.

All issues are not morally equivalent. Some involve fundamental principles, such as the right to life, that can never be violated, even to achieve a good end. Others require prudent judgments about the best way to apply Catholic teachings to deal with compelling societal problems. It is a mistake, therefore, to make no ethical distinctions among the issues. The right to life is not simply one of a multitude of concerns of equal importance that should be acknowledged when deciding for whom to vote.

Abortion, euthanasia, assisted suicide, destruction of human embryos, and same-sex marriage are intrinsically evil, that is, the acts are immoral in and of themselves, regardless of the motives behind them, and must always be opposed. Certainly, health care, education, immigration, jobs, taxation and national security are also important concerns and should not be neglected. Advancing the benefits of these issues, however, cannot compensate for disregarding the value of a human life. The strongest economy, finest health care system, fairest immigration laws, and soundest economy do nothing for the child who is never born.

Pope St. John Paul II, in his 1988 apostolic exhortation *Christifideles Laici*, stated: *The common outcry, which is justly made on behalf of human rights -- for example, the right to health, to home, to work, to family, to culture -- is false and illusory if the right to life, the most basic and fundamental right and the condition of all other personal rights, is not defended with maximum determination.*" If one must choose between improving the quality of life and protecting life itself, human life must take precedence.

In matters of lesser moral definitiveness, there may be legitimate diversity among individual prudential judgments. Catholics may differ on approaches to reduce poverty, stimulate the economy, the best immigration, health care or housing policies, or on a decision to wage a just war because these judgments do not involve the direct choice of an intrinsic evil, while promoting various human benefits. This does not mean these issues are of lesser moral interest or can be summarily dismissed. They are significant concerns that challenge consciences and

require action, but they are open to principled debate that may result in differing, even opposing, views.

Catholics not only have an obligation to exercise their right to vote, but have the additional responsibility to do so with a well-formed conscience, guided by the tenets and teachings of the Church. They are tasked to bring faith-refined principles, augmented with informed prayerful reflection, to the consideration of and decisions about candidates and issues. This duty is more than preparing to vote in a given election. Developing a well-formed conscience is a lifelong effort in order to deal with the changing conditions, issues and circumstances of the world.

When candidates support actions or programs that are intrinsically evil, they should be considered less acceptable for public office. As *Forming Consciences for Faithful Citizenship*, an election guide issued every four years by the United States Conference of Catholic Bishops, teaches, "*Those who knowingly, willingly, and directly support public policies or legislation that undermine fundamental moral principles cooperate with evil.*"

The failure to protect life in its most vulnerable stages, or to support other intrinsic evils, renders suspect a candidate's positions on all matters affecting human dignity. The right to life is a fundamental precept inscribed in America's Declaration of Independence. If a candidate disregards a foundational principle of the nation and asks voters to violate their moral consciences, people have the obligation to cast their ballots for someone else.

With the duty of voting comes the responsibility to know where the candidates stand on the issues. One rarely finds a candidate with whom he agrees on everything. The key question is the relative importance of the issues on which the two disagree. A voter will have abetted a candidate's future immoral actions if he helps elect a person who favors programs that are intrinsically evil when there is a morally acceptable candidate on the ballot.

What does one do, however, when there is no such alternative? Deciding not to vote is often not the best solution. When all candidates support an intrinsic evil, it is morally permissible to vote for the candidate who poses the least threat to human life and dignity and thus limit the harm. It is important, therefore, to vote with a well-formed conscience that perceives the proper relationship among moral goods.

In the coming election, every voice will matter, every vote count. Cast your ballot. Exercise your cherished right and solemn duty as a Catholic American citizen, faithful to the teachings of our Church.


