

### **Battle for Life Turns to the States**

After the republican Congress lost the negotiations on Federal Funds to Planned Parenthood, pro-lifers have been taking the battle to the states, with some great successes. Indiana is one such state that has passed 2 bills that went into Law July 1st, 2011.

“These are monumental advances in state policy that place Indiana on the leading edge of national efforts to curb abortion,” states Indiana Right to Life president Mike Fischer.

Highlights of these new policies include:

- Women must be informed that human physical life begins at fertilization.
- Indiana will opt-out of abortion coverage in any state health exchange required under the new federal health law passed by Congress in 2010.
- Pain-capable children beginning at 20-weeks gestational age will enjoy enhanced protections.
- All abortions on girls under the age of 14 must be reported to child protective services within three days of the abortion in order to facilitate prompt investigation into child sexual abuse.
- Women must be informed that abortion may increase the risk of infertility, infection, or hemorrhaging.

- Doctors who do abortions in Indiana must have local hospital admitting privileges, provide medical licensing numbers, and provide emergency contact information to women having abortions.
- Women considering abortion must be informed about Indiana’s safe haven law that allows for mothers who decide to carry their children to term but are unable to care for their children to leave them with safe haven providers such as local police without criminal repercussions.

### **Summer of Mercy 2.0**

Twenty years ago over 50,000 Christians responded to a call from the Holy Spirit and came to Wichita, Kansas in the summer of 1991. They publicly stood as a peaceful and prophetic witness for life. The focus, then, was on ending the tragedy of late-term abortions. Wichita, at the time was the home of late term abortionist George Tiller, whose assistant was LeRoy Carhart. This event became known as “The Summer of Mercy.

LeRoy Carhart, the most infamous late-term abortion provider in America today, now operates in Maryland. This July 30-August 7, 2011, Summer of Mercy 2.0 will be held in Germantown, MD, at Carhart’s abortion facility.

The event is sponsored by the Archdiocese of Baltimore and Archdiocese of Washington, in collaboration with the MD Coalition for Life. An insert in church bulletins in the two archdioceses includes events sponsored by the archdioceses. Information about prayer services and daily rallies, sponsored by the MD Coalition for Life, including a rally on Saturday evening, July 30, at which Fr. Frank Pavone of Priests for Life will speak, can be found at <http://summerofmercy.com>.

Cormac 'Mac' Michael Murray was born a healthy beautiful baby boy on September 10, 2004. He checked out perfectly & we were home in 24 hours ready to begin our new life as a family!

After hitting many of the infant milestones...sitting up, crawling, eating solids, saying some words...we became concerned at 18 months. The manner in which Mac 'walked' or attempted to walk was awkward at best. After checking out fine at an orthopedic appointment...the doctor said the next step would be for Mac to see a neurologist at age 2. We made the appointment with a children's neurologist at JHU straight away...we were not going to wait until Mac turned 2. Mac did great at his evaluation...we left the neurologist's office with a diagnosis of 'mild cerebral palsy'...we left the doctor's office that day with strict instructions to *'make college plans'* because Mac would *'get better at doing it (walking) badly'* with physical therapy & braces.

Fast forward roughly 1 year...and after many grueling physical therapy sessions & hours of stretching at home and wearing braces...Mac was not getting better at doing anything – in fact, he was getting significantly worse. He was not taking any steps anymore, he was not saying many more words, his hands had begun to shake, he was losing head control, he had had a few seizures & in general he seemed uncomfortable & downright unhappy at times. We were frustrated and sad for him.

We made our way over to Kennedy Krieger Institute to see a doctor there who specialized in cerebral palsy. After a very thorough initial examination so that they could get a 'baseline' for Mac...they agreed it was NOT cerebral palsy & wanted to reevaluate Mac again in 6 months. We scheduled a follow up appt. 6 months later they agreed that Mac was getting worse and ordered his blood and urine tests...they suspected a type of Leukodystrophy but were not sure which one yet.

1 month before Mac's 3<sup>rd</sup> birthday the test results were back & we received the news that Mac had a rare, genetically inherited, terminal disease called Late Infantile Metachromatic Leukodystrophy, or MLD. There is no treatment and there is no cure. With modern medicine and therapies we are able to keep Mac comfortable for the most part...but he has lost everything due to this devastating disease. He is 6 years old and he cannot walk, talk, swallow, move his limbs, sit upright, hold his head up or smile. He takes 8+ medicines every 6 hours to help control neurological pain, muscle spasms, seizures, contractions, reflux and many other things. He lives every day like a CHAMPION and he is our hero and our inspiration. The doctors told us most children with MLD do not survive past 5...our Hero is 6.5.
