State sponsored **Family Rosary Rally** in honor of Our Lady at Our Lady of Fatima Cistercian Monastery, Mount Laurel on **Sunday, October 5, 2014 at 3pm.**

Annual Retreat Weekend, sponsored by NJ State Council, is held the weekend of **Oct 24-26 at San Alfonso Retreat Center**, West Long Branch, NJ. Donation is \$185.00 (meals included).

We are now beginning the third month of this Columbian year and our councils should have established a plan for reaching their goals. Primary in reaching your goals is the **planning for membership growth** for your councils. Schedule frequent first degrees, there should be at least one first degree every month in each council or at the least in each district.

Publicize the scheduled degrees by Chapter / Federation email and post the degrees on the State Website. Grand knights have the privilege and responsibility for posting first degrees on the website.

Keeping with the motto from Supreme introduced last year, our membership theme is, **One Member per Council per Month.** New membership is the lifeblood of the council and will provide the manpower for your programs and also provide talented future leaders of your councils.

We are stressing again this year that membership growth occurs **365** days a year, not just during the fall and spring membership drives. We reprised the **"Summer Three for All"** program to encourage recruitment in the traditionally slow months of July through September. Please take advantage of this opportunity and help us grow the order so we will have a louder, larger collective voice to **"Proclaim and Defend our Faith."**

Labor Day, the first Monday in September, is a creation of the labor movement and is dedicated to the social and economic achievements of American workers. It was **declared a Federal Holiday by President Grover Cleveland** in 1894. The Labor Day holiday is interesting because it evolved over a period of years. In 19th century America, there was already a tradition of having parades, picnics and various other **celebrations in support of labor issues**, such as shorter hours or to rally strikers.

As manufacturing increasingly took over from agriculture as the primary source of American employment, labor unions, which had first appeared in the late 18th century, grew more prominent and vocal. They began organizing strikes and **rallies to protest poor conditions** and compel employers to renegotiate hours and pay. Many of these events turned violent during this period, including the infamous Haymarket Riot of 1886, in which several Chicago policemen and workers were killed.

But most historians emphasize one specific event in the development of today's modern Labor Day. That pivotal event was the parade of unions and a massive picnic that took place in **New York City on Sept. 5, 1882.**

- **Patriot Day event** 9/11, honor a vet, raise a flag, Order **One Nation Under God** materials to hand out
- **National Health and Fitness Day** 9/27, maybe sponsor a blood pressure screening after Mass



State Council E-Mail System Update

In an effort to control Spam, Internet Viruses, and legitimate e-mails being blocked, it became necessary to take steps to protect our members. Effective August 1st we discontinued the usage of "role-driven" e-mails (i.e. gk16000@njkofc.org or [\(x\)tournament@njkofc.org](mailto:(x)tournament@njkofc.org), etc.) except for state officers, past state deputies, program directors, and deputy directors – they will continue to have firstname.lastname@njkofc.org e-mail addresses.

Certain other major programs, and contacts, will continue with "real" e-mailboxes (i.e. [\(x>alert@njkofc.org](mailto:(x>alert@njkofc.org), [\(x\)drive@njkofc.org](mailto:(x)drive@njkofc.org), etc.). All other e-mail contacts will revert to utilizing personal e-mail addresses.

All addresses are contained in the State Directory – which is distributed only to Grand Knights; Financial Secretaries; similar officers in the 4th Degree, Chapters and Federations; and also State Program Directors and Chairmen. The State Directory is currently accessible on-line to all those with level 2 authorization or higher. To contact these officers refer to the printed or on-line directories (go to www.njkofc.org; log-in; then click on **Members**, then **Manuals & Directories**, then **2014-2015 State Directory**).

Please note the updated legal caution against improper use of information contained within the soon-to-be-available "paper" state directory, as well as the online state directory:

"This directory is protected by Federal and International Internet Privacy Laws. Access to, and use of, the information contained in this directory is restricted to official business of the Order only.

On-line access to this directory, and the information contained herein, is intended for use by authorized members of the Knights of Columbus with the understanding that they are personally responsible for safeguarding the content and respecting the privacy of rights of individual members of the Knights of Columbus at all times.

Culture of Life Corner

Brothers:

Now that the Labor Day weekend is upon us, and we are heading towards fall, we need to ramp up our efforts for the Culture of Life here in New Jersey. There are certainly lots to do, and you do need at least four [4] pro-life activities in order to **get Star Council**. It is best to get started now!

Voter Registration Drive - Hopefully you have scheduled a voter registration drive in your area for this month. The deadline to get the **registration** forms in to vote in this election is **October 14**, so be sure to hold one by the end of this month, so as to have enough time to get the registration forms in. See if you can get something scheduled in one of our Catholic high schools, so that seniors who have already turned 18 can vote for the first time! Morality in the Media - New Jersey scored a major coup at the Supreme Convention on Morality in the Media! Although resolutions from other jurisdictions (namely District of Columbia, Kansas, Michigan, and Nebraska) were submitted on this subject, ours was selected for adoption as the one that most completely and accurately reflected the Supreme Council's position on the matter! Let us continue to take the lead on this and plan a **White Ribbon program** in every council (car magnets are still available for \$5 each), while all of our members turn off our TVs on October 21. 

Promoting Life Through Education and Assistance - Two of the most effective ways to turn women away from abortion are education and assistance. Educate them through the placement of **ultrasound machines, Windows to the Womb**, and the **Truth Booth** cards. Assist them by getting those diapers, wipes, formula, a home, or crisis care. Please dedicate yourselves as a council to getting involved in **Diapers for Babies, Homes for Moms**, and **Supporting Pregnant Women in Crisis**. 

A major victory on the education front was won in PA, which recently passed a bill that requires that a Down syndrome diagnosis be accompanied by useful, accurate information about the genetic disorder. **The Down Syndrome Prenatal and Postnatal Education Act, effective Oct. 1**, mandates that medical practitioners give expectant or new parents "informational publications," to be provided online by the state health department. Hopefully, this will lead to fewer women aborting their babies due to this diagnosis. Let's work to have New Jersey join PA and five other states (including Delaware) by passing a similar law!

Quality of Life - Let us not forget the importance of promoting quality of life. As you raise money for culture of life programs this fall, please consider a donation to **Deborah Hospital** and the **Alzheimer's Respite Care program**. A donation of \$200 to each can make so much of a difference and will help us get to our goal!

National Grandparents Day

The motivation for a National Grandparents Day originated with **Marian McQuade**, a housewife in Fayette County, West Virginia. Her primary objective was to champion the cause of lonely elderly in nursing homes. She also hoped to persuade grandchildren to tap the wisdom and heritage their grandparents could provide. **President Jimmy Carter, in 1978, proclaimed that National Grandparents Day would be celebrated every year on the first Sunday after Labor Day. This year, Grandparents Day falls on Sept. 7th**

The official flower of the U.S. National Grandparents Day is the “forget-me-not” which blooms in the spring. As a result, seasonal flowers are given in appreciation to grandparents on this day.

The holiday is expected to grow in significance over the next decade and beyond as the number of grandparents in the United States rises from 65 million in 2011 to 80 million in 2020 as a result of the baby boom. They are increasingly responsible for child care and support. In 2012, 30% of children under five with working mothers were cared for on a regular basis by a grandparent.

2013 saw increased exposure for the holiday, with the greatest public engagement and press coverage in its 35 year history.
