All of us, whether we ever think about it or not, have "first inclinations" in many areas of our life. I have a first inclination to play spades if anyone indicates a desire to play cards. My first inclination when I turn on the television is to go to a sports channel to see what sport is being highlighted or is being played. I'm sure if we reflected on the life of Jesus (as we have come to know it through scripture) we would discover that he had first inclinations that showed in his words and actions.

One of the most important of these was his first inclination of mercy in all the stories of his ministry AND in his risen life as he showed himself to the apostles on the evening of his Resurrection. Let's let the example of Christ in this and in all things inspire us and keep us in the Lord's peace throughout the Easter season and for the rest of our lives. Vivat Jesus.

I am confident that most, if not all, councils in our state support the Supreme Programs; however, as communicated in the mid-year report, the documentation of their efforts could use improvement.

This year's State Free Throw Contest was a good example of a successfully run program. Hot Springs Arkansas' K of C **Council 6419 Honored** as Arkansas' State Large Council of the Year 2014 -2015

FOR IMMEDIATE RELEASE: KNIGHTS OF COLUMBUS COUNCIL 6419 IN HOT SPRINGS, ARKANSAS WINS TOP HONORS AS THE STATE OF ARKANSAS' 2015 LARGE K OF C COUNCIL OF THE YEAR

LITTLE ROCK, Arkansas – April 25, 2015 - Hot Springs, Arkansas is the home of the Knights of Columbus (K of C) Council 6419 and Assembly 1892. In Fraternal Year 2014 - 2015 Council 6419 *surged with service* winning Top Honors as the State of Arkansas 2015 Large Council of the Year.

The Hot Springs, Arkansas' Council 6419 Knights and its youth's Circle 5700 Squires and their families are keenly aware that each of their service programs, *Charity, Unity, Fraternity and Patriotism*, embody the mission of their global Order. Each of Council 6419's seventy-nine (79) Fraternal Year 2014 – 2015 service programs presented a unique opportunity to contribute locally to the global efforts of millions of Catholic Knights, each focused on the same mission, to help those in need.

As a direct result of their past year's service programs, Council 6419 significantly increased its services to the needy in Garland County Arkansas, such as the following:

- The Council's semi-annual Rummage Sales resulted in over **\$50,000** raised for Council 6419's monthly charitable cash donations, totaling \$3,500 per month, donated to *Change Point* (a Pro-Life Pregnancy Resource Center); *Jackson House for Crisis Intervention Services*; *The Caring Place* (Adult Day Care); *Safe Haven*; *The Branch at Snow Springs*; *Charitable Christian Medical Clinic*; *Project Hope Food Bank*; *Hot Springs Housing Authority*; and *St. Vincent de Paul*.
- The annual Charity Golf Tournament for St. John's Catholic School (provided another **\$9,100**); plus a donation to Garland County's Suicide Prevention (**\$800**);
- The annual *Drive for People with Intellectual Disabilities / First Step / "I Can Dance" / Arkansas Special Olympics*. (*Tootsie Roll Drive* raised another **\$8,300**);
- A second pro-life donation of an ultra-sound machine in 2012, plus **\$7,800** cash in 2015 from the annual baby bottle campaign to support the local *Change Point Pregnancy Care Center*,
- Relief donations to the families who were the victims of Super Storm Sandy in both New York and New Jersey;
- Church and Religious Education activities, highlighted by hosting a local Religious Vocation Celebration Dinner with Arkansas' Bishop Anthony Taylor, and conducting a very successful fund raising event to help seminarians with their financial needs;
- Council 6419 also makes donations at the State level by contributing to the "Keep Christ in Christmas" campaign and to the "Pennies from Heaven Campaign," which provide(s) a statewide Knights of Columbus reserve of cash to provide assistance to families who are suddenly faced with one kind of hardship or another;
- Lastly, but perhaps most commendable, Council 6419 has received the Star Council Award from the Supreme Council for nine consecutive years. The Star Council Award recognizes Council 6419's outstanding achievement in membership, insurance and service program activities. To be eligible to earn the Star Council Award, a council must also qualify for the Father McGivney, Founder's, and Columbian awards.
- Hot Springs' K of C Council 6419's contributions totaled over **\$79,000** and they volunteered **12,874 hours** as they provided their 2014-2015 charitable donations to Garland County Arkansas.

On March 29, 1882 in New Haven, Connecticut the *Knights of Columbus* were initially chartered as a fraternal benefit society. The Order is still true to its founding principles of charity, unity and fraternity. The Knights of Columbus has grown from several members in one council to more than 14,000 councils and 1.8 million members throughout the United States, Canada, the Philippines, Mexico, Poland, the Dominican Republic, Puerto Rico, Panama, the Bahamas, the Virgin Islands, Cuba, Guatemala, Guam and Saipan. The *Knights of Columbus* has no affiliation with the manufacturers, distributors, or sale companies of ultrasound machines or technical training. The Knights of Columbus is one of the most active charitable organizations in North America. Knights last year also set charitable records by providing more than **70 million hours of charitable service** and over **\$158 million in donations** to charitable causes. Cumulative figures

2014-15 State Membership Report

Brother Knights,

It is an honor, to have the opportunity to speak at this, the 107th Arkansas Knights of Columbus State Convention, hosted by District 1, and it's DD John Lett. Welcome to our worthy State Chaplain, State Officers, District Deputies, Program Directors, Council Delegates, and all members of the Order. A special welcome to Arkansas, for our Supreme Delegate Jose Jimenez.

Before I move into the discussion of our membership growth around our state, I would like to discuss our current demographics in Arkansas. Let me begin by stating that I am a firm believer that we have a great opportunity that many of our councils are choosing to ignore. We are one of four states that have the lowest percentage of Catholics in the entire USA. Our Catholic population in Arkansas is currently at 8%, along with Alabama, Tennessee, and Mississippi, compared to Rhode Island with 54%. To make matters worse we have the lowest percentage of people practicing traditional Catholicism, at 4%.

Out of the 75 counties in Arkansas, 30 have less than one percent of their population are Catholic, and a handful of counties do not even have a Catholic Church. On top of that, we have many counties that have a negative population growth, with Monroe County having a more than 20% negative population growth ratio. The demographics of our state are changing and the money and population growth is shifting. It makes no sense to me that Supreme places a quota on councils that are located in counties and cities with that are slowly dying. The quota system is unattainable in certain councils throughout our state, as my presentation will attest.

Even though I have stated all of the negatives that we are facing. Again I want you to know of the great opportunity that our Order has in Arkansas. Our state, yes Arkansas, has the highest percentage growth rate among Catholics in the USA. Yes, you heard correctly, our state has the highest Catholic growth rate in the country. Now, who are these Catholic brothers and sisters that are moving into Arkansas? They are mainly move-ins from other states and immigrants from other countries. My home parish in Bentonville is probably one of most diversified in the state. It almost looks like a United Nations session, with majority Anglo population, but with Asians (mainly Vietnamese and Filipinos), Indians from the subcontinent, Europeans, and Hispanics representing just about all of the Spanish-speaking countries. Every parish in Arkansas has that ability to have that diversity; and I believe it's the Knights of Columbus that can help make that happen.

The next portion of my report is the presentation of the membership growth from all 16 districts in the Arkansas Jurisdiction. It congratulates all the districts and councils that have attained their membership goals, as prescribed by Supreme. One thing I would like you to notice is the location and the year of chartering of each of the councils and think about how our demographics have affected, both positively or negatively our growth throughout the different areas of Arkansas.

Your state officers have done a fantastic job this year. Last fraternal year, our growth was -1. Currently our growth is over +100. We have about two months before this fraternal year ends. How many lives can you help change? As many as you want! Open your council doors to as many Catholic families as possible. Let's live Father McGivney's legacy now, while we have the opportunity.





He is continuing his catechesis on the family, by stating” If we cannot generate sympathy for the covenant between men and women, children will be increasingly uprooted. The social devaluation of the stable and generative covenant of the man and woman is certainly a loss for everyone.”





The results of the 2014 Campaign For Persons With Intellectual Disabilities are in. The good news is that this year we were able to raise even more money for charity than last year. We exceeded 2013's total by more than \$2,000. This undoubtedly is because of all of the hard work of those councils participating in this year's state campaign.

Last year, in 2013, raised a total of \$70,722.31. It was the first time we had raised over \$70,000 in many years. However, that amount was exceeded in 2014 with a grand total of \$73,153.98. Of

that amount, over \$62,000 went to the local charities of each council's choice. In ~~the~~ March 2015, the former grand deputy, Mike Kieffer, and I presented a check in the amount of \$11,089.79 to this year's State charity of choice which is The ARC of Arkansas. The recipients told us it was the largest check that they had ever received from a charitable organization. This money will be used to help fund their summer camp which is ^a ~~a~~ vocational camp as well as a one-week opportunity for persons with intellectual disabilities to be able to enjoy nature and the outdoors.

I was particularly pleased that many councils participating in both the 2013 and 2014 fund raisers showed increased amounts from last year. Some of these increases were substantial in nature. In addition, we had four councils which had fund raisers this year which had not participated in 2013. Those councils were Charleston, Altus, Arkadelphia, and Siloam Springs. I want to personally thank each of those councils for their efforts.

I would also like to take the time to congratulate the Hot Springs Council, the Hot Springs Village Council, and the Bella Vista Council all of whom showed significant increases from what they had raised in 2013. Leading the pack was the Hot Springs Council with an 89% increase in moneys raised with the Hot Springs Village and Bella Vista councils each raising over 20% more than last year.



SUBJECT: Supreme Council Policies re: Knights of Columbus Events & Public Officials

In light of recent events, the Knights of Columbus Supreme Council takes this opportunity to reaffirm our long-standing policies of not inviting to any Knights of Columbus event, persons, especially public officials or candidates for public office, who do not support the legal protection of unborn children, or who advocate the legalization of assisted suicide or euthanasia, and that we prohibit such persons from speaking at Knights of Columbus events, or bestowing on them honors or privileges of our Order of any kind, or inviting them to serve as honorary chairpersons of events, celebrations, or committees, or hold any office in the Knights of Columbus.

This clear position is based on the policy of the United States Conference of Catholic Bishops (USCCB) that "The Catholic community and Catholic institutions should not honor those who act in defiance of our fundamental moral principles. They should not be given awards, honors or platforms which would suggest support for their actions" (*Catholics in Political Life*, 2004).

Violations of these policies by local councils result in public confusion about our positions, and damage to the good name of both the local council and the Order as a whole.

We therefore encourage you to take steps within your jurisdiction to ensure that these important policies are respected and followed by every local council.
