Principles

Unity and Patriotism—2 of our founding Principles of the Order are very timely for the current state of affairs. This month marks the 20th Anniversary of the September 11th attacks on our Nation. It's hard to fathom that this was already 20 years ago, but in the last few weeks we have been reminded of how quickly time has passed as well as HOW LONG 20 years is as we also had the official end of the war in Afghanistan. 20 years—some of our new members into our Order weren't even born in 2001! 20 years ago—as a Nation we stood united. Though

at times prior to this we were divided, immediately following the September 11th attacks as a nation we put differences aside as we all felt the pain of that day.

Fast forward to today where over the last year we once again faced a challenging time in our Nation's history with the pandemic. During this last year and a half though, instead of again being 'united' we are seeing growing times of division. 20 years ago Social Media had yet to come into the fold, so people relied on newspapers and nightly news to gain access to the information of the day around the globe. The internet wasn't common in all homes at that time, so many had to rely on these 2 mediums for receiving information and news. Nowadays we have wide-spread 'truths' and 'fake news' that bombard us on a daily basis. Where do we turn to find what is 'truth' and what is fake?

Maybe it's time we focus back on the 'truths' of what binds us together, united, as a Catholic family.

Truths: 1. Jesus was born 2. Jesus died for our sins 3. Jesus was resurrected and ascended into Heaven 4. Jesus will come again

As Catholics—we all share in our belief of these truths! No political division. No statements of who rightfully can receive the eucharist. This is the belief of our Church—and if we put aside our differences and stand in **UNITY** in the 'Eucharist' and the belief of what it represents we will once again witness the revival that is a focal point of our Bishops.

I have heard recently complaints that some Council meetings within our state have at times turned into political platforms for leaders to expound their opinions. Troubling when this happens from a pulpit, it's further troubling when it happens in our Council chambers! At times over the last year when our focus should be on helping others that are suffering—to focus on **CHARITY**—we have had some pursue selfish ideals.

It's time for us all to seek a similar revival back to the principles of our order—that of Charity, Unity, Fraternity and Patriotism as our focal point of what we stand by as Knights of Columbus. We are all brothers—A **FRATERNITY**—and we all took the same oaths, so our differences need to be cast aside so that we can continue the good works of fulfilling our founder Blessed Michael J. McGivney's vision.

At this same time, in reviewing the responses from our recent COVID Recovery Plan survey, I found some councils frustrated and angered by their Priests and Bishops response to the pandemic of the past

2 years. Instead of growing frustrated, why would we not try to 'UNITE' with our Parish and Diocesan leaders to try and ease the burden and 'WELCOME' people back to the Parish?

It's been 20 years since the attacks on September 11th, 2001, but so quickly it seems that we have once again grown divided as a Country. Imagine what our Parishes and our Catholic Church will look like in 20 years from now if we further sow seeds of Division?

We have already experienced troubling times of declining mass attendance and having our young Catholics move away from the Church. Instead of continuing to worry of the past or further push people away with 'opinions' or 'political viewpoints'—why would we not 'invite' back all to share in the wonder of the Eucharist?

My hopes for councils in this new fraternal year is that we work to put a stop to division within our Parishes and our Councils—to truly live out one of the original messages from the Knights of Columbus during the World War II era—'EVERYBODY WELCOME, EVERYTHING FREE.' This includes the freedom to have different opinions but at the end of the day to not allow those differences to interfere in our UNITY AS A CHARITABLE FRATERNAL ORGANIZATION!



Time is Running out!



This year's State Membership Incentive programs titled "WISCAPITA" give councils a chance to reduce or eliminate per-capita billing from the State Council. Here is how it works:

- **First Quarter** – if a council reaches and maintains their Supreme Membership Intake Quota by September 30, the State Council will waive 75% of the Council's October 1st billing and will have their April 1 per capita (4.25 a member) waived.
- **Second Quarter** – if a Council reaches and maintains their Supreme Membership Intake Quota by December 31, their April 1 per capita will be waived.

As your State Advocate one of my duties is to ensure that the Safe Environment training is completed. My first step was to note that about 5 dozen knights had not completed the training. I sent reminders out to all of those that were due by mid-September. Fortunately, I have heard back from many knights that they will complete the training by the due date.

In addition to that there are over 60 councils who have not submitted their forms 185 and/or form 365. Needless to say, that means we have probably 150 or more knights who need to get the training completed. I have started sending reminders to those councils and will have that completed in the next few days.

In our upcoming DD huddle, we need to stress the importance to our District Deputies of getting these forms submitted. If we do not know who needs the training it is certainly difficult to ensure that they complete it.

The Safe Environment training is critical in our mission to ensure that those we serve are not put into jeopardy. Not only that but we also need to protect ourselves to ensure that we do not create an environment where issues might occur.

Please take the time to ensure that your councils complete their forms and complete the training that is required.

Online Membership

There is a new membership class within the Knights of Columbus. It only exists within the ranks of the jurisdictional at-large online membership. It is called an Affiliate Member. Supreme has implemented this program over the last year and a half beginning with a trial program similar to online membership a few years ago. It is now under full implementation. 'On-boarding' of these members is underway.

What does this mean? To put it rather succinctly, when a member is suspended from a council for, let's say, 'non-payment', he no longer is removed from the membership rolls but is transferred into the state's at-large membership. This was fully implemented in February, but we are now seeing its effects. Just this last week we had an increase of 27 Affiliate members, all from one council.

While Supreme is forgiving council per capita payments and the state is offering incentives to reduce or eliminate per capita, councils are continuing to suspend their members for non-payment of dues. WHY? The at-large membership in Wisconsin grew from 214 to 291 just this last month primarily with Affiliate members.

Programs

Brothers,

As we head into September, a quarter of the way into our Fraternal Year, there's much to be done with school beginning, fall programming to be done, planning for winter activities, all the while battling the Delta COVID variant! Be sure that you are connecting with your Diocesan Program Coordinator, as well as your Diocesan Membership Coordinator every month. The DPCs are: James Vosters (Green Bay), Gary Wolf (La Crosse), Bill Paar (Madison), Dave Sytkowski (Milwaukee) and Mike Frase (Superior). You should also be paying close attention to the Fraternal Leaders Advisory that comes out from Supreme on a bi-weekly basis. It should be coming to all Council leaders on the 185 and 365 forms – a tremendously valuable tool! In addition, you should be signing up for the virtual training sessions (Delta Drive, Enhancing Membership Experience, Council Growth, Council Recovery Project, Council Meetings, and You Are Your Programs) in September hosted by our Regional Training Director

Jon Olson. If you're not receiving the Flocknote with the links to sign up for those sessions, contact jon or State Training Coordinators Chuck Rohr or Rick Raulin for more information.

Continue to plan and operate programs that both meet the priorities and needs of your pastor and parish as well as those Faith in Action, Leave No Neighbor Behind and State programs that you can manage. No matter what you do, use every program as a recruiting opportunity, whether it's a Church Drive, Information or Fraternal Benefits Night, a breakfast or dinner, or a Holy Hour or PPK contest. Have literature and handouts there; informed Brothers who can answer questions or invite guys to consider joining involving parents and parishioners in the cooking, serving or praying, etc. Reminder that the Diocesan PPK and fall Soccer Contests will be held from October 9-23 if sufficient numbers in a Diocese warrant holding the contest. Otherwise, DPCs will send council winners on to the State Contest. Check with your DPC for details. Forward all Council winners, alternates, their scores and contact information to your DPC. Travel cards can be obtained from DDs, DPCs, State Office or me. The State PPK and fall Soccer Finals are slated for Regis High School in Eau Claire on October 30.

I would recommend that every Council plan to do at least 1 major program in September and October (larger Councils do 2) that are Faith in Action- or Leave No Neighbor Behind-based. I'd suggest RSVP or Holy Hour/Rosary Program (Faith), Family of the Month or Family Prayer Night (Family), Catholic Citizenship or Culture of Life Essay Contest or PPK/Soccer Challenge (Community), Pregnancy Center Support or LifeSavers for Life/Baby Bottles program (Life). You can also do a Blood Drive or Get Catholics Back to Mass/Support the Pastor program (LNNB). You also have the usual October Church Drives or other membership programs, with the Information Nights and Knighthood Exemplifications. Strive for a parish or District Drive (in-person Exemp). You can also register candidates for the State Virtual Knighthood Exemp or September 8, September 29, October 11. Check the State website or with PSD Jack Wrbanich for details as well as for information on present incentives for Councils. The Supreme Virtual Knighthood Exemp continues to be available on demand. See the Supreme website for details.

Finally on the larger range, it's time to be planning your November-January programming, ordering supplies needed, securing dates and sites. You should be arranging for Sentiments for Seminarians, Keep Christ in Christmas signs, poster contest information, Consecration to the Holy Family (December 26), March for Life, Special Olympics, Free Throw Contest supplies, etc. Coats for Kids needs to be arranged. We are especially looking for sites in need of Coats for Kids in need (esp. minorities); Councils/Districts can work together and also share in the coats supplied by State/Supreme. If you have ideas for where or how those can be distributed, contact your State Officer in Charge of your Diocese (Jack Wrbanich –

Green Bay, Miles Casey – La Crosse, John Huttenhoff – Madison, Mike Tennies – Milwaukee, Don Schoenherr – Superior) or your DPC. Many other programs, relevant to your parish, Council, community can also be done in the November-January time frame. You'll receive more information from the September DD Huddles and December Diocesan Tour.

Communications the Key to Accountability

I recently attended our Associate Regional Growth & Training Director (ARGTD) Jon Olson webinars, where he told a story about four Knights named Everybody, Somebody, Anybody, and Nobody.

The story goes: "There was an important job to be done, and Everybody was sure that Somebody would do it. Anybody could have done it, but Nobody did it. Somebody got angry about that because it was Everybody's job. Everybody thought Anybody could do it, but Nobody realized that Everybody wouldn't do it. So it ended up that Everybody blamed Somebody when Nobody did what Anybody could have.

The story may be confusing, but the message is clear: no one took responsibility, so nothing got accomplished.

It's a story that plays out often in our councils, parishes, and on our teams - anywhere there is a culture that lacks accountability.

Biblical accountability begins with taking responsibility for one's actions and making a conscious choice to allow God and others to help accomplish what is right. Accountable to God Asking God for protection was a sign of dependence on God and accountability to him.

One aspect of organizational accountability begins with communications. Council leaders and members who don't know what is going on will have difficulty attending programs and events and participating in your council's good works. It's important to note there are many ways to communicate – phone, email, social media, text. I will leave that for another article.

Suffice to say, receiving and disseminating information from our State and Supreme Council will ensure Council Leaders and members receive up-to-date information. So, whether it's signing up for State Council Flocknote messages or receiving Knightline from Supreme, how can you be accountable to your member??

To sign up for State Council Flocknote messages, you can text **BROTHER** to **84576** on your cell phone. On your computer or pad, type <http://flocknote.com/knightswisc>. There is no charge, and you can discontinue at any time. Procedures have been added to prevent spying and "hacking" information.

Supreme sends out 'The Fraternal Leader Advisory' monthly it is sent to all state deputies, state and council membership directors, state and council program directors, state and council faith, family, community and life directors, executive secretaries, district deputies, grand knights and financial secretaries to help them keep current on the Order's objectives. 

I am happy to be renamed the Wisconsin Knights of Columbus Helping People with Intellectual Disabilities Program. It was a position I held from 2013-2019, and as I told State Deputy Corey it is the job which makes me most proud to be a Knight.

September brings opportunities to the Helping People with Intellectual Disabilities Program. We have closed the books on the 2021 Drive which allows Councils who turned in checks and forms to be able to return funds to organizations in their community who assist those with intellectual disabilities. Closing the books also allows Councils who didn't participate the last two years to begin fresh with this awesome program. We are hoping to begin building the ID Program back to the most recognizable Knights of Columbus Program in the State of Wisconsin and we will do it! 2021 collection was a 42% increase over 2020 and if we can make another step of 40-50% increase we will be back!

How do we come together to bring this program back to the record setting collection amounts we were able to obtain each year?

Run the program in your community!

Sound too simple but it really is that simple. People in all towns of all religions, races, sexes, and political affiliations, believe in assisting people with intellectual disabilities.

An easy benchmark to see if your council is doing as well as other councils is to aim for \$20 per member which has been the state average in the 2010s. If your council hasn't run the program for years and have struggled? Aim for \$10.

Still have Tootsie Rolls in your possession? Sell a box or an entire case to local business or council members. The candy is easy to get rid of for Trick or Treating. Try to conduct your 2022 ID Drive with new softer candy. Plus, if you sell your candy for a bit more than you have in it you have a jump on next year's collection.
