My Dear Brother Knights

As Knights of Columbus we cannot be part of what Pope Francis has called the "complicit silence" of many who hear of these atrocities and do nothing. We must act.

My Brother Knights,

No Cross, No Crown!

No cross, no crown. No pain, no gain. No guts, no glory. St. James summons us to see the challenges we face as opportunities to rise to new heights of existence, "Blessed is the one who perseveres under trial because, having stood the test, that person will receive the crown of life that the Lord has promised to those who love him" (Jas 1:12).

In the military, the cross and crown symbolizes a soldier's willingness to remain faithful to the mission at hand, to each other, and to country, no matter what. This kind of unwavering dedication is exactly what Jesus meant when He gave us the criterion for enlisting in His elite fighting force: "If any man would come after Me, let him deny himself and take up his cross daily and follow Me. For whoever would save his life will lose it; and whoever loses his life for My sake, he will save it. For what does it profit a man if he gains the whole world and loses or forfeits himself?" (Lk 9:23-25).

While sounding like a military drill instructor, St John Vianney expounds on this radical call to discipleship: "There is no doubt about it: a person who loves pleasure, who seeks comfort, who flies from anything that might spell suffering, who is over-anxious, who complains, who blames, and who becomes impatient at the least little thing which does not go his way — a person like that is a Christian only in name; he is only a dishonor to his religion, for Jesus Christ has said so: 'Anyone who wishes to come after Me, let him deny himself and take up his cross every day of his life, and follow Me.'"

The Gospels stories show how Jesus touched people in ways that made them question the direction of their lives. Some turned away because His challenge seemed to be too hard. But many others were so moved by His mission and ministry that they were compelled to search for a more perfect way of living and being. Where do you stand? Are you ready to put it all on the line? This means nothing less than to do what God is calling you, from the depths of your being, to do; to rouse yourself to action on behalf of the kingdom. Are you ready to say "yes" to the call to become His champion?

(State Deputy continued) Government officials and legislature should feel overwhelmingly compelled to take quick and decisive action in light of this. Yet with the complicit silence of the secular media many, even some who call themselves Catholic, continue to support the grisly practice of violently killing the innocent.

We will not be complicit with silence. We have acted and we will continue to act. We will also speak. And we encourage each and every one of you to use your God-given voice to speak out as well.

Through the Wisconsin Catholic Conference, our Bishops have spoken. This is what they have said: *The Wisconsin Catholic Conference, the public policy voice of the state's Catholic bishops, strongly supports Assembly Bill 305, which would prohibit the sale and use of fetal body parts derived from an unborn child whose life is terminated by an induced abortion. The two pillars of Catholic social teaching that support every position we take are 1) that human life is sacred and 2) that human life is social.*

However, these are not simply religious principles. Rather, as the Founders asserted in the Declaration of Independence, these are self-evident truths. Life is sacred not because it is a choice made for us by others, but because it is an endowment from the Creator. And because all of us are connected by our common humanity and all of us are created equal, when the rights of one are trampled, the rights of all are threatened. That is why the Founders asserted that government exists to secure these rights.

The practice of selling human tissue, especially when it is procured by the willful destruction of a developing human life, is an assault on both those principles. This practice is wrong not only because it violates the teaching of various religious traditions, but also because it rejects the values enshrined in the Declaration of Independence itself.

Human life is not a commodity to be bought and sold or otherwise diminished for the gain of others. A civilized society treats every human being as an end, not as a means to an end. A human being must never be seen as a collection of spare body parts. The sale of fetal tissue and organs is one more example of what Pope Francis has called the "throwaway culture, which has today enslaved the hearts and minds of so many."

Research involving the use of human tissue and organs offers exciting possibilities for the prevention and treatment of diseases and disabilities. We all long for the day when cancer, Parkinson's, and Alzheimer's can be cured or prevented entirely. But the manner in which this research is conducted is as important as the cure. Medical progress must always be accompanied by moral progress. Medical progress must always be measured in light of its impact on the human person.

*As the bishops wrote in their 2008 pastoral letter, *Serving All and Sacrificing None: Ethical Stem Cell Research*: [R]aising moral concerns is essential for genuine scientific progress. Consider the infamous biomedical case of the Tuskegee Syphilis Study. Even after penicillin was discovered in 1947, medical researchers working for the U.S. Public Health Service in Tuskegee, Alabama, deliberately withheld the drug from infected African-American men—impoverished and mostly illiterate—without their consent, so that they could study the full progression of the disease. Today, no one would dispute that ethical standards were sorely lacking in the Tuskegee Study and that true scientific progress can be made only when those standards are securely in place.*

The Catholic Church firmly believes that medical progress can be made without selling human body parts as if they were mere commodities. Today when medical experimentation on animals is falling out of favor with the general public and with many in the scientific community, we need to insist that scientists find other ways to cure diseases without sacrificing human lives. We are confident that if the sale of aborted fetal body parts is prohibited, human ingenuity will find other, moral means of conquering diseases. The many cures made possible by the use of adult stem cells is proof of this.

Finally, we are very concerned that the trade in fetal body parts depends on providing false or misleading information to young and vulnerable women about what will happen to their aborted children. How many of these women are truly consenting to what has become a lucrative trade? We see parallels here with the practice of harvesting adult organs from the poor in developing countries for the benefit of wealthier persons in the developed world. We must not allow this to continue.

I would like to close with another quote from the bishops' stem cell pastoral: Many scientists are people of deep faith and moral conviction. They recognize that faith and science, far from being mutually exclusive, in fact complement one another. Instead of asking, "Will we be religious, or will we be scientific?" they ask, "How can our scientific research best serve humanity? How can we best respect our human subjects in our research?"

AB 305 affirms the dignity of the most vulnerable human life, both mother and child. It affirms ethical scientific progress. We strongly urge you to support it.

Once again, I join PSK Virgil Dechant in decrying the lack of moral clarity in our country today evidenced by the unwillingness of so many to confront this epic and so clearly evident evil.

What can we do? First, each of us can pick up the phone and make sure our representatives know that we fully support our good bishops in this. Next, let us further respond by inviting every Catholic man to join our ranks. We are 36,000 strong in Wisconsin, but if we are honest with ourselves we know we should be 136,000 strong, especially in times like these.


Lastly, in this extremely important work, let us not forget our brothers who have already joined our order. Take on the responsibility to reach out to them with a personal contact at least twice every year, once on their birthday and once on the anniversary of their becoming a Brother Knight. Each and every man who joins our order is important to us. Every human life has infinite value. Our actions need to bear witness to that fact if we are to have integrity when we invite new men to join us.







"The matrimonial covenant, by which a man and a woman establish between themselves a partnership of the whole of life, is by its nature ordered toward the good of the spouses and the procreation and education of offspring." (1601)

"The intimate community of life and love which constitutes the married state has been established by the Creator and endowed by him with its own proper laws. . . . God himself is the author of marriage.' The vocation to marriage is written in the very nature of man and woman as they came from the hand of the Creator. (1603a)

"Since God created them man and woman, their mutual love becomes an image of the absolute and unfailing love with which God loves man . . . And this love which God blesses is intended to be fruitful and to be realized in the common work of watching over creation." (1604)

"Holy Scripture affirms that man and woman were created for one another: 'It is not good that the man should be alone.' The woman, 'flesh of his flesh,' his equal, his nearest in all things, is given to him by God as a 'helpmate'; she thus represents God from whom comes our help." (1605)

The experience [of evil all around and within us] makes itself felt in the relationships between man and woman. Their union has always been threatened by discord, a spirit of domination, infidelity, jealousy, and conflicts that can escalate into hatred and separation. To heal the wounds of sin, man and woman need the help of the grace that God in his infinite mercy never refuses them. (1606, 1608)

Member Retention

Proposing a new member is a commendable achievement and one to be proud of. However, as a proposer, turning over a completed Membership Document (#100) is not the end of the job. You must also take the responsibility to see that your recruit becomes fully accepted by his fellow council members and stays involved in council activities. There are several steps you can take to ensure this.

- Explain to him that the council's Admission Committee will examine his qualifications for membership and accompany him to the Admission Committee meeting. Introduce him to the members present.
- After he has been accepted, escort him to his First Degree and remain with him throughout the event. Following the exemplification, introduce him to his fellow council members.
- Take the newly initiated member and his family "under your wing". See that he learns council procedures, such as meeting times, committee assignments, etc. Introduce him and his family at council events. Encourage him to involve his family in council-sponsored activities.
- Accompany your recruit to his Second Degree and Third Degree exemplifications and stay with him throughout the day.
- Contact him before each council meeting and bring him to the meeting if necessary. If the new member becomes inactive for some reason, try to find out why. Call and ask to visit with him. Explain your concern about his absence and offer support or assistance.

Encourage him to earn "Shining Armor" status within the council.

If the Knight becomes inactive, his proposer should work with the retention committee to find out the reasons for his lapsed interest and try to converse his membership.

With a little personal effort you can help guarantee that your recruit becomes an active member of the Knights of Columbus.

How to make a Charity Grant Request:

When submitting a Wisconsin State Council Knights of Columbus Charity Request Form to the State, a Knight must interview the individual/family and fill out the form completely. We get many forms which are incomplete which only delays the recipient receiving funds in a timely fashion.

The State Charity Request Form can be found on line at www.wikofc.com. If you have a problem locating this form, contact the State Charity Director. Use this updated form and discard any older forms you may have on file.

Individuals in need should NEVER complete forms themselves, as Knights we help people! As stated on the Wisconsin State Council Knights of Columbus Charity Request Form.

“The Form must be filled out by a Knight of Columbus but the beneficiary need not be Knight of Columbus or a Catholic to be considered for a charitable donation from the Wisconsin State Council Charity Fund.” If the beneficiary is a Brother Knight or a member of his family, the form must be filled out by another Brother Knight. This is quite sad as well as embarrassing that they had to plead their own case. This is the job of the Requester KNIGHT. The Grand Knight must sign the Charity Request Form.

The Committee for Helping People with Intellectual Disabilities (ID)

The Helping People with Intellectual Disabilities Committee has had a very interesting past 2 years. Sadly two long time committee members have passed away in 2015, Jim Neubauer in June (LaCrosse) and Ray Dufano in September (Green Bay). Ray and Jim were both still members of the committee upon their deaths. When I joined the ID Committee in 2013 the six members of the committee had a total of 128 years of combined experience. The ID Committee had been a stable force within the Knights of Columbus in the State of Wisconsin. The 2015 Committee will have all newer members who hopefully can gain the experience, Chuck Simmons (Member 14 and Director 15 years, 29 total years), Ray Dufano (Green Bay-13 years), Jim Neubauer (LaCrosse-27 years), John Bednarek (Madison 19 years), James Krupski (Milwaukee- 13 years), and Morris Marsolek (Superior-27 years), gave to the program.

The 2015 ID Committee members are: Mark Jelinek (Director-3rd year), Greg Sutton (LaCrosse-1st year), Jim Vogt (Madison-1st year), Dan Castle (Milwaukee-2nd year), and Don Schoenherr (Superior-2nd year). The ID Committee will name the Green Bay Committee Member before our annual meeting in January.

With a brand new ID Committee, groups who have been approved or denied money in the past from the State ID Grant Disbursement Meeting may change. Potentially, New Men=New Thoughts. As of September 12, no groups have applied to receive a grant from the State ID Program. This is money raised by your councils through the Tootsie Roll Drive. Instructions of how to apply are below.

The Wisconsin State Council Knights of Columbus has released the final figures of their recent Tootsie Roll Drive to "Helping People with Intellectual Disabilities". The 2015 program raised in excess of \$679,000.00. Local councils have distributed in their immediate area over \$464,000 of these funds to local groups and organization that assist the intellectually disabled. The State Committee has available an additional \$154,000 to distribute through their grant application process.

Organizations that work with People with Intellectual Disabilities are encouraged to submit applications for these funds to the Wisconsin State Knights of Columbus. Grant applications can be directed to: Wisconsin State Council Knights of Columbus % Mark Jelinek, State Director, 120 North Park Street, Richland Center, WI 53581. Fifteen (15) copies of the application are necessary and must be submitted by November 20, 2015. Applications must be written on your organizations letterhead and must contain the following information: who do you serve, how many people you serve will be impacted by the grant, how much money you are seeking, and what the money will purchase or provide.

Knights of Columbus Councils are encouraged to assist groups to apply for grant money but the application itself must come from the organization who will receive the grant.

A list of the 2015 Approved Grants can be found on the Wisconsin Knights of Columbus Website, Forms Page, Community Heading.

All groups who apply will be notified in mid-January with the decision of the Wisconsin Knights of Columbus, Helping People with Intellectual Disabilities Committee.


I'm the guy who asked to join your organization. I'm the guy who paid his dues to join.



Holy Family Prayer Program

A new Knights of Columbus Holy Family Prayer Program centered on the Holy Family was launched August 5th at the 133rd Supreme Convention held in Philadelphia. The image is a copy of the original which features an etching of the Holy Family by the 18th-century artist Giovanni Balestra. At the end of the Wednesday morning Mass, State Deputies from each of the order's seventy-four jurisdictions received a specially prepared framed image of the "Holy Family" for use in the prayer program. Presiding at the ceremony was Archbishop Chaput who inaugurated the Order's new Holy Family Prayer Program, who prayed for God's blessing upon the State Deputies as they prepared to take the image to their jurisdictions. Archbishop Chaput of Philadelphia, during his homily remarked on the theme of this prayer program; "We are called to love and serve one another and to see the gifts and talents of our family members as gifts from God that can enrich us all," he said. "We must ask God to restore our families in love, and teach us to be more forgiving, and to cherish and nurture the unique gifts of others." The initiative will begin with prayer for the success of the World Meeting of the Families as well as the Synod of Bishops on the family, which will take place in Rome in October.



This is real easy. You need only location and people. Grand Knights, appoint a person to contact your parish priest to introduce and promote a service. We would like to see each council host at least one service. Local councils are asked to sponsor prayer services in parish churches and other locations before sending the image to a neighboring council. Contact your District Deputy to schedule your Holy Family Prayer Program.

Each image will come in a specially designed carrying case, which will allow the image to be safely transported throughout the jurisdiction

Inside the case will be a log book for that image. Each time a council conducts a prayer service, the number of attendees should be noted in the log book.

Throughout the program, the Program Coordinator (Kevin Blau) will periodically ask for updates on the number of services and the number of attendees...these completed log books will be the only means to access that information.

A supply of Holy Family Prayer Books and Prayer Cards for each image will be provided. These will come in a sturdy plastic briefcase, again to allow safe transportation throughout the jurisdiction. Supreme has also post electronic versions of these books and cards to the Order's web site at www.kofc.org. These supplies will not last the duration of the program, you'll be able to order additional quantities at any time through our State Coordinator Kevin Blau... please allow about two weeks for delivery.

A supply of booklets and other initiatives encouraged by our State Deputy Ron Faust for the State of Wisconsin will be included with instructions with the image.







Assembly Bill (AB) 305 bans the sale and use of aborted fetal body parts. The bill was amended by Assembly Substitute Amendment (ASA) 1. Under ASA 1, fetal body part is defined to mean a cell, tissue, organ, or other part of an unborn child who is aborted by an induced abortion after January 1, 2015. ASA 1 also requires the abortionist to arrange for the final disposition of fetal body parts resulting from the induced abortion. Final disposition is defined to mean the disposition of fetal body parts by burial, interment, entombment, cremation, or incineration.

Speaking to the *International Business Times*, Nahren Anweya, an Assyrian-American activist, said that **the extremist group is seeking to suppress any Christian presence in the region.** Our entire ancestral homelands have been completely taken and now they won't even allow us to sustain our religious faith in one God and his son Jesus Christ, "Anweya said. **We have been purged out of Mosul, Nineveh, Khabour, Hassaka, Qaryatian and many more ancestral Assyrian homelands. They took our native homelands, our girls, our churches and now they want the few lives we have left."** At least 450,000 of Syria's pre-2011 Christian population of 1.17 million are either internally displaced or living as refugees abroad, the *Catholic Herald* reports.

After reading over the list of 11 rules for Christians living under ISIS, taking time to specifically note the promise that Christians will be safe, so long as they obey these rules, you should realize this: all of these rules come straight from Islamic teaching on dealing with Christians. This is how Islam deals with Christianity, and this is why, in the Muslim world, each day there are fewer and fewer Christians living there. The promise of peace, for obedience, is a lie. Even as ISIS promises Christians they will be safe if they obey the rules, Christian money is stolen, property confiscated, children kidnapped, women raped and men murdered.

The philosophy, beliefs and practices of the monsters in ISIS are abominable and have been for over a thousand years. We cannot "coexist" peacefully because the basic tenets of Islam teach that it must dominate... and so long as this is, how can Christians, Buddhists, Atheists, or anyone "coexist" with them in any manner other than as slave to master? **It is impossible.**

The [Syrian Observatory for Human Rights is reporting](#) that Christians in towns captured by ISIS were recently issued these new commandments and will be forced to obey under threat of the penalty of death. These new rules are in addition to the "jizya" (or tax) already imposed on all non-Muslims living under ISIS rule.

The text of covenant stated, "this is what Abdullah Abo Baker al- Baghdadi Amir al- Mueminin gives to the Christians in Damascus State – al- Qaryatin sector, where he guarantees their money, souls, not to force them to change their religion and not to harm anyone of them. The text of covenant added some conditions on the Christians in the city of al- Qaryatian that are:

- **Not to establish any church, monastery and hermitage.**
- **Not to show a cross or anything from their books** in Muslims roads and markets, and not to use amplifiers when they perform their prayers.
- **Not to make Muslims hear the recitation of their books and sound of their bells, and to use the bells only inside the churches.**
- **No to do any aggressive acts against "Islamic State" such as hiding spies and the wanted, and if they know that there is conspiracy against Muslims they have to reported that.**
- **To commit themselves not to show something of their rituals of worship.**
- **To respect Islam and Muslims, so not to vilify anything in their religion.**

The Christians must comply with paying Jizya (a religiously required per capita [tax on non-Muslims](#) under Islamic law) that is 4 golden dinars (the dinar here means the golden dinar that was used in transactions because it has fixed amount that is 4.25 gm of pure gold) paid by the rich, half of them paid by the middle class and half of that on the poor, and they can pay them in two installments a year.

- They cannot have weapons.
- Do not trade in the sale of pork or wine with Muslims or in their markets and do not drink wine in public.
- They have their own cemetery as usual.

To commit themselves of regulations imposed by "Islamic State" like modesty in wearing clothes and regulations of buying and selling etc. The statement concluded, "if they comply with these conditions, so they have are safe in their lands, money and souls, and they are not going to pay one-tenth except they bring money to trade from outside the IS territories not oppressor nor oppressed. None of them is going to be punished under a sin committed by another else of them. **In case they violate the conditions of this writ, then "Islamic State" is going to deal with them as they deal with people of war (warriors).**



OPERATION ARCHANGEL - Sheboygan



The Fourth Degree Knights of Columbus are themed on Patriotism and love for God and Country. In recent years, the Monsignor Philip Dreis Assembly 1204 has made donations of prayer books and bibles to the Milwaukee VA Center, where there is an associated Chaplains Services Department. While funds in the Assembly weren't always plentiful, a new idea was needed to help provide for the faithful at the VA center. As expected, a group of Sir Knights based in Sheboygan answered the need.

After receiving inspiration from a veteran related promotion in Columbia Magazine, and having a father who had served in Vietnam, Francis Goettl (Grand Knight of Council #722 at the time) stepped forward with his wife, Jackie, to chair the group. Francis and Jackie began contacting Brother Knights and fellow parishioners. The plan which formed was a Fund Drive very similar to the "Tootsie Roll Drive", using the same canisters with new printed wraps; a distribution of Tootsie Pops, and a partnership between the Fourth Degree Knights and the Catholic Parish based Boy Scout and Cub Scout Troops. The Fund Drive would be named "Operation Archangel" in respect of the great Archangels St. Michael, St. Raphael, and St. Gabriel who serve God selflessly, just as our brave veterans have served God and Country. The motto formed was "Help Chaplains Care for our Veterans."

When the plan was formed, permission was granted by the Priests from St. Dominic, Holy Name of Jesus, and the Southside Tri-Parishes in Sheboygan. The Fourth Degree Assembly agreed to sponsor the "Operation Archangel" and Our Lady of the Rosary, Council 722 provided use of its Tootsie Roll Canisters. Sir Knight Bob Jeske handled the ordering of the Tootsie Pops, SK Don Pitzen gathered volunteers for St. Dominic Parish, SK Andy Hughes coordinated with Boy Scout Troop #818 and Cub Scout Pack #3816 for the Southside parishes, and Boy Scout Leader Brooks Hesselink coordinated Boy Scout Troop #890 and Cub Scout Pack #3821 for Holy Name Parish.

On Memorial Day Weekend, May 23 and 24, 2015, the Fourth Degree Knights of Columbus Assembly 1204, Cub Scouts, and Boy Scouts from the Sheboygan Catholic Parishes, with support from Sheboygan Knights of Columbus, Council 722, held the very first "Operation Archangel" fund drive with the motto: "Help Chaplains Care for Our Veterans" Profits from the drive were almost \$1300.00. Announcements thanking everyone were placed in all the Sheboygan Catholic Parish Bulletins. This was a successful event, begun with the 4th Degree and radiating outward to the community.

It would be wonderful if other Fourth Degree Assemblies would initiate their own "Operation Archangel" and the State Council would encourage events like this which support Veterans through their Chaplains. At this date, we are aware of only the Milwaukee VA Center which has a Chaplain Services Department.




